Dear Mr. President,

RE: project of vital importance

I am an independent researcher, PhD, an Israeli citizen, currently a pensioner, 77. I apply to you with a project vital for the destiny of civilization, for the destiny of the Jewish people, in particular. I apply to you because you seem to be the only person in Israel with the wisdom and authority to support the project.

The project is based on my life-long research in exact sciences and humanities and provides for the establishing in Israel of **AN INTERNATIONAL SCIENTIFIC CENTER** aimed at reforming modern science and education. At present there is a virtual prototype of that institution, my website, *The Reform Science Center* ([www.reformscience.org](http://www.reformscience.org)).

The urgency of such an institution is emphasized by the recent UN recognition of the Palestinian statehood, which will most likely lead to a new most dangerous, irreconcilable confrontation. The only way to settling the Israeli-Palestinian conflict is to turn Israel into a state for both peoples, the Jews and Palestinians. But that conversion would require a radical reform of ideology of both societies and therefore the reform of science and education. Thus, if the government of Israel is seriously concerned in the security of the Jewish people, it should abandon its current Zionist dream and adopt the scientific approach to the problem. Scientifically, Israel cannot be recognized as a Jewish state, which the government insists on, just because it does not have recognizable geographical borders; such borders would only appear for the one joint state. Besides, the joint state would be much more consistent with the present geopolitical trend of globalization.

In this connection would you please take urgent measures to find a donor, in this super-rich country, for me to establish and run the above scientific NGO; my first task would be to put the reform of science on track and prepare younger researchers to substitute me when necessary. It should also be kept in mind that the reform of science and education would be good in itself and elevate the moral. As to my own conditions, I live now in a hostel controlled thoroughly by foreign agents and need an appropriate accommodation for the mission. Please, find additional information on the matter enclosed.
