e. Entre Companions. The City (Scott Erickson) has obtained the key to the storage unit and we are now in control of it. The City will be moving the equipment in the storage unit to a secure storage area at the City garage.

Friday (November 16, 2012) is the deadline to respond to the City's letter. Mark Ruppe wanted to know the dollar amount of the delinquencies. (The loan balance is \$344,619 as of today's date.)

Mark said he also had a conversation with Black River Dental and the owner said he would pay.

8. Burton Industries loan agreements/Ottawa Forest Products.

Director Brown informed the EDC that Burton has indicated they are not able to move forward on leasing the Spec Building from the City. Ottawa Forest Products seem interested. It's been indicated that eight new jobs could be created with Ottawa moving in. The City has control of the \$300,000.
