Dear Mr. Abbas,

RE: proposal vital for the PA

I am an independent researcher, PhD, an Israeli citizen, 80. I appeal to you for assistance on matters of paramount importance for the destiny of civilization, in general, for the proper solution of the Israeli-Palestinian conflict, in particular. This is a new version of my email to you of 24.03.12.

Scientifically, the two-state solution is impossible in principle. The one-state solution is the only proper solution of the Israeli-Palestinian conflict, because, in particular, it would lead society forward to a higher ideology consistent with the current trend for globalization, unity and cooperation, while the two-state solution would push society backward to the wildness of primitive nationalism fraught with a new most dangerous confrontation. The one-state solution would be very much useful for the Jewish people of Israel as well.

The one-state solution however needs the proper reform of ideology and society, which suggests the necessity for the reform of modern science, education and religion. Such a reform is urgently necessary in general to overcome the present general ideological crisis of civilization now threatening the very existence of humankind and manifesting itself perhaps most acutely in the Middle East. No doubt, such a reform is quite a task in itself, but there is no other way for survival.

Fortunately, the way to such a reform has been paved by my decades-long independent research in exact sciences and humanities. The only world organization that should lead the reform of modern science is UNESCO. However UNESCO, as well as the major scientific centers and universities, seem to be thoroughly paralyzed by scientific establishment who resist any reform threatening their privileges. For that reason, I have launched my own website, the Reform Science Center, aimed at coordinating the reform of modern science, but such a project cannot be fruitful in Israel. Besides, such a mission cannot be hinged long on the enthusiasm of a pensioner, but needs support and participation of the whole scientific community. To proceed with that mission properly, it is necessary to establish a small office (for 7-10 persons) or a center, for example, THE MIDDLE EAST REFORM CENTER (MERC).

In this connection, given your UNESCO membership, as well as your interest and resolution to find the proper solution of the Israeli-Palestinian conflict, would you please mobilize the power and finance of your supporters to overcome the resistance of the European establishment and create either the proper new department in UNESCO or the above Center in Europe, possibly under my direction for two years at least, which would enable me to proceed with the above mission and prepare younger researchers to take it over when necessary.
