

The “LIZZIE BORDEN PUB DAY” INSTAGRAM Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Sweepstakes may only be entered in or from the 50 United States and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the Sweepstakes if you are not located within the 50 United States or the District of Columbia.

1. How to Enter. During the Sweepstakes Period (defined below), access the Instagram application on your mobile device, and follow the links and instructions to become a follower of Sponsor @simonbooks. Take a photo (“Photo”) of “**The Trial of Lizzie Borden publication day post**” and/or write a caption on “The Trial of Lizzie Borden publication day post” in 140 characters or less (“Caption”) which describes or names a friend who is also interested in reading (“Theme”) and upload the “**Photo**” with the hashtags #LizzieBordenBook to your Instagram account story or feed. Your post must include the hashtags #LizzieBordenBook. You must have an Instagram account to enter this Sweepstakes and you must make sure the “Photos Are Private” option in the account settings on your Instagram account are set to “OFF”.

If you enter using your mobile device, standard data fees may apply. You should consult your wireless service provider's pricing plan for details. You agree to incur any and all charges demanded by your wireless carrier. You should also check your device's features for capabilities and check the device manual for specific use instructions.

The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

2. Sweepstakes Entry Start/End Dates. Sweepstakes begins at [10:00 AM] Eastern Time ("ET") on [March 12, 2019] and ends at [10:00AM] ET on [March 13, 2019] ("Sweepstakes Period").

Participation open only to legal residents of the fifty (50) United States and the District of Columbia, who are at least [sixteen (16) years of age and the age of majority in their state of residence].
