**Step 1:** Prepare needed documents and send them to us through our secure portal. The audit period is from 03/01/2021 to 03/01/2022. Further below you will find the documents we need to complete the audit of your policy. Enter Work Order # Code **WpzGAM** in the field provided. If you have trouble accessing or using the records portal, you may also obtain technical assistance by calling 866-873-4952.

<u>Important!</u> – The security of your data is of the utmost importance to us at Overland Solutions. Our auditors are prohibited from accepting paper copies of records or records by fax, e-mail or US Mail due to security issues. Please do not upload any documents that have PII (personally identifiable information such as social security numbers, employee addresses, etc.). That information must be redacted if you have documents that contain it.

If you do not have any of the above-indicated records, a review of your check register, deposits, or tax returns may be necessary.

**Step 2:** Confirm with me by e-mail or phone that your documents have been uploaded and you will be able to speak to me by phone on 03/30/2022 between the hours of 8:00AM to 5:00PM. If the date and time I have selected does not work for you, we can work to find another day and time.

**Step 3:** When we meet by phone I will interview you to obtain an overall description of your business, job duties of employees, if required and a listing of the owners or principals. Lastly, I will complete an exit interview to make sure that you and I both understand the audit report.

All information that you provide will be kept strictly confidential and reported only to your insurance carrier. My contact information is below if you have any questions regarding the audit.
