Ex-Nashville Police Officer Fired For Facebook Post Sues

A former MNPD officer, fired in February 2017 after an inflammatory Facebook post about the Philando Castile shooting, is suing.

NASHVILLE, TN -- A former Metro Nashville Police officer, fired last year for an inflammatory Facebook post about a Minnesota police shooting, is suing the city for violating his First Amendment rights.

On July 7, 2016, Anthony Venable, a Hermitage Precinct officer, posted in Facebook comment thread about Philando Castile, who was shot during a traffic stop in Falcon Heights, Minn. the day before. "Yeah. I would have done 5," Venable wrote. Castile was shot four times.

Venable, who is represented by notable Nashville defense attorney David Raybin and Brentwood attorney Larry Crain, argues that the department's social media policy is selectively enforced, noting that just days after his firing, another officer was decommissioned, though not fired, for posting a picture of Black Panther Party National Chairman Bobby Seale and Defense Minister Huey Newton standing armed in Oakland, Calif. in 1967.





Attorney Larry Crain declined to represent the Davis family in June 2009, a month before Steve McNair was murdered. In Feb 2016, Attorney Larry Crain filed a \$3 million "defamation-invasion of privacy" lawsuit to silence Austin Davis. A \$2.1 million "defamation" default judgment is now protected by a permanent injunction. Apparently, all of this is legal and ethical in Tennessee. A notice of appeal has been filed with the Middle Tennessee Appellate Court.

Dear Austin and Catherine,

It was my pleasure to meet with both of you today. I have since had an opportunity to review the documents that you left with me concerning your case.

The facts as related by you raise a host of legal and constitutional issues, all of which are complex in nature. It appears to me that you have sought repeatedly to resolve this matter following the admonition of the Holy Scriptures in 1 Corinthians: 6, Matthew: 18 and others. It is indeed unfortunate that your appeals to the ecclesiastical authorities of the church seem to have fallen on deaf ears. Austin Davis, Covenant Presbyterian, and the Present Day Battle of Nashville, Tennessee

On a picturesque hill in southern Nashville, Tennessee, a knoll the old-timers named Red Bud Hill, sits a beautiful building called Covenant Presbyterian Church (PCA). 





On July 2, two days before Steve McNair was murdered, his 20-year-old girlfriend Sahel Kazemi decided to unload all of her furniture on Craigslist. Family members say she was preparing to move in with McNair, who she believed was getting a divorce.

Though this is just educated speculation, it would appear to be further evidence of a murder-suicide: Young woman believes she's about to move in with former quarterback. But former quarterback isn't actually getting a divorce, and decides he might have run the old I'm-Going-To-Leave-My-Wife string just a bit too long, since his mistress is selling all her furniture. So he decides to come clean. This couldn't have been a pretty conversation.

Either way, we may get a final police ruling today. **Chief Ronal Serpas has scheduled a press conference for 2:45.** And chiefs, being the boss and all, usually don't decide to headline press conferences unless there's a significant breakthrough to unveil.


Was someone else inside the condo that night? Or before police arrived?

According to an officer who arrived on scene at 3:15 p.m. on July 4, both the back door in the dining room leading to a balcony deck and the door leading to the garage were found unlocked. Conceivably, an intruder could have entered or exited the condo from either area.

Another intriguing third party figure surfaces in a supplemental report to the case.

In it, Sgt. John Nicholson states upon arrival at the scene he was informed by lead investigator Charles Robinson that "three citizens, friends of McNair, had been through the apartment prior to police arrival."

Three citizens? Public reports repeatedly named only two people who set foot inside the condo before police arrived - Wayne Neeley, McNair's roommate, and another friend who Neeley called to the scene, Robert Gaddy. So who is Citizen No. 3? Who else was in that condo before police ever arrived?

Neeley told police that he first arrived at the condo at around 12:40 p.m. He walked through the living room - the crime scene -- thinking the male and female were both asleep - somehow missing all the blood and bullet holes - before entering the kitchen and getting a beer from the refrigerator. From there, Neeley said, he walked back to the living room and finally noticed the blood, stopping to pick up a shell casing. At this point Neeley told police he still didn't recognize the male victim as McNair. He then exited the condo and called Gaddy, who arrived about 15 minutes later and immediately exclaimed, "Oh my God, it's Steve!" By the time Gaddy called 911 at 1:35 p.m., 55 minutes had passed since Neeley first showed up. Which begs these questions: how did Neeley not know it was McNair, a guy he'd lived with for at least three years? And what happened during that nearly one-hour interlude before police and medical personnel arrived?

The police said they "looked at" Neeley as a suspect. Postiglione went so far as to call his story "ridiculous." But in the end they chalked it all off to Neeley being in a "state of shock" and determined he had "told the truth."

"If he was involved," said Postiglione, "I would think he would come up with a whole lot better scenario than that one."




Financial Snapshot

For the current fiscal year, Covenant is operating under an annual budget of \$4.1 million. Approximately 59% of members contribute to the general fund. RULE 6: THE GRAND JURY.

(a) Formation of the Grand Jury.

(1) Formation at a Regular Term. On the first day of each term of court at which a grand jury is required to be impaneled, the judge of the court authorized by law to charge the grand jury and to receive its report shall direct the names of all the qualified jurors in attendance for the criminal courts of the county to be written on separate slips of paper and placed in a box or other suitable receptacle and drawn out by the judge in open court. The foreperson and the twelve qualified jurors whose names are first drawn constitute the grand jury for the term and shall attend the court until dismissed by the judge or until the next term.


The following oath shall be administered to all members of the grand jury, including the foreperson:
You as members of the grand jury do solemnly swear (or affirm) that you will diligently inquire, and true presentment make, of all offenses given you in charge, or otherwise brought to your knowledge, committed or triable within this county; that you will keep secret the state's counsel, the other jurors' and your own; that you will present no person from hatred, malice, or ill will, nor leave any unpresented through fear, favor, or affection, or for any reward, or the promise or hope thereof, but that you will present the truth, the whole truth, and nothing but the truth, according to the best of your skill and understanding. So help you God.

Nashville DA says grand jury foreman was felon

NASHVILLE, Tenn.—Nashville's top prosecutor said Thursday he is expecting a flood of appeals of criminal cases after it was discovered that a grand jury foreman was a felon and ineligible for jury service under state law.

The Tennessee grand jury led by Eugene Grayer returned 919 indictments during its three-month term between July and September of 2011.

About 800 of those cases had been resolved, mostly with guilty pleas, Davidson County District Attorney General Torry Johnson said at a news conference Thursday. About 90 cases still are pending.

Since the discovery two weeks ago of Grayer's 35-year-old conviction arising from a theft scheme, prosecutors have been working to repair the pending cases—either by getting new indictments from the current grand jury or issuing a criminal information, which bypasses the grand jury process but requires the consent of the defendant.

Of the 800-or-so other cases, Johnson said, "The worst-case scenario would be that all the cases and defendants are sent back to court and their cases are redone. ...In the best-case scenario, that would only happen in cases where the defendant could show he was somehow prejudiced by the fact that Mr. Grayer was on the grand jury, something I think would be exceedingly difficult."

Johnson said ultimately state appeals courts will have to decide whether the indictments are valid because of Grayer's conviction.

A call to the phone number listed on Grayer's handgun carry permit application rang unanswered, as did a call to a number listed for him in a phone directory.

Criminal defense attorney David Raybin said he has several clients who were indicted by the grand jury on which Grayer served, but he does not expect to appeal any of those cases.


That's because those clients pleaded guilty, waiving their rights to challenge any defects in the grand jury when they pleaded.

"However, those cases where there was a jury trial will probably have to be retried," the attorney said.

Raybin said his reading of the case law is that having a felon on a grand jury, particularly as the foreman, makes the indictments questionable in cases where the defendant pleaded not guilty.



McNair case won't be reopened

A former Nashville police officer's request to have the Steve McNair case reopened has been denied.

Vincent Hill told ESPN.com on Thursday night that he received word from a three-member Davidson County grand jury panel that there was insufficient proof to move forward and present his 32-page complaint to a full grand jury.

Hill, who spent 4½ years on the Nashville force and resigned in 2006, has disputed the police's ruling that McNair, the former Tennessee Titans quarterback was murdered by Sahel Kazemi, who then turned the gun on herself. Hill self-published a book called "Playbook to a Murder" and has spent the past 11 months conducting interviews and trying to debunk police findings that Kazemi murdered McNair in a downtown Nashville condo in the early morning hours of July 4, 2009.

On June 11, the panel heard a 30-minute presentation from Hill on what he described as "multiple errors" in the police investigation. The former Metro Nashville traffic police officer says he was informed of the grand jury's decision Thursday in a letter from foreman **Richard Hillenbrand**.

Reached Thursday night, Hillenbrand said he couldn't comment on any decisions because the report is sealed.

"Win, lose or draw, it's historic to just get it at that stage," Hill said. "Obviously, they thought there was something worth hearing just to even listen to the case.


"I would say that it's not over at this point."





WE, the Davidson County Grand Jurors for the April 2010 term, submit the following report in a summary of the last three months we have served. It has been an honor to serve under the auspices of the Honorable Mark Fishburn. We, as a Grand Jury, believe that through the process, we have gained insight into the structure of our judicial system, and have gained an increased respect for all those who work hard to make it flow smoothly.

In accordance with Tennessee Rules of Criminal Procedure, the Grand Jury deliberated upon 978 cases over the past three months. We presented the court with 885 True Bills, 3 No True Bills, 90 Sealed True Bills, and 0 Sealed No True Bills. We also had the opportunity to create panels that heard two closed cases concerning John J. Hooker and Steve McNair.

TIMES OVER MULTIPLE John J. Hooker: Mr. John J. Hooker requested an opportunity to present his case concerning his belief in the criminal intent of the state Supreme Court judges. The committee discussed the issues raised and did not find enough SPECIAL ASSISTANT TO evidence of criminal activity to present the case to the entire Grand Jury. The panel appreciated Mr. Hooker's concerns about the impact of actions on the Tennessee Constitution, but decided that that was not a matter for the Grand Jury to consider.

> Steve McNair: The Grand Jury was asked to hear information to reopen the Steve McNair case. Mr. Hill wanted to present this information, though he declined to ask for an indictment. He shared with the committee his views of the case but lacked evidence to support his views. Questions raised by Mr. Hill were cleared by evidence gathered by the Metro Police Department. The panel felt that this was a case that should not be heard by the other members of the Grand Jury.

We, as a Grand Jury, felt that having the chance to participate in ride alongs and take field trips was very beneficial. They allowed us to gain a better understanding of the law enforcement field. At the training academy, we were impressed with the simulations, training, and equipment available to the trainees. We did, however, feel as though our time at the Police Academy was too limited. We would have liked to have had additional time to learn more specifics about how our city officers are trained. The field trip to the jail was enlightening. Not only were we able to tour the facilities, we were shown the procedures used in booking, feeding, and housing the inmates. We were disappointed that the aftermath of the flood eliminated our field trips to the juvenile justice facility and drug court. At COMPSTAT we heard updates about the activities that had been going on across our city since the Nashville Flood of 2010. We also learned that the city is considering adding extra precincts. Many of us on the Grand Jury thought that was an excellent method of keeping the police more involved in the communities they serve.

SUGGESTIONS FOR GRAND JURY

- There are many terms used in the legal system that the public is not aware of. We feel as though it would be helpful to future Grand Juries if they were supplied with a list of terms and definitions of the "legal lingo" used when cases were presented.
- 2. Allowing the Grand Jury to sit in on a quick case, such as a Jail Docket, would be helpful with understanding the legal process.
- 3. A Monday, Tuesday, Thursday schedule would perhaps allow for better and more convenient attendance, especially in the summer months.

LEGAL SUGGESTIONS

- We felt as though in some cases, the punishment did not always fit the crime. This was a concept that bothered most of us sitting on Grand Jury. Stiffer punishments should be handed out for second and third offenders.
- 2. Higher DUI penalties should be imposed, especially for vehicular homicide where the defendant is traveling at excessive rates of speed.
- 3. Drug offenses when a child is present, whether being in a car or home, should carry stiffer penalties.
- 4. DUI offenders, anything more than a second offense, should be treated as "Habitual Offenders" and should receive harsher penalties.
- 5. Children should be better protected. We are concerned for children who are returned to or left in situations in which they or others have been harmed.





There's a familiar face in the room when Nashvillians gather in secret to decide whether a person should face criminal charges: an 81-year-old wire company exec.... He's Stan Fossick, a Nashville businessman with ties to the city's police force and a history of donating to district attorney candidates and a judge,... Fossick is an executive with Mid-South Wire in Nashville...A 2013 Tennessean articled noted Fossick has known Judge Seth Norman since high school, interacted with Judge Steve Dozier's father at community events, met Judge Cheryl Blackburn when she worked with the prosecutor's office in the 1990s and occasionally grabs dinner with outgoing Judge Randall Wyatt. Since those relationships began, Fossick has been chosen by the judges to serve as foreman of at least 42 grand juries, the most of anyone named in the 92 quarterly reports since 1993, according to a Tennessean analysis. Some reports are not publicly available. Those numbers show that in the last decade, he served as foreman a majority of the time... When Dozier ran for re-election in 2014, campaign records show, Fossick donated \$500. Dozier has appointed Fossick grand jury foreman a dozen times since 1993.... After former District Attorney General Torry Johnson announced his retirement in 2014, Fossick contributed to each candidate vying to replace him: \$250 to Glenn Funk, \$500 to Rob McGuire and \$400 to Diane Lance, according to records. Carol Etherington, Fossick's wife, worked for the police department until 1992. spending about 20 years as a specialist helping crime victims, according to a Vanderbilt University report. The report states Etherington, a nurse, established the Victim Intervention Program, one of the first police-based crisis counseling initiatives in the country...Funk, whose office plays a key role in cases that go before the grand jury, tells each panel its role is to serve as a check on his own authority... Funk said in an interview Tuesday he had no concerns about Fossick...But reports when Fossick is the foreman praise police and the courts..."There are angels who walk among us: They wear uniforms, sit behind desks, walk the streets, drive fast cars, carry guns and rescue children and wounded people every day. They work undercover, behind the scenes and look into the darkest corner of life, and aren't thanked enough," reads a report from the fourth quarter of 2003. Earlier this year, Fossick was the foreman when grand jurors raised concerns that police presentations were leading to bias in deliberations. And in early 2016, under the supervision of a different foreman, jurors suggested they should not meet inside the district attorney's office.

STATE'S REQUEST FOR COURT TO RULE ON DEFENDANT'S USE OF PERSONAL RECORDING DEVICE DURING COURT

Comes now, the Office of the District Attorney General, to respectfully ask this court to determine whether the defendant is entitled to personally record court proceedings outside the official court record. Neeley said they went back outside and that Gaddy called 911. Neeley said he then left the scene and telephoned General Sessions Judge Casey Moreland.

Gaddy said Neeley told him that he found someone shot inside the condo, but that he didn't recognize the person... Gaddy stated that he and Neeley both entered the condo and he recognized the male as McNair. Gaddy said he then went outside and called 911 (at 1:35 p.m.).

Judge Casey Moreland

General Sessions Judge Casey Moreland stated that has been friends with Wayne Neeley for approximately 15 years. Moreland said Neeley telephoned him at 1:47 p.m. on July 4, sounded shaken, and said that he had just found someone shot in the condo. Neeley told Moreland that he was not sure who had been shot, but that it was a man and a woman. Neeley told Moreland that he had picked up a shell casing and then put it back down.





