"It was very thorough, very uhm, deliberate investigation, you know, into what had occurred. The evidence clearly indicates it's a murder-suicide versus any other scenario... uh, double-homicide, for example, we know that scenario has come up... or that (deep breath)... I guess that allegation has come up several times... but the evidence clearly supports a murder-suicide with Sahel Kazemi being the person that shot Steve, and then sat on his lap, and then shot herself, and then slowly slid off his lap, and fell onto the floor. And the evidence clearly backs that up. And all the other scenarios that are brought in, are apparently are being brought in by people that have no idea what the crime scene looked like." ### FALL OF A TITAN – HAVE YOU LISTENED TO THE “EPILOGUE?”

Ex-Metro Police Officer, Vincent Hill, asked DA Investigator Norris Tarkington if he could see the Steve McNair crime scene photographs. Norris Tarkington told Vincent Hill he would have to ask Det. Charles Robinson.

#### **A Luxury?**

Det. Charles Robinson: “He was afforded the luxury of talking to a DA investigator, uh, in the DA’s office, and, and they made it clear, unless you have new evidence, because, uh, they knew that he had already been heard before with the last DA. Unless he had new evidence that’s the only thing they wanted to hear about. He could not bring any new evidence. But they sat down and talked to him to see what evidence he had, and he had no new evidence. It was just all speculation.

Det. Pat Postiglione: “Not that he didn’t have any new evidence, he didn’t have any evidence. That’s very important. He had speculation. Theory. That’s what he was going with. To this day, I think he is still trying to push whatever agenda he’s got, and I am not really clear on what it is. But we reviewed it-- every angle that could possibly be reviewed-- and anything we-- we can dispute every single thing, every allegation, everything he says. We can clearly dispute. So... that’s not an issue.”

Vincent Hill: “They keep going back to: I don’t have any physical evidence. But my argument is, well, if you let me see the crime scene photos, I guarantee you, I can show you how this doesn’t match up. They won’t give up those crime scene photos. Hey, what are you hiding? Like, I can get Michael Jackson’s crime scene photos. And Michael Jackson is 30 times bigger than Steve McNair. I can get his crime scene photos. I’ve seen his naked body, as gross as it is, on the bed. but I can’t see Steve’s? Come on, what are you hiding? *(Vincent Hill provided the secret 3-person grand jury panel a 50+ page presentation to re-open the case).*

Sports Illustrated’s Tim Rohan requested crime scene photographs. Nashville Police denied the request “out of deference and respect to the McNair children and Ms. McNair.”

Does Steve McNair, Jr. qualify as a child: “I wanted to see what the police were talking about and how he was sitting. I want to see everything. I want to see all of the details. I wish I could have been there to see his body, but I couldn’t. Just a lot of things I want answers to.”

“Charles Robinson, the lead investigator, and his supervisor, Pat Postiglione, sat down and talked with (Rohan) about the case. The detectives who were in charge, and this police department, stand by the results of that investigation.”

“We reviewed the crime scene extensively, and I went over it with Pat and other investigators. It is clear to us that it was a murder-suicide. There is no question that is what happened. So many things pointed to that. We found the person who sold her the gun. The way the body was positioned, it would have been impossible to stage (a crime scene). That is the ultimate finding. We were the fact-finders and investigators. We’ve been down this road with this person (Hill) so many times. Mr. Hill is not an experienced investigator, but he keeps pushing this rather than look at the facts.”

Pat Postiglione –  
Retired Detective

“The evidence clearly points to a murder-suicide. We follow the evidence, that’s it. If the evidence pointed to a double homicide we would have been all over it. There are some that argue it’s a double homicide, but other than speculation and guess work they have nothing to support their theory. Just because they continue to repeat it, doesn’t make it so. The investigators who were involved in this are highly experienced in homicide investigation. Those on the outside making these claims have absolutely no experience in investigation, let alone homicide investigation. As in all homicide investigations, there will be unanswered questions that have absolutely nothing to do with what actually occurred.”

Davidson County District Attorney Torry Johnson said Hill's conclusions are not backed up by facts. “As these theories have been suggested, any necessary police work has been done to follow up,” Johnson said. “But each time, those views have proven to be wholly without merit or contained a misrepresentation of the facts.”

“Detectives with decades of cumulative homicide investigative experience worked hundreds of hours to develop the facts surrounding the circumstances of these deaths,” Nashville Police Chief Steve Anderson said. “Without any doubt, I remain confident in the murder-suicide conclusion.”
