Huckabee also believes the 2008 investigation should never have become public. He says the "the private disclosure of many actions by minors because 'being a minor means that one's judgment is not mature'."

## Nashville ghostwriter sues Christian publisher over new Billy Graham biography

In an abundance of caution, the protected child molester's name is not provided in submission to Larry Crain's permanent injunction request granted on Sept 24, 2018.



Attorney Larry Crain – Obtained permanent injunction and \$2.1 million judgment against Austin Davis after contested default was granted. Mr. Crain also filed \$1.5 million defamation lawsuit against the mother of the Brentwood Academy alleged rape victim.

In a statement, Brentwood attorney Larry L. Crain, who is representing REDACTED called the lawsuit filed in the U.S. District Court in the Middle District of Tennessee a simple breach of contract case.

Police investigated REDACTED in October 2012 after learning that a woman said he sexually abused her between the ages of 11 and 14, Metro police spokesman Don Aaron said.

"Allegations of sexual battery were substantiated" by investigators, Aaron said.

Charges could not be filed because the statute of limitations had passed.

THE "MANN ACT" HAS NO STATUTE OF LIMITATIONS FOR CHILDREN.

The lawsuit makes no mention of the investigation or other civil legal action related to the allegations.

This morning, I made a very important announcement ([view here at midway mark](#)). I shared how that for too long churches have been largely inept at aiding victims of sexual assault and abuse, and at providing a protective and safe environment for all its members. Certainly, these lapses were not always intentional, but the church-at-large cannot afford to hide behind excuses any longer. That is why Belmont desires to lead the way in our city, state and nation in providing a template for other churches, especially independent churches, to follow. It is time for us to set the pace and the bar high. True discipleship also means protecting our members.

He said the subject was not belligerent, but was confrontational. He only felt concerned when he learned the subject asked the security officer if he had a gun. He gave me the names of the security officers - Juan Knight and Troy Stackhouse.</p> <p>I went to 5895 Willshire to speak with the suspect and his wife regarding the harrassment complaint.</p> <p>Mrs. Davis spoke with me alone. Her husband was not home. She gave me history on the complaint (a subject named Greg had been accused six years earlier of issues and they did not think he was guilty. They pushed the issue but have never seen documentation that was official. No one from the church told them exactly what happened.) She said her husband is stable, has a good job, has no history of mental health issues, she is not concerned, that he's a great father, and that she is very committed to him. I discussed his fixation on this issue and that it was not reasonable to spend so much time and energy sending letters as he has done. She said she felt responsible for pushing the issue and that he'd never do it again. She was upset that it had become such a serious issue. She spoke freely. She called him to come on home so he could also speak with me.</p> <p>He arrived and I spoke with him candidly. He explained why he had felt things had been done wrong and why he felt he had to deal with the issue. He was surprised there had been such a response. We discussed that bad things do happen with church members and that society does not take a chance. I explained stalking, harrassment and trespass to him. He understood and said he'd have no more contact nor go to the church. He does not want to be arrested and was very concerned that he might be later on. I told him he would only be arrested if his behavior continued.</p>
