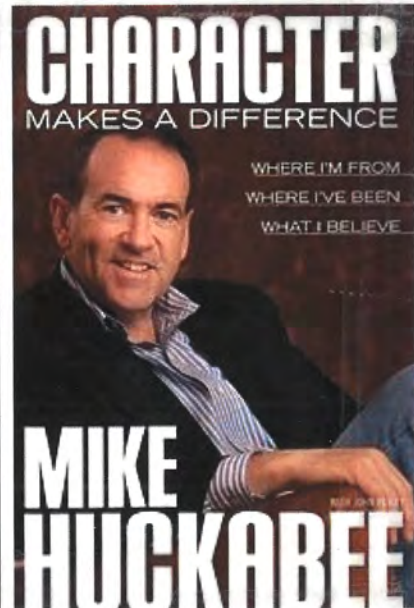
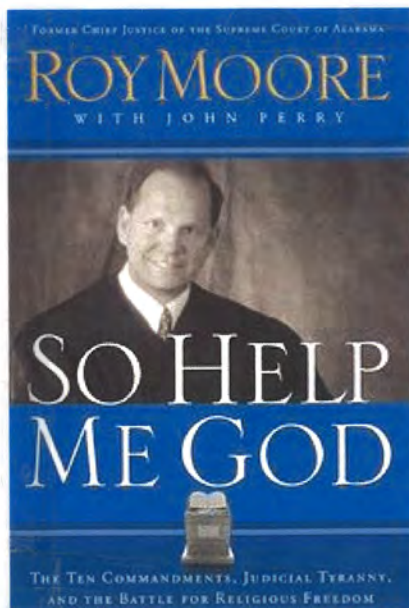

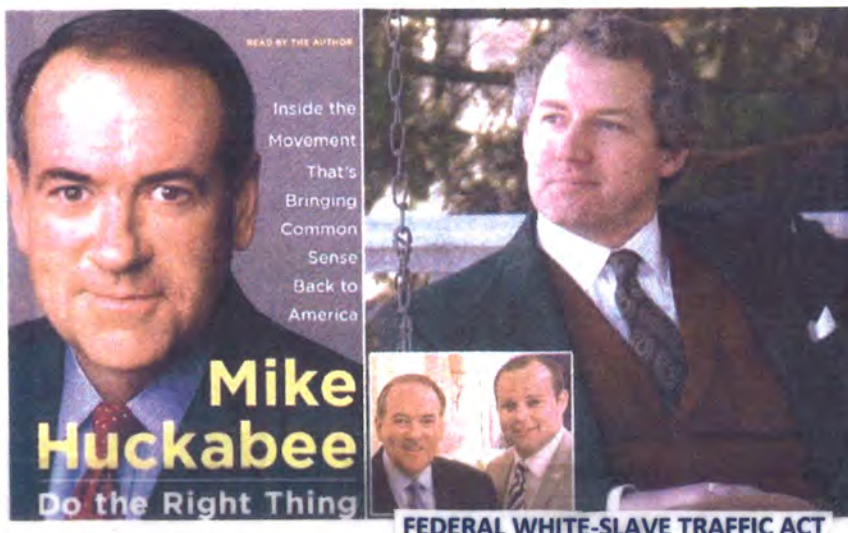

## THE WHITE-SLAVE TRAFFIC ACT (MANN ACT)

### 2027. MANN ACT

Cases arising under the Mann Act, 18 U.S.C. § 2421 et seq., are investigated by the Federal Bureau of Investigation... Sections 2421 to 2423 of the Act set forth several offenses including the offense of knowingly transporting any individual, male or female, in interstate or foreign commerce or in any territory or possession of the United States for the purpose of prostitution or sexual activity which is a criminal offense under the federal or state statute or local ordinance. Section 2423 is concerned solely with the transportation of minors under the age of 18 years and provides for an enhanced penalty. This section should generally be used when minors are victims, although the other two sections also cover minors ("any individual").

### NO STATUTE OF LIMITATIONS FOR SEX ABUSE OF CHILDREN

#### 18 U.S. Code § 3283. Offenses against children

No statute of limitations that would otherwise preclude prosecution for an offense involving the sexual or physical abuse, or kidnaping, of a child under the age of 18 years shall preclude such prosecution during the life of the child, or for ten years after the offense, which ever is longer.

"Allegations of sexual battery were substantiated" by investigators, Aaron said. Charges could not be filed because the statute of limitations had passed.

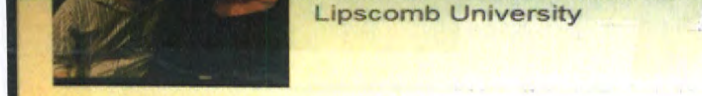
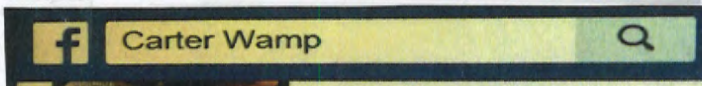
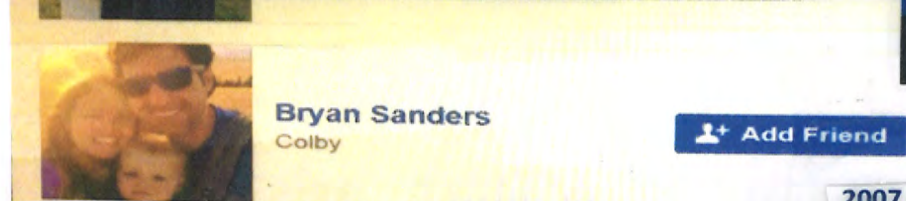
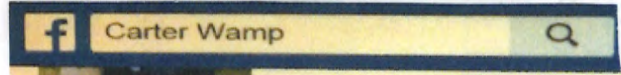
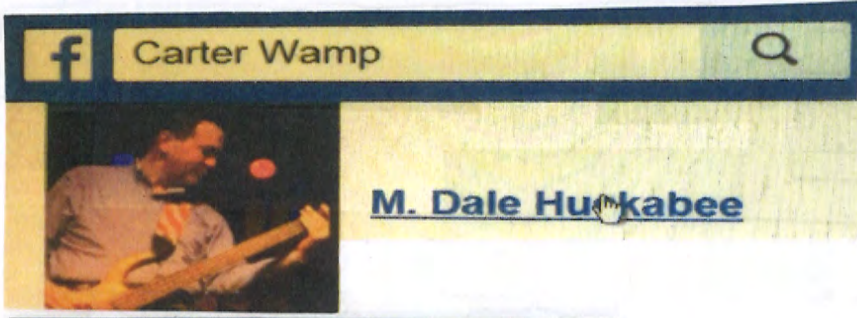

Published Oct 30, 2008, without the child-molester’s name on the front cover, about 4 months after Nashville Police silenced and banned Austin Davis.

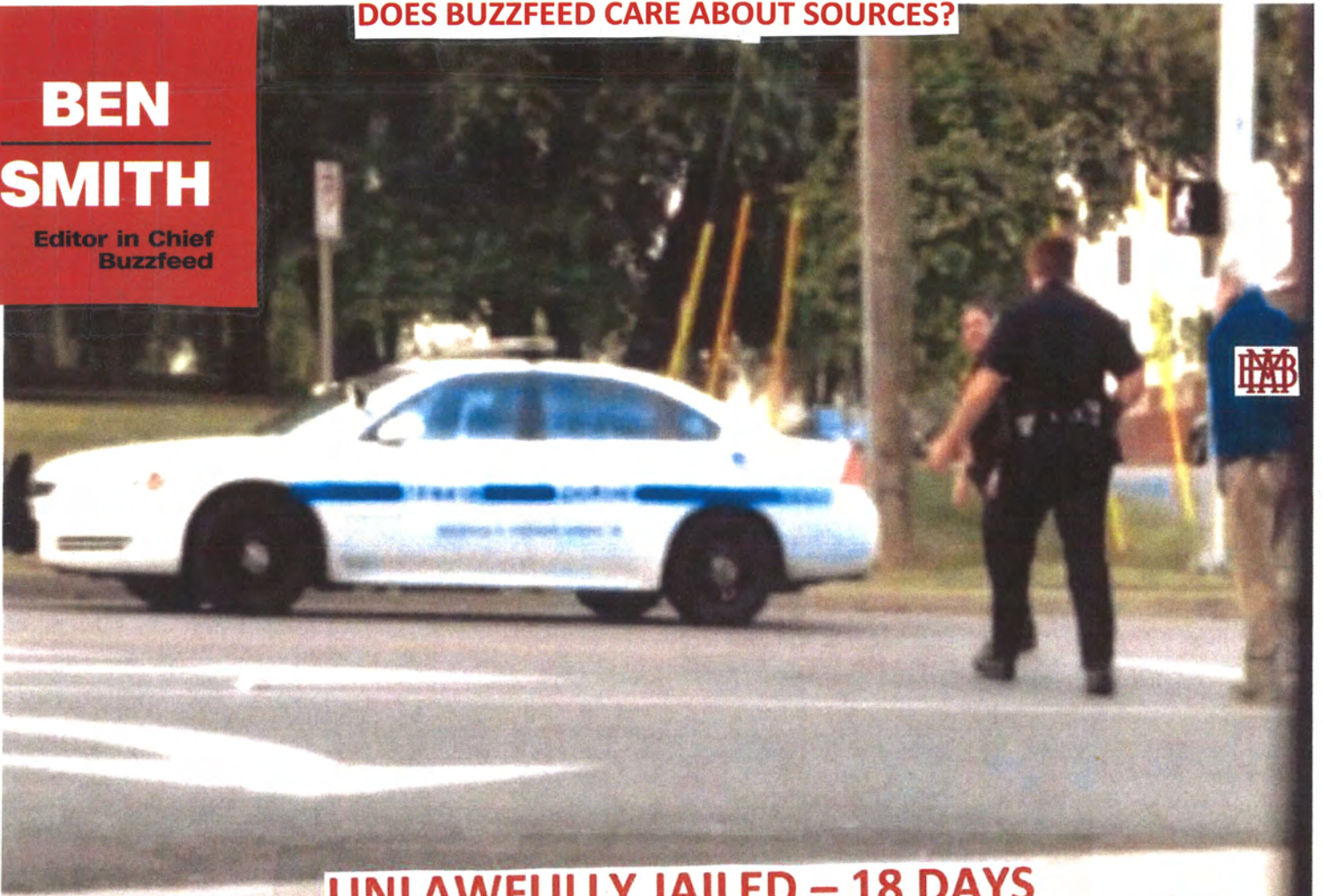

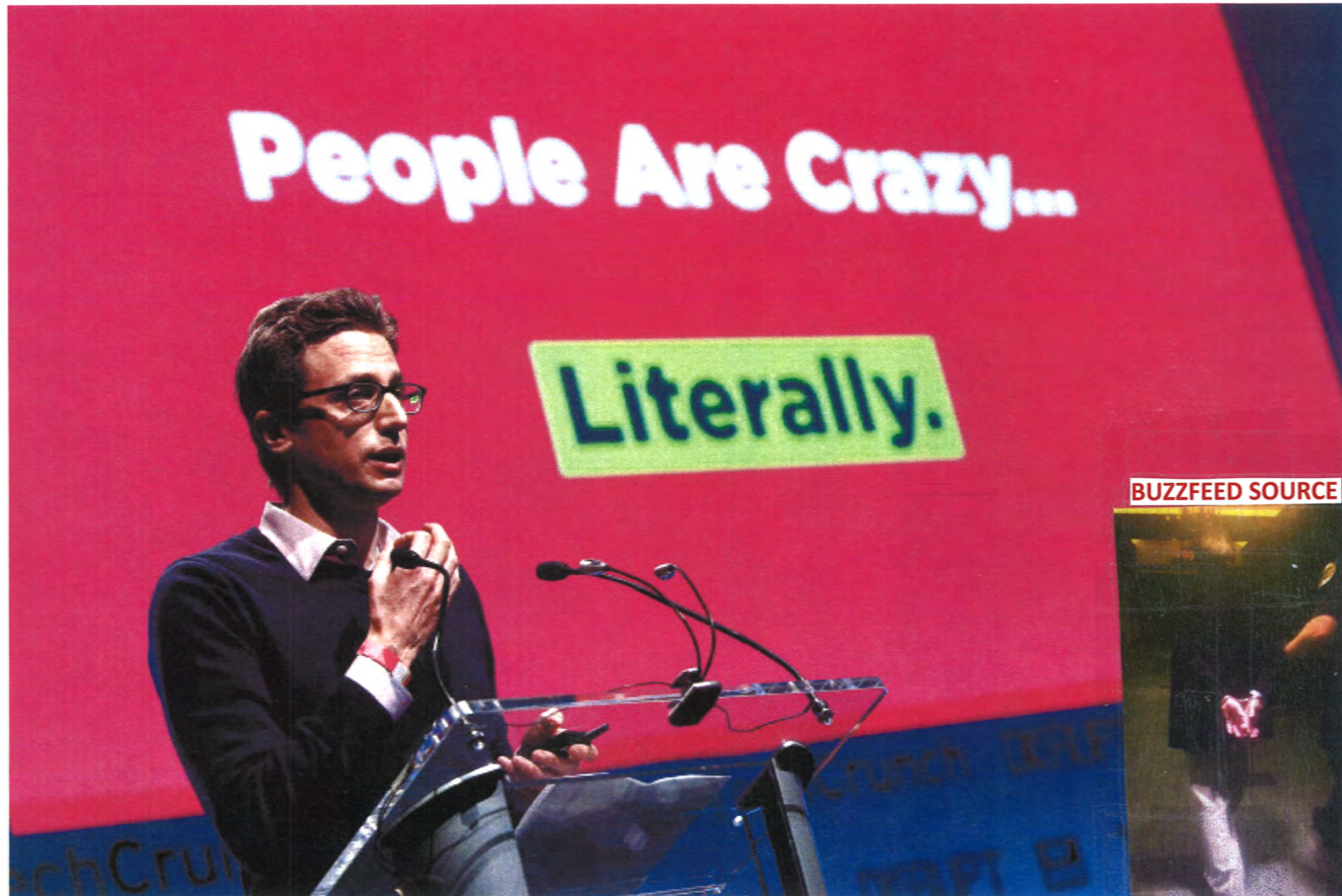

**FALSE**

I talked with the pastor Jim Bachmann. He has an extensive file on the subject with the letters he has sent. They have dealt with this for six years and did not want to involve police. They made a report because he came to the location on Sunday after being officially advised not to. He sent a letter which they perceived to be threatening. Security was present on Sunday. Mr. Bachmann said they will not prosecute unless it continues. I explained the **mental health options** if an arrest does become necessary.

**FALSE**

I spoke w/ Worick Robinson, who witnessed the trespass. He said the subject was not belligerent, but was confrontational. He only felt concerned when he learned the subject asked the security officer if he had a gun. He gave me the names of the security officers - Juan Knight and Troy Stackhouse.

I went to 5895 Willshire to speak with the suspect and his wife regarding the harassment complaint.

Mrs. Davis spoke with me alone. Her husband was not home. She gave me history on the complaint (a subject named Greg had been accused six years earlier of issues and they did not think he was guilty. They pushed the issue but have never seen documentation that was official. No one from the church told them exactly what happened.) She said her husband is stable, has a good job, has no history of mental health issues, she is not concerned, that he's a great father, and that she is very committed to him. I discussed his fixation on this issue and that it was not reasonable to spend so much time and energy sending letters as he has done. She said she felt responsible for pushing the issue and that he'd never do it again. She was upset that it had become such a serious issue. She spoke freely. She called him to come on home so he could also speak with me.



He arrived and I spoke with him candidly. He explained why he had felt things had been done wrong and why he felt he had to deal with the issue. He was surprised there had been such a response. We discussed that bad things do happen with church members and that society does not take a chance. I explained stalking, harassment and trespass to him. He understood and said he'd have no more contact nor go to the church. He does not want to be arrested and was very concerned that he might be later on. I told him he would only be arrested if his behavior continued.

In March 2002, Greg's children were placed in John Perry's "safe house" for about 30 days without Greg's knowledge or consent. Covenant Leadership and Nashville Police are still protecting John Perry as of June 20, 2019. The Tennessee Statute of Limitations is extended by the cover-up, and the Federal "Mann Act" has NO SOL for child sex abuse. By Tennessee and Federal Law and for the protection of other vulnerable children, child sex abuse is a criminal matter, not a "private" or "clergy-protected" family matter.

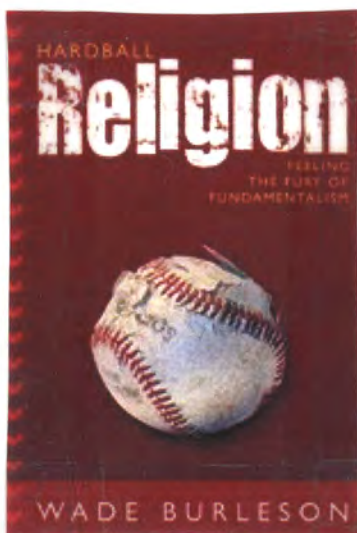

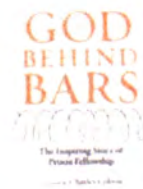
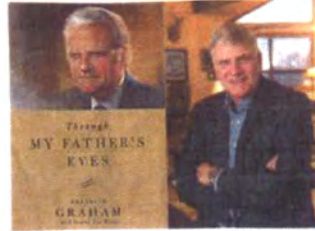

17 Dr. Diane Langberg told me this story personally. Several years ago the then current head of  
18 woman's ministry in the PCA was talking with Dr. Langberg about child sexual abuse. She  
19 said to Dr. Langberg, "I'm so glad we don't have this in the PCA." Dr. Langberg told her at  
20 her next women's ministry conference to list child sexual abuse as an issue faced by women  
21 and see what happens. She said don't even mention it, just list it in one of the handouts. A  
22 few months later the head of women's ministry called Dr. Langberg and said, "What do I  
23 do? They are coming out of the woodwork!"

Dear Mr. Smith:

I hope BuzzFeed will follow-up to correct a story written about my family in June 2015?

Nashville Police lied to BuzzFeed reporters that the "statue of limitations was tolled, barring prosecution" in a child sex abuse cover-up case. BuzzFeed has not followed up or made a correction to a story with a significant untrue police statement.

I was arrested after the BuzzFeed story was published, jailed for 18 days, lost a \$2.1 million defamation lawsuit via a contested default judgment, and was back before the Middle Tennessee Appellate Court for oral arguments again yesterday.

I've been in a court battle with Jay Sekulow's long-time attorney friend, Larry Crain, but Mr. Crain did not come to court on Wednesday. Instead, a young lady lawyer appeared in his position who was apparently not listed as an attorney on the court docket. (I have a tape recording of the hearing).

The judges were provided new information about the Federal White-Slave Traffic Act, also known as the Mann Act, which does not have a statute of limitations for the sexual abuse of an 11 year old child taken across state lines.

Mr Crain also represented the child-molester, John Perry, in a 3-million lawsuit against Rev. Billy Graham's publisher, Harper Collins.

John Perry has co-authored manuscripts with Rev Franklin Graham, Gov Mike Huckabee, Roy Moore, Richard Land, Chuck Colson, and possibly Jay Sekulow's ACLJ organization.

Opposing attorneys informed the Court that a "contempt" order was in the works against me so I guess I will be put in jail again for speaking out and trying to protect children, including a 6th grade Brentwood Academy alleged rape victim, and his siblings, who live about 12 houses away from where John Perry lived, or possibly still lives.

Attorney Larry Crain has also filed a \$1.5 million lawsuit against the mother of the 6th grade Brentwood Academy alleged gang rape victim.

I appreciate BuzzFeed scratching the surface on an elaborate child-molester cover-up back in 2015.

I hope you will follow up to report the rest of the "Mann Act" cover-up story in 2019.
