### 2027. MANN ACT

### NO STATUTE OF LIMITATIONS FOR SEX ABUSE OF CHILDREN

Cases arising under the Mann Act, 18 U.S.C. § 2421 et seq., are investigated by the Federal Bureau of Investigation and are referred directly to the appropriate United States Attorneys. The Child and Exploitation and Obscenity Section of the Criminal Division is responsible for supervision of the Act.

Sections 2421 to 2423 of the Act set forth several offenses including the offense of knowingly transporting any individual, male or female, in interstate or foreign commerce or in any territory or possession of the United States for the purpose of prostitution or sexual activity which is a criminal offense under the federal or state statute or local ordinance. Section 2423 is concerned solely with the transportation of minors under the age of 18 years and provides for an enhanced penalty. This section should generally be used when minors are victims, although the other two sections also cover minors ("any individual").

Section 2423 was amended on February 6, 1978 by Pub.L. No. 95-225, on November 7, 1986, by Pub.L. No. 99-628, and again on September 13, 1994 by the Violent Crime Control and Law Enforcement Act. The legislative history of these amendments demonstrates Congress' special concern with the sexual exploitation of minors. Thus, cases falling under these statutes which involve minors as victims should be given special priority.

In *United States v. Holte*, 236 U.S. 140 (1915), the Supreme Court held that under certain circumstances a woman could be indictable as a conspirator in her own transportation. However, in *Gebardi v. United States*, 287 U.S. 112 (1932), the Court, while not disavowing *Holte*, held that a woman who merely assents to her transportation, without taking a more active role in promoting it is not guilty of a substantive offense under these statutes. The Court also held that such a woman cannot be charged with conspiracy, and that where the only coconspirator is the man who transported her or caused her transportation, a conspiracy charge against him must fall also. *Gebardi* has been cited and followed in more recent lower court decisions. This strongly suggests that it may be difficult to sustain a prosecution against a transportee "victim" for the substantive offense or for conspiracy, or a conspiracy case against a sole coconspirator who was the transporter, unless the "victim" was active in promoting the transportation and not merely acquiescent.

## 5 Convicted in Chicago Sewage Contract Bribe Scheme

A federal trial on charges surrounding an alleged \$1.3 million in bribes paid to win contracts to haul Chicago's sewage ended today with the convictions of a prominent Southern businessman and four other persons.

The Southerner is Frederic B. (Fritz) Ingram, 43, the handsome and socially correct chairman of Ingram Corp. of New Orleans, one of the largest family-held enterprises in the United States. He admitted on the witness stand that he had authorized \$730,000 in payoffs in the early 1970s to win contracts from Chicago's Metropolitan Sanitary District to transport treated sewage by barge and pipeline to a landfill 160 miles south of the city.

Ingram contended that he was a victim of extortion by sanitary district officials and "members of the Daley machine" - the late Mayor Richard J. Daley's Democratic organization - but the jury didn't buy it. He was found guilty of conspiracy, 15 counts of interstate travel in furtherance of

His brother, E. Bronson Ingram, 47, who brought golfer Arnold Palmer to the stand as a character witness, was acquitted of similar charges, although he admitted that he arranged a \$100,000 loan to meet one alleged payoff demand from Chicago officials for a 1972 contract.

Former Ingram Corp. senior vice president William Joseph Benton, 55, testifying under a grant of immunity, was the government's star witness during the eight-week trial before U.S. District Court Judge John F. Grady. Benton told an almost incredible story of international financial maneuvers and surreptitious meetings in hotels to deliver payoffs for \$43 million worth of contracts.

Defense lawyers contended that Benton fabricated much of the bribery story to escape prosecution and cover up his own illegal activities.

James Neal, a former Watergate prosecutor who defended Bronson Ingram, declared that Benson "would rather climb trees and tell lies than stay on the ground and tell the truth." Other defense lawyers called Benton a "master thief," "cheat," "Machiavelli," "artful dodger," "conniver," and "con man."

On Sept 6, 2019, the Middle TN Appellate Court upheld a \$2.1 million judgment against Austin Davis in a related lawsuit filed by Attorney Larry Crain in which Mr. Crain argued that child sex abuse is a "private" matter. In a dissenting opinion, Appellate Judge Andy Bennett wrote: *"The right to a fair trial before an impartial tribunal is a fundamental constitutional right... I believe Mr. Davis did not receive an impartial trial."* On July 12, 2019, an attorney for Austin Davis argued in criminal court that a criminal indictment and criminal trial should be quashed because a Covenant Security Guard and Davidson County Sheriff Sergeant had participated in the arrest of Austin Davis and was also later discovered as a member of the secret grand jury that indicted Austin Davis. As of Sept. 11, 2019, Judge Cheryl Blackburn has not ruled on whether Austin Davis received a fair indictment and fair trial, or whether it was unfair. **Question:** Do you think the process was fair?

Sept 11, 2017 – On the 16<sup>th</sup> Anniversary of the 9/11 attack, a rigged indictment was finalized via a trial that took place place before Judge Steve Dozier.
