Oct 22, 2019: Two years ago this week, MBA Father Austin Davis was banned and jailed for 18 days. Attorney Larry Crain also was awarded a \$2.1 million default judgment against Austin Davis, and Mr. Crain also filed a \$1.5 million defamation lawsuit against the mother of the 6th grade Brentwood Academy alleged rape victim. The Tennessee Supreme Court has denied 7 petitions connected to a related child sex abuse case with numerous ties to Covenant Presbyterian Church, and an 8th petition to the Tennessee Supreme Court is due on Nov 5, 2019.

Ex-officer files federal complaint

EEOC case charges sexual harassment, intimidation

A former Metro policewoman fired in August for using cocaine has complained to the federal Equal Employment Opportunity Commission that she was sexually harassed and intimidated by superior officers.

"Basically, it says that her rights were violated at the police academy and that she was sexually harassed and intimidated because of her sex," said Phillip Davidson, attorney for [REDACTED]

He said the formal complaint, mailed to the EEOC yesterday, also alleges that she was harassed as a probationary officer after her graduation in 1986, that any improper or illegal acts she may have committed were the result of threats and intimidation and that the department condoned the acts by firing her.

"If I sound mad, I am," Davidson said. "I am extremely angry that this could happen in this city."

[REDACTED], 21, first leveled charges that police academy instructors coerced her into having sex after she was accused in April of using cocaine in 1986.

Davidson said the EEOC complaint was filed against the Police Department to give her the option of filing a federal lawsuit to get her job back.

Davidson said the matter might be settled sooner, though, if the Metro Civil Service Commission finds in her favor.

[REDACTED] filed an appeal with the commission asking to be reinstated after she was fired for drug use. A hearing is scheduled for Feb. 21.

The EEOC investigates possible violations of the federal Civil Rights Act and grants the right to sue where

there is probable cause to believe someone's rights have been violated, Davidson said.

He said [REDACTED] was "psychologically forced" to comply with improper requests made by her superiors. He said the department's high command should have known what was going on and that the Master Patrol Program fostered a climate of intimidation that led to the abuses.

He said reported incidents of sexual harassment against other recruits would be presented as evidence at the Civil Service Commission hearing.

The charges against [REDACTED] came from [REDACTED] and [REDACTED] who had set off an internal investigation after stating they had used drugs with at least seven police officers.

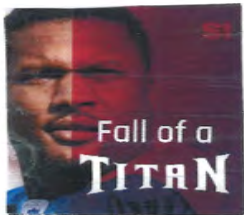
[REDACTED] accused [REDACTED] of using cocaine with him off duty and drinking with him on duty.

[REDACTED] was fired for drug use in 1986. His [REDACTED] resigned from the School Mothers Patrol in July.

Lt. [REDACTED] and Sgt. Richard Hillenbrand were demoted after being found guilty during an August hearing of having sex with [REDACTED]

[REDACTED] South Patrol Sgt. [REDACTED] also was disciplined because of sexual remarks he made to [REDACTED]

On Sept 6, 2019, the Middle TN Appellate Court upheld a \$2.1 million judgment against Austin Davis with the Honorable Andy Bennett dissenting. The TN Supreme Court has denied 7 petitions connected to a related child-molester cover-up effort, and an 8th petition is due at the TN Supreme Court on Nov. 5, 2019. As a result of the court battles, an abundance of caution is now exercised and some police names are redacted to avoid further retaliation in Tennessee Courts, and possibly more time in jail for exercising First Amendment rights.

Police sex claims renewed in cocaine firing

A female police officer fired yesterday for cocaine use has told department investigators that three high-ranking officers made sexual advances toward her while she was a recruit at the Metro Police Training Academy.

The officers, who are the target of a four-month internal affairs investigation, have been identified by ex-South Patrol Officer [REDACTED].

[REDACTED] is Capt. [REDACTED], a 19-year-veteran who supervises academics and physical training at the academy. He has been at the academy since 1978 and is a member of the department's SWAT unit.

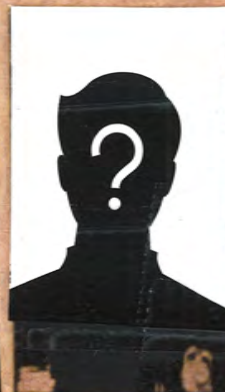
LL [REDACTED] a 17-year veteran who supervises firearms training. He joined the academy in 1971 and is also a member of the SWAT unit.



Testified against superiors

Sgt. Richard A. Hillenbrand, a 14-year veteran who oversees defensive tactics training. He joined the academy in 1983 and is a SWAT unit member.

None of the three men could be



reached for comment last night. The internal affairs probe began several months ago after Stojanowski, 23, was questioned about her use of drugs following graduation from the academy in 1986.



A written statement she gave investigators at that time is expected to lead to department charges against the three instructors within several days.

fired for drug use yesterday, renewed charges that she had sex with the three instructors during a brief hearing yesterday morning before a police disciplinary board which later found her guilty of using cocaine on at least two off-duty occasions.

Others fired yesterday for drug use were Officers [REDACTED] and [REDACTED]. Detective [REDACTED] was suspended for 30 days without pay for observing drug use but not reporting it to authorities.

The allegations against all three men involve charges of marijuana use during hunting trips between 1979-84.

Former Titan slain as he slept on condo couch

Sahel Kazemi ended a life that was coming undone, as she got in trouble with the law, faced mounting bills and saw a new relationship with former Titans quarterback Steve McNair unraveling.

Police believe that's why she killed McNair with a 9mm semi-automatic pistol while he slept, then turned the gun on herself in the early morning hours of July 4.

Investigators have ruled out the possibility that anyone else fired the fatal shots.

"We can't put ourselves in the minds of people who do these horrible, irrational acts, but there is evidence she was spinning out of control," Metro Police Chief Ronald Serpas said.

Kazemi, a Dave & Buster's waitress at Opry Mills, wasn't sure how to pay the bills for her upscale Hermitage apartment and new SUV. She was arrested for DUI on July 2 with her former boyfriend in the passenger seat. And, she suspected McNair, who was married, was involved in a second affair. Kazemi had told friends and relatives that she and McNair were going to be together because he was divorcing his wife.

Thousands expected at McNair service

A Nashville megachurch is planning for up to 5,500 mourners at former NFL quarterback Steve McNair's funeral service tonight, an event that will end days of remembrances around Nashville.

Mt. Zion Baptist Church, which operates from three sites in the Nashville area,

will host the 7 p.m. service at its Whites Creek facility just off Old Hickory Blvd. There, the sanctuary can hold 4,500 people, with space for 1,000 mourners in overflow seating.

It will be the funeral the McNair family wants, said Bishop Joseph Walker III, Mt. Zion's pastor — one focusing on the whole of McNair's life rather than the circumstances of his death. Relatives and fel-

low athletes will speak, but the list hasn't been finalized.

"Steve's life was given to the world, so they wanted all of this community to have the opportunity to grieve as well," he said. "To not have something for this community is just not the McNair way."

But crafting the eulogy has been a "mammoth" task, Walker said.

"He wasn't just a parish-

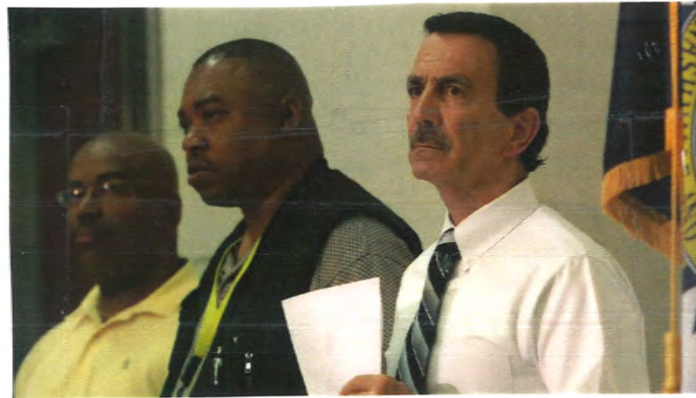

Ex-Metro cop wants McNair case reopened

He cites errors,
conflicting alibis

A former Metro police officer will ask a grand jury Friday to reopen an investigation into the death of former Tennessee Titans quarterback Steve McNair.

Vincent Hill said Tuesday night that police made multiple errors in investigating McNair's death and that alibis

were contradictory for several people involved in the case.

But the Metro police department "stands by its investigation and the conclusions drawn, which were that McNair was a homicide victim at the hands of Sahel Kazemi, who then died of a self-inflicted gunshot wound" on July 4, 2009, spokesman Don Aaron said Tuesday evening.

Aaron said Hill "resigned from the police department in 2006 with disciplinary action pending. He was never a

detective with the Metro police department."

Hill said he resigned to spend more time with his daughter, who was then 10 years old.

Hill said he filed a 32-page complaint June 1 and that the grand jury has agreed to examine it.

"At this point they've at least reviewed what I sent them and want to review the case," Hill said.

A grand jury hearing a civilian complaint is "not unheard of, and indeed I think the

grand jury is being responsible for at least reviewing what this gentleman has to say," Nashville attorney David Raybin said Tuesday.

Hill said he is now a fraud investigator for a credit card company and he hopes to earn his private investigator license in August. He self-published a book, *Playbook to a Murder*, giving his theories on McNair's death.

"It's never been about selling the books, because I spoke out on this a few days after the murder," Hill said.

Casey shakes up training academy

Leading officers demoted, suspended

Chief Joe Casey cleaned house at the police training academy yesterday, demoting two instructors for having sex with a female recruit and cutting a lieutenant's pay for changing a test grade on an in-service examination.

In addition, academy director [REDACTED] was suspended for five days and will be reassigned to the Police Department's planning and research division for allowing a grading policy for recruits to be changed without Casey's approval.

The salary of Lt. [REDACTED], 52, an academy in-service supervisor, was ordered cut for changing a test score on an in-service examination. He will be reassigned to the department's supply division.

Lt. [REDACTED], 40, and Sgt. Richard A. Hillenbrand, 41, both

academy instructors, were found guilty of having sex with former South Patrol Officer [REDACTED] when she was a recruit in 1986.

A fifth officer — South Patrol Sgt. [REDACTED] — was also disciplined yesterday as a result of charges leveled by [REDACTED], who was fired two weeks ago for cocaine use.

[REDACTED], a 14-year veteran, was demoted to sergeant, suspended for seven days without pay and will be reassigned to the patrol division. The demotion will cost him about \$326 a month in salary.

Hillenbrand, a 16-year veteran, was demoted to a police officer, suspended for five days without pay and will be reassigned to the traffic division. His demotion will cost him about \$358 a month.

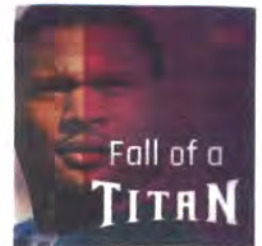

us with any information about the Steve McNair homicide."

Still, the grand jury foreman and two members will review the complaint and decide whether the entire group should take it up. Typically, the 13-member grand jury decides whether to issue indictments based on evidence presented by police and prosecutors. Their deliberations and documents filed with them are shielded from public view.

Foreman Richard Hillenbrand said the fact McNair was a famous athlete won't change the way he handles the complaint.

"I can't speak about this," Hillenbrand said. "But I'm a retired police officer, so I know the system."

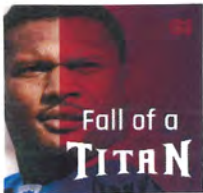
A spokesperson for McNair's estate — Lou Taylor of Tri Star Sports and Entertainment Group — did not return calls seeking comment Wednesday.

It's unlikely, given the fact Hill has no connection to the crime, the grand jury will take up his case, said Glenn Funk, a former Davidson County prosecutor.

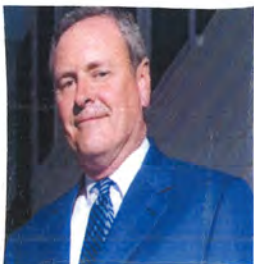
"A person can't go in front of a grand jury and ask for an indictment or investigation if they don't have knowledge of a crime," he said. Cases arising under the Mann Act, 18 U.S.C. § 2421 et seq., are investigated by the Federal Bureau of Investigation... Sections 2421 to 2423 of the Act set forth several offenses including the offense of knowingly transporting any individual, male or female, in interstate or foreign commerce or in any territory or possession of the United States for the purpose of prostitution or sexual activity which is a criminal offense under the federal or state statute or local ordinance. Section 2423 is concerned solely with the transportation of minors under the age of 18 years and provides for an enhanced penalty. This section should generally be used when minors are victims, although the other two sections also cover minors ("any individual").

18 U.S. Code § 3283. Offenses against children

No statute of limitations that would otherwise preclude prosecution for an offense involving the sexual or physical abuse, or kidnaping, of a child under the age of 18 years shall preclude such prosecution during the life of the child, or for ten years after the offense, which ever is longer.

Mr. Brad Gioia,

Why did you write a letter to the MBA community on October 20th saying you contacted the police on a former MBA parent? If you contacted the police, why is there no police report in the MNPD records division? Why did you say the former parent's concerns "seem entirely unrelated to MBA," when you should be aware that at least two MBA faculty members are part of a continuing child-molester cover-up campaign?

During the MBA spaghetti supper, four police officers came to our home to arrest Austin to shut him up. Why did you ban Austin from the MBA campus? You know Austin shouldn't be banned. The army of boys Austin has coached since the 80s also know the banning is ridiculous. Everyone who knows Austin knows he loves and cares about kids. Yet for simply writing an email, Austin was thrown in jail for 18 days without an appearance before the night commissioner. No police report. No hearing. 18 days in jail.

I am disappointed you did not apologize to my children yesterday as Austin requested. Instead, he is back in court before Judge Cheryl Blackburn this morning.

MBA Headmaster Brad Gioia testified that he felt "threatened" by the above email from Catherine Davis. Mr. Gioia also testified he did not apologize to the children as requested.

How many innocent people have been arrested, prosecuted, and jailed in Davidson County? Will John Grisham and The Innocence Project review the work of Richard Hillenbrand, Judge Steve Dozier, Stan Fossick and others?

Judge Steve Dozier's good friend, Stan Fossick, has been appointed as Grand Jury Foreperson on 40% of the grand juries since 1993. Stan Fossick was foreperson of both indictments of Austin Davis in a rigged indictment process.



Stan Fossick and Richard Hillenbrand served on at least one grand jury together.

Judge Steve Dozier dismissed repeated concerns about ex-Judge Casey Moreland and obtaining a "fair trial."

There's a familiar face in the room when Nashvillians gather in secret to decide whether a person should face criminal charges: an 81-year-old wire company exec.... He's **Stan Fossick**, a Nashville businessman with ties to the city's police force and a history of donating to district attorney candidates and a judge.... Fossick is an executive with Mid-South Wire in Nashville... [A 2013 Tennessean article](#) noted Fossick has known Judge Seth Norman since high school, interacted with Judge Steve Dozier's father at community events, met Judge Cheryl Blackburn when she worked with the prosecutor's office in the 1990s and occasionally grabs dinner with outgoing Judge Randall Wyatt. Since those relationships began, Fossick has been chosen by the judges to serve as foreman of at least 42 grand juries, the most of anyone named in the 92 quarterly reports since 1993, according to a Tennessean analysis. Some reports are not publicly available. Those numbers show that in the last decade, he served as foreman a majority of the time... When Dozier ran for re-election in 2014, campaign records show, Fossick donated \$500. Dozier has appointed Fossick grand jury foreman a dozen times since 1993.... After former District Attorney General Torry Johnson announced his retirement in 2014, Fossick contributed to each candidate vying to replace him: \$250 to Glenn Funk, \$500 to Rob McGuire and \$400 to Diane Lance, according to records. Carol Etherington, Fossick's wife, worked for the police department until 1992, spending about 20 years as a specialist helping crime victims, according to a Vanderbilt University report. The report states Etherington, a nurse, established the Victim Intervention Program, one of the first police-based crisis counseling initiatives in the country... Funk, whose office plays a key role in cases that go before the grand jury, tells each panel its role is to serve as a check on his own authority... Funk said in an interview Tuesday he had no concerns about Fossick... But reports when Fossick is the foreman praise police and the courts... "There are angels who walk among us: They wear uniforms, sit behind desks, walk the streets, drive fast cars, carry guns and rescue children and wounded people every day. They work undercover, behind the scenes and look into the darkest corner of life, and aren't thanked enough," reads a report from the fourth quarter of 2003. Earlier this year, Fossick was the foreman when grand jurors raised concerns that police presentations were leading to bias in deliberations. And in early 2016, under the supervision of a different foreman, jurors suggested they should not meet inside the district attorney's office.

McNair DUI case officer transferred

The officer who arrested Sahel Kazemi two days before she killed Steve McNair — and who also arrested the Titans quarterback in 2003 — has been transferred out of the DUI unit, Metro police said.

Effective Tuesday, Officer [REDACTED] will work in patrol at the North Precinct instead of the unit focused on traffic enforcement, Metro police spokesman Don Aaron said.

[REDACTED] is under investigation for "unprofessional" comments in a phone call during Kazemi's traffic stop, captured by the microphone of the dashboard camera in his patrol car.

The move out of the unit is not punishment, Aaron said.

"The internal affairs investigation into the unprofessional phone call is continuing," Aaron said. "But given the totality of the circumstances, the police department felt another assignment for [REDACTED] is appropriate at this juncture."

[REDACTED] arrested McNair after a DUI stop in 2003, charges that were later dropped. The former Titans quarterback was in the passenger seat on July 2 when Kazemi was arrested. Police said McNair was not given an owner-operator DUI — a charge for allowing a drunken person to drive — because the Cadillac Escalade Kazemi was driving was titled in both her and McNair's names.

Police said Kazemi, 20, shot McNair four times before turning the gun on herself in McNair's condo on July 4.

The move does not represent a pay scale change or any demotion for [REDACTED], Aaron said. [REDACTED] could still face punishment in the internal affairs investigation.

Officer's 'hunch' not good enough, judge rules

Metro police Officer [REDACTED] actions have come under fire since he arrested Titans quarterback Steve McNair in May 2003 charging DUI and possession of a handgun.

In the end, a judge ruled yesterday that the officer's "hunch" that McNair was driving under the influence may have been correct, but that a hunch wasn't sufficient reason to stop McNair.

Davidson County Criminal Court Judge Cheryl Blackburn made that ruling yesterday before suppressing the evidence against McNair.

The judge ruled that the officer's **wrongful stop** of McNair made all of the evidence in the case — including McNair's blood alcohol concentration and his possession

of a handgun — inadmissible.

[REDACTED] was suspended for 15 days last year for violating the Police Department's DUI procedures during the stop, as well as for taking home copies of police videotapes of DUI arrests, including McNair's.

At the heart of the case against [REDACTED] was the question of how aggressively he had asked McNair to take a breath-alcohol test. [REDACTED] was accused of repeatedly asking and finally persuading McNair to take the test after McNair at first refused.

A Metro police disciplinary committee found that [REDACTED] was not guilty of improperly administering the breath test. But it found fault with [REDACTED] telling McNair that he would be released if his breath test was below a certain level, after the officer had docu-

mented indications that McNair was impaired.

There also were accusations by McNair's attorney that [REDACTED] had targeted the quarterback.

A limousine driver, Eddie E. Brown Jr., said in an affidavit that he was parked in front of Graham Central Station on Second Avenue just before midnight on the night of McNair's arrest when he saw [REDACTED] being approached by another officer who said, "McNair is up the street."

Brown said that [REDACTED] replied, "I will get him when he comes out."

[REDACTED] contradicted Brown's statement during a preliminary hearing in October 2003.

[REDACTED] said at the hearing that he didn't realize McNair was driving the vehicle until after he noticed the sport utility vehicle swerving

Many questions linger a year after Steve McNair's murder

Estate remains unsettled, as details still bring family pain

Steve McNair's second-eldest son used to look forward to the July Fourth family get-togethers around the grill, waiting for the sun to set and fireworks to start.

Even though his father usually wasn't there in Mount Olive, Miss., he could call him in Nashville anytime he wanted.

This year, Steven O'Bryan Koran McNair, 16, can't even talk about it. None of it. Not the holiday, and certainly not the fact it marks the murder-suicide that took his father and stunned a nation that admired the former Titans quarterback.

"When talks of July Fourth came up, he'd just lay on the couch wish-

ing that day would never come," said his mother, Sheila McNair. "He's doing OK. He has his good days and bad days."

The relatives and enterprises McNair left behind have struggled to move on without him. His Green Hills, Tenn., mansion was on the market for \$3.2 million before he died, but it's no longer listed. His wife, Mechelle, and their two sons, Tyler and Trenton, still live there. His youth foundation's offices are closed, its online events calendar ending with a September 2009 memorial. His restaurant, Gridiron 9 in North Nashville, sits empty.

Even his estate remains unsettled. Because McNair left no will, family members must wait until at least September

to find out what share of \$19 million they're due.

Few even want to discuss the man whose public life was lauded and whose private life got him killed. Sahel "Jenni" Kazemi, a waitress he met at Opry Mills mall, shot him four times, then fatally shot herself, according to official reports. The shooting ended a tumultuous affair that included her arrest for drunken driving while he was in the car and the gift of a Cadillac Escalade she couldn't afford to maintain, plus a second girlfriend Kazemi apparently followed to an apartment McNair was paying for.

McNair, 36, and Kazemi, 20, were discovered by two friends — Robert Gaddy and Wayne Neeley — in the condo he rented with Neeley. Neither returned multiple calls for comment, nor did his wife, mother, foundation leaders or the pastor who officiated his funeral.

In the end, the star

quarterback, known to play through pain, inflicted some of his own when details emerged from the investigation.

Estate details revealed

Mechelle McNair is untangling her late husband's estate, settling with creditors and asking for enough to support herself and her children. She'll learn the answer in probate court on Sept. 23, as will the mothers of McNair's two older children in Mississippi — Steven L. McNair Jr., 18, an incoming freshman at Pearl River Community College in Mississippi, and Steven O'Bryan Koran McNair.

Also to be decided is who gets McNair Farms Inc. in Mississippi, described as a ranching and farming business, and "The Ranch," a mansion near his boyhood home of Mount Olive in southern Mississippi.

McNair and investors

hoped for big money from Gridiron 9, a North Nashville restaurant near Tennessee State University that carried his Titans jersey number. It closed shortly after his death, and the "for lease" sign is still hanging a year later, along with pictures of a heroic McNair wearing the jersey and gripping a football.

When he died, McNair was making a transition from athlete to businessman, and it was going to be a successful one, said Charlie Robin, who manages the property. McNair partnered with his cousin, Raymond White, and friend Gaddy to open the casual restaurant, which served burgers, shrimp, catfish, salads, and grilled and fried chicken.

"He was running a great, strong business," Robin said.

Kazemi's family objects

On the other side of the picture is a family still

mourning Kazemi's death and insisting she couldn't have killed McNair. Former Metro police officer Vincent Hill contacted the family with his suspicions that Kazemi wasn't at fault and ultimately became their spokesman, writing a book with his alternative theories of the crime.

"They still don't believe she did it," Hill said. "Suicide? They never saw those signs. They talked to her Friday night (July 3, 2009)."

Hill recently asked a Davidson County grand jury to reopen the investigation. It didn't.

Metro investigators and the district attorney's office insist the investigation yielded the correct results.

Davidson County District Attorney Torry Johnson. "We've seen nothing to refute the fact that anyone other than Sahel Kazemi fired the fatal shots."

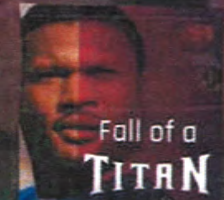

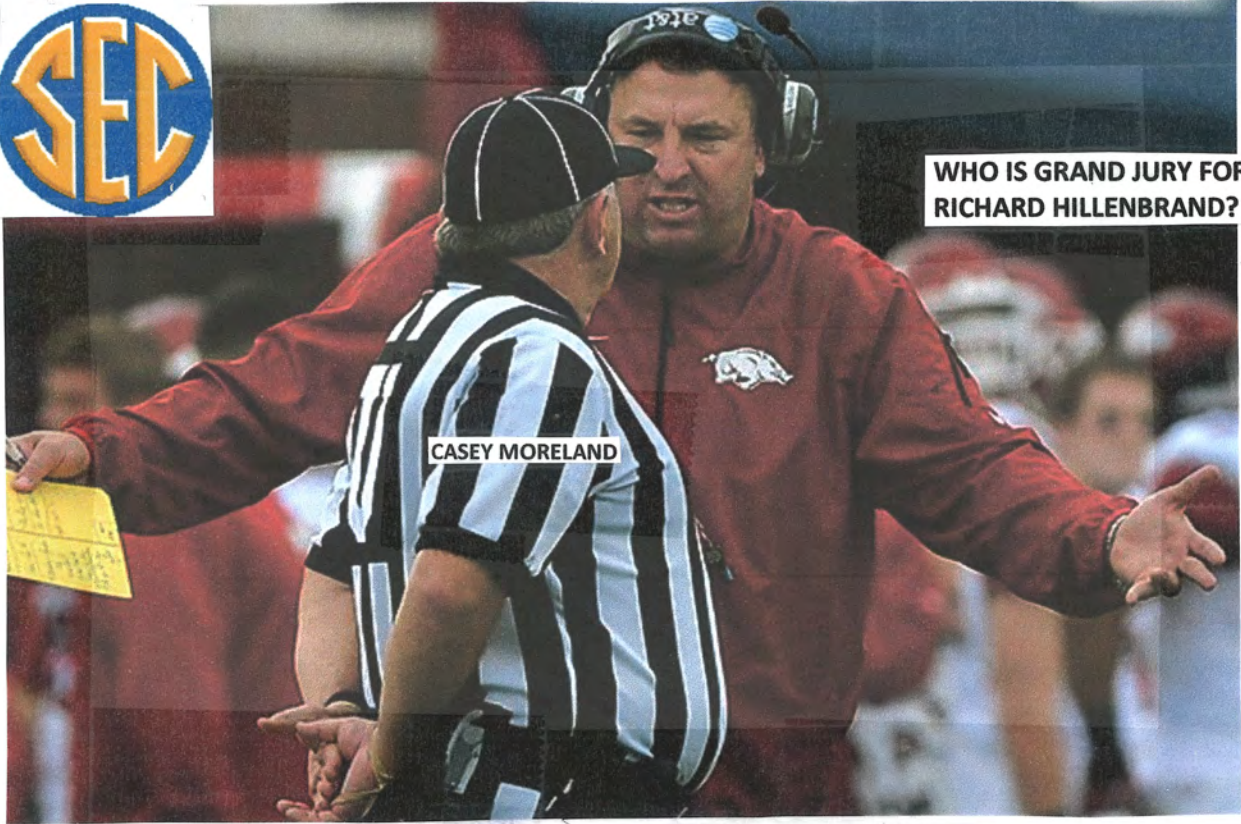

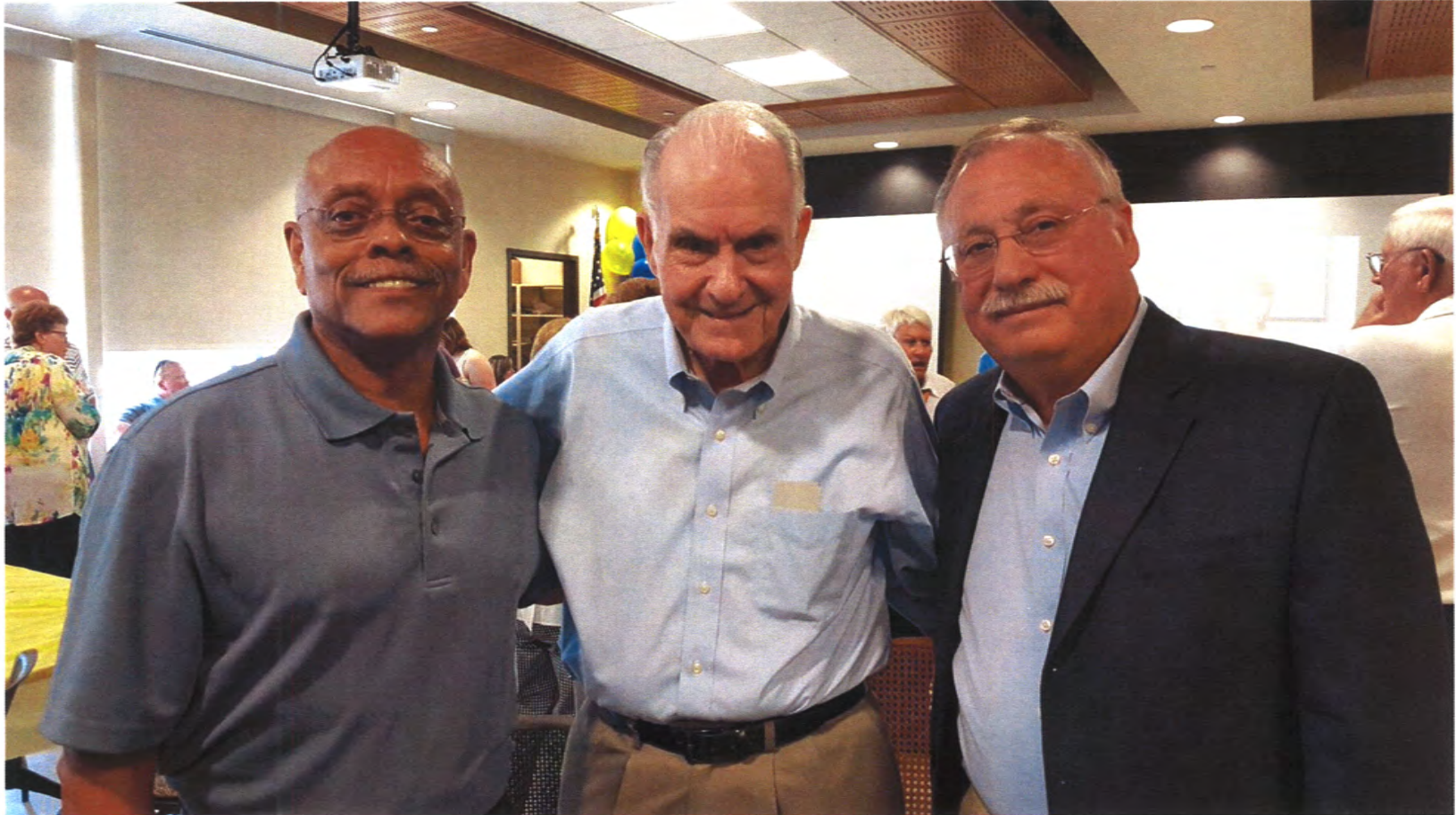

3 officers promoted to ranks they held before sex offenses

The Metro Police Department has restored the original ranks of three officers demoted in 1988 for having sex with police recruits in 1986.

Lt. [redacted], Sgt. [redacted] and Officer Richard H. Hillenbrand — all former instructors at the training academy who were found guilty by the department of sexual improprieties — were promoted to their previous ranks, according to a list of promotions and transfers.

Department policy prohibits sexual relations between academy instructors and recruits to avoid the appearance of favoritism in exchange for sexual acts.

All the promotions and transfers will be effective Friday, Chief Bob Kirchner said.

[redacted] will be the captain running the central patrol sector, replacing Capt. Emmett H. Turner, who will be promoted to major and transferred to support services.

[redacted] will be a lieutenant in the booking room and Hillenbrand will be a sergeant in the tactical section.

The promotions were among 27 announced last week and needed to fill most of the vacancies among supervisory jobs created this year and last when dozens of employees took early retirement.

Kirchner said there are still 35 supervisory openings.

These promotions also were re-

leased:

Capt. John A. Manning, to major in the same assignment; Lt. Shirley J. Davis, to captain, from central patrol sector to investigative services; Lt. Tommy E. Cox, to captain, from polygraphs to identification; Lt. William T. Hibbs, to captain, same assignment.

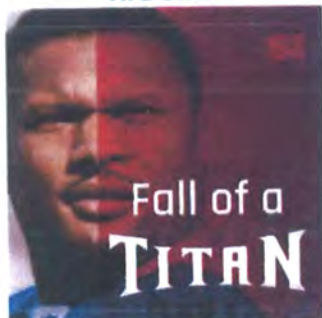

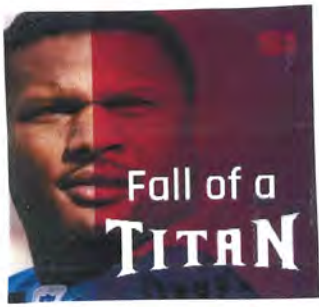

GRAND JURY FINAL REPORT

WE, the Davidson County Grand Jurors for the April 2010 term, submit the following report in a summary of the last three months we have served. It has been an honor to serve under the auspices of the Honorable Mark Fishburn. We, as a Grand Jury, believe that through the process, we have gained insight into the structure of our judicial system, and have gained an increased respect for all those who work hard to make it flow smoothly.

In accordance with Tennessee Rules of Criminal Procedure, the Grand Jury deliberated upon 978 cases over the past three months. We presented the court with 885 True Bills, 3 No True Bills, 90 Sealed True Bills, and 0 Sealed No True Bills. We also had the opportunity to create panels that heard two closed cases concerning John J. Hooker and Steve McNair.

John J. Hooker: Mr. John J. Hooker requested an opportunity to present his case concerning his belief in the criminal intent of the state Supreme Court judges. The committee discussed the issues raised and did not find enough evidence of criminal activity to present the case to the entire Grand Jury. The panel appreciated Mr. Hooker's concerns about the impact of actions on the Tennessee Constitution, but decided that that was not a matter for the Grand Jury to consider.

Steve McNair: The Grand Jury was asked to hear information to reopen the Steve McNair case. Mr. Hill wanted to present this information, though he declined to ask for an indictment. He shared with the committee his views of the case but lacked evidence to support his views. Questions raised by Mr. Hill were cleared by evidence gathered by the Metro Police Department. The panel felt that this was a case that should not be heard by the other members of the Grand Jury.



Serving under the esteemed leadership of Grand Jury Foreman Mr. Richard Hillenbrand was a wonderful opportunity for us all. His detailed understanding of the law and the way he communicated or explained cases to the rest of the Jury was very helpful. We feel that his vast knowledge of the law and of law enforcement was very useful to us all. He did an excellent job of keeping us on task while still giving us ample time for questions and comments.

McNair case won't be reopened

A former Nashville police officer's request to have the Steve McNair case reopened has been denied.

Vincent Hill told ESPN.com on Thursday night that he received word from a three-member Davidson County grand jury panel that there was insufficient proof to move forward and present his 32-page complaint to a full grand jury.

Hill, who spent 4½ years on the Nashville force and resigned in 2006, has disputed the police's ruling that McNair, the former Tennessee Titans quarterback was murdered by Sahel Kazemi, who then turned the gun on herself. Hill self-published a book called "Playbook to a Murder" and has spent the past 11 months conducting interviews and trying to debunk police findings that Kazemi murdered McNair in a downtown Nashville condo in the early morning hours of July 4, 2009.

On June 11, the panel heard a 30-minute presentation from Hill on what he described as "multiple errors" in the police investigation. The former Metro Nashville traffic police officer says he was informed of the grand jury's decision Thursday in a letter from foreman **Richard Hillenbrand.**

Reached Thursday night, Hillenbrand said he couldn't comment on any decisions because the report is sealed.

"Win, lose or draw, it's historic to just get it at that stage," Hill said. "Obviously, they thought there was something worth hearing just to even listen to the case.

"I would say that it's not over at this point."

Davidson County District Attorney Torry Johnson said in a news release that theories relating to the McNair investigation are not backed up by facts.
