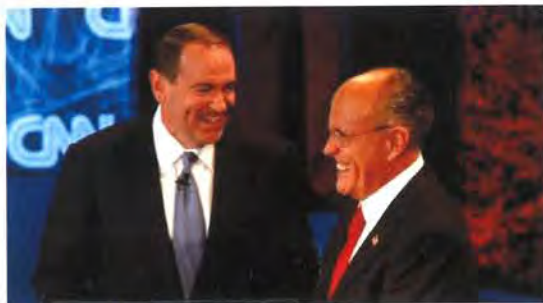

### 2027. MANN ACT

Cases arising under the Mann Act, 18 U.S.C. § 2421 et seq., are investigated by the Federal Bureau of Investigation... Sections 2421 to 2423 of the Act set forth several offenses including the offense of knowingly transporting any individual, male or female, in interstate or foreign commerce or in any territory or possession of the United States for the purpose of prostitution or sexual activity which is a criminal offense under the federal or state statute or local ordinance. Section 2423 is concerned solely with the transportation of minors under the age of 18 years and provides for an enhanced penalty. This section should generally be used when minors are victims, although the other two sections also cover minors ("any individual").

## Rudy Giuliani says prosecutors 'know how to contact' him as part of any criminal investigation

The president's personal lawyer Rudy Giuliani said Monday he has not seen any subpoenas for records related to his consulting firm as part of a reported criminal investigation by federal prosecutors.

Giuliani, who was also spotted in Nashville on Oct. 17, denied traveling to Music City to visit with Jay Sekulow, another one Trump's personal lawyers and who lives in the Nashville area.

"I have a personal reason, but I'm not here to see Jay," Giuliani said of the purpose for his recent travels to Nashville. "It has nothing to do with the case or anything else. It just has to do with me and my friends. That's all part of my private life."

Giuliani declined to name which friends he was in town to visit.

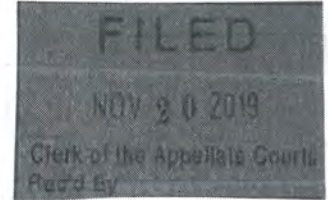

IN WITNESS WHEREOF, the parties mutually agree as follows:

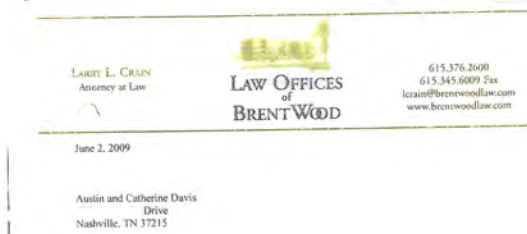

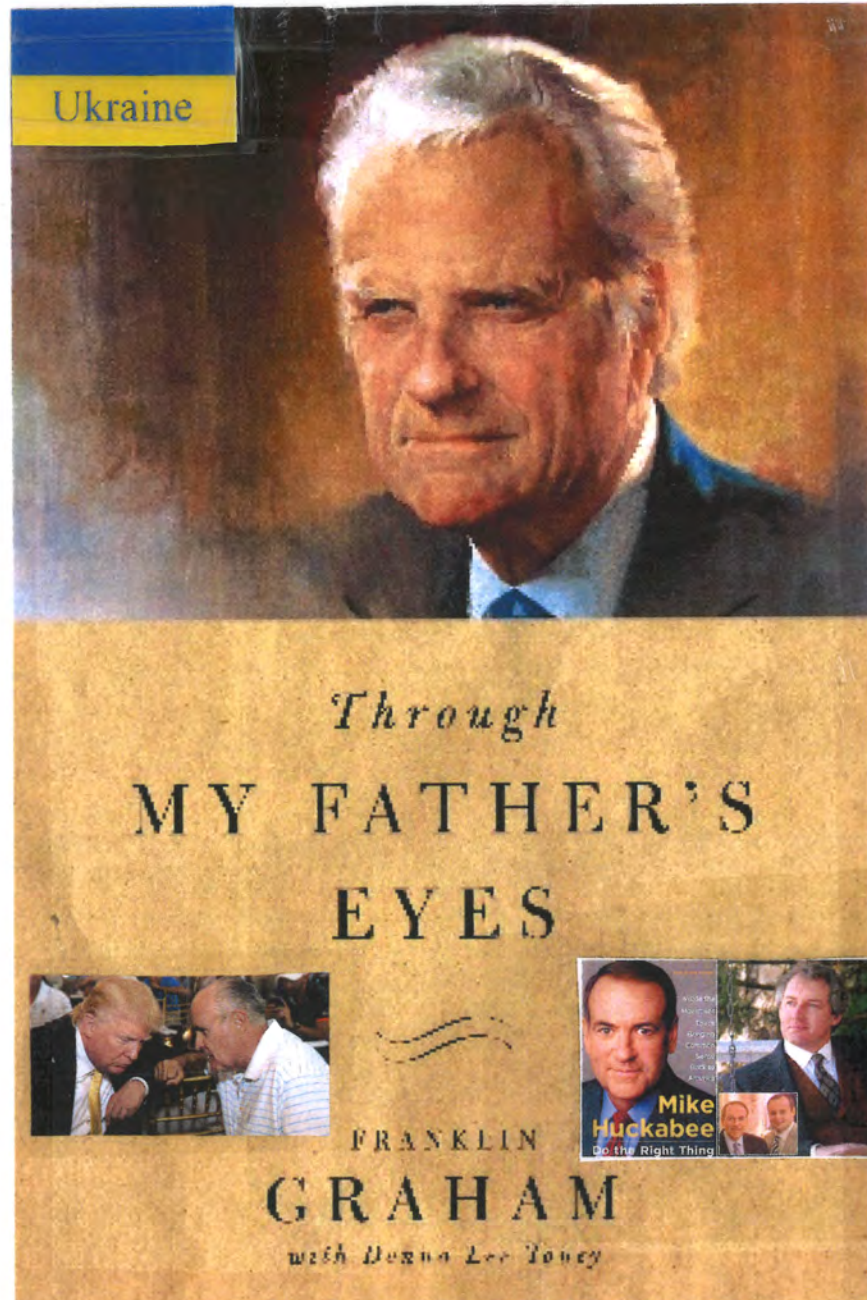

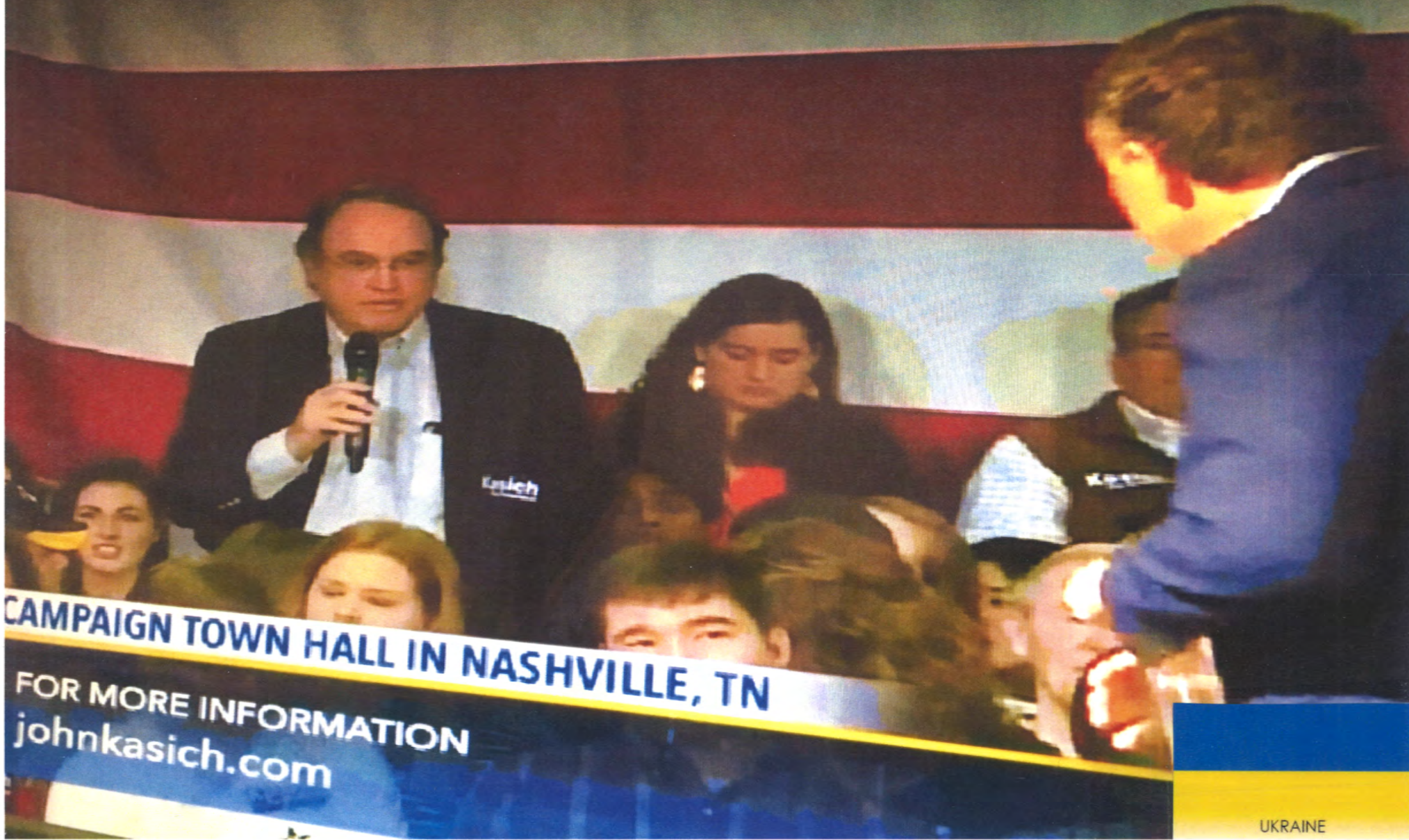
In 2012, shortly after the *Tennessean* investigation appeared, Larry Crain, who was senior counsel at the ACLJ for 15 years, left the organization. Asked if his departure was related to the newspaper's revelations, which the ACLJ called a "flawed" and "biased... attack," Crain said, "I really—I'm not at liberty to discuss that. It was a mutual decision. I'm just not at liberty to discuss that." Jay Sekulow, Crain assured me, is "brilliant" and "I have the highest regard for Mr. Sekulow."

During the Presidential Election of 2008, Nashville Police silenced Austin Davis protecting child-molester, John Perry. In 2009, Attorney Larry Crain wrote a letter declining to represent Austin Davis. During the Presidential Election of 2016, Attorney Larry Crain filed for a temporary injunction to silence Austin Davis, and also filed a \$3 million “invasion of privacy – defamation” lawsuit against Austin Davis. In 2018, Attorney Larry Crain filed a \$3 million lawsuit against Rev. Billy Graham’s publisher on behalf of child-molester, John Perry.



In 2017, Larry Crain filed a \$1.5 million “defamation” lawsuit against the mother of the 6<sup>th</sup> grade Brentwood Academy alleged gang rape victim. Larry Crain also filed a \$300,000 “defamation” lawsuit against Michelle and Will Nowell in a related Brentwood Academy alleged gang rape lawsuit. Child-molester John Perry lived, or still lives, approximately 12 houses away from the family of the Brentwood Academy alleged gang rape victim’s family.

In Feb 2016, Attorney Larry Crain filed a temporary injunction motion and \$3 million lawsuit against Austin Davis a few days before Austin Davis had a C-SPAN Town Hall exchange with GOP Presidential Candidate John Kasich.

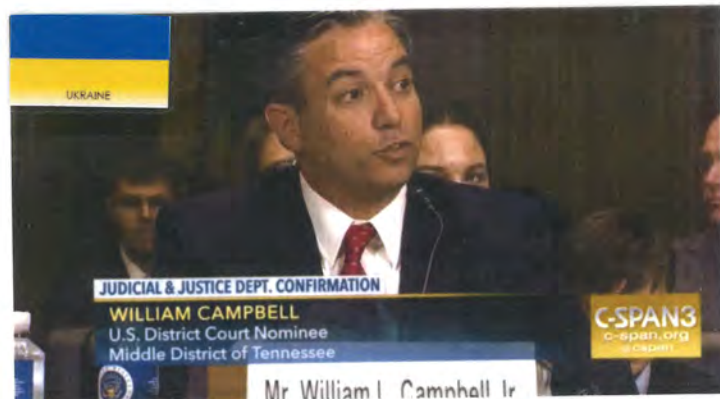

Our client, Nashville Presbytery, was served recently with the Complaint in the referenced action. Pursuant to Tenn. Rule of Civ. Proc. 11, we request that your client dismiss his claims against the Nashville Presbytery in this case. If he fails to do so, we expect to file the attached Motion for Sanctions.

For the most part, the basis for this request is set forth in the draft Rule 11 motion for sanctions sent to you by the attorneys for Covenant Presbyterian Church of Nashville and Jim Bachmann. Additionally, this lawsuit appears to be based on the allegations that were asserted in the June 19, 2013 lawsuit (No. REDACT filed by your client in the Circuit Court of Davidson County. The dismissal of the claims in that lawsuit against the Nashville Presbytery has been confirmed by the Tennessee Court of Appeals. Regardless of whether that court allows for the rehearing that Mr. Davis requested, the fact remains that the claims in this lawsuit against the Nashville Presbytery mirror claims in that previous lawsuit. Further, based on your client's prolific communications about the subject matter of both lawsuits, it is clear that this latest suit was filed for in improper purpose with the sole intention of harassing the Nashville Presbytery and other defendants.

In sum, Mr. Davis' claims against the Nashville Presbytery in the referenced lawsuit are not warranted under the law and were brought for an improper purpose. I trust that you will agree that this latest lawsuit should be dismissed and act accordingly. If not, we reserve the right to file the attached motion.
