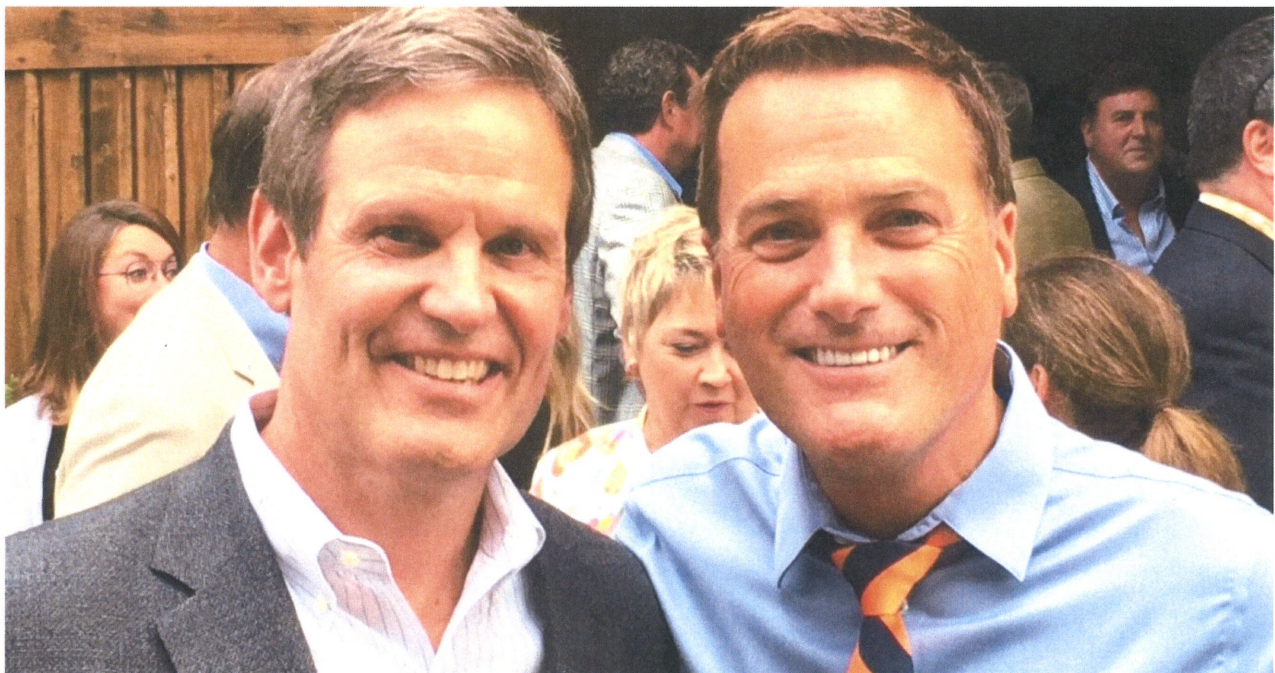

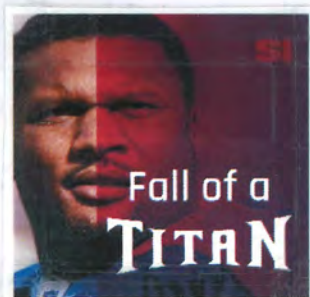

Now, **Lead Pastor Chad Scruggs** is asking congregants to pray for those who are ill.

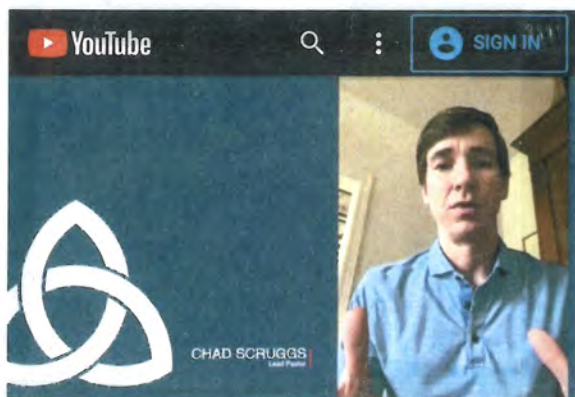

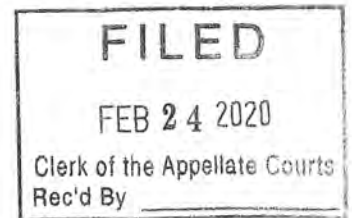

MOTION FOR EXTENSION OF TIME FOR FILING BRIEF

Pro Se Appellant, Willie Austin Davis, requests 60 days extension of time within which to file a brief from the original due date of March 5, 2020, in this case.

I am "pro se" and this is my first attempt at writing a legal brief for a criminal appellate case. The Honorable Andy D. Bennett wrote a minority appellate opinion in a related child sex abuse cover-up civil case (REDACTED), stating: "I believe Mr. Davis did not receive an impartial trial." From Appellant's knowledge of facts, my arrest at a public Sunday church service and the subsequent trespass prosecution case was used to protect a safe house - child sex abuse Mann Act Federal crime cover-up case connected to Covenant Presbyterian Church (Nashville), Presidential Politics, Jay Sekulow, Rev. Billy Graham's final biography, and the Ukraine. As an Appellant without legal representation, I respectfully request more time to study, review, research, and to prepare my written brief. Also, Pro Se Appellant still has questions about the accuracy of court transcripts but a court reporter has informed the Appellant that the court will not give out the court video and audio record to the Defendant-Appellant. Also, the Davidson County grand jury issues I have discovered are not only important to my individual case, but are also important to the "integrity" and "public interest" of other cases, including Tennessee Titans Quarterback Steve McNair's grand jury. In closing, Attorneys James G. King, Parke Morris and Phil Harvey are no longer my attorneys and should not be listed on my court record as my attorneys.

Attendance and Administration: TEs Matthew Bradley (Stated Clerk), Caleb Cangelosi (Recording Clerk), Bing Davis and Len Hendrix (Chairman) were present. TE Marvin Padgett joined by telephone. REs John Avery (Moderator), Patrick Kelly, Greg Wilbur, and Buz Graham were present. **Chip Campbell, attorney of record, was also present.** Len Hendrix opened the meeting with prayer. After adjournment, Greg Wilbur closed the meeting in prayer.

Items Discussed:

The FacCom held a called meeting to discuss a lawsuit in which Nashville Presbytery is named, and to retain counsel.

As the first order of business, it was moved and seconded to approve **Mr. Chip Campbell** as our attorney of record. The motion carried.

It was moved and seconded that Matt Bradley, as Stated Clerk of the Nashville Presbytery, represent the Presbytery as liaison with outside counsel. The motion carried.

It was moved and seconded to designate **\$10,000** of existing monies to cover any initial expenses pertaining to the lawsuit; once our defense is concluded, any remaining money will be undesignated. The motion carried.

It was moved and seconded to retain **Mr. Chip Campbell** and Frost, Brown, Todd as our legal counsel. The motion carried.

It was moved and seconded to notify the Presbytery by email that we are named in a lawsuit, and that we have retained counsel. The motion carried.

Recommendations:

1. That the actions of the June 27, 2013 called meeting of the Facilitating Committee be ratified by the Presbytery.



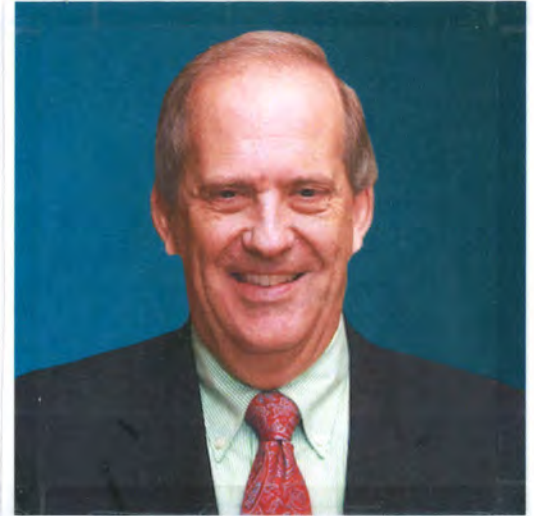

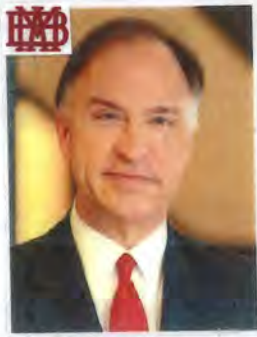

Our client, Nashville Presbytery, was served recently with the Complaint in the referenced action. Pursuant to Tenn. Rule of Civ. Proc. 11, we request that your client dismiss his claims against the Nashville Presbytery in this case. If he fails to do so, we expect to file the attached Motion for Sanctions.

For the most part, the basis for this request is set forth in the draft Rule 11 motion for sanctions sent to you by the attorneys for Covenant Presbyterian Church of Nashville and Jim Bachmann. Additionally, this lawsuit appears to be based on the allegations that were asserted in the June 19, 2013 lawsuit (No. **REDACT** filed by your client in the Circuit Court of Davidson County. The dismissal of the claims in that lawsuit against the Nashville Presbytery has been confirmed by the Tennessee Court of Appeals. Regardless of whether that court allows for the rehearing that Mr. Davis requested, the fact remains that the claims in this lawsuit against the Nashville Presbytery mirror claims in that previous lawsuit. Further, based on your client’s prolific communications about the subject matter of both lawsuits, it is clear that this latest suit was filed for in improper purpose with the sole intention of harassing the Nashville Presbytery and other defendants.

In sum, Mr. Davis’ claims against the Nashville Presbytery in the referenced lawsuit are not warranted under the law and were brought for an improper purpose. I trust that you will agree that this latest lawsuit should be dismissed and act accordingly. If not, we reserve the right to file the attached motion.

2027. MANN ACT

Cases arising under the Mann Act, 18 U.S.C. § 2421 et seq., are investigated by the Federal Bureau of Investigation... Sections 2421 to 2423 of the Act set forth several offenses including the offense of knowingly transporting any individual, male or female, in interstate or foreign commerce or in any territory or possession of the United States for the purpose of prostitution or sexual activity which is a criminal offense under the federal or state statute or local ordinance. Section 2423 is concerned solely with the transportation of minors under the age of 18 years and provides for an enhanced penalty. This section should generally be used when minors are victims, although the other two sections also cover minors ("any individual").

18 U.S. Code § 3283. Offenses against children
 No statute of limitations that would otherwise preclude prosecution for an offense involving the sexual or physical abuse, or kidnaping, of a child under the age of 18 years shall preclude such prosecution during the life of the child, or for ten years after the offense, which ever is longer.

This firm has been retained by Westminster Chapel, Inc. d/b/a Stephens Valley Church (“Stephens Valley Church”) regarding the matters set forth herein. This letter serves as notice to each of you that you do not have the permission or the consent of Stephens Valley Church to enter upon or otherwise remain on the property located at 6000 Pasquo Road, Nashville, Tennessee, 37221 (the “Church Property”).

To clarify, you are prohibited from entering upon or otherwise remaining on the Church Property at any time whatsoever, regardless of the day of the week or the time of day. This prohibition is in effect 24 hours a day, 7 days a week.

Police sex claims renewed in cocaine firing

A female police officer fired yesterday for cocaine use has told department investigators that three high-ranking officers made sexual advances toward her while she was a recruit at the Metro Police Training Academy.

The officers, who are the target of a four-month internal affairs investigation, have been identified by ex-South Patrol Officer [REDACTED] as:

Capt. [REDACTED] a 19-year-veteran who supervises academics and physical training at the academy. He has been at the academy since 1978 and is a member of the department's SWAT unit.

LT. [REDACTED] a 17-year veteran who supervises firearms training. He joined the academy in 1971 and is also a member of the SWAT unit.



Testified against superiors

Sgt. Richard A. Hillenbrand, a 14-year veteran who oversees defensive tactics training. He joined the academy in 1983 and is a SWAT unit member.

None of the three men could be



reached for comment last night. The internal affairs probe began several months ago after Stojanowski, 23, was questioned about her use of drugs following graduation from the academy in 1986.



A written statement she gave investigators at that time is expected to lead to department charges against the three instructors within several days.



HILLENBRAND

[REDACTED] one of three officers

fired for drug use yesterday, renewed charges that she had sex with the three instructors during a brief hearing yesterday morning before a police disciplinary board which later found her guilty of using cocaine on at least two off-duty occasions.

Others fired yesterday for drug use were Officers [REDACTED] and [REDACTED]. Detective [REDACTED] was suspended for 30 days without pay for observing drug use but not reporting it to authorities.

The allegations against all three men involve charges of marijuana use during hunting trips between 1979-84.

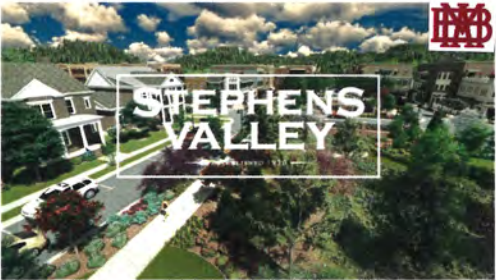

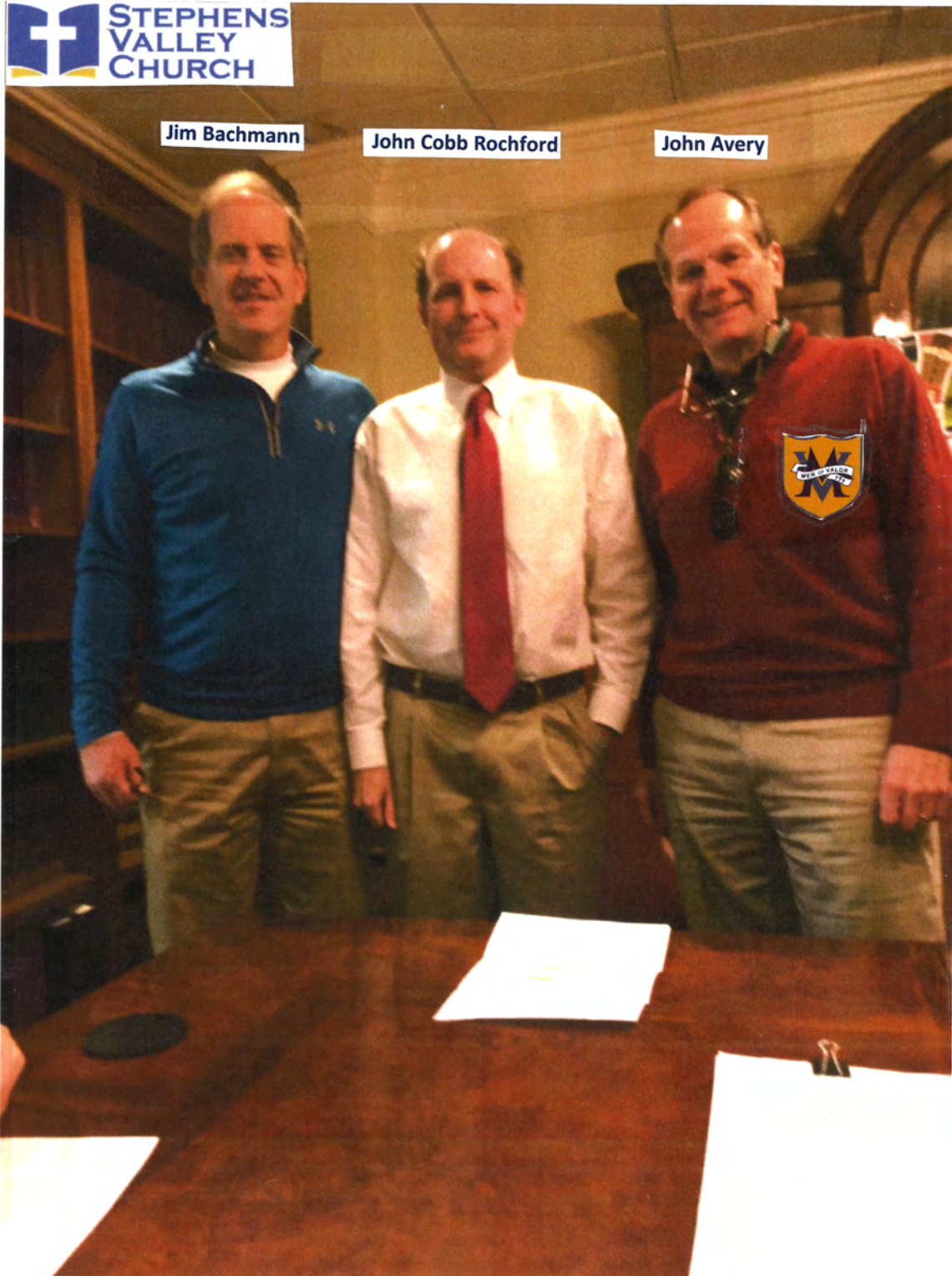
