David Garner preached a sermon called "An Open and Shut Case" 15 days after Judge Carol Soloman dismissed the first PCA child sex abuse cover-up lawsuit.

### June 9, 2014

A called session meeting convened where Roy Taylor, Stated Clerk of the General Assembly was present.

Roy Taylor informed the session that the meetings of May 12 and May 19 were improper and out of order.

He also stated that the meetings of the pastors and elders in which they investigated Pastor Jim were improper and out of order.

He also suggested that the pastors and ruling elders involved offer their resignations.

- No pastor or elder offered a resignation that night, but two pastors did offer resignations weeks later.

At this Session Meeting, Pastor Matt Bradley and Pastor J. Hager both admitted prior knowledge of Pastor Nathan's intention to record a private conversation and both acknowledge that they did nothing to prevent or discourage Pastor Nathan from so doing.

Re: Prohibition from Stephens Valley Church Property

Dear Austin, Catherine, Daisy and Drew:

This firm has been retained by Westminster Chapel, Inc. d/b/a Stephens Valley Church (“Stephens Valley Church”) regarding the matters set forth herein. This letter serves as notice to each of you that you do not have the permission or the consent of Stephens Valley Church to enter upon or otherwise remain on the property located at 6000 Pasquo Road, Nashville, Tennessee, 37221 (the “Church Property”).

To clarify, you are prohibited from entering upon or otherwise remaining on the Church Property at any time whatsoever, regardless of the day of the week or the time of day. This prohibition is in effect 24 hours a day, 7 days a week.

In the event that any of you ignore this letter, Stephens Valley Church will immediately notify law enforcement to remove you from the Church Property and arrest you for criminal trespass and for any other violations of Tennessee law.

I sincerely hope that each of you will choose to voluntarily comply with this letter and Tennessee law.

As we communicated to you in September, the Davis family brought a suit against Harpeth Hall that was dismissed. The court's decision is final and unappealable.

He continues to violate our privacy policy with each mass email to our community. The ultimate reality that I live with is that if my abuser had been [Nathaniel Morales](#) instead of Larry Nassar, if my enabler had been [an SGM pastor] instead of [MSU gymnastics coach] Kathie Klages, if the organization I was speaking out against was Sovereign Grace under the leadership of [Mahaney] instead of MSU under the leadership of Lou Anna Simon, I would not only not have evangelical support, I would be actively vilified and lied about by every single evangelical leader out there. The only reason I am able to have the support of these leaders now is because I am speaking out against an organization not within their community. 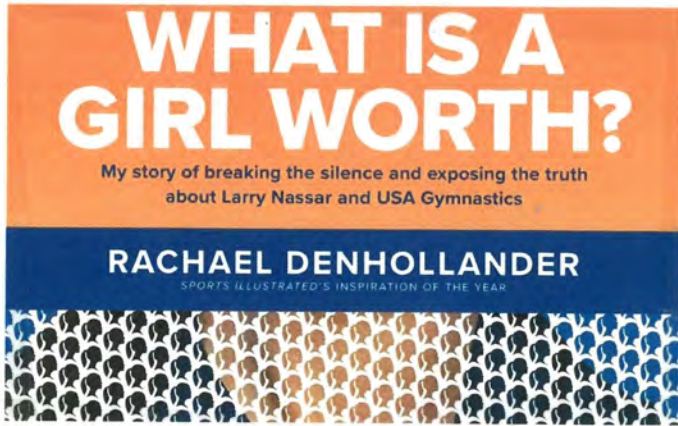

REs John Avery (Moderator), Patrick Kelly, Greg Wilbur, and Buz Graham were present. Chip Campbell, attorney of record, was also present. Len Hendrix opened the meeting with prayer. After adjournment, Greg Wilbur closed the meeting in prayer.

### **Items Discussed:**

The FacCom held a called meeting to discuss a lawsuit in which Nashville Presbytery is named, and to retain counsel.

As the first order of business, it was moved and seconded to approve Mr. Chip Campbell as our attorney of record. The motion carried.

It was moved and seconded that Matt Bradley, as Stated Clerk of the Nashville Presbytery, represent the Presbytery as liaison with outside counsel. The motion carried.

It was moved and seconded to designate \$10,000 of existing monies to cover any initial expenses pertaining to the lawsuit; once our defense is concluded, any remaining money will be undesignated. The motion carried.

It was moved and seconded to retain Mr. Chip Campbell and Frost, Brown, Todd as our legal counsel. The motion carried.

It was moved and seconded to notify the Presbytery by email that we are named in a lawsuit, and that we have retained counsel. The motion carried.

### **Recommendations:**

1. That the actions of the June 27, 2013 called meeting of the Facilitating Committee be ratified by the Presbytery.

**Dr. L. Roy Taylor, Boz Tchividjian, Mike Sloan, and Dr. Diane Langberg met with other PCA Leaders to write a PCA child sex abuse public statement about six months after a PCA child sex abuse cover-up lawsuit was filed.**

1 I know an RUF campus pastor who is currently ministering to seventeen students who were  
2 victims of child sexual abuse. Not seventeen over the life of his ministry – seventeen current  
3 students in his RUF chapter. Let that sink in for a minute.

4  
5 I know two pastors who have had their daughters sexually assaulted in the PCA churches  
6 they were serving at the time. One of my best friends knows a man who was found to be  
7 serially molesting his own granddaughter. This man is a long-time PCA member and has  
8 been a leader in Bible Study Fellowship. I could tell you many other stories of abuse from  
9 people I know personally.

10  
11 I know of multiple cases where the PCA church did not report the abuse. One of the two  
12 PCA pastors I mentioned, the elders and the pastor at the time knew about the abuser was  
13 guilty of child rape but did not call the authorities. When my friend was called to come  
14 pastor the church he knew something was not right in the church, but before he could figure  
15 it out his own young daughter was sexually assaulted by the same abuser.

16  
17 Dr. Diane Langberg told me this story personally. Several years ago the then current head of  
18 woman’s ministry in the PCA was talking with Dr. Langberg about child sexual abuse. She  
19 said to Dr. Langberg, “I’m so glad we don’t have this in the PCA.” Dr. Langberg told her at  
20 her next women’s ministry conference to list child sexual abuse as an issue faced by women  
21 and see what happens. She said don’t even mention it, just list it in one of the handouts. A  
22 few months later the head of women’s ministry called Dr. Langberg and said, “What do I  
23 do? They are coming out of the woodwork!”

**H. Statement Regarding Overture 6 by TE Mike Sloan:**

**I. Background**

Most of you know that the short statement on child sexual abuse brought by the Overtures Committee to the floor of the 41st General Assembly in Greenville, SC, was sent back to the Overtures Committee to be reconsidered at the 42nd General Assembly in Houston. In Greenville, the sentiment on the floor was that this statement was not nearly strong enough because it did not even encourage our churches to report this horrific sin to the civil authorities. With all due respect to my dear fathers and brothers on the Overtures Committee, it was clear to me that very few in the room had any education or training in child sexual abuse awareness and prevention. This year has given me time to seek out more input from PCA experts on this issue. **Ten of us gathered back in December in Sarasota, FL,** to work on a strong statement that would help churches understand the current situation and encourage them to lead in protecting children:


On February 3, 2010, I received your letter dated February 1, 2010. On September 6, 2006 you sent me an extensive document which included a copy of my letter of March 4, 2002 to Mr. Greg Lurie in which I stated essentially the same thing I wrote to you on January 19, 2010 concerning the polity of the PCA, and on which copy you had made your own notations. In that document of September 6, 2006, you made reference to my letter of March 4, 2002 in your notations on an undated letter (winter/spring of 2004).

To summarize PCA polity:

- The polity of the PCA is non-hierarchal Presbyterianism.
- The civil courts recognize two forms of church polity; hierarchal and non-hierarchal.
- Civil courts on several levels have recognized the PCA as a non-hierarchal denomination.
- PCA local church pastors are employees of the local churches who pay their salaries; PCA local church pastors are not employees of a Presbytery or of the General Assembly. This also has been affirmed in civil courts on several levels.
- I do not have either the ecclesiastical or civil authority to command any PCA minister, PCA Church Session, or PCA Presbytery to conduct investigations.
- There are procedures specified in the *Book of Church Order* for the handling of judicial matters. There is no provision in the *Book of Church Order* for me as Stated Clerk to forward your request for an investigation of the Rev. Jim Bachman to the General Assembly.

Though you are no longer a member of the PCA, I am bound to act within the polity of the PCA. There is no provision in the polity of the PCA for me to accede to your requests.

Our client, Nashville Presbytery, was served recently with the Complaint in the referenced action. Pursuant to Tenn. Rule of Civ. Proc. 11, we request that your client dismiss his claims against the Nashville Presbytery in this case. If he fails to do so, we expect to file the attached Motion for Sanctions.

For the most part, the basis for this request is set forth in the draft Rule 11 motion for sanctions sent to you by the attorneys for Covenant Presbyterian Church of Nashville and Jim Bachmann. Additionally, this lawsuit appears to be based on the allegations that were asserted in the June 19, 2013 lawsuit (No. REDACT filed by your client in the Circuit Court of Davidson County. The dismissal of the claims in that lawsuit against the Nashville Presbytery has been confirmed by the Tennessee Court of Appeals. Regardless of whether that court allows for the rehearing that Mr. Davis requested, the fact remains that the claims in this lawsuit against the Nashville Presbytery mirror claims in that previous lawsuit. Further, based on your client's prolific communications about the subject matter of both lawsuits, it is clear that this latest suit was filed for in improper purpose with the sole intention of harassing the Nashville Presbytery and other defendants.

**May 22, 2014**

Bryce's report to the session following the meeting with the pastors did not reflect that some or all of the grievances against Pastor Jim were petty and personal in nature. The report also failed to provide a perspective on the nature of the "sex claim." Pastor Jim asked that Rev. Arch Warren and David German be allowed to address the session, but the request was denied.

**June 9, 2014**

A called session meeting convened where Roy Taylor, Stated Clerk of the General Assembly was present.

- Roy Taylor informed the session that the meetings of May 12 and May 19 were improper and out of order.
- He also stated that the meetings of the pastors and elders in which they investigated Pastor Jim were improper and out of order.
- He also suggested that the pastors and ruling elders involved offer their resignations.
- No pastor or elder offered a resignation that night, but two pastors did offer resignations weeks later.

At this Session Meeting, Pastor Matt Bradley and Pastor J. Hager both admitted prior knowledge of Pastor Nathan's intention to record a private conversation and both acknowledge that they did nothing to prevent or discourage Pastor Nathan from so doing.

**July 21 2014 Monday**

In the absence of action by the Session to investigate the serious events that had come to light in Session meetings during the previous sixty days, all of the Emeritus Elders, along with inactive elders and two active elders signed a resolution (ref. Exhibit A) encouraging the Session to authorize the Moderator (Pastor Jim) to appoint an investigative committee to look into the events that had transpired. The resolution was passed due to a tie-breaking vote by the moderator. Gary Dean changed his vote so the Moderator wouldn't have to break a tie. One amendment was made to the resolution. The task of the committee was to "conduct an investigation of its own actions and inactions...as well as members of the pastoral staff." Pastor Jim was not under investigation though he was interviewed twice by the committee. All told the committee conducted 18 interviews from July 28-August 9 over 168 hours. Among those interviewed were 7 pastors, 7 ruling elders 1 inactive ruling elder, 1 deacon, and 1 member. Eight members who were present at the Saturday November 14th Session Meeting brought charges against elder Jack Bailey for his comments about Pastor Jim during the Saturday November 14th Session Meeting which included accusations of writing a schismatic communication to the congregation, lying, moral failure, heinous sin, and sedition. The substitute moderator ruled them out-of-order due to a lack of compliance with the steps advised in Matt. 18: 15-17.

**November 16, 2015** **Nov 15, 2015 – A whistleblower was wrongfully arrested.**

At the session meeting, moderated again by Rev. Tom Darnell, a formal request is made for all Session information, records, and reports to be provided to all church members. The Session was given until Tuesday November 24th to respond.

Eight members who were present at the Saturday November 14th Session Meeting brought charges against elder Jack Bailey for his comments about Pastor Jim during the Saturday November 14th Session Meeting which included accusations of writing a schismatic communication to the congregation, lying, moral failure, heinous sin, and sedition. The substitute moderator ruled them out-of-order due to a lack of compliance with the steps advised in Matt. 18: 15-17.

I genuinely hope that an appropriate resolution is found soon. Please accept my best wishes.

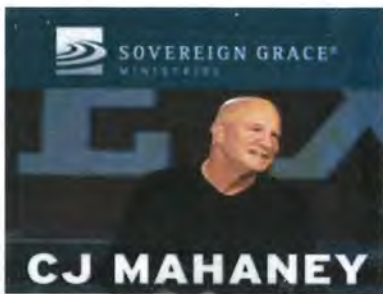

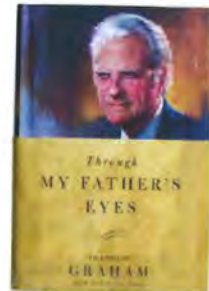

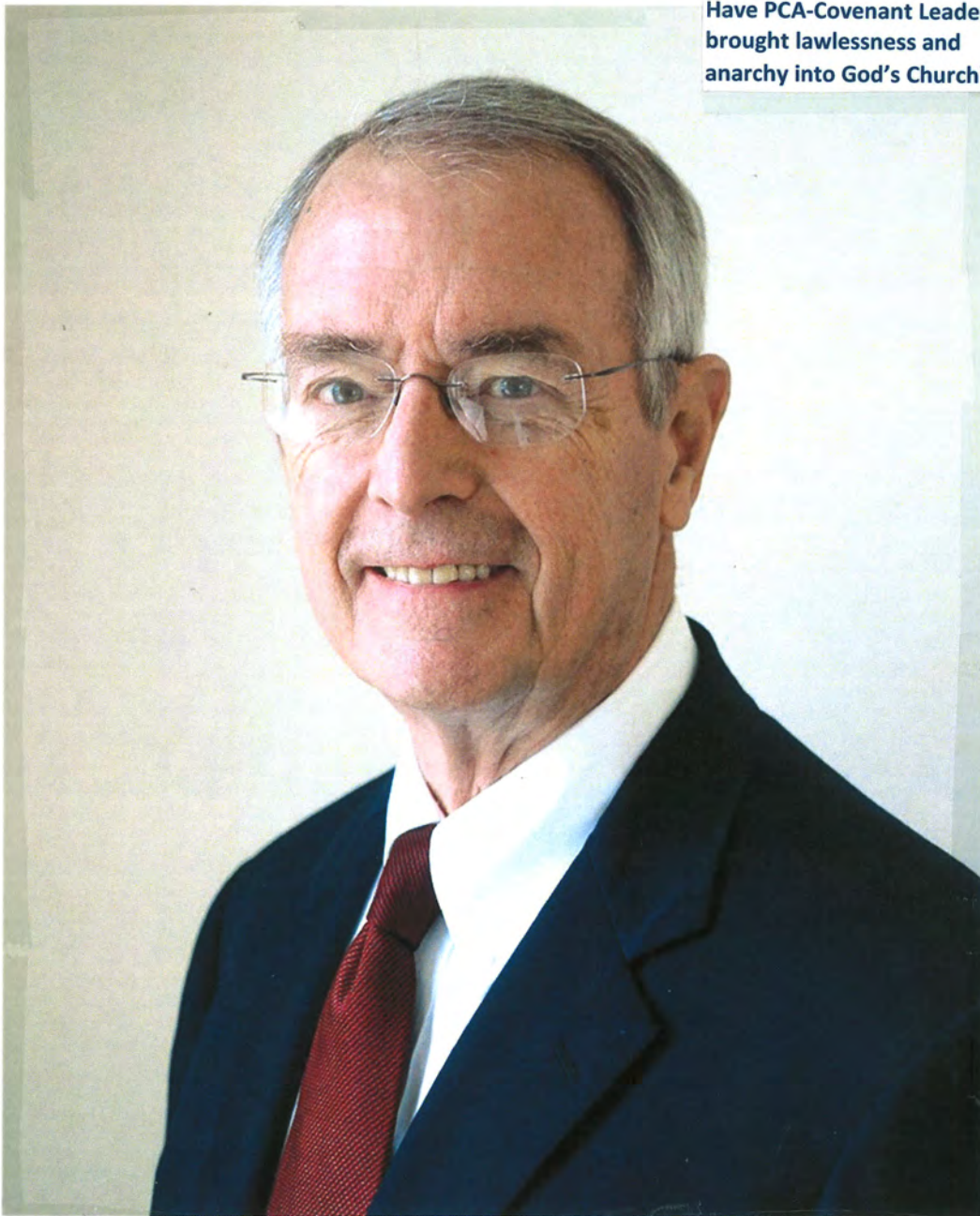
