Dear Ms. Davis:

This firm has been retained by Covenant Presbyterian Church of Nashville ("Covenant") regarding the matters set forth herein. This letter serves as notice to you that due to the actions and disruptive behavior you demonstrated immediately outside the sanctuary during Covenant's late worship service on Sunday, November 15, 2015, you do not have the permission or the consent of Covenant to enter upon or otherwise remain on the property owned by Covenant located at 33 Burton Hills Boulevard, Nashville, Tennessee (the "Property"). As a result, you are prohibited from returning to the Property at any time whatsoever, regardless of the day of the week or the time of day. **This prohibition is in effect 24 hours a day, 7 days a week.**

In the event that you ignore this letter, Covenant will immediately notify law enforcement to remove you from the Property and **arrest you** for criminal trespass and for any other violations of Tennessee law. Although not required to enforce the Tennessee criminal trespass statute, Covenant has filed an Authorization to Enforce & Prosecute Criminal Trespass Violations ("Criminal Trespass Waiver") **with law enforcement to expedite your arrest** should you return to the Property.

We hope that you will choose to voluntarily comply with this letter and Tennessee law.

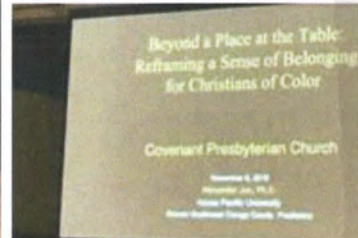

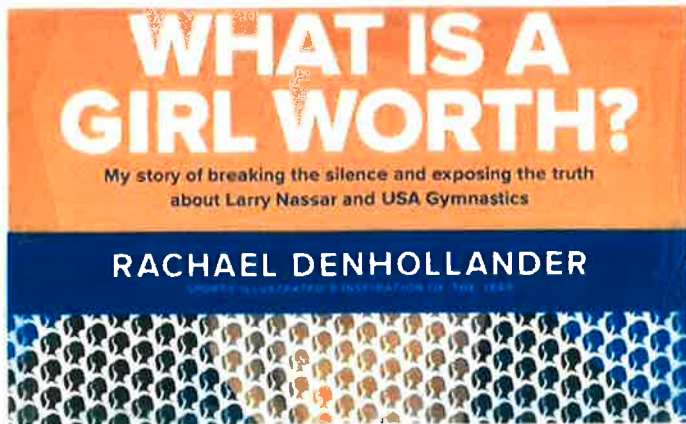

Hi all -

My name is Daisy Davis. I'm not used to writing emails, but for all of you who have been following the child molestation coverup at Covenant, I wanted to take a chance to update you.

This morning around 11:30, Austin Davis, my unarmed father, was falsely accused and arrested. He was taken downtown to be prosecuted and jailed by Metro Police. I was told that REDACTED also went to the court to prosecute him. The child molester, however, has still yet to be prosecuted although it appears that the statute of limitation on his history of sexual abuse has not yet expired.

If the paying members of Covenant are the rightful property owners, and not the church's leadership team, then the members are in charge of important decisions being made about the property. They deserved to vote before any action was taken against my dad. There should've been a congregational meeting that allowed for all member's questions to be answered in detail. The information provided to the members should have included that John Perry confessed the child molestation, that he was not prosecuted, and that he was allowed to remain a member after he confessed. They also needed to address whether he abused other children while he was running a safe house and if he was prosecuted for sexually abusing them. The church leadership also needs to explain why my dad is a "threat" for informing people of the coverup if his fact-based allegations are proven to be correct. The child molester in Belle Meade needs to be properly prosecuted before a guy just trying to go to church is.

It's easy to write off my dad. He has been ostracized and lied about by the community. It's easy to write off his 20 year old daughter, too. It was easy to write off the sexually abused victim when RED sought help. It's easy, but is it right? Easy silences and undermines, but doing the right thing empowers and protects. **Redacted = RED**

For those of you who don't want to get involved, I understand. It's messy and it's hard to be brave when your social status is at stake. Maintaining a good reputation can be done if you are willing to lie, cheat, and steal to keep it. Reputation means having a good PR team, but character means having a good track record.

There are people my age looking up to adults to see how they will react in the face of injustice. Our generation is just as scared as you all are, if not more so. We see violence and corruption at every turn and we crave hope and true leadership. We want to see our mothers and fathers take a stand. We want to know that if we live with integrity and pursue the truth, then evil will not prevail and our bravery will be rewarded. Our generation needs more heroes to admire, not cowards.

When I was little I read a book about a girl whose father takes a stand for justice. The town she lives in shames him and settles for the lies because the community is too lazy, too scared, or too intolerant to concern itself with the truth. There is a line from the book that says that it's a sin to kill a mockingbird. I always thought that line meant that it's wrong to take away someone's innocence. However, after today, I have a different point of view. Mockingbirds' songs reflect the world around them. They sing the truth they find in their surroundings. Maybe what Harper Lee was trying to say is don't shoot the messenger.

I am proud of my dad. He is my hero and I will stand by the truth with him.

1 I know an RUF campus pastor who is currently ministering to seventeen students who were  
2 victims of child sexual abuse. Not seventeen over the life of his ministry – seventeen current

5 I know two pastors who have had their daughters sexually assaulted in the PCA churches  
6 they were serving at the time. One of my best friends knows a man who was found to be  
7 serially molesting his own granddaughter. This man is a long-time PCA member and has  
8 been a leader in Bible Study Fellowship. I could tell you many other stories of abuse from  
9 people I know personally.

10

11 I know of multiple cases where the PCA church did not report the abuse. One of the two  
12 PCA pastors I mentioned, the elders and the pastor at the time knew about the abuser was  
13 guilty of child rape but did not call the authorities. When my friend was called to come  
14 pastor the church he knew something was not right in the church, but before he could figure  
15 it out his own young daughter was sexually assaulted by the same abuser.

17 Dr. Diane Langberg told me this story personally. Several years ago the then current head of  
18 woman's ministry in the PCA was talking with Dr. Langberg about child sexual abuse. She  
19 said to Dr. Langberg, "I'm so glad we don't have this in the PCA." Dr. Langberg told her at  
20 her next women's ministry conference to list child sexual abuse as an issue faced by women  
21 and see what happens. She said don't even mention it, just list it in one of the handouts. A  
22 few months later the head of women's ministry called Dr. Langberg and said, "What do I  
23 do? They are coming out of the woodwork!"
