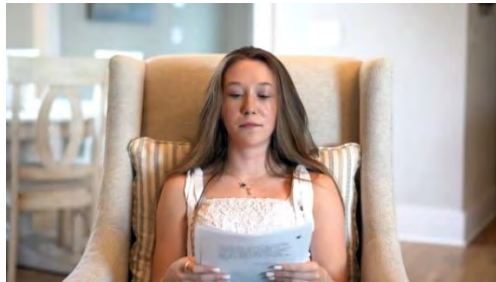

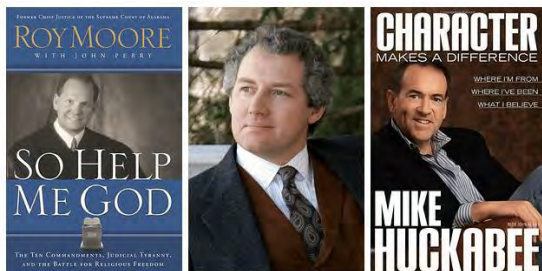

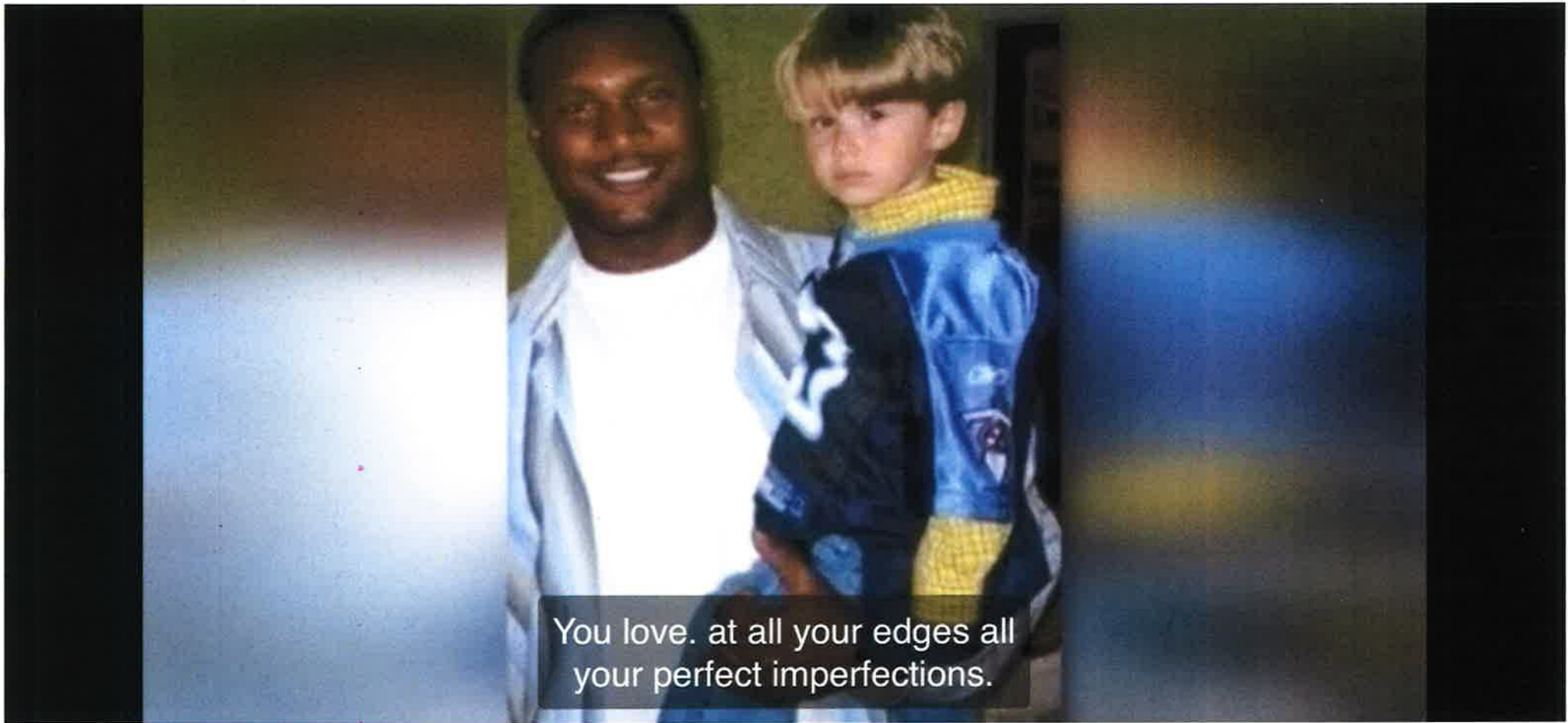

Allegations that Grace Chapel Church ignored reports of abuse 'demonstrably false,' says lead pastor

Rob Rogers, who has been acting lead pastor at Franklin's Grace Chapel Church since [Steve Berger's departure from the role earlier this year](#), addressed on Sunday recent allegations that church staff had ignored reports of abuse, calling them "blatantly and demonstrably false."

The allegations levied against Grace Chapel are just a small part of the [allegations recently made against former WSMV Channel 4 News anchor Aaron Solomon](#), who has been accused by his 14-year-old daughter Gracie Solomon of sexual abuse and of being involved with the death of his then-18-year-old son Grant Solomon.

Gracie, whose family attended Grace Chapel, has alleged that her brother Grant had told then-lead pastor Berger — now founding pastor and church elder — of the abuse she and Grant had allegedly suffered at the hands of their father. That meeting between Grant and Berger, which took place on May 7, 2018, was later said by Berger to have only been about faith.

Are Pastor Steve Berger and WSMV TV (the devil) telling the truth, or is information being withheld from 6.5 million Tennesseans?

DECLARATION OF STEVE BERGER

My name is Steve Berger. I have first-hand knowledge of the following events:

1. I am the founding Pastor of Grace Chapel in Leipers Fork, Tennessee.
2. In January of 2021, I completed a three-year long transition out of the role of Senior Pastor of Grace Chapel and now serve in the role of Founding Pastor. I also serve on Grace Chapel's Elder Board and still preach there occasionally.
3. I have learned that a group of social media accounts known as #freedomforgracie (the "Accounts") have made public allegations that Grant Solomon met with me and shared information that his sister was sexually abused by her father, Aaron Solomon, and that the family lived in fear of him.
4. The Accounts have further alleged that I and Grace Chapel failed Gracie Solomon and her family because I did not report these allegations to the authorities.
5. The Accounts' allegations are untrue.
6. I did meet with Grant Solomon on or about May 8, 2018, at 11:30 am. We met privately in my office.
7. Our conversation consisted of a discussion of spiritual matters, namely how Grant could grow closer to Christ.
8. At no time in this meeting (or otherwise) did Grant report to me any sexual abuse allegations of any kind involving his sister, his father, or any other person.
9. At no time in this meeting (or otherwise) did Grant express to me that he was afraid of his father or that his father had abused him or Gracie in any way whatsoever.

10. As a mandatory reporter, I would have had the obligation to report any allegation of abuse to the proper authorities. I take this responsibility very seriously and would have promptly reported any such allegations if they had been made.

11. At some point after my meeting with Grant, I learned that Angie Solomon had reported allegations of abuse to an employee of Grace Chapel on April 30, 2018. That employee accompanied Ms. Solomon to the Williamson County Sherriff's Department to make a report of the allegations on May 4, 2018, and an investigator was assigned to the case. At no time did Grant mention anything to me about his mother's trip to the Sherriff's Department or any claims of abuse.

12. Upon Grant's death from a tragic accident on July 20, 2020, the family asked me to speak at his funeral, which I did.

13. The family held Grant's funeral at Grace Chapel.

14. The family rode with me from the funeral to the cemetery.

15. I am also told that the GoFundMe campaign related to the Accounts indicated that I had donated \$10. I did not make that donation and any statement or implication that I did so is false.

16. I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge, information, and belief.

Our client, Nashville Presbytery, was served recently with the Complaint in the referenced action. Pursuant to Tenn. Rule of Civ. Proc. 11, we request that your client dismiss his claims against the Nashville Presbytery in this case. If he fails to do so, we expect to file the attached Motion for Sanctions.

Dear Ms. Ashley:

This firm is legal counsel to Grace Chapel Church located at [REDACTED] Road, Franklin, Tennessee.

This letter concerns a recent blog posted by you on June 12, 2021 on Medium.com entitled “14yo Gracie Says Her Father Raped Her and Murdered Her Brother”. This blog contains several material misstatements regarding Grace Chapel Church which, taken as a whole, present a false and defamatory publication and which cast the church in a false light. In addition, your post appears to adopt wholesale and re-publish certain false and defamatory statements contained in a video statement published by Gracie Solomon.

Specifically, you state in your blog post the following false characterizations regarding the church and its present and former staff:

- (a) Let me warn you --- it’s a really difficult video to watch. In it, Gracie describes many instances of sexual abuse. She talks about the various ways their father belittled, intimidated, and controlled her brother, and how her whole family has suffered at the hands of Aaron Solomon...not to mention Grace Christian Academy and Grace Chapel.**

This statement is patently and demonstrably false as it relates to Grace Chapel. To the contrary, Grace Chapel has provided financial assistance to Angelia Solomon with a benevolence gift. In addition, when Ms. Solomon first reported to a member of the church staff her concerns about abuse on April 30, 2018, four days later, on May 4, 2018, the staff member accompanied her to the Williamson County Sheriff’s Department where a report was promptly taken of this allegation.

(b) Gracie attends Grace Christian Academy, which is effectively run by Grace Chapel in Franklin, Tennessee.

Grace Chapel Church is a wholly separate corporate entity from Grace Christian Academy. The two entities have their own independent boards and there is absolutely no oversight, control or governance by Grace Chapel of Grace Christian Academy.

(c) Aaron, a member of their (Grace Chapel's) church is currently suing more than 20 people including a GCA classmate Anna Smit for giving video testimony about her talks with Grant, Gracie, and school counselors.)

Aaron Solomon is not a member of Grace Chapel.

(d) As a survivor of evangelical abuse and a mother who lives less than three hours away from Grace Chapel, I have a pretty good feel for the garbage Gracie and her mother are up against.

This statement is susceptible of a false and malicious inference that Grace Chapel engages in "evangelical abuse" and is constitutes defamation by innuendo.

The purpose of this letter is to place you on formal notice that these false and defamatory statements constitute actionable and threaten to injure the reputation and standing of Grace Chapel in the community. On behalf of my client, I am hereby making demand that you publicly retract these statements forthwith and that you cease and desist from making or publishing any such false statements in the future regarding Grace Chapel. You are further advised that unless I receive at my office proof of a retraction by you of these comments by **June 21, 2021**, I have been directed by my client to proceed with an action to enforce its legal and equitable remedies and to seek compensatory as well as punitive damages, costs and attorney's fees.

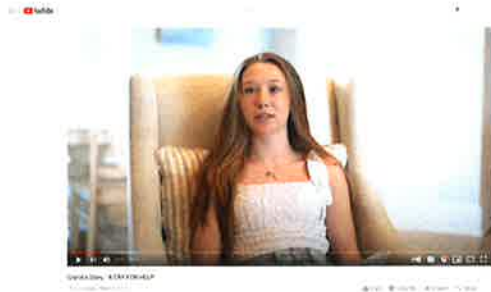

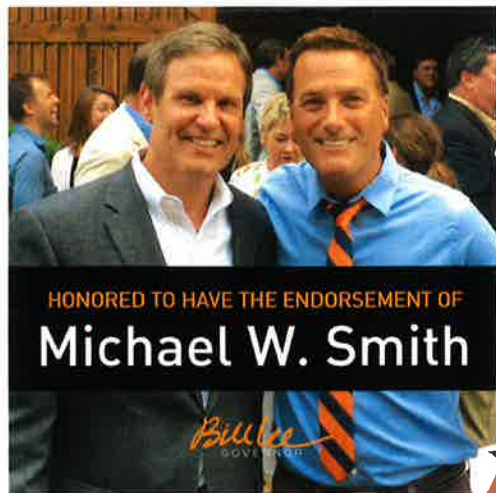

Dear Austin and Catherine,

It was my pleasure to meet with both of you today. I have since had an opportunity to review the documents that you left with me concerning your case.

The facts as related by you raise a host of legal and constitutional issues, all of which are complex in nature. It appears to me that you have sought repeatedly to resolve this matter following the admonition of the Holy Scriptures in 1 Corinthians: 6, Matthew: 18 and others. It is indeed unfortunate that your appeals to the ecclesiastical authorities of the church seem to have fallen on deaf ears. What is even more disturbing is the apparent pattern on the part of some church leaders within Covenant Presbyterian to use their political influence to try and intimidate you through the use of law enforcement and civil authority. This pattern opens the church and leadership to potential civil liability under such theories as invasion of privacy, defamation and for casting you in a false light.

Over the course of my thirty years practice I have specialized in representing churches and Christians in a wide spectrum of church/state issues. I have been on both sides of church discipline cases and will tell you that when civil courts become involved, these cases rapidly escalate into a warfare in which the casualty often is the reputation of Christians, particularly in the eyes of non-believers. It is for this reason that I must advise you to tread cautiously into your decision whether to bring any type of civil action against those who have usurped their role as church leaders, and I am convinced that you have prayerfully considered any such action.

I will continue to give this matter further thought and consideration as I review the documents that you have provided me. You should also be mindful of the fact that there is a one year statute of limitations which may expire as early as **June 27, 2009**; as to certain causes of action you may have against these defendants. This statute of limitations is, of course, tolled as to your daughter, Daisy, because of her minority status.



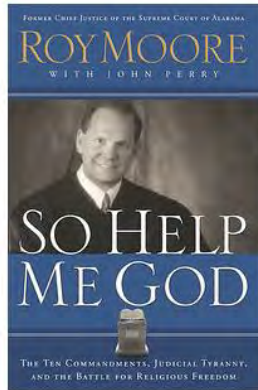

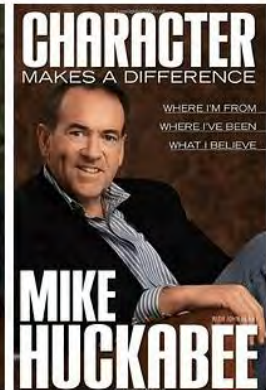

Covenant Deacon Ken Cheeseman was the Head of the "Green Hills" feeder school cited in paragraph 15. Ken Cheeseman was already a participant in the John Perry – Mann Act Federal crime cover-up at Covenant when his school was cited in the BA alleged rape lawsuit. Ken Cheeseman is now Head of School at The Webb School in Bell Buckle, TN.

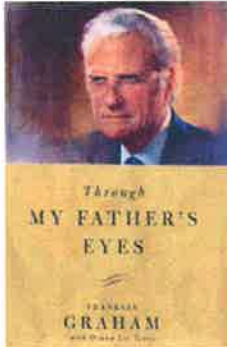

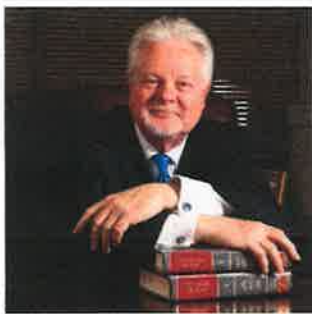

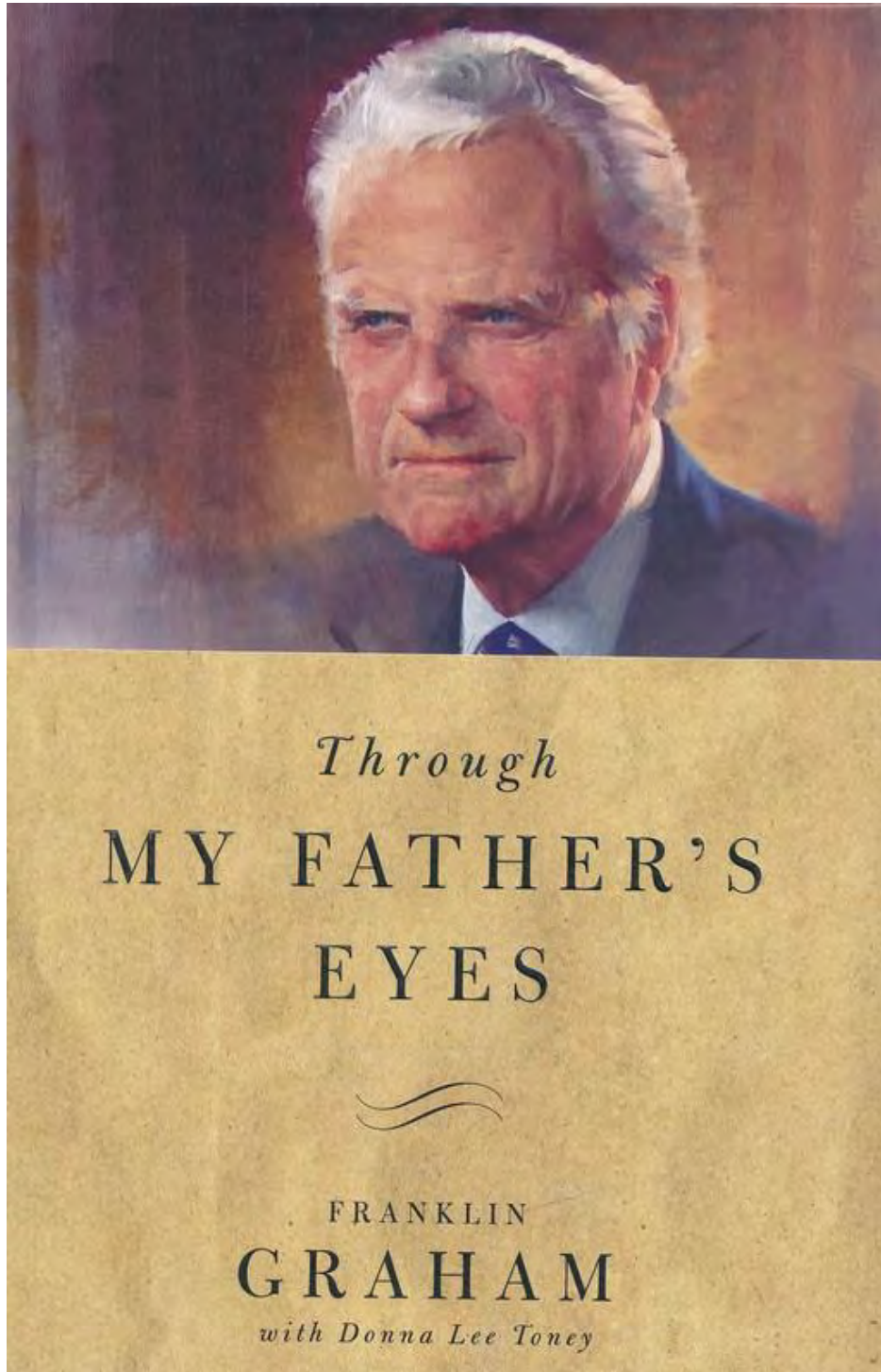

Then he said, “Sounds like a cover-up.” He also asked me questions such as, “Are you sure you are not a victim?” and “What about your son?” He referred me to Larry Crain and said something about not working with the media. *(Note: Attorney Nick Tidwell is a law partner with Attorney Robert Pautienus at Fidelis Law who sent Austin Davis a “cease and desist” letter on April 26, 2021.)*

When we met with Larry, he asked a lot of unusual questions such as, “Are you sure your email is secure?” He also advised that I archive all of my emails. I don’t delete my emails and shared this information with the attorneys. After asking a few questions and discussing the situation, he told me that I had a lot of sensitive information. He said that we are going to handle this one step at a time. I didn’t know what he meant by that.

Larry listened to our concerns, which he considered troubling. We discussed with him an upcoming meeting with church pastors. He said that he believed all of the children should be evaluated for harm. We pursued evaluations and consulted with him until we had tangible evidence of harm for our child. He said that he was hoping to be able to meet with the church board, but that was not going to be able to happen.

Secret Settlements in Child Sexual Abuse Cases: Cover-Up in Williamson County – Part 3

Initial Representation

I was referred to Larry Crain, [who we retained](#). Larry listened to our concerns, which he considered troubling. We discussed with him an upcoming meeting with church pastors. He said that he believed all of the children should be evaluated for harm. We pursued evaluations and consulted with him until we had tangible evidence of harm for our child. Around this time, he told me that some people only respond to threats. He said that he was hoping to be able to meet with the church board, but that was not going to be able to happen. In addition, he worked with churches setting up their legal protocols and recently started working with churches in Franklin and Brentwood. As a result, he could no longer work with us. I told him that I was disappointed, and he thanked me for my candor.

At first, when Larry Crain decided to let us go, it was disappointing, but I understood it in the context of the elevated status of the institutional church within our community, which many refer to as “the buckle of the Bible belt”. But, then again, he considered all the children at risk for abuse, that they all should be evaluated, and perceived there were parents “in the dark” regarding the risks their children were exposed to.

I don't understand that when there are victims in a church setting, some might feel comfortable supporting privately but would not consider doing this publicly. Everything we walked through was so difficult, it really was discouraging to repeatedly feel like we were perceived as lepers in our attempts to search for answers and advocate for our son and others.

I cannot help but think of the passage in [Matthew 25:31-46](#).

Matthew 25:45 “He will reply, ‘Truly I tell you, whatever you did not do for one of the least of these, you did not do for me.’”

At the time that I was consulting with Larry, I did share his name with a pastor at another [church](#). I had continued conversations with this pastor, and this may be a church that Larry worked with on their legal protocols. Recent [news](#) reports also show he represents Grace Chapel and recently sent a cease and desist letter to a blogger.

1st three-year old victim

Secret Settlements in Child Sexual Abuse Cases: Cover-Up in Williamson County – Part 3

Settlement with the Church

We settled with the church with allegations of sexual assault during a mediation September 28, 2016. We had our court hearing on November 8, 2016, with Judge Deanna Johnson as our judge... I also shared that I believe secret settlements for child sexual abuse cases are immoral... *(Note: Sen. Jack Johnson and Judge Deanna Johnson attend Grace Chapel along with Michael W. Smith, Gov. Bill Lee and First Lady Maria Lee. First Lady Maria Lee is a former girls youth leader at Christ Presbyterian Church, and a former teacher at Christ Presbyterian Academy.)*

We also began working with the attorneys on the settlement paperwork. To the best of our ability, we struck out any language that would convey any sense that we were interested in keeping the overall situation confidential... For our court hearing, we went to a back conference room in the court house to sign paperwork. The court hearing lasted about 10 minutes. We were told that we were signing paperwork that we had already reviewed. However, during the court hearing, new paperwork was introduced with language that we had not had a chance to review beforehand. This made the confidentiality of the settlement very broad.

Cease and Desist Letter

We found out about the broad confidentiality after reporters called the church which led to the **church giving us a notice of the breach. Quoted from the letter, “The agreement was violated so quickly that it leads us to conclude that your violation was planned in advance and made with actual malice. If our client suffers damage because of your actions we will be forced to pursue all available remedies for damages caused by this intentional malicious disclosure including but not limited to an award of punitive damages against each of you to deter future conduct in violation of the agreement.”**

We never intended to enter into an agreement and violate it immediately. It was definitely a very scary letter to receive. We were frightened at what actions the church would take against us. As a result, we retracted any statements about the church and sought to address all issues through legal means. The Tennessean did publish an article about the cases in December 2016, but I didn't even realize an article had been published until sometime the next spring or summer. *(Note: A Tennessean article by Holly Meyer and Dave Boucher from Dec 16, 2016 cites the case of the 1st three-year old sexual assault victim, but not the 2nd three-year old sexual assault victim. Holly Meyer and Dave Boucher are well informed of the John Perry cover-up but The Tennessean has also protected the John Perry – Mann Act Federal crime cover-up.)*

In November 2015, two alleged child sex abuse cover-up cases collided in the children's wing of Fellowship Bible Church: 1) The John Perry child sex abuse cover-up at Covenant Presbyterian Church; 2) The alleged sexual assaults of two three-year children at Fellowship Bible Church. On Nov 29, 2015, after a month of meeting in the children's wing, Matt Bradley's new Covenant splinter church announced it was beginning weekly worship services in the barn at Fellowship Bible Church. The announcement was made two weeks after Austin Davis was handcuffed and arrested at a public Sunday church service at Covenant Presbyterian Church to protect the John Perry – Mann Act Federal crime cover-up.

Former Fellowship Bible Pastor Bill Wellons is now associated with Pine Cove Christian Camps which serves 40,000 campers per year. Per the mother of the 2nd three-year old alleged sexual assault victim at Fellowship Bible Church, a 2nd lawsuit was settled in mediation on Sept 28, 2016, exactly one month after Pastor Bill Wellons announced his resignation from Bible Fellowship Church leadership on Aug 28, 2016.

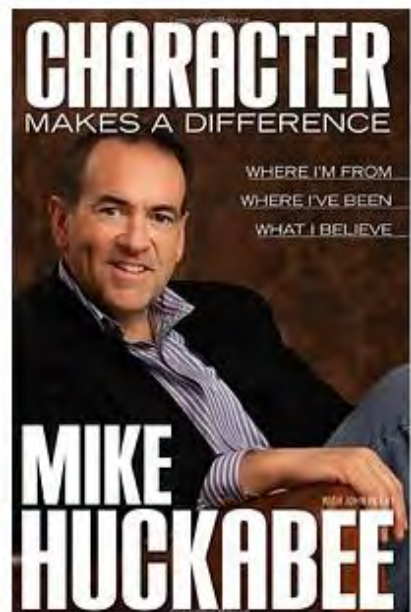
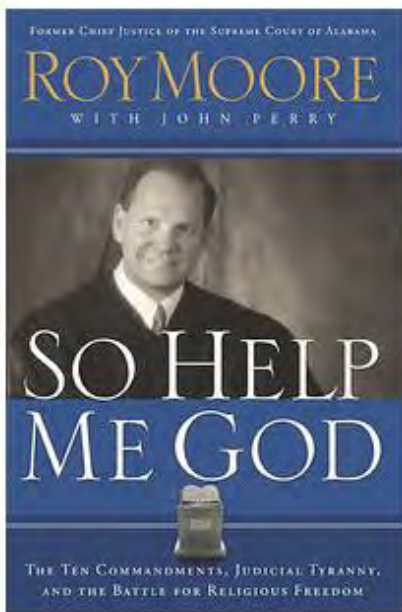
Two eyewitnesses of an alleged cover-up of sex crimes are accusing J.D. Greear and The Summit Church of conducting a “sham” investigation into the past of newly-hired executive pastor Bryan Loritts.

Summit hired Loritts on June 1, despite allegations that Loritts had covered up criminal voyeurism committed by his brother-in-law, Rick Trotter, 10 years ago at Fellowship Memphis. In a May 24 letter, Greear, who’s also president of the Southern Baptist Convention, assured his congregation that Summit leaders had thoroughly investigated Loritts to ensure that “his prior conduct aligns with our missional values and beliefs.”

Lin Wood, the prominent Atlanta lawyer who brought several unsuccessful lawsuits challenging the results of the 2020 presidential election, filed an affidavit in federal court on Tuesday reaffirming bizarre allegations he made about Chief Justice John Roberts and branding former **Vice President Mike Pence as a traitor...** “I have also exercised my right of free speech to advocate for protection of the Bill of Rights, honest elections, and against pedophilia and child sex trafficking,” Wood wrote. “I have also received credible evidence of serious wrongdoing by high-ranking government officials which I have brought to the attention of the public and to federal law enforcement officials. The evidence of wrongdoing includes evidence of potentially serious crimes perpetrated by the Chief Justice of the United States Supreme Court.”

In a series of filings made in Atlanta federal court on Monday, the state bar said Wood, who embraced conspiracy theories and gained a large social media following challenging former President Donald Trump's election defeat, would not lose his law license if he failed to be evaluated.

This letter serves as a demand to cease and desist from further making or disseminating any defamatory statements regarding my client, Pastor Steve Berger. As well, he demands that you take down the defamatory video described below and related defamatory posts on social media sites, including ones on *freedomforgracie* on Instagram. If you are represented by counsel, please forward this letter to that person immediately.

My investigation into this matter indicates you are familiar with the circumstances surrounding the defamatory video and its dissemination since you were present when the video was created. I will briefly recount the facts here.

Earlier this year, [REDACTED] recorded a video of Gracie in which she reads various statements, including a statement that Grant Solomon shared allegations of child abuse with Pastor Berger. The video further states that Pastor Berger did nothing after being told of the child abuse. Those accusations are false and defamatory.

As you should know, just days before Grant met with Pastor Berger, a representative from Grace Chapel (where Steve Berger served as Pastor) took Gracie's mother to the police station after the Solomons made the Church aware of allegations of child abuse. After an investigation by the police department, the allegations apparently were not substantiated. The fact, however, is that Pastor Berger takes his legal obligations seriously and would have fulfilled his reporting obligations had such allegations been made. Of equal importance, Grace Chapel had already taken protective action. Thus, Pastor Berger, through his church, had already taken appropriate action. As a result of the dissemination of the video which implies that Pastor Berger failed to fulfill his legal obligations, including those obligations set forth in Tenn. Code Ann. §37-1-403(a)(1), he has been and continues to be defamed. To be clear, at no point did Grant ever inform

Pastor Berger about any allegations of abuse. Had Grant done so, Pastor Berger would have ensured that the allegations were reported, just like they were a few days before.


Pastor Berger has a cause of action for defamation against those who orchestrated the publication of the defamatory video. Our investigation indicates that you helped create and publish the video. As a result of your actions, the Williamson Home Page republished the defamatory statements further damaging Pastor Berger's reputation. Through this conduct, you and others are now potential defendants in a defamation action.

To start to attempt to mitigate the damages you have caused Pastor Berger, we demand that you take down the video and all related defamatory comments found on related social media sites. Should you fail to act fully and promptly, we may be forced to take legal action against you. Please understand that we will not accept the excuse that you do not know who now controls the video. You either know or can find out who can access the social media sites to take down the video.

If the video and offending social media posts are not taken down from Instagram, YouTube, and other social media sites by 5:00 PM on Friday, August 20, we will assume that you have chosen to ignore our request.

We hope you will do the right thing.

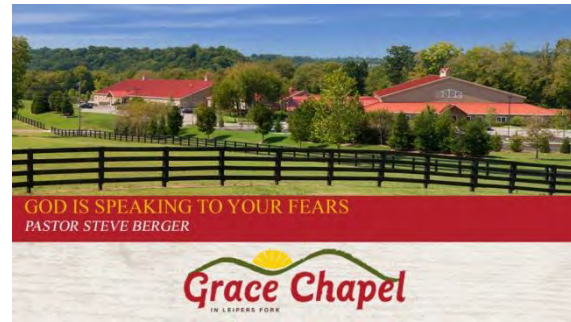

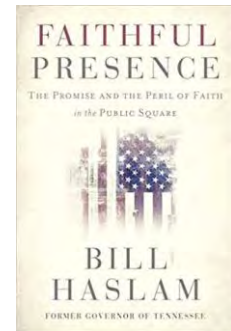
