The agenda for this meeting was approved by the Session and is established as the agenda of the meeting based on *Book of Church Order (BCO)* 12-5.d, 12-5.e, and 25-2.

There are two dissolution motions being acted on and they may not be amended. They are:

- o The Session of Covenant Presbyterian Church recommends that the congregation dissolve the pastoral relations between Senior Pastor Jim Bachmann and Covenant Presbyterian Church (BCO 23-1).
- o Having received a petition (BCO 25-2) to hold a congregational meeting for the purpose of voting on the dissolution of the official relationship between Covenant Presbyterian Church and ruling elder Bryce Sullivan (BCO 24-7), the Session puts the motion to dissolve RE Sullivan's official elder relations before the congregation upon request of the petitioners.

- I. Moderator TE Jim Bachmann will call the meeting to order and open in prayer.
- II. The congregation elects a Clerk (Session recommends RE Roderick Russ).
- III. The rules contained in *Robert's Rules of Order, Newly Revised* governs this meeting of the congregation as approved by the Session.
- IV. If desired by TE Bachmann, the congregation elects a Moderator *Pro Tem*. The Moderator or Moderator *Pro Tem* appoints a parliamentarian to assist him in his moderating of the meeting.
- V. The Moderator will announce that at 4:45 p.m. two secured ballot boxes (one for each dissolution motion) will be available in the narthex for depositing the ballots of any member who chooses to leave the meeting and vote early. Ballots will also be collected in the sanctuary after debate ends on each motion.

The procedure of each motion being acted on by the congregation will be as follows:

- 60 minutes will be allowed for debate on the first motion and 30 minutes for the second motion
- The debate will begin with someone speaking in favor of the motion
- The debated will continue in alternating fashion, e.g., speaking against the motion, in favor of the motions, against the motion, etc.
- No person debating may speak longer than 3 minutes
- Debate will stop and voting by secret ballot will commence at the order of the day

The Communication Commission of the Session will present a report.

ORDER OF THE DAY / Reading of the first motion and debate commences.

The Session of Covenant Presbyterian Church recommends that the congregation dissolve the pastoral relations between Senior Pastor Jim Bachmann and Covenant Presbyterian Church (BCO 23-1).

- IX. ORDER OF THE DAY / 60 minutes after debate commenced – Debate ceases, secret ballots cast and collected.
- X. ORDER OF THE DAY / Reading of the second motion and debate commences.
Having received a petition (BCO 25-2) to hold a congregational meeting for the purpose of voting on the dissolution of the official relationship between Covenant Presbyterian Church and ruling elder Bryce Sullivan (BCO 24-7), the Session puts the motion to dissolve RE Sullivan's official elder relations before the congregation upon request of the petitioners.
- XI. ORDER OF THE DAY / 30 minutes after debate commenced – Debate ceases, secret ballots cast and collected.
- XII. Meeting to recess until announcement of the votes.
- XIII. Singing hymns and songs.
- XIV. Announcement of the outcome of the votes by the Moderator.
- XV. Meeting will adjourn with the Doxology and a prayer.

Aaron Solomon's Statement

In the 911 call - [CLICK HERE TO LISTEN](#) - Aaron immediately says "I've got 3 guys here." He does not mention them here. According to a witness, he came out when he heard sirens and saw Aaron alone pacing on his cell phone in the parking lot.

Investigation Complete

All evidence indicates the incident happened at the bottom of the driveway by the ditch. The truck and Grant's body were located on government property. However, Aaron Solomon's statement was taken, the incident logged as occurring on private property, and the investigation marked complete.

Injuries Do Not Match Aaron's Account

According to his father, Grant's truck dragged him across the asphalt of the parking lot, over the grassy knoll, and down into a steep rocky ditch. Grant's injuries are completely inconsistent with that statement.

Grant's Injuries

A bruise on the upper thigh. A bruise on his hip. A blow to the jaw. And a single fatal blow to the back of Grant's head. NO OTHER INJURIES. (Any other indicators referred to actions of the EMS.)... This firm is legal counsel to Grace Chapel Church located at [REDACTED] Road, Franklin, Tennessee.

This letter concerns a recent blog posted by you on June 12, 2021 on Medium.com entitled "*14yo Gracie Says Her Father Raped Her and Murdered Her Brother*". This blog contains several material misstatements regarding Grace Chapel Church which, taken as a whole, present a false and defamatory publication and which cast the church in a false light. In addition, your post appears to adopt wholesale and re-publish certain false and defamatory statements contained in a video statement published by Gracie Solomon.

Specifically, you state in your blog post the following false characterizations regarding the church and its present and former staff:

- (a) Let me warn you --- it's a really difficult video to watch. In it, Gracie describes many instances of sexual abuse. She talks about the various ways their father belittled, intimidated, and controlled her brother, and how her whole family has suffered at the hands of Aaron Solomon...not to mention Grace Christian Academy and Grace Chapel.**

This statement is patently and demonstrably false as it relates to Grace Chapel. To the contrary, Grace Chapel has provided financial assistance to Angelia Solomon with a benevolence gift. In addition, when Ms. Solomon first reported to a member of the church staff her concerns about abuse on April 30, 2018, four days later, on May 4, 2018, the staff member accompanied her to the Williamson County Sheriff's Department where a report was promptly taken of this allegation.

(b) Gracie attends Grace Christian Academy, which is effectively run by Grace Chapel in Franklin, Tennessee.

Grace Chapel Church is a wholly separate corporate entity from Grace Christian Academy. The two entities have their own independent boards and there is absolutely no oversight, control or governance by Grace Chapel of Grace Christian Academy.

(c) Aaron, a member of their (Grace Chapel's) church is currently suing more than 20 people including a GCA classmate Anna Smit for giving video testimony about her talks with Grant, Gracie, and school counselors.)

Aaron Solomon is not a member of Grace Chapel.

(d) As a survivor of evangelical abuse and a mother who lives less than three hours away from Grace Chapel, I have a pretty good feel for the garbage Gracie and her mother are up against.

DECLARATION OF STEVE BERGER

My name is Steve Berger. I have first-hand knowledge of the following events:

1. I am the founding Pastor of Grace Chapel in Leipers Fork, Tennessee.
2. In January of 2021, I completed a three-year long transition out of the role of Senior Pastor of Grace Chapel and now serve in the role of Founding Pastor. I also serve on Grace Chapel's Elder Board and still preach there occasionally.
3. I have learned that a group of social media accounts known as #freedomforgracie (the "Accounts") have made public allegations that Grant Solomon met with me and shared information that his sister was sexually abused by her father, Aaron Solomon, and that the family lived in fear of him.
4. The Accounts have further alleged that I and Grace Chapel failed Gracie Solomon and her family because I did not report these allegations to the authorities.
5. The Accounts' allegations are untrue.
6. I did meet with Grant Solomon on or about May 8, 2018, at 11:30 am. We met privately in my office.
7. Our conversation consisted of a discussion of spiritual matters, namely how Grant could grow closer to Christ.
8. At no time in this meeting (or otherwise) did Grant report to me any sexual abuse allegations of any kind involving his sister, his father, or any other person.
9. At no time in this meeting (or otherwise) did Grant express to me that he was afraid of his father or that his father had abused him or Gracie in any way whatsoever.

10. As a mandatory reporter, I would have had the obligation to report any allegation of abuse to the proper authorities. I take this responsibility very seriously and would have promptly reported any such allegations if they had been made.

11. At some point after my meeting with Grant, I learned that Angie Solomon had reported allegations of abuse to an employee of Grace Chapel on April 30, 2018. That employee accompanied Ms. Solomon to the Williamson County Sherriff's Department to make a report of the allegations on May 4, 2018, and an investigator was assigned to the case. At no time did Grant mention anything to me about his mother's trip to the Sherriff's Department or any claims of abuse.

12. Upon Grant's death from a tragic accident on July 20, 2020, the family asked me to speak at his funeral, which I did.

13. The family held Grant's funeral at Grace Chapel.

14. The family rode with me from the funeral to the cemetery.

15. I am also told that the GoFundMe campaign related to the Accounts indicated that I had donated \$10. I did not make that donation and any statement or implication that I did so is false.

16. I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge, information, and belief.

This letter serves as a demand to cease and desist from further making or disseminating any defamatory statements regarding my client, Pastor Steve Berger. As well, he demands that you take down the defamatory video described below and related defamatory posts on social media sites, including ones on *freedomforgracie* on Instagram. If you are represented by counsel, please forward this letter to that person immediately.

My investigation into this matter indicates you are familiar with the circumstances surrounding the defamatory video and its dissemination since you were present when the video was created. I will briefly recount the facts here.

Earlier this year, [REDACTED] recorded a video of Gracie in which she reads various statements, including a statement that Grant Solomon shared allegations of child abuse with Pastor Berger. The video further states that Pastor Berger did nothing after being told of the child abuse. Those accusations are false and defamatory.

As you should know, just days before Grant met with Pastor Berger, a representative from Grace Chapel (where Steve Berger served as Pastor) took Gracie's mother to the police station after the Solomons made the Church aware of allegations of child abuse. After an investigation by the police department, the allegations apparently were not substantiated. The fact, however, is that Pastor Berger takes his legal obligations seriously and would have fulfilled his reporting obligations had such allegations been made. Of equal importance, Grace Chapel had already taken protective action. Thus, Pastor Berger, through his church, had already taken appropriate action. As a result of the dissemination of the video which implies that Pastor Berger failed to fulfill his legal obligations, including those obligations set forth in Tenn. Code Ann. §37-1-403(a)(1), he has been and continues to be defamed. To be clear, at no point did Grant ever inform

Pastor Berger about any allegations of abuse. Had Grant done so, Pastor Berger would have ensured that the allegations were reported, just like they were a few days before.

Pastor Berger has a cause of action for defamation against those who orchestrated the publication of the defamatory video. Our investigation indicates that you helped create and publish the video. As a result of your actions, the Williamson Home Page republished the defamatory statements further damaging Pastor Berger's reputation. Through this conduct, you and others are now potential defendants in a defamation action.

To start to attempt to mitigate the damages you have caused Pastor Berger, we demand that you take down the video and all related defamatory comments found on related social media sites. Should you fail to act fully and promptly, we may be forced to take legal action against you. Please understand that we will not accept the excuse that you do not know who now controls the video. You either know or can find out who can access the social media sites to take down the video.

If the video and offending social media posts are not taken down from Instagram, YouTube, and other social media sites by 5:00 PM on Friday, August 20, we will assume that you have chosen to ignore our request.

We hope you will do the right thing.

The Writer's grant of such rights shall extend for the entire time period of the copyright, patent, and/or trademark pertaining to the Proposal, the Manuscript or the Work. The Writer shall promptly sign any and all documents and forms as requested by the Author to accomplish the intents and purposes hereof.

ORDER

The defendant, Willie Austin Davis, proceeding *pro se*, filed a motion requesting the members of the Tennessee Supreme Court to recuse themselves from consideration of his Rule 11 application in the above-styled matter.¹ The defendant asserts, among other things, that the Court cannot be fair and impartial because of the Court's constitutional obligation to appoint the Attorney General. The defendant is also aggrieved by the Court's previous denial of his Rule 11 applications filed in other cases.

Tennessee Supreme Court Rule 10, Canon 1.2 provides: "A judge shall act at all times in a manner that promotes public confidence in the independence, integrity, and impartiality of the judiciary, and shall avoid impropriety and the appearance of impropriety." Canon 2.11(A) provides further, in pertinent part: "[a] judge shall disqualify himself or herself in any proceeding in which the judge's impartiality might reasonably be questioned. . . ."


Each Justice having reviewed the assertions contained in the defendant's motion and accompanying affidavit, the Court concludes the defendant has failed to establish that the Court's exercise of its constitutional obligation to appoint the Attorney General generally, or its appointment of Attorney General Herbert H. Slatery III specifically, merits recusal of the members of the Court, individually or collectively. Likewise, recusal is not warranted simply because the Court has previously ruled adversely to the defendant in other matters. *See In re Cameron*, 151 S.W. 64, 74 (Tenn. 1912).

Gov. Bill Haslam attended Christ Presbyterian Church during his tenure as Tennessee Governor.

¹ The motion also sought recusal of Justice Cornelia A. Clark. Sadly, our colleague and friend, Justice Clark, passed away on September 24, 2021.
