In the 2019 Sundance NOW Original documentary series, The Oslo Killing, Judge Alan E. Judge Cheryl Blackburn: Well, in this particular issue, you don't have a First Amendment freedom of speech.

Austin Davis: Okay. That's good to clarify.


Franklin's Grace Chapel Church's lawyers at Crain Law Group sent a cease and desist letter on Wednesday to Shannon Ashely, an online blogger, after the writer published a <u>lengthy</u> <u>story</u> alleging "evangelical abuse" against the Franklin church.






