The Brentwood Academy (BA) alleged gang rape case involved Attorney Larry Crain who filed a \$1.5 million *"defamation"* lawsuit against the mother of the alleged 6th grade victim, and a \$300,000 lawsuit against BA parents, Michelle and Willis Nowell. Larry Crain had previously filed a \$3 million *"invasion of privacy – defamation"* retaliation lawsuit against Austin Davis in a related John Perry child sex abuse cover-up case. On May 12, 2021, alleged child sex abuse victim, Gracie Solomon, was courageous to make a public *"cry for help"* claiming her father, Aaron Solomon, had raped her, and also killed her brother, Grant Solomon. After Gracie Solomon made her public cry for help, Grace Chapel Attorney Larry Crain, sent a *"cease and desist"* letter to Medium Writer Shannon Ashley who was brave to report on Gracie Solomon's public cry for help. Four months later on Sept 26, 2021, Carrie Underwood performed at a Grace Christian Academy (GCA) Benefit Concert to raise money for the private school located on the property of Grace Chapel Church. 1. <u>April 14, 2021</u> – Child sex abuse whistleblower, Austin Davis, sent an email to Grace Chapel Staff and Richard Anderson (GCA High School Principal) about John Perry's child sex abuse of an 11-year-old victim across state lines in violation of the Federal Mann Act. The email included information about numerous connections to the alleged Brentwood Academy gang rape case, and the rape of at least one three-year old child at Fellowship Bible Church in Brentwood.

TIMELINE

- <u>April 22, 2021</u> The Tennessee Supreme Court denied a recusal appeal which provided the Court with information about the John Perry – child sex abuse cover-up and a conflict of interest with Christ Presbyterian Church, Christ Presbyterian Academy, Gov. Bill Lee, Attorney General Herbert Slatery, and many others. GCA High School Principal Richard Anderson was the former Headmaster at Christ Presbyterian Academy (CPA).
- 3. <u>April 26, 2021</u> Brentwood Attorney and Brentwood High School Asst. Track Coach, Robert Pautienus, sent former Ensworth Coach Austin Davis a *"cease and desist"* letter on behalf of Christ Presbyterian Church and Christ Presbyterian Academy (CPA). Gov. Bill Lee's children graduated from Christ Presbyterian Academy, along with one of childmolester John Perry's children. Gov. Bill Lee also attended Grace Chapel Church, and First Lady Maria Lee is a former Christ Presbyterian Academy teacher who taught under the leadership of former CPA Headmaster Richard Anderson, and was also a Christ Presbyterian Church youth ministry girls discipleship leader.
- 4. <u>May 12, 2021</u> Gracie Solomon made a public statement that her father raped her, and killed her brother, Grant Solomon. Gracie and Grant Solomon both attended GCA.

- 5. <u>June 4, 2021</u> Gracie Solomon signed a sworn affidavit under penalty of perjury that she was she sexually molested in Asheville, North Carolina, when she was 11-years old in violation of the Federal Mann Act.
- 6. <u>June 12, 2021</u> Shannon Ashley wrote an article posted on Medium about Gracie Solomon's YouTube video and Gracie Solomon's rape and murder allegations.
- 7. June 16, 2021 Brentwood Attorney Larry Crain sent Shannon Ashley a "cease and desist" letter on behalf of Grace Chapel Church in Leipers Fork, Tennessee. Attorney Larry Crain previously filed a \$3 million retaliation lawsuit against child sex abuse whistleblower, Austin Davis, and he also filed a \$1.5 million lawsuit against the mother of a 6th grade alleged gang rape victim at Brentwood Academy. Brentwood Attorney Larry Crain represented, or still represents, protected child-molester John Perry.
- Aug 11, 2021 Attorney Todd McMurtry sent at least one "cease and desist" letter to a supporter of Gracie Solomon on behalf of Grace Chapel Pastor Steve Berger. Todd McMurtry and Lin Wood represented Nicholas Sandmann against CNN and other news organizations.
- 9. <u>Aug 29, 2021</u> Pastor Steve Berger's wife, Sarah Berger, interrupted a Grace Chapel Sunday morning church service which was reported in the Washington Post.
- 10. <u>Aug 30, 2021</u> Pastor Steve Berger announced he was resigning from Grace Chapel Church Leadership.
- 11. <u>Sept 9, 2021</u> Austin Davis sent an email to GCA Baseball Coach Brad Myers about four alleged child sex abuse cases involving Attorney Larry Crain. Attorney Larry Crain was the former attorney for Atlanta lawyer Lin Wood, a national advocate against child sex abuse and trafficking who now lives in Beaufort County, South Carolina.
- 12. <u>Sept 13, 2021</u> An anonymous source released a secret recording of Grant Solomon meeting with GCA educators about the mistreatment of his little sister, Gracie Solomon.
- 13. <u>Sept 24, 2021</u> Austin Davis sent an email to Gov. Bill Lee and GCA parents with a 1minute audio recording of 16-year-old Grant Solomon meeting with GCA educators about his abused little sister, Gracie.
- 14. <u>Sept 26, 2021</u> Carrie Underwood performed at a GCA Benefit Concert during an alleged Mann Act Federal crime cover-up involving 11-year-old victim, Gracie Solomon, and an alleged murder/cover-up involving 18-year-old Grant Solomon.
- 15. <u>Nov 19, 2021</u> GCA Director of Development and Baseball Coach Brad Myers wrote a letter to GCA families announcing that GCA had purchased approximately 59 acres of land from Grace Chapel Church. The letter also stated that GCA had received funds, or a commitment for funds totaling over \$3 million since the Carrie Underwood GCA Benefit Concert. The letter also stated that GCA is seeking to raise an additional \$6.3 million in cash by Feb 1, 2021.
