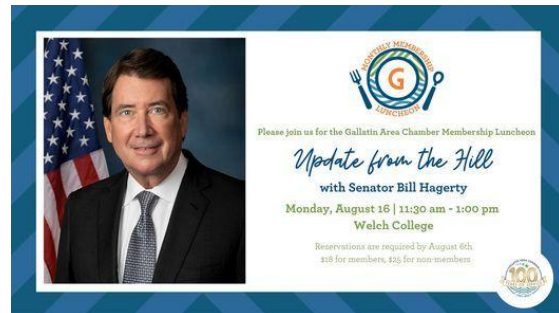

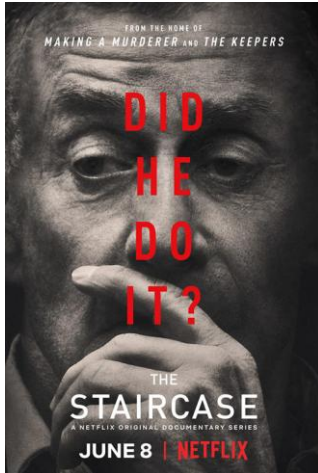

8 of 9 emergency responders are standing on the driver side of truck.

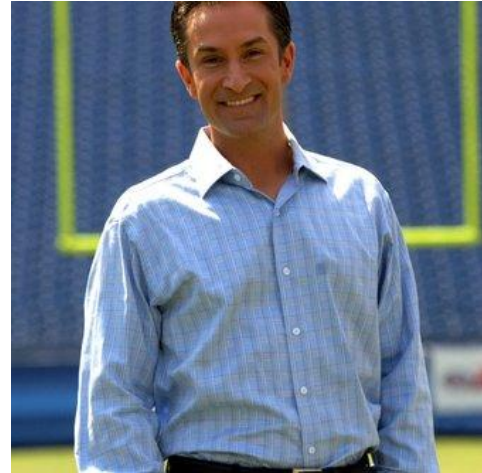

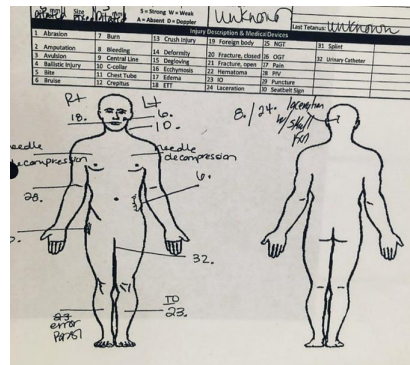

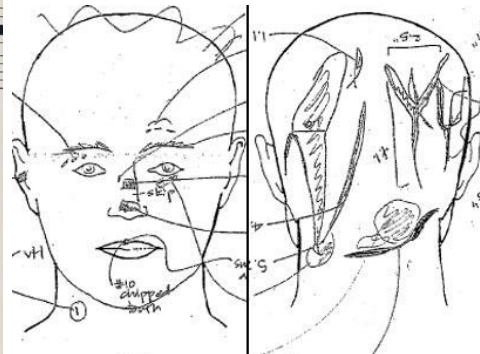

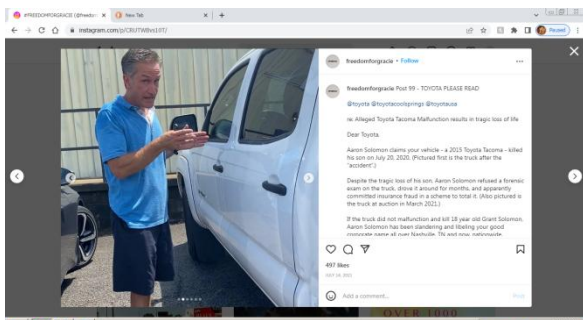

Michael Peterson freely talked about the alleged accidental death of his wife, Kathleen Peterson, during a docuseries entitled, The Staircase. Aaron Solomon freely talked about the alleged “truck accident” approximately eight days after the alleged murder of 18-year-old, Grant Solomon, on or about July 28, 2020. In at least four videos, Aaron Solomon described and/or demonstrated for a grieving mother how her only son was run over on a downhill slope where Grant’s body finally came to rest lying face-up on sharp-edged rocks beneath the passenger side of the truck near a large culvert pipe. Aaron’s friend, Sam Johnson, long-time friend of Grace Chapel Founding Pastor Steve Berger, assisted with the “accident” demonstration. 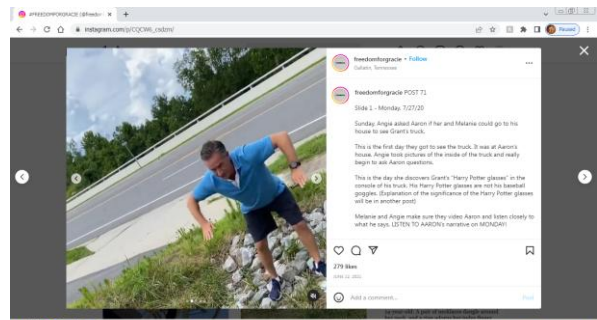

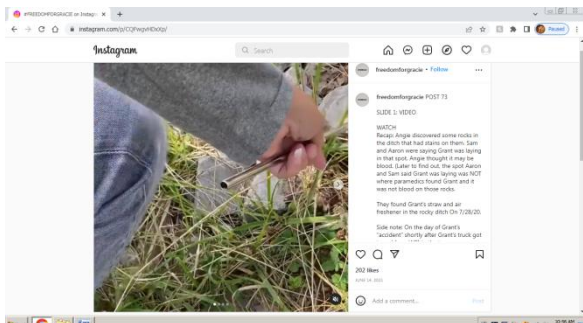

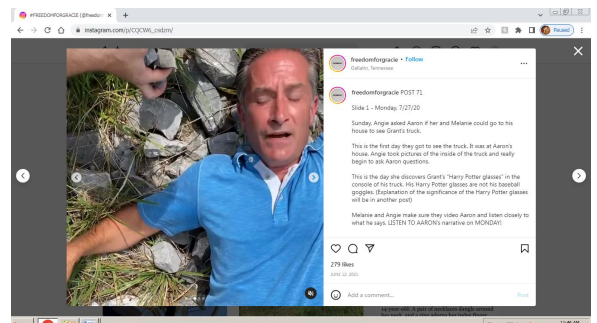

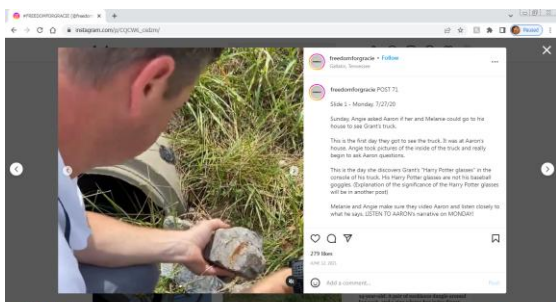
Aaron Solomon – explaining how the truck landed at the bottom of the hill.

On or about, July 28, 2020, Aaron Solomon physically demonstrated for a grieving mother how her only son was lying face-up on the passenger side of the truck. Drew Hall, a WPI employee, provided a statement that Grant Solomon's head was on the driver side of the truck. At least one emergency responder report also recorded that Grant Solomon's body was physically extracted towards the driver side of the truck. Grant's blood was located on the driver side of the truck, along with Grant's glasses. In the photo below, 8 of 9 of the emergency responders were standing on the driver side of the truck.

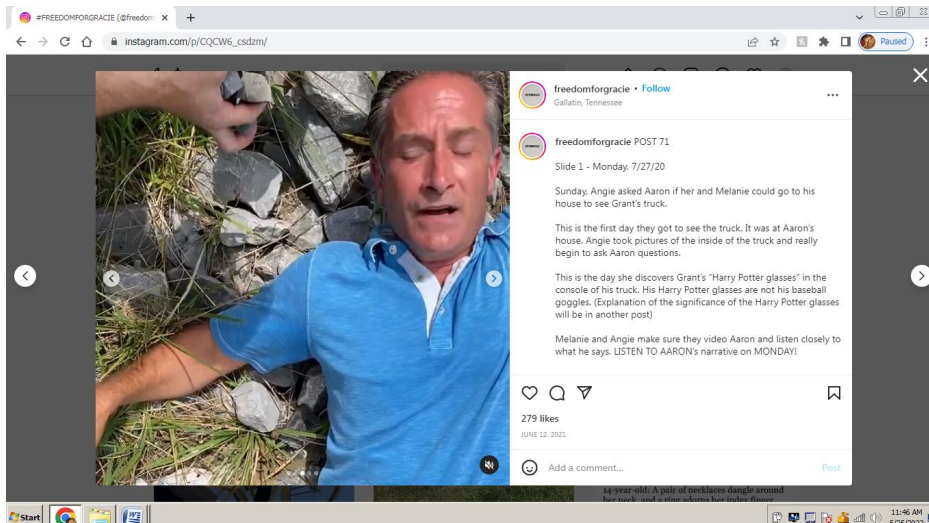
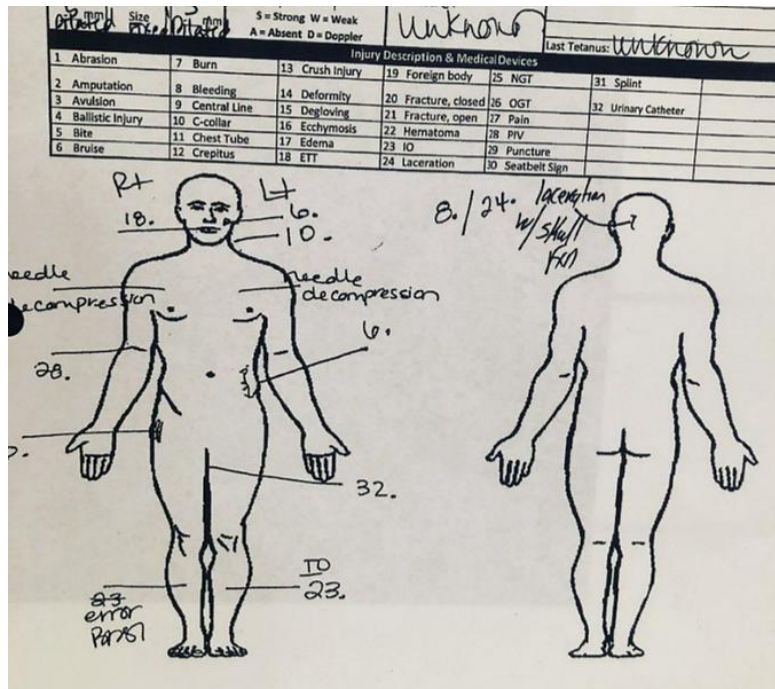

<p>My son Grant & I pulled into WPI separately, parked side by side. I was still in my car, but noticed my son get out to get his baseball gear out of the back of his truck. I looked down to check a work email & the next thing I know I hear see the truck roll backwards into the ditch, I get out of my car to try to find my son & saw that he was trapped underneath the truck & immediately called 911.</p>					

If Aaron Solomon told an elaborate false story to a grieving mother about her son lying face-up on the **passenger** side of the truck, why do Gallatin Police and Gov. Bill Lee still believe anything Aaron Solomon says about what allegedly happened at the top of the hill?

Aaron Solomon claims that Grant Solomon parked his truck next to Aaron's vehicle at the top of the hill. Aaron Solomon claims that Grant Solomon's truck rolled backwards crashing into the rocky ditch on top of Grant's body which was lying face-up on the **passenger** side of the truck. The injury report records only one injury to the back of Grant's skull, with no other injuries to Grant's backside. Is Aaron Solomon's story really even plausible? Kathleen Peterson allegedly fell a shorter distance down some steps suffering numerous injuries, but Grant Solomon was allegedly run over by a large truck in a steep ditch with sharp-edged rocks and only suffered one head injury with no other back wounds, back bruises, or visible injuries to the back of Grant's body.



Question: If Grant Solomon fell backwards, and/or was run over, and/or dragged across large sharp-edged rocks, wouldn't Grant's back have more bruises, bleeding cuts, and/or broken bones than one fracture injury to the back of Grant's skull?

Did the truck roll down hill or did Aaron Solomon deliberately drive the truck into the ditch and over the injured body of Grant Solomon? See left tire track (driver side) at the bottom.

TimeLine

2018: Grant Solomon spoke with Grace Christian Academy (GCA) educators about his sister, Gracie Solomon, an alleged child sex abuse victim within Tennessee, and beyond Tennessee. Gracie Solomon is represented by Attorney Alex Little. Grace Christian Academy and GCA Head of School Robbie Mason are represented by Attorney W. Tyler Weiss.

On or about, May 8, 2018: Per Steve Berger's sworn affidavit filed on behalf of Aaron Solomon, Grace Chapel Pastor Steve Berger met privately with Grant Solomon to discuss spiritual matters and how Grant could grow closer to Christ. See pages 8 and 9 at this link:

Per Gracie Solomon's You Tube video supported by Gracie Solomon's sworn affidavit (see page 2 in link above), Grant Solomon was scared and sought help from Grace Chapel's "Pastor Steve" for his mother, Gracie and himself: <https://www.youtube.com/watch?v=bpNRNuaFhAk>

Ex-Grace Chapel Pastor Steve Berger is represented by Kentucky Attorney Todd McMurtry. Attorney Todd McMurtry also represents Steve Berger's friend, Sam Johnson, who recently filed a Federal lawsuit against anti-Trump comedian Kathy Griffin. Pastor Steve Berger and Sam Johnson are both friends of accused child molester and accused murderer, Aaron Solomon, a former WSMV TV news anchor. Attorney Todd McMurtry is also a former co-counsel with Attorney Lin Wood on the Nicholas Sandmann "defamation" lawsuits filed against CNN, Washington Post, New York Times, and other news organizations.

Grace Chapel Church is represented by Attorney Larry Crain. Attorney Larry Crain represented Attorney Lin Wood. Attorney Larry Crain also represented protected child-molester John Perry, and John Perry's Victim #1. Attorney Larry Crain also filed a \$3 million lawsuit against Rev. Billy Graham's Publisher (HarperCollins Publishing), and a \$3 million lawsuit against child sex abuse whistleblower, Austin Davis.

April 14, 2021: Austin Davis provided information to Grace Chapel Pastor Steve Berger via his executive assistant, Elise Glasser, about Gov. Bill Lee (a Grace Chapel Church member), protected child-molester John Perry, and John Perry's attorney, Larry Crain. Austin Davis also provided the same information to Grace Christian Academy High School Principal, Richard Anderson. Richard Anderson was the former Headmaster of Christ Presbyterian Academy (CPA) during the same time when John Perry was a CPA father along with Gov. Bill Lee. John Perry is a prominent Southern Baptist Convention biographer via B & H Publishing who has co-authored or ghostwritten books with Thom Rainer, Jimmy Draper, Richard Land, former GOP Presidential Candidate Mike Huckabee, former U.S. Alabama Senate Candidate Roy Moore, and Rev. Franklin Graham, son of Rev. Billy Graham who was a 50+ year member of First Baptist Church in Dallas, Tx. John Perry also wrote two books about Prison Fellowship Founder, Chuck Colson, a long-time Southern Baptist and former White House Special Counsel to President Richard Nixon during the Watergate Seven cover-up scandal.

April 26, 2021: Christ Presbyterian Attorney Robert Pautienus sent Austin Davis a threatening "*cease and desist*" letter stating criminal conspiracy allegations against his client were patently false. Mr. Pautienus also attempted to silence Austin Davis from sending any further communications regarding Christ Presbyterian Church, Christ Presbyterian Academy, and any other related entity. Christ Presbyterian Pastor Scott Sauls is a long-time friend of Gov. Bill Haslam who regularly attended Christ Presbyterian Church, along with Sen. Marsha Blackburn who is a member of Christ Presbyterian Church, and a Christ Presbyterian Academy mother. Attorney Robert Pautienus is a deacon at Forest Hills Baptist Church along with deacon Jonathan Howe, the Vice-President of Communications for the Southern Baptist Convention's Executive Committee.

May 12, 2021: Grace Christian Academy student, Gracie Solomon, made a public You Tube statement about her alleged child sex abuse, and the alleged murder of her 18-year-old brother, Grant Solomon. To date (May 30, 2022), no attorney has sent 15-year-old Gracie Solomon a "*cease and desist*" letter, or filed a "*defamation*" lawsuit against her.

May 23, 2021: Austin Davis spoke by phone with Attorney Lin Wood about protected child-molester John Perry, and John Perry's attorney, Larry Crain. After the phone conversation, it is the understanding of Austin Davis that Lin Wood dismissed Attorney Larry Crain from representing him in two cases related to: 1) A Georgia State Bar Complaint against Lin Wood; 2) A lawsuit filed against Lin Wood by Nicole Wade, Jonathan Grunberg, and Taylor Wilson.

June 14, 2021: Attorney W. Tyler Weiss sent Melanie Hicks and Wynn D. Hicks a "*data preservation and demand for retraction*" letter on behalf of Grace Christian Academy (GCA) and GCA Head of School, Robbie Mason. Attorney W. Tyler Weiss stated the May 12, 2021, You Tube video contained false, defamatory statements about Grace Christian Academy (GCA). To date (May 30, 2022), Attorney W. Tyler Weiss has not yet sent 15-year-old Gracie Solomon a "*cease and desist*" letter, or filed a "*defamation*" lawsuit against 15-year-old Gracie Solomon.

June 16, 2021: Attorney Larry Crain sent a "*cease and desist*" letter on behalf of Grace Chapel Church to Medium Writer Shannon Ashley. Larry Crain stated in the "*cease and desist*" letter that Gracie Solomon **published** a You Tube video with false and defamatory statements against Grace Chapel Church. It is presently unknown if Gracie Solomon **published** the You Tube Video, or if Attorney Larry Crain possibly made an untrue statement in his "*cease and desist*" letter sent to Medium Writer Shannon Ashley. To date (May 30, 2022), Attorney Larry Crain has not yet sent 15-year-old Gracie Solomon a "*cease and desist*" letter, or filed a "*defamation*" lawsuit against 15-year-old Gracie Solomon.

Aug 11, 2021: Attorney Todd McMurtry wrote Melanie Hicks a “*cease and desist*” letter stating that Gracie Solomon made false and defamatory statements against Grace Chapel Pastor Steve Berger during the You Tube video. Attorney Todd McMurtry also demanded that Melanie Hicks take down the video and offending social media posts by 5:00 PM on Friday, August 20, with no year specified. To date (May 30, 2022), the You Tube video and social media accounts have not been taken down, and Attorney Todd McMurtry has not sent Gracie Solomon a “*cease and desist*” letter, or filed a “*defamation*” lawsuit against 15-year-old Gracie Solomon.

Aug 13, 2021: President Donald J. Trump endorsed Gov. Bill Lee for reelection as Tennessee Governor during the on-going John Perry child sex abuse cover-up, and the alleged Aaron Solomon child sex abuse and murder cover-up. To date (May 30, 2022), it is unknown if President Trump knows anything about Attorney Larry Crain, GCA High School Principal Richard Anderson, Gov. Bill Lee, the John Perry child sex abuse cover-up, and the Aaron Solomon alleged child sex abuse and alleged murder cover-up. The John Perry child sex abuse cover-up involved Nashville Police, Covenant Presbyterian Church, the Nashville Presbytery, the Presbyterian Church in America, and many others, who participated in the wrongful arrest and the retaliation jailing of child sex abuse whistleblower, Austin Davis. Prior to unlawful retaliation arrest and 18-day jailing, Attorney Autumn Gentry of Dickinson-Wright represented Covenant Presbyterian Church, Federal Judge Chip Campbell of Frost, Brown and Todd represented the Nashville Presbytery, and Michael Brezina of Hodges, Carson and Doughty represented the Presbyterian Church in America.

Aug 27, 2021: Austin Davis filed a recusal motion for all five justices of the Tennessee Supreme Court. The Tennessee Supreme Court had a conflict of interest with Attorney General Herbert Slatery, Gov. Bill Haslam, Gov. Bill Lee, Attorney Gif Thornton, Christ Presbyterian Church, and many others. The Tennessee Supreme Court was provided information about Christ Presbyterian Church, a child sex abuse spider web, the John Perry child sex abuse cover-up, the Aaron Solomon alleged child sex abuse and alleged murder cover-up, and the rigged secret grand jury of Tennessee Titans quarterback Steve McNair.

Sept 24, 2021: Tennessee Supreme Court Justice Cornelia A. Clark passed away.

Oct 13, 2021: The Tennessee Supreme Court denied the recusal motion filed by Austin Davis.

Nov 7, 2021: The Tennessean published a full-page article entitled, “Grace Chapel restructures in wake of founding pastor’s departure.” Child sex abuse whistleblower, Austin Davis, was interviewed as a source for the article, but The Tennessean (owned by the Gannett Corporation) intentionally concealed information from the public about several cases which are now collided: 1) The John Perry child sex abuse cover-up; 2) The Aaron Solomon alleged child sex abuse and alleged murder cover-up; 3) The rigged secret grand jury of Tennessee Titans quarterback Steve McNair. Also, The Tennessean did not provide significant information to the public about retired Christ Presbyterian Pastor Charles McGowan, who possibly still is a senior advisor to Grace Chapel Leadership on behalf of the McGowan Global Institute. Grace Chapel Church Leadership hired the McGowan Global Institute during an alleged child sex abuse and alleged murder cover-up, and GCA high school principal and former CPA Headmaster, Richard Anderson, worked with Christ Presbyterian Pastor Charles McGowan for many years.

Nov 10, 2021: A small group of Gracie and Grant Solomon supporters held a peaceful candlelight prayer vigil in front of the Tennessee State Capitol. Gov. Bill Lee and the Tennessee General Assembly were invited to visit the candlelight prayer vigil but no elected public servant attended the event.

Nov 18, 2021: The Tennessee Supreme Court denied a petition filed by Austin Davis which included information about a child sex abuse spider web, the John Perry child sex abuse cover-up, the Aaron Solomon alleged child sex abuse and alleged murder cover-up, and the rigged secret grand jury of Tennessee Titans quarterback Steve McNair.

Nov 23, 2021: Per AP news, the Governor's Council for Judicial Appointments announced public hearings for Dec 8-9, 2021, to review 11 candidates who applied for an open Tennessee Supreme Court Justice position. The chairman of the judicial appointment committee was Adams and Reese Managing Partner, Attorney Gif Thornton, a long-time friend of Gov. Bill Lee and a Christ Presbyterian Church Ruling Elder.

Nov 26, 2021: Melanie Hicks wrote a 6-page letter pleading with Gov. Bill Lee to re-open the investigation of Grant Solomon's alleged murder in Gallatin, TN. To date (May 30, 2022), Gov. Bill Lee has not yet personally responded to citizen, voter and taxpayer, Melanie Hicks.

Dec 2, 2021: Austin Davis filed a "*motion for relief - effect of error*" motion with the Tennessee Supreme Court which was file stamped as received by the Tennessee Appellate Court Clerk's Office. A 6-page letter written to Gov. Bill Lee by Melanie Hicks was included as Exhibit 1 with the "*error*" motion because of numerous connections between both alleged Mann Act Federal crime cover-up efforts. It is unknown if the Tennessee Supreme Court read the "*error*" motion, or the 6-page letter written by Melanie Hicks, because the original motion and the copy were returned in the mail to Austin Davis without being scanned or included in the Appellate court public case history record available via the Tennessee Supreme Court web site.

Dec 9, 2021: Per U. S. News and World Report, Judicial Appointment Chairman Gif Thornton and the Judicial Appointment Committee provided Gov. Bill Lee with three names for the open justice position on the Tennessee Supreme Court: 1) Tennessee Associate Solicitor General Sarah K. Campbell; 2) Tennessee Court of Appeals Judge Kristi Davis; 3) Tennessee Court of Appeals Judge William Neal McBryer.

Jan 12, 2022: Per The Tennessean, Gov. Bill Lee nominated Tennessee Associate Solicitor General Sarah K. Campbell as the replacement for departed Justice Cornelia Clark. Gov. Bill Lee, Chairman Gif Thornton, Attorney General Herbert Slatery, and Solicitor General Sarah K. Campbell, all have strong friendships and connections with people who attend Christ Presbyterian Church.

Feb 3, 2022: Williamson Home Page reporter, Alexander Willis, asked Gov. Bill Lee if he had received the 6-page letter from Melanie Hicks, and if he would push for a new investigation into the suspicious death of 18-year-old Grant Solomon. Gov. Lee was uncertain if he had received the letter from Melanie Hicks. Gov. Lee also explained that the 6-page letter would have appropriately gone through a review process by Department of Safety (Homeland Security), or Legal Services, if it was received.

Feb. 10, 2022: Per The Tennessean, the Tennessee General Assembly confirmed Sarah K. Campbell as the new Tennessee Supreme Court Justice. Sarah K. Campbell is a member of Christ Presbyterian Church, and is a former clerk for U.S. Supreme Court Justice Samuel Alito.

April 27, 2022: Austin Davis read a Williamson Home Page article about a Federal lawsuit filed by Sam Johnson against anti-Trump comedian Kathy Griffin. Sam Johnson is a friend of Grace Chapel Founding Pastor Steve Berger, and both Sam Johnson and Pastor Steve Berger are represented by Kentucky Attorney Todd McMurtry. Sam Johnson is also represented by Todd McMurtry's co-counsel, Attorney J. Will Huber, and Attorney Lindsay Smith (daughter of Grace Chapel Financial Board Member Reese Smith III). Sam Johnson and Pastor Steve Berger are friends with accused child-molester and accused murderer, Aaron Solomon, a former news anchor and sports reporter for WSMV TV.

May 22, 2022: Austin Davis reviewed a video of Sam Johnson and Aaron Solomon at the Ward Performance Institute (WPI) in Gallatin, Tennessee, which was filmed on or about, July 28, 2020, about eight days after the alleged murder of 18-year-old Grant Solomon. In the video, Aaron Solomon physically stretched out his body over the large, sharp-edged rocks in the alleged murder scene to demonstrate the location of Grant Solomon's head lying face up on passenger side of the Toyota Tacoma Truck. However, Grant Solomon's blood was located on the driver side of the truck near the front tire, and WPI employee, Mr. Drew Hall, provided a statement that Grant Solomon's head was barely visible behind the front driver side tire.

May 22, 2022: The Southern Baptist Convention released a nearly 300-page report on sexual abuse allegations. Per Baptist News Global, Jonathan Howe, the SBC VP of Communications, wrote at least one email which was included in the SBC sex abuse report. If the news report is true, the email would most likely be insulting to those who have survived sexual abuse within Christian churches. Jonathan Howe is a Forest Hills Baptist deacon along with Attorney Robert Pautienus, the attorney who threatened and attempted to silence child sex abuse whistleblower, Austin Davis, on behalf of Christ Presbyterian Church. Jonathan Howe reportedly wrote an email to SBC Executive Committee President Ronnie Floyd which stated: "The 'survivor community' is all up in arms about things they have no clue about" and "online survivor folks, they just want to burn things to the ground... They just have to be ignored. They don't reason. They don't listen." Forest Hills Baptist Church is located a mile from Christ Presbyterian Church on Old Hickory Blvd.

May 31, 2022: Former Trump White House staff member, Garrett Ziegler, posted a Telegram message asking if anyone lived in or around Franklin, Tn. Garrett Ziegler received a lot of responses to his "help" request, but apparently he selected a person for the job who lives across the street from Grace Chapel Church in Leiper's Fork. It is unknown at the moment if the person he selected attends Grace Chapel Church, or if the person knows Pastor Steve Berger, Sam Johnson, or Aaron Solomon. The assistance Garrett Ziegler needed possibly involves an attorney for Hunter Biden who possibly lives, or owns property, in Leiper's Fork, Tennessee. On or about May 17, 2022, the London Daily Mail reported that Garrett Ziegler's organization, Marco Polo, had uploaded 128, 775 emails from Hunter Biden's laptop to a searchable database.

May 31, 2022: As a gentleman courtesy, Austin Davis sent an email invitation to Attorney Todd McMurtry and several other attorneys, to join Austin Davis, Melanie Hicks, and Grant's Army for a peaceful prayer vigil on June 13, 2022. The June 13th event will be a 2nd prayer vigil to make another request for a new investigation into the alleged murder of 18-year-old Grant Solomon. More details about the June 13th prayer vigil will be announced soon.
