Subject: MBA1 - A Mother's Letter To MBA Headmaster Brad Gioia - No Apology Offered To My Children

Mr. Brad Gioia,

Why did you write a letter to the MBA community on October 20th saying you contacted the police on a former MBA parent? If you contacted the police, why is there no police report in the MNPD records division? Why did you say the former parent's concerns “seem entirely unrelated to MBA,” when you should be aware that at least two MBA faculty members are part of a continuing child-molester cover-up campaign?

During the MBA spaghetti supper, four police officers came to our home to arrest Austin to shut him up. Why did you ban Austin from the MBA campus? You know Austin shouldn't be banned. The army of boys Austin has coached since the 80s also know the banning is ridiculous. Everyone who knows Austin knows he loves and cares about kids. Yet for simply writing an email, Austin was thrown in jail for 18 days without an appearance before the night commissioner. No police report. No hearing. 18 days in jail.

I am disappointed you did not apologize to my children yesterday as Austin requested. Instead, he is back in court before Judge Cheryl Blackburn this morning.

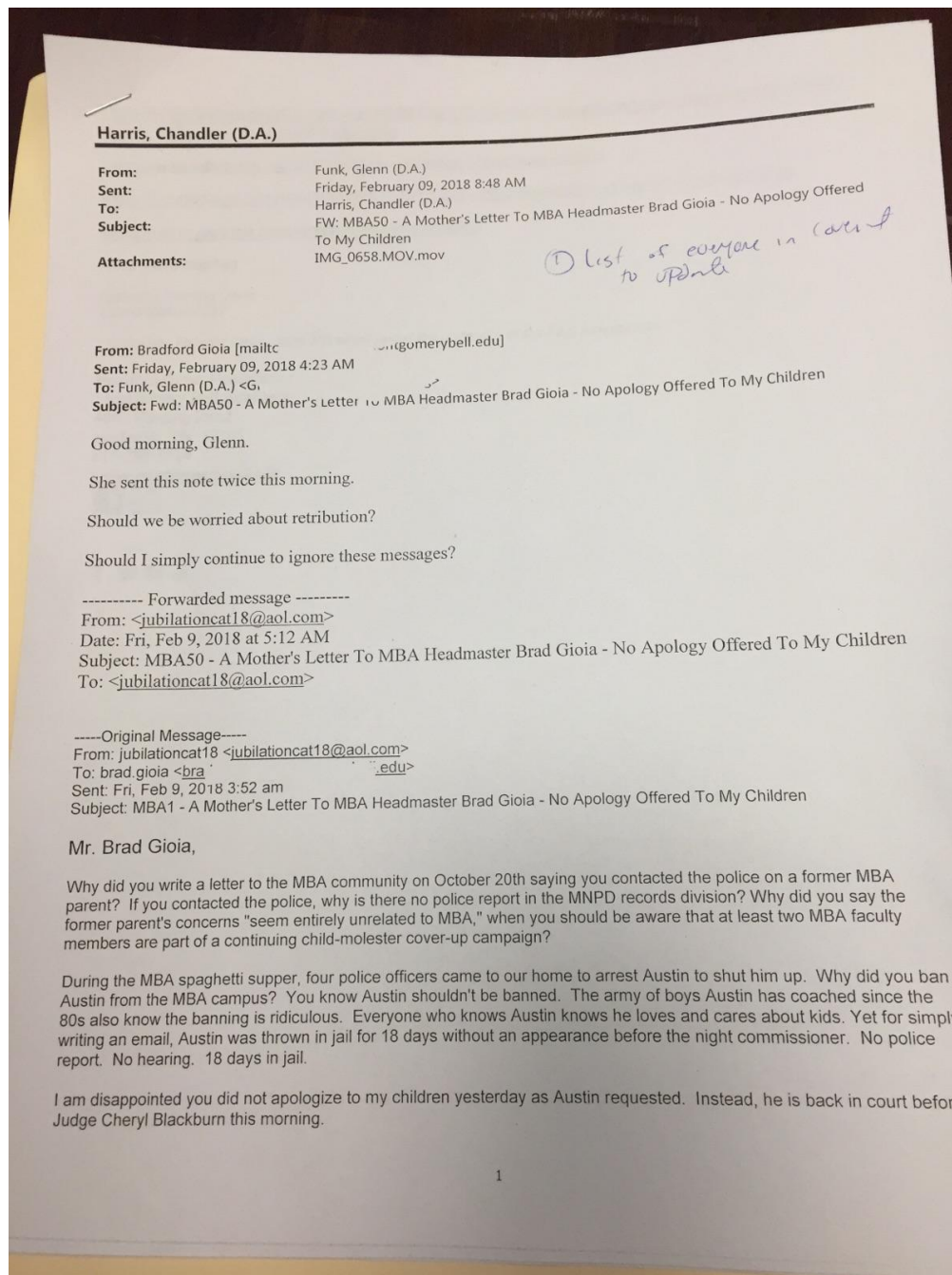

*I, Catherine Fleming Davis, send this email under the protection of the First Amendment.*

*(Note: Some links in the emails above are redacted-disabled to comply with Attorney Larry Crain's limited injunction granted on 9/24/2018. Attorney Larry Crain represents protected child-molester, John Perry.)*

"You are going up against the powers, the big boys, the old guard here in Nashville, big law firms... wow... I mean, you are getting crushed like a bug... and I feel for you... simply because all you say rings true to me." MBA parent email to Austin Davis the night he was arrested and jailed – Oct 20, 2017.

Below is the email MBA Headmaster Brad Gioia sent to Nashville DA Glenn Funk, a MBA father. This email was sent approximately eight months after the Darlington Survivors filed their sex abuse allegations lawsuit against a former teacher and the Darlington School. The handwritten note says: "List of everyone in Covenant to update." Asst DA Chandler Harris has fled Tennessee to relocate in Philadelphia, PA, after protecting the child sex abuse spider web with the malicious prosecution of the innocent child sex abuse whistleblower, Austin Davis.



Below is the email sent by MBA Headmaster Brad Gioia to MBA parents in response to the supposed “security” concerns caused by the harmless email of child sex abuse whistleblower, Austin Davis. Austin Davis attempted to warn MBA and Brentwood Academy families about the John Perry child sex abuse cover-up with connections to Attorney Larry Crain, the alleged gang rape of a 6<sup>th</sup> grade Brentwood Academy student, and the rape of a 3-year-old child at Fellowship Bible Church. However, Austin Davis was unlawfully arrested in his private home and jailed for 18 days to silence him from speaking out about a child sex abuse spider web. Former Darlington Headmaster Brad Gioia took this retaliatory, unlawful action approximately 4 months after the Darlington Survivors filed a sex abuse allegations lawsuit against a former teacher and the Darlington School. Per the London Daily Mail, former Darlington Headmaster Brad Gioia stated he did not know about the teacher and the sex abuse at the Darlington School: “You would think I would know, but I wasn’t told anything.”

Child sex abuse whistleblower, Austin Davis, was skillfully defamed and criminalized in a rigged “church trespass” trial by DA prosecution witnesses, Scott Troxel, and Federal Judge John Bryant. Scott Troxel artfully portrayed Austin Davis as a potential “Sandy Hook” mass shooter concern in order to protect child-molester John Perry, and a child sex abuse spider web, which now includes the Darlington Survivors. DA prosecution witness, Federal Judge John Bryant, also testified that Covenant parents were concerned about the safety of their children after the “Connecticut school shooting.” To date (Nov 27, 2022) it is unknown if former U. S. Attorney Jack Smith, Federal Judge John Bryant, and/or Judge Steve Dozier, had a friendship, or working relationship, as Federal and local public servants. Former Covenant Deacon, Austin Davis, was wrongfully convicted of “church trespass” by a contaminated trial jury on Sept 12, 2017, almost a year after the suicide of a former Darlington student. The Darlington student wrote a suicide note about his sexual abuse prior to committing suicide on Sept 14, 2016.

Asst. DA Chandler Harris: Mr. Troxel, after Mr. Davis was banned from the property, are you aware of any pastor or member of the church leadership that wore bulletproof vest in the pulpit?

Scott Troxel: I believe, Jim Bachmann did, yes, the senior pastor.

Asst. DA Chandler Harris: Okay... was that-- to your knowledge, was that as a result of Mr. Davis?

Scott Troxel: Certainly.

Asst. DA Chandler Harris: Again, after this occurred, was there other security meetings had by the church regarding Mr. Davis?

Scott Troxel: Well, there were subsequent meetings several years later when there was a flurry of now-- kind of new entity of emails.

Asst. DA Chandler Harris: From him?

Scott Troxel: Yes. So members again were concerned about safety. It was shortly after **Sandy Hook** and there were members, especially parents that were concerned about the safety of their children.

Asst. DA Chandler Harris: Okay. And Mr. Davis talked about some of the **myths**. I believe that he believes the church is hiding from him or something. Are you aware that Mr. Davis ever attempted to subpoena any of this information.

Scott Troxel: I'm not aware of it.

*Scott Troxel admitted during cross-examination that Covenant Leadership knew about the John Perry child sex abuse crime in July 2008. John Perry's name was redacted from the trial transcript in submission to Attorney Larry Crain's injunction request which was granted on Sept 24, 2018. Attorney Larry Crain represents protected child-molester, John Perry. The second link below does not redact John Perry's name from the court transcript.*

Four months after the Darlington Survivors filed a sex abuse lawsuit against a former teacher and the Darlington School, Catherine Davis requested to be heard as a witness at the rigged sentencing hearing of her husband, Austin Davis. Judge Steve Dozier and DA Glenn Funk's malicious prosecution team did their very best to wrongfully portray Austin Davis as an obsessed "knight in shining armor" who was fixated on the "myth" of the John Perry child sex abuse cover-up crime. After Asst. DA Jenny Charles attempted to humiliate Catherine Davis on the witness stand, Austin Davis requested the opportunity to ask more questions of his wife who was told by Judge Steve Dozier to cleanse herself and to put all the concerns about child sex abuse behind her. Judge Steve Dozier had several conflicts of interest which were undisclosed to Defendant Austin Davis prior to trial and sentencing, including that his Uncle Don Dozier was a member of Covenant Presbyterian Church. However, Judge Steve Dozier did not recuse from the case until after Austin Davis was falsely arrested three weeks following the sentencing hearing on Oct 20, 2017. The sentencing hearing occurred on Sept 28, 2017, and former Darlington Headmaster, Brad Gioia, falsely reported Austin Davis to Nashville police three weeks later on Oct 20, 2017.



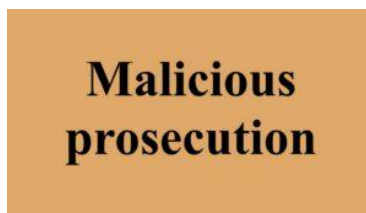

Judge Steve Dozier: Take that as a hint that maybe he did have something to do with where he is today. And just cleanse yourself. I have down here—.

Catherine Davis: Well, I'm a reasonable woman, and I do-- I do--.

Judge Steve Dozier: Well, that -- I would have to look up your definition of reasonable. But just—.

Catherine Davis: Well, I am.

Judge Steve Dozier: Just – I will talk more about this in a moment. But just take those doors right there when you go out those doors with your husband here shortly, Covenant Presbyterian Church is behind you. You don't have to -- you don't have to worry about them. You don't have to deal with them. They are scum from your perspective, that's my word, you didn't use that word. They are horrible people from your perspective, you don't have to deal with them anymore, isn't that going to be a blessing?

Catherine Davis: I understand what you're saying.

Judge Steve Dozier: Good. Did you have --.

Austin Davis: Do I get to finish asking her--.

Judge Steve Dozier: Sure.

Austin Davis: We understand what the judge is telling us and what they are saying. They don't want us to talk about any of this anymore. But are you aware of any other sex predator and child sex abuse cases that are going on that are tied into Covenant from other places in the country.

Catherine Davis: Yes.

Austin Davis: Thank you.

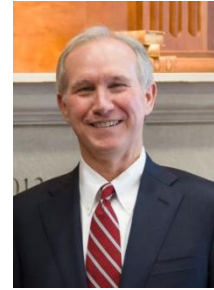

April 6, 2018 - Judge Cheryl Blackburn – See Court Excerpt Below – Austin Davis sworn testimony after former Darlington Headmaster Brad Gioia provided untrue sworn testimony to the court with impunity.

Austin Davis: I was trying to communicate to people about a child sex abuse cover-up and its connection to the rape of a, an alleged rape of a sixth grade student.

Judge Cheryl Blackburn: Okay, Mr. Davis, that is an issue I think that has gotten you in a lot of trouble.

Austin Davis: It shouldn't..... the DA's office should be prosecuting child molesters instead of covering them up... There's a molester living on Belle Meade Boulevard about twelve doors away from--... She's asking me why, because I don't want to be shackled on that issue.

Judge Cheryl Blackburn: Okay. Well. You're going to be shackled on that issue, one way or another, and that would be by me telling you something or I'm going to put you in jail again."

Austin Davis: So the state wants us not, the citizens not talk about child sex abuse if we know where a molester is?... It's called First Amendment freedom of speech. You just have a right to speak.

Judge Cheryl Blackburn: Well, in this particular issue, you don't have a First Amendment freedom of speech.

Austin Davis: Okay. That's good to clarify.

On June 11, 2015, the London Daily Mail wrongly reported that the “*statute of limitations*” for John Perry’s child sex abuse crimes had expired.
