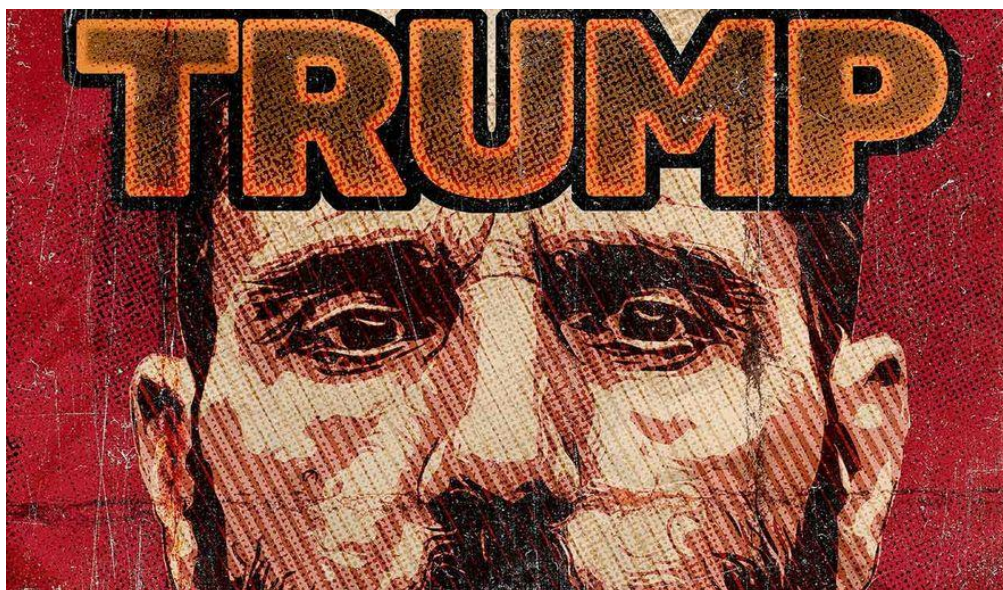

Judge Steve Dozier: All right. Do you care to be heard, Mr. Davis.

Austin Davis: It should have only taken **one email**. It should have only taken **one visit** to the DA’s office and the police office. There is a child-molestation cover-up did go down and Worrick Robinson, who is sitting in the room, is involved in it. And so you can say whatever you want to say, that’s what happened and just because everybody has covered up including you all.

Asst. DA Chandler Harris: Judge, I’m going to object to this. This is--.

Judge Steve Dozier: Okay. Just address yourself to the Court, I mean, don’t get to bantering with the other side. But go ahead.

Austin Davis: Well, I mean, I’m being accused of being a creep pee stalker is what was told to the jury. I have a lot of issues with the trial. I have a lot of issues with the fact that Judge Casey Moreland, close friend of Worrick, is the one that bound me over for indictment. So I have a lot of issues. The Court can do whatever it wants to do and I’m sure it will. I respect the Court. So I’m just saying, I’m not going to stand her defenseless while Mr. Harris runs me down. I think there is a lot of lying going on. I think there is a public judge that came in here and really lied big time and he lied to the Court. He told the jury things that were not true. That’s-- this may not be the place and the time to adjudicate that, but there are some really serious issues about witnesses that came in here and witnesses that the DA didn’t even provide me prior to them coming in. And Federal Judge John Bryant being one of them...

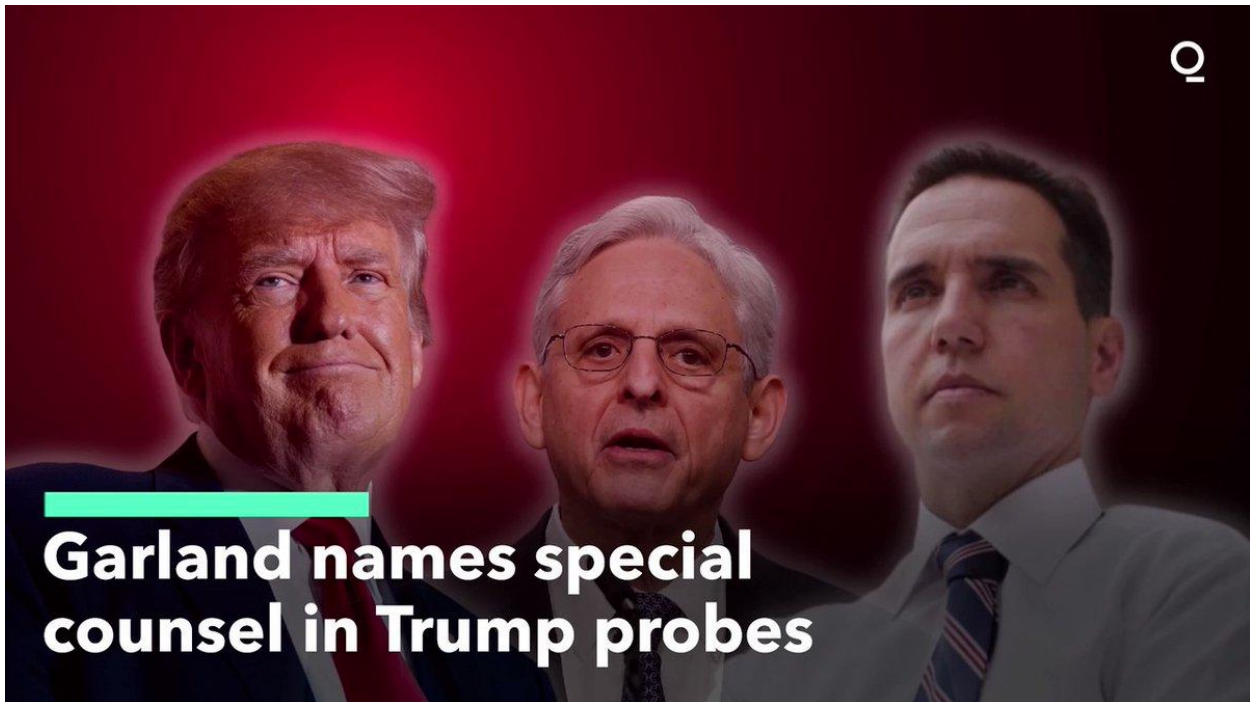

MBA Headmaster Brad Gioia is the former Darlington School Headmaster who served almost 18 years as a teacher, director of admission, principal, and headmaster from Aug 1976 – June 1994. Three months after at least 10 Darlington Survivors filed a sex abuse allegations lawsuit in June 2017, MBA Headmaster Brad Gioia made a false report to Nashville Police which resulted in child sex abuse whistleblower, Austin Davis, being arrested, jailed and silenced on Oct 20, 2017. Also in June 2017, Austin Davis requested for Middle Tennessee U.S. Attorney, Jack Smith, to provide child sex abuse spider web cover-up information to President Trump and Attorney General Jeff Sessions. MBA father and WSMV TV attorney, Robb Harvey, was also copied on the Jack Smith email (*See email on page 3*). To date (Nov 27, 2022), it is unknown if President Trump or Attorney General Jeff Sessions, possessed knowledge, ordered, or encouraged Middle Tennessee U. S. Attorney, Jack Smith, to protect the child sex abuse spider web, which now includes at least 10 student sex abuse allegations against the Darlington School, previously led by current MBA Headmaster, Brad Gioia. Oct 20, 2017 - Nashville Police falsely arrested, jailed and silenced child sex abuse whistleblower and MBA-Harpeth Hall father, Austin Davis.

In June 2017, at least 10 former Darlington students filed a sex abuse lawsuit against a former teacher and the Darlington School. Four months later, on Oct 20, 2017, former Darlington Headmaster and current MBA Headmaster, Brad Gioia, made a malicious false report to Nashville Police which resulted in MBA-Harpeth Hall father and child sex abuse whistleblower, Austin Davis, being arrested, jailed, silenced and banned from the MBA school property. The Darlington Survivors sex abuse lawsuit was filed in June 2017. Ex-Darlington Headmaster Brad Gioia provided untrue sworn testimony in April 2018, stating two *"apology"* email requests sent by Austin and Catherine Davis were perceived to be *"veiled threats."* Child-sex abuse whistleblower, Austin Davis, stated under sworn oath that ex-Darlington Headmaster Brad Gioia was hiding something during Brad Gioia's untrue, retaliatory sworn testimony. Asst. DA Chandler Harris, who has now fled Tennessee to relocate to Philadelphia, PA, cross-examined Austin Davis about his alleged *"threat"* email sent to ex-Darlington Headmaster Brad Gioia. Judge Cheryl Blackburn further punished Austin Davis, on behalf of ex-Darlington Headmaster Brad Gioia, after the sworn testimony was provided below.

Asst. DA Harris: Do you agree that your emails cause people to feel concern about you?

Austin Davis: No. I don't agree with that.

Asst. DA Harris: So, even in light of the testimony of Mr. Gioia, you disagree with his assertion that he felt threatened by you?

Austin Davis: I think that they can create any kind of threat they want if they've got something they're hiding, and I think that's what they're doing.

Asst. DA Harris: So you think that Mr. Gioia is now hiding something?

Austin Davis: Yeah, I do.

Asst. DA Harris: Along with everyone else at MBA?

Austin Davis: Not everyone at MBA. Just some like Mr. Gioia. Yeah. Him personally.

Judge Cheryl Blackburn: Did you go--.

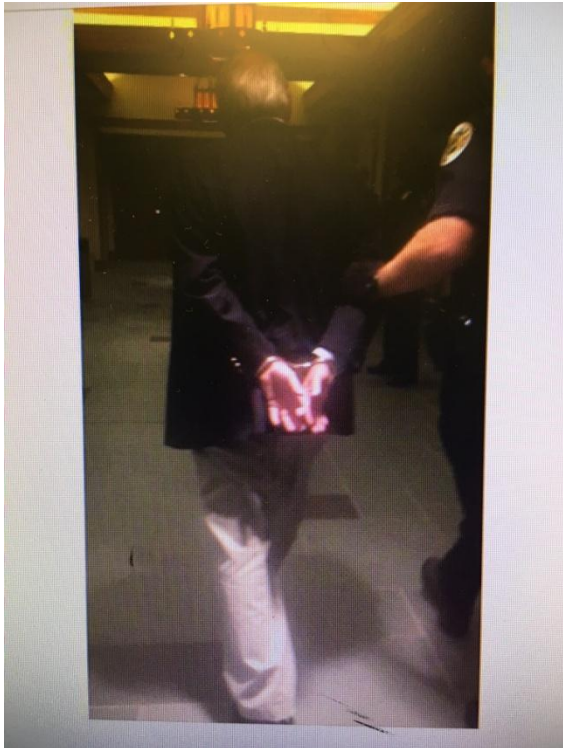
