News of the World hacked Milly Dowler’s phone during police hunt

Exclusive Paper deleted missing schoolgirl’s voicemails, giving family false hope

The News of the World illegally tapped the missing schoolgirl Milly Dowler and her family in March 2009, interfering with police inquiries into her disappearance. An investigation by the Guardian has established:

• Scotland Yard is investigating the episode, which is likely to lead new pressure on the then editor of the paper, Rupert Brooks, over reports that the paper’s chief executives in the UK and the then deputy editor, Andy Coulson, who resigned in January as the prime secretary to the prime minister.

• The Dowler family lawyer, Mark Lewis, issued a substantial payment to the News of the World to settle an “access” and “negligence” claim. The Dowler family are now pursuing a damages claim against the News of the World.

• Milly Dowler disappeared at the age of 13 on her way to school in Northampton, Northants, on 12 March 2009.

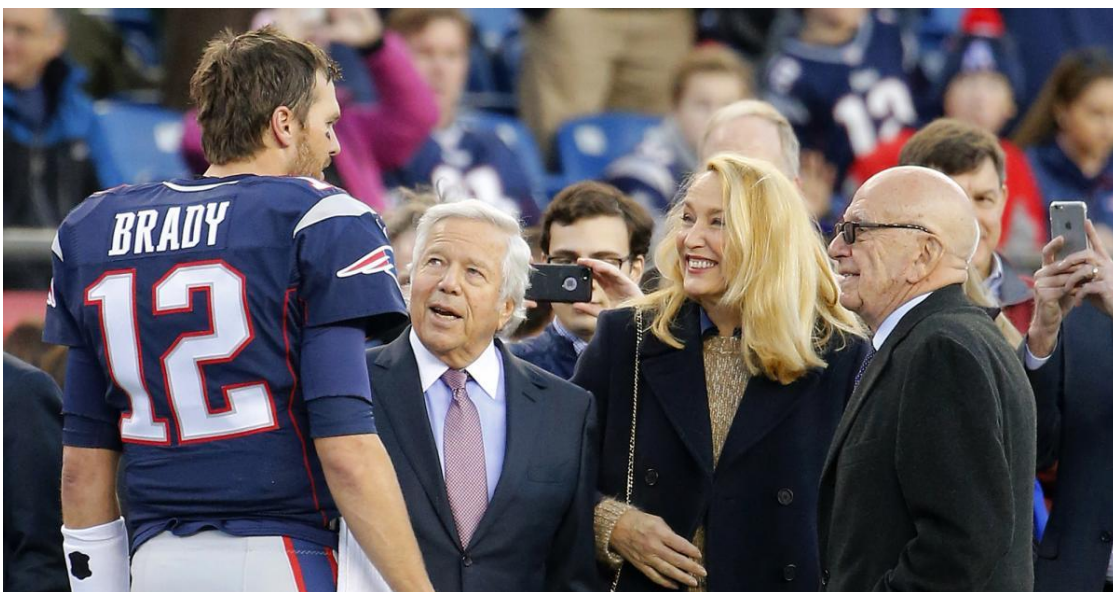



