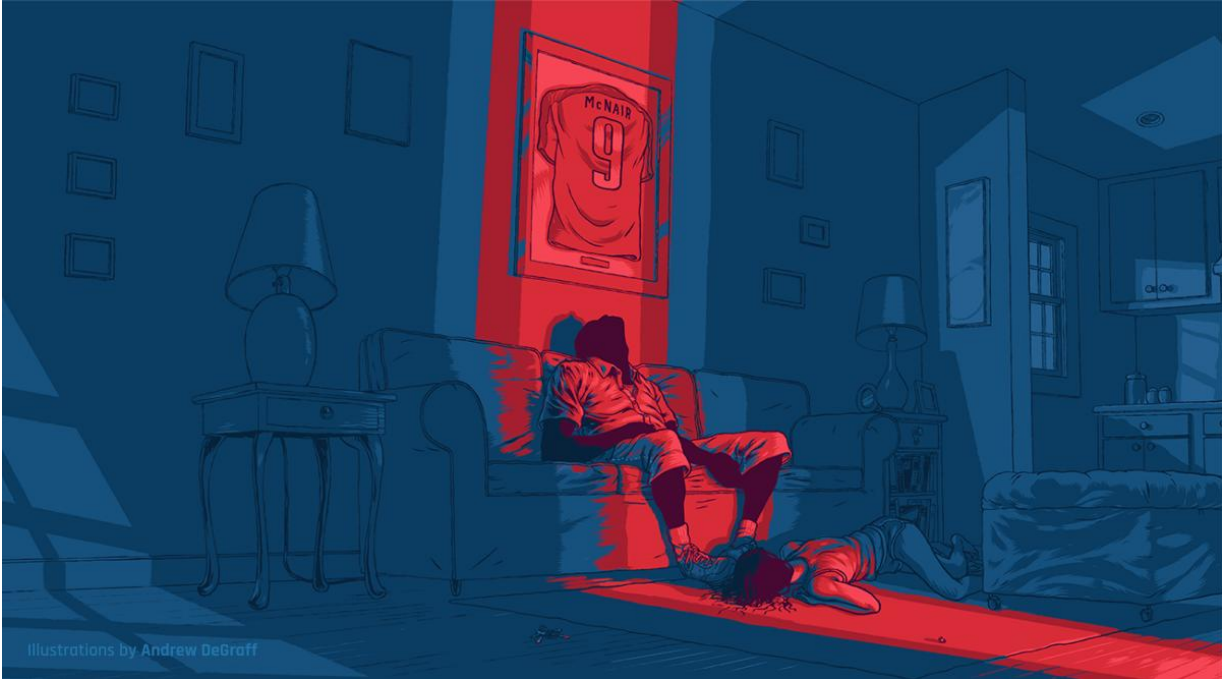

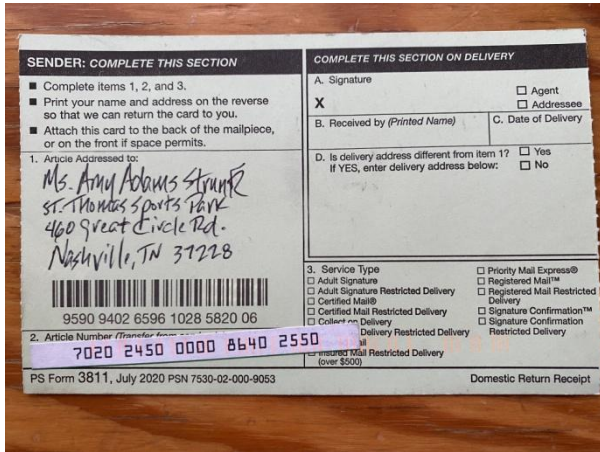

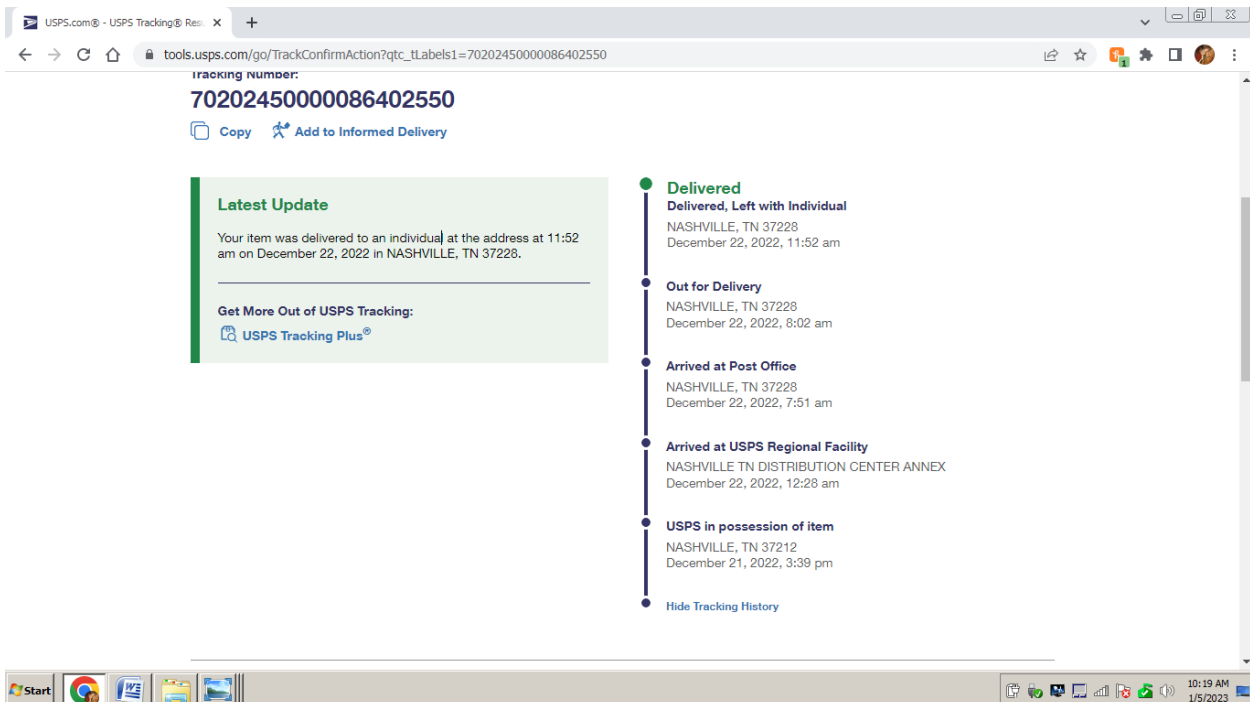

Emails have been sent to the Tennessee Titans organization about Steve McNair's rigged grand jury since April 27, 2019. In addition, Austin Davis sent Tennessee Titans owner, Ms. Amy Adams Strunk, a certified letter on Dec 21, 2022. In reviewing the return card, it seems peculiar that the certified letter was delivered to the Tennessee Titans Headquarters without anyone signing the return delivery card. To review the unsigned return delivery card, look at the photograph below on the left side.

Austin Davis also sent a certified letter to Fox Corporation Chairman Rupert Murdoch, and the return card was signed when delivery was accepted (*See link at the bottom of this page.*) Mr. Rupert Murdoch and his global media empire are connected to several cover-up cases: 1) The John Perry substantiated child sex abuse cover-up case via Thomas Nelson-HarperCollins-News Corp; 2) The Gracie Solomon substantiated child sex abuse cover-up case via Pastor Steve Berger and Fox News (Dan Bongino - Laura Ingraham); 3) The Grant Solomon murder cover-up case via Pastor Steve Berger and Fox News (Dan Bongino - Laura Ingraham); 4) The Steve McNair rigged grand jury cover-up case via Fox News and Fox-NFL Sports. To date (Jan 9, 2023), Fox News and Fox-NFL Sports have not yet reported on any of the connected criminal cover-up cases cited above.

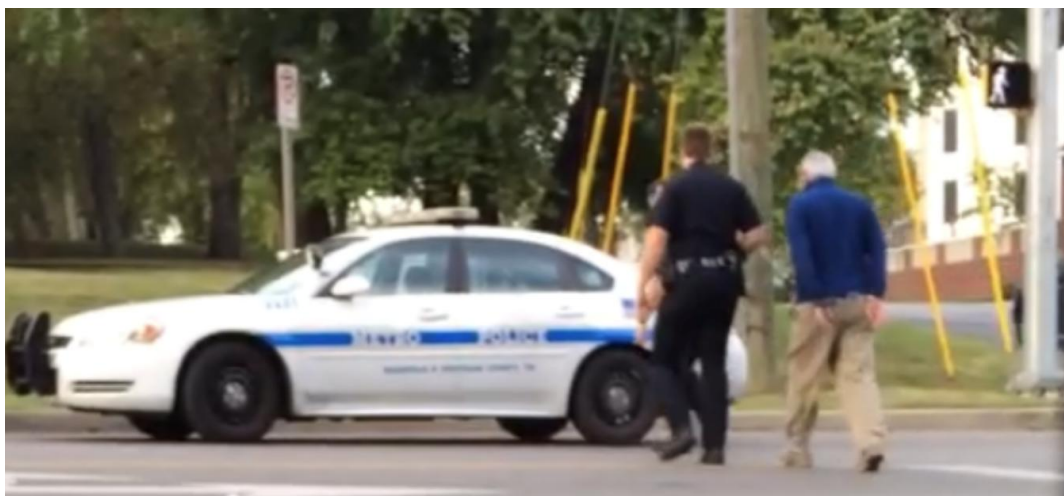

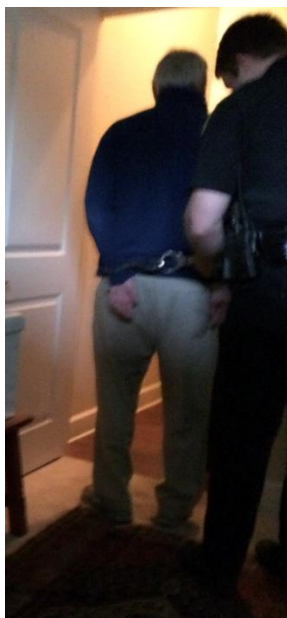


Oct 20, 2017- Austin Davis was falsely arrested and jailed prior to MBA vs. Brentwood Academy football game.

A Call to Coaches emcee, Paul Kuharksy, has also not reported that MBA Headmaster Brad Gioia falsely reported Austin Davis to Nashville Police as a potential security threat after Austin Davis provided MBA and Brentwood Academy families with information on Attorney Larry Crain, the John Perry child sex abuse cover-up, the alleged gang rapes of a 6th grade Brentwood Academy student, and the rape of a 3-year old child at Fellowship Bible Church (Brentwood, TN). In Nov 2022, it was discovered that the 18-day retaliation jailing also occurred 3 months **after** the Atlanta Journal Constitution reported on former Darlington School students who filed a sex abuse lawsuit vs. a former Darlington School teacher, and the Darlington School in June 2017. In April 2018, former Darlington School Headmaster, Brad Gioia, disclosed none of the Darlington School sex abuse lawsuit details during his false sworn testimony against Austin Davis when Brad Gioia was protecting the John Perry child sex abuse cover-up, and a child sex abuse spider web, which now includes his former employer, the Darlington School in Rome, GA. Governor,

Here is a draft response to inquiries regarding the Grant Solomon matter. It's very sad and he appears to have been an exceptional young man, but there appears to be significant misinformation about the circumstances of his death. I'll be glad to discuss further and refine this response as needed:

My office reached out to the statewide district attorney general's conference to ask about this matter. In response, the executive director of the conference visited the scene and reviewed the evidence. He did not see any basis for reopening the homicide investigation or filing charges. He said some of the information circulating about this matter is not consistent with what the investigation found. But the information you provided also includes an allegation of possible insurance fraud, which may be a basis for a separate federal investigation. The independent investigator who reviewed this case could consider forwarding evidence of insurance fraud to the Postal Inspectors, the FBI, or the Secret Service.

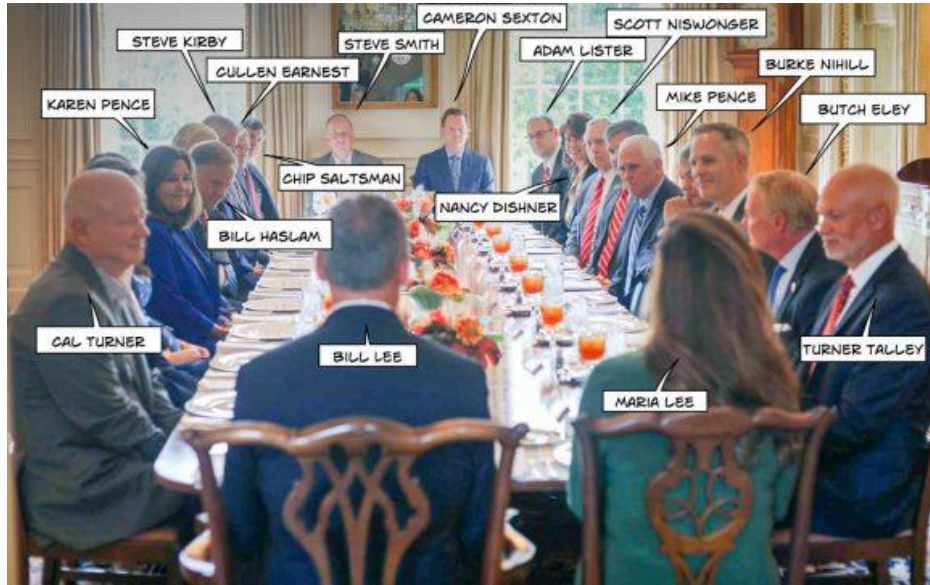

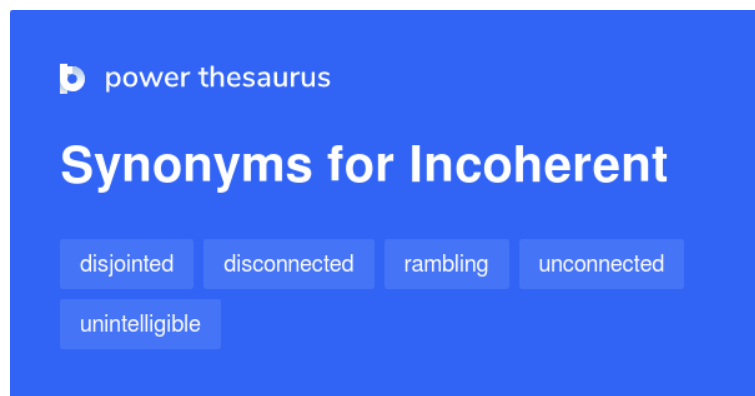

Police sex claims renewed in cocaine firing

A female police officer fired yesterday for cocaine use has told department investigators that three high-ranking officers made sexual advances toward her while she was a recruit at the Metro Police Training Academy.

The officers, who are the target of a four-month internal affairs investigation, have been identified by ex-South Patrol Officer Lisa M. Stojanowski as:

Capt. Richard Briggance, a 19-year-veteran who supervises academics and physical training at the academy. He has been at the academy since 1978 and is a member of the department's SWAT unit.

Lt. Phillip D. Sutton, a 17-year veteran who supervises firearms training. He joined the academy in 1971 and is also a member of the SWAT unit.

Sgt. Richard A. Hillenbrand, a 14-year veteran who oversees defensive tactics training. He joined the academy in 1983 and is a SWAT unit member.

None of the three men could be reached for comment last night.

The internal affairs probe began several months ago after Stojanowski, 23, was questioned about her use of drugs following graduation from the academy in 1986.

A written statement she gave investigators at that time is expected to lead to department charges against the three instructors within several days.

Stojanowski, one of three officers fired for drug use yesterday, renewed charges that she had sex with the three instructors during a brief hearing yesterday morning before a police disciplinary board which later found her guilty of using cocaine on at least two off-duty occasions.

Others fired yesterday for drug use were Officers Larry Hayes and Robert Thornton. Detective Willis Bruce Amos was suspended for 30 days without pay for observing drug use but not reporting it to authorities.

The allegations against all three men involve charges of marijuana use during hunting trips between 1979-84.

Ex-Metro cop wants McNair case reopened

He cites errors, conflicting alibis

A former Metro police officer will ask a grand jury Friday to reopen an investigation into the death of former Tennessee Titans quarterback Steve McNair.

Vincent Hill said Tuesday night that police made multiple errors in investigating McNair's death and that alibis were contradictory for several people involved in the case.

But the Metro police department "stands by its investigation and the conclusions drawn, which were that McNair was a homicide victim at the hands of Sahel Kazemi, who then died of a self-inflicted gunshot wound" on July 4, 2009, spokesman Don Aaron said Tuesday evening.

Aaron said Hill "resigned from the police department in 2006 with disciplinary action pending. He was never a detective with the Metro police department."

Hill said he resigned to spend more time with his daughter, who was then 10 years old.

Hill said he filed a 32-page complaint June 1 and that the grand jury has agreed to examine it.

"At this point they've at least reviewed what I sent them and want to review the case," Hill said.

A grand jury hearing a civilian complaint is "not unheard of, and indeed I think the grand jury is being responsible for at least reviewing what this gentleman has to say," Nashville attorney David Raybin said Tuesday.

Hill said he is now a fraud investigator for a credit card company and he hopes to earn his private investigator license in August. He self-published a book *Playbook to a Murder*, giving his theories on McNair's death.

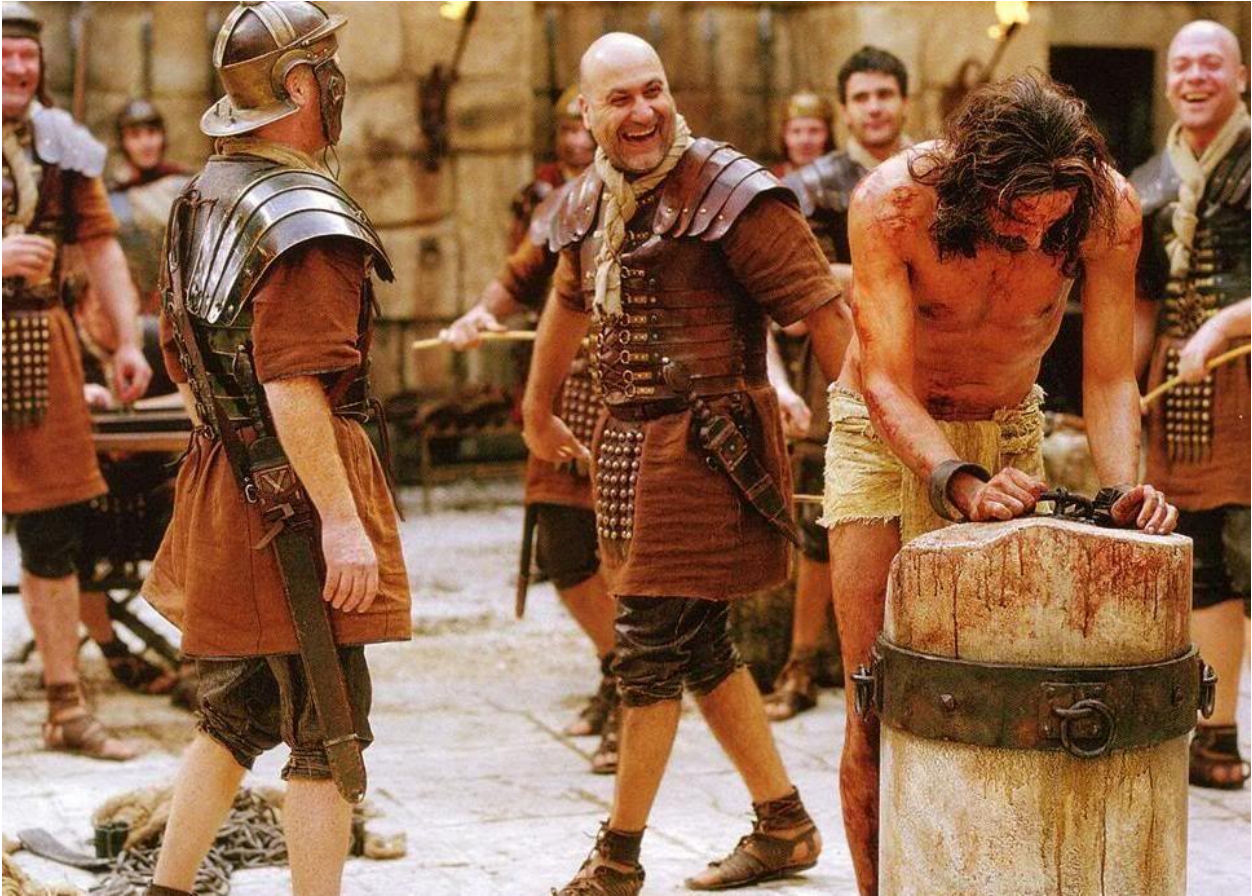
"It's never been about selling the books, because I spoke out on this a few days after the murder," Hill said.
