

## Grand Jury Decides Against Reopening McNair Case – June 18, 2010 - FoxSports



During his untrue sworn testimony, Brad Gioia did not disclose to the court that at least 10 former students at the Darlington School had filed a \$345 million sex abuse lawsuit against a former Darlington School teacher, and the Darlington School, or that he was the former headmaster at the Darlington School. Tragically, one of the former students wrote about his sexual abuse in his final suicide note.
