During the same period of time when MBA was announcing a \$103 million financial gift prior to the construction of the H. 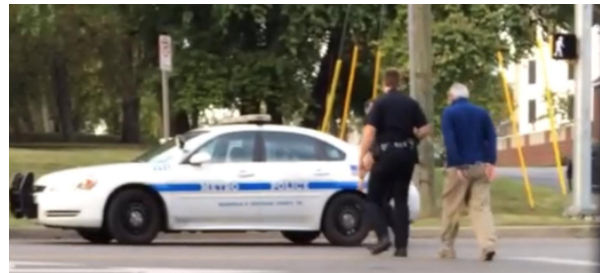

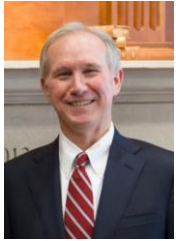

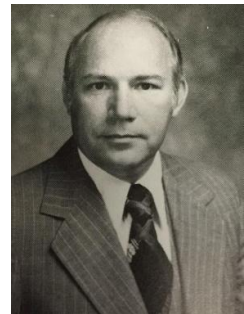
Prior to his MBA legacy being honored by Sen. Bill Hagerty and Sen. Marsha Blackburn, MBA Headmaster Brad Gioia was the former headmaster of the Darlington School in Rome, GA. Based upon a Darlington School reunion Facebook post, it appears that Brad Gioia was the Darlington School Headmaster from 1985 – 1994, or possibly earlier than 1985: Brad Gioia was employed by the Darlington School from 1976 – 1994 when numerous sex abuse survivors allege they were abused by Darlington School English teacher, Roger Stifflemire. Darlington School Headmaster, Brad Gioia, knew about the Roger Stifflemire child sex abuse allegations prior to the Darlington Survivors \$345 million child sex abuse lawsuit filed in June 2017. However, Brad Gioia chose to protect Roger Stifflemire and another protected child-molester, John Perry, on Oct 20, 2017, four months after the Darlington Survivors lawsuit was filed. Per the Northwest Georgia News, on April 22, 2022, the Darlington School dedicated a plaque to a group of student victims who were sexually abused from 1974-1994. Per a WSBTV news report on Nov 16, 2021, the Darlington School settled with the sex abuse victims and released a public statement (see below). Per the Atlanta Journal Constitution, the Darlington School “stopped short of acknowledging that school officials brushed off complaints about Stifflemire,” which effectively protected former Darlington School Headmaster, Brad Gioia, from additional scrutiny or accountability. To date (March 12, 2023), based upon Brad Gioia’s deceptive sworn testimony and subsequent silence since a Nashville court hearing on April 6, 2018, Brad Gioia remains resolute against Austin Davis that he is not “hiding” anything, and knew nothing about the sex abuse of Darlington School students during his time as Darlington School Headmaster, or his 18-years of employment by the Darlington School.



“This has been a horrible situation for these survivors and for the school. Mr. Stifflemire’s intimidation, manipulation and exploitation have left scars that may never fully heal. The abuse suffered was abhorrent, and we are truly sorry for the pain these men feel because of their time under our care. The Board of Trustees wishes to express its gratitude for the strength of these men to come forward with their horrific experiences while under the supervision of Darlington. Although this will be a stain forever on the history of our beloved school, we are relieved that the truth has been exposed and addressed. We wish to express our sincere apologies for the experiences these men and their families have endured and their lifelong pain. We are also sorry that the school did not do a better job of protecting them or of recognizing what was happening at the time. To date (March 12, 2023), the wife and children of Austin Davis are abused victims of the John Perry – Mann Act Federal crime cover-up, which has no statute of limitations. On Oct 20, 2017, the wife and children of Austin Davis became victims of the Roger Stifflemire cover-up as Brad Gioia falsely reported Austin Davis to Nashville Police to protect the Roger Stifflemire cover-up, and the on-going John Perry cover-up. Four months later, on April 6, 2018, Brad Gioia escalated his RICO child sex abuse cover-up commitment by falsely testifying against Catherine and Austin Davis to obtain a “no contact” ban against child sex abuse whistleblower, Austin Davis. Prior to this retaliation ruling, the wife and children of Austin Davis were unconstitutionally banned from contact with the MBA community on Feb 9, 2018, without notice, legal representation or an appearance before Judge Cheryl Blackburn.

Former Darlington School Headmaster, Brad Gioia, protected former Darlington faculty member, Roger Stifflemire, during a RICO child sex abuse cover-up which lasted four decades. Brad Gioia also protected himself and three MBA faculty members who have all willingly participated in the on-going John Perry child sex abuse cover-up, and also possibly knew about the Roger Stifflemire child sex abuse cover-up: 1) Robert Sawyer; 2) Roderick Russ; 3) Mike Martin. Based upon both RICO child sex abuse cover-up cases, it is now more clear that threats and intimidation are a bad fruit of Brad Gioia's headmaster leadership style. Per the Darlington Survivors lawsuit, threats and intimidation were used to silence young kids who were sexually abused by former Darlington English teacher, Roger Stifflemire. As Austin Davis worked for the Thomas Nelson Publishing company after his junior year at Ole Miss (summer-1976), Brad Gioia began his professional career as an English teacher at the Darlington School in 1976. Roger Stifflemire began his tenure as an English teacher at the Darlington School in approximately 1974. Based upon a Darlington School reunion Facebook post, it appears that Brad Gioia was the Darlington School Headmaster from 1985 – 1994, or possibly earlier than 1985. Brad Gioia knew about the Roger Stifflemire child sex abuse allegations prior to the Darlington Survivors sex abuse lawsuit filed in June 2017. Per an amended Darlington Survivors child sex abuse lawsuit, at least 17 students claimed they were sexually abused by Darlington School faculty member, Roger Stifflemire, between 1970 – 1990, including both oral and anal sodomy, and other sexual actions. Darlington School survivors stated the sexual abuse was reported to the school, headmaster, faculty, and others in authority. Excerpts from the amended complaint are below:

“Redacted was sexually abused by Stifflemire from 1979 – 1981 while he was a boarding student in Wilcox Hall. During this time, Stifflemire ‘groomed’ redacted and told him about the beauty of the male body, bought him liquor, and showed him pornography. Mr. Stifflemire also asked redacted to report back to him on the penis size of his other dorm mates and encouraged him to initiate sexual encounters with his roommates and report back to him... During his twenty-year tenure at Darlington, Stifflemire sexually abused Darlington students, and others, both within his dormitory, at other locations on campus, in his car, and off campus on private and public land... Stifflemire’s abuse ranged not only from sexual abuse such as sodomy, forced masturbation, and assault and battery, but also to psychological abuse such as invading students’ dorm rooms while they were sleeping and watching them and continuously harassing and propositioning them to enter into a sexual relationship with him... His negligence in supervising the young boys entrusted to him led to direct contact between Darlington students and other sexual predators like Defendant Fred Marquette... Stifflemire not only abused Darlington students for more than twenty years, but through negligence and intent by joint venture and agency, encouraged and permitted other adults to also sexually abuse various Plaintiffs. Specifically, Stifflemire using the power and authority vested in him by Darlington, negligently placed his victims in situations whereby they would be sexually abused by other adult men, and allowed said men to come to the school and take students off school property to be abused at other locations including lake houses, public parks, and nearby restaurants. Perhaps the most egregious of these examples is Stifflemire’s repeated trips with Darlington students to Marquette’s lake cabin in Lake Jordan, AL, for overnight trips where they were sodomized and abused by both Stifflemire and Marquette... Marquette pled guilty to sodomizing teens during the 1980’s.”

Per the Atlanta Journal Constitution which published an article by Alan Judd on June 29, 2017, the Darlington School took no action after students reported allegations that Darlington School faculty member, Roger Stifflemire, sexually abused the students: *“One summer day in 1988, as he prepared to return to boarding school, **Redacted** broke down crying. He refused to go back. Then he begged his mother not to tell anyone why. **Redacted’s** mother called the Darlington School in Rome, Georgia, anyway, and repeated what her son had told her. A teacher named Roger Stifflemire had sexually abused him for the previous two years. This was at least the third time Darlington had been told that Stifflemire preyed on students. But school officials handled the report from **Redacted’s** mother the way they did the others. They did nothing.”* In 1988 when a Darlington Survivor sex abuse victim refused to go back to school, Brad Gioia was the Darlington School Headmaster.

“Upon information and belief, students and former students reported Stifflemire’s abuse from 1974-1994, but Darlington did nothing about it for more than forty years... Darlington ignored the truth of Stifflemire’s behavior and allowed him to continue on as a Dorm Parent, showered him with awards, including most influential teacher in 2002 and the Hanks Faculty Recognition Plaque in 2007. Stifflemire left Darlington in or about 1994 to take a position as Principal of Prattville High School in Alabama. Upon information and belief, Darlington never informed Prattville of any of the allegations of sexual abuse against Stifflemire... Stifflemire also facilitated other men to meet up with Darlington Students where they were sexually molested... At other times, Stifflemire used his position of influence on the Discipline Committee to threaten students with expulsion if they did not do his bidding... The response of the Darlington School, at the least, was to do nothing and let the situation continue, or threaten the student that they could get in a lot of trouble from making the accusations or physically assaulting the victim Plaintiff.”

Note: Brad Gioia was the Darlington School Headmaster from 1985 – 1994, or possibly earlier. Fred Marquette was released from prison in 2009. To date (March 12, 2023), based upon Brad Gioia’s deceptive sworn testimony and subsequent silence since a Nashville court hearing on April 6, 2018, Brad Gioia remains resolute against Austin Davis that he is not *“hiding”* anything, and knew nothing about the sex abuse of Darlington School students during his time as Darlington School Headmaster, or his 18-years of employment by the Darlington School.

In 2002 (per the amended complaint), the Darlington School honored the accused child-molester as an influential teacher approximately eight years after he departed the school in 1994. In 2002-2003, Roger Stifflemire's accused accomplice, Frederick Marquette, was arrested and pled guilty to committing sodomy on three kids in the 1980's. In 2007, a Hanks Faculty Recognition Plaque was presented in honor of Roger Stifflemire. Per the amended complaint, the Darlington School was repeatedly made aware of the student sex abuse allegations against Roger Stifflemire, however the Darlington School chose to honor the accused and protected child molester, Roger Stifflemire, and his alleged adult accomplices, during a RICO child sex abuse cover-up case which lasted four decades. To date (March 12, 2023), based upon Brad Gioia's deceptive sworn testimony and subsequent silence since a Nashville court hearing on April 6, 2018, Brad Gioia remains resolute against Austin Davis that he is not "hiding" anything, and knew nothing about the sex abuse of Darlington School students during his time as Darlington School Headmaster, or his 18-years of employment by the Darlington School.

"Marquette pled guilty to sodomizing teens during the 1980's... Darlington, through its administration, faculty, Heads of House, and Board of Trustees, encouraged and facilitated the sexual abuse of Plaintiffs... Defendants negligently misrepresented and fraudulently concealed the true nature of the horrific events described in this Complaint... Further, when Stifflemire's abuse was reported at least in 1978 and 1988, incredibly, the Darlington faculty, administration, and board members actually lashed out at some of the victims further compounding the harm done... students and former students reported Stifflemire's sexual abuse from 1974-1994, but Darlington did nothing about it for more than forty years... Other students and former students came forward and reported Stifflemire's sexual abuse to Darlington administrators and faculty. Consistent with policies, practices, and institutional behavior, Darlington took no action on the matter... Darlington knew about the abuse of students going back to at least the 1970's and took no corrective action. Darlington did not take any steps to promptly address issues brought to its attention at any time before May 26, 2017. And as of today, Darlington has done nothing to address the abuse suffered by the Plaintiffs."

Former Darlington School Headmaster, Brad Gioia, knew about the Roger Stifflemire child sex abuse allegations prior to the Darlington Survivors sex abuse lawsuit filed in June 2017. “At the time of the abuse Plaintiff suffered physical and psychological damages causing them to be incapable of speaking about the abuse or processing their experience for decades... At the time of the filing of this Complaint, it is impossible to know how many Darlington students were victimized by Stifflemire. At least one victim has since committed suicide and upon information and belief, another victim committed suicide while he was a student at Darlington.” Amended Complaint – Filed Feb 8, 2022.

*“A year earlier, **redacted** had told an administrator named Joe Campbell that boys stayed behind closed doors in Stifflemire’s apartment until late at night, long after lights-out... Campbell who died in 2002, also fielded the 1988 call from **redacted’s** mother. What he did afterward is not clear. Brad Gioia was Darlington’s headmaster at the time. In an interview, he said Campbell never notified him about the complaint. “You would think I would know, but I was not told anything,” said Gioia, now the headmaster at Montgomery Bell Academy in Nashville. “I’d be one of several people he would have told. Or he could have decided to do nothing.” **Redacted’s** family soon dropped the matter. **Redacted** spent several months in a psychiatric hospital and later moved to New York, where he joined a 12-step recovery program. By 1999, he had been sober for several years. It was time, he decided, to atone for not doing more to stop Stifflemire. ‘Finally,’ he said, ‘I needed to tell Darlington my story.’ Atlanta Journal Constitution – By Alan Judd – June 29, 2017.*

To date (March 12, 2023), Brad Gioia continues to abuse and damage a former Harpeth Hall student through his previous false criminalization of the young woman's father on Oct 20, 2017. Brad Gioia's hysterical use of lies, armed police, untrue sworn testimony, and his cultivation of an "intimidation-bully" culture has damaged the young girl and her family in ways not fully known. Brad Gioia still has no genuine care or concern for the health and welfare of Daisy Davis (a female member of the MBA Thespian Club), and yet he possesses knowledge of the Darlington Survivors lawsuit which states: "At least one victim has since committed suicide and upon information and belief, another victim committed suicide while he was a student at Darlington."

Former Darlington School Headmaster, Brad Gioia, knew about the Roger Stifflemire child sex abuse allegations prior to the Darlington Survivors sex abuse lawsuit filed in June 2017. In 2014 a former student notified Darlington again about misconduct occurring in the 1980s. In response the school began an investigation. In 2015, an unprecedented opportunity arose when the Georgia Legislature passed the Hidden Predator Act. This provided a two-year window for victims to take legal action against their alleged abusers. Darlington was presented with another opportunity to carry out its mission to "Act with Integrity" by reaching out to former students, faculty and staff.

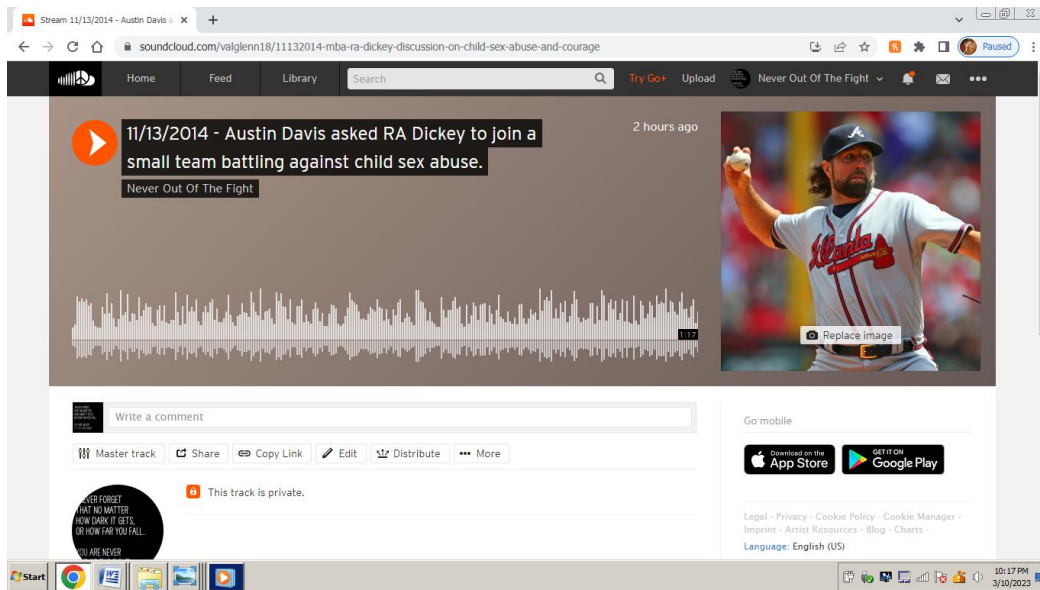
In May 2017, nearly three years after beginning its investigation, Darlington did send a letter to alumni asking them to come forward with any information related to sexual misconduct. This allowed only thirty-five days before the Hidden Predator Act expired.

Darlington has yet to release the information about its investigation.

To date (March 12, 2023), Brad Gioia has not disclosed to Austin Davis if he was contacted or interviewed by the Darlington School legal investigation team in 2014. R.A. Dickey’s trusted pastor is Carter Crenshaw (West End Community Church). West End Community church is a sister church of Covenant Presbyterian Church founded by Pastor Jim Bachmann. Pastor Jim Bachman’s daughter is a sister-in-law to R. A. Dickey. R.A. Dickey’s brother-in-law, Will Bartholomew, is a former teammate and long-time friend of Peyton Manning. Austin Davis coached R.A. Dickey’s other brother-in-law, Bo Bartholomew, who also attended Ensworth and MBA. R.A. Dickey’s alma mater is led by MBA Headmaster Brad Gioia, who participated in the retaliation arrest of Austin Davis on Oct 20, 2017. 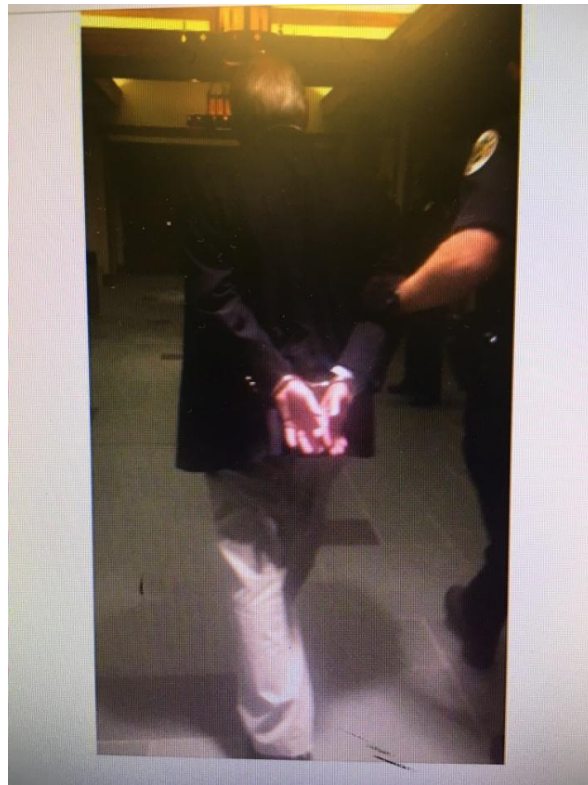

Robert Sawyer, Dean of the MBA High School, continued to protect the John Perry child sex abuse cover-up when a YouTube video was posted on Oct 25, 2017. 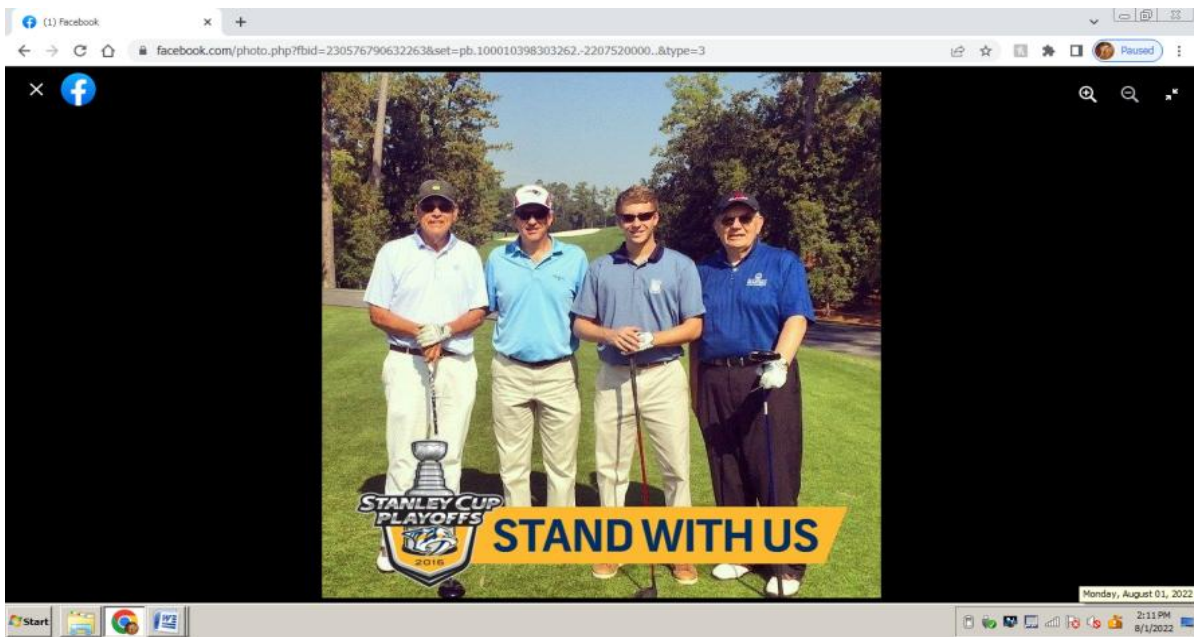

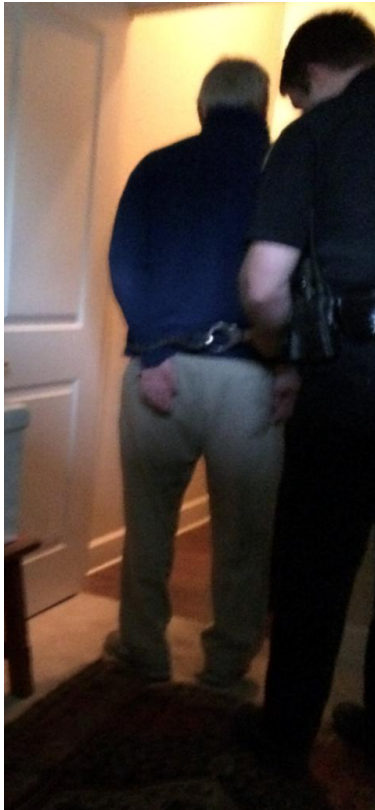

Excerpt from amended complaint: *“Most recently, the May 26, 2017 letter from Darlington falsely states that Darlington was not aware of any other allegations of sexual abuse... To date, we have not learned of any similar allegations concerning this former faculty member. At no time did Darlington reveal that it was aware of prior reporting of instances where students were sexually abused. Darlington also issued a follow-up email in August 2017. These communications constitute the additional predicate acts of mail fraud and wire fraud for the purpose of depriving Plaintiff and others of money and property by enticing them to make donations and/or enroll their children at Darlington. This constitutes racketeering activity by the Defendants which was part of a common and continuous pattern of fraudulent schemes, perpetrated for the same or similar purpose and constituting a “pattern of racketeering activity.” Through racketeering activities, the Defendants deceived and victimized Plaintiff and others, whereby Plaintiff was damaged all for Defendants pecuniary and selfish gain which was invested in the enterprise since tuition paid by Plaintiff and his parents helped fund salaries of Defendant Stifflemire and Darlington, so as to further the enterprise. The Georgia RICO Act prohibits any person from engaging in certain enumerated activities through a pattern or racketeering conspiracy. Defendants agreed to enter into a conspiracy to violate Georgia law... which resulted in the assault, battery, and child sexual abuse as well as the cover up and concealment of the abuse...”*

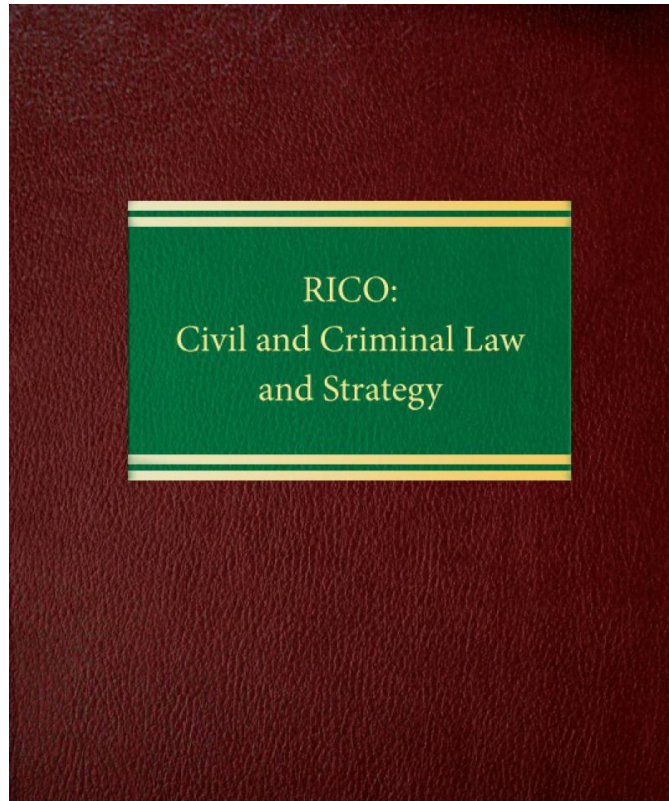


2017 – At least two RICO child sex abuse cover-up cases in progress

Per the amended complaint, the May 26, 2017, letter to Darlington School Alumni falsely stated there was only one student who had an inappropriate and uncomfortable experience, but there was no physical contact with the student. In response to the May 26th letter, at least 10 Darlington Survivors filed a sex abuse lawsuit against Roger Stifflemire and the Darlington School in June 2017. One of the Darlington Survivor plaintiffs was a relative of a deceased student who wrote a suicide note that he had been sexually abused at the Darlington School by Roger Stifflemire (per a judicial order signed by Judge Adele P. Grubbs). After the Darlington Survivors sex abuse lawsuit was filed, former Darlington School Headmaster, Brad Gioia, was interviewed for an article published in the Atlanta Journal Constitution on June 29, 2017. Brad Gioia was quoted in the article as saying: *“You would think I would know, but I wasn’t told anything.”* Four months later on Oct 20, 2017, Brad Gioia participated in at least two RICO child sex abuse cover-up cases involving the Darlington School in Rome, GA, Montgomery Bell Academy in Nashville, Tennessee, and WSMV TV, currently owned by Gray Television in Atlanta, GA.



Oct. 20, 2017 – At least 2 RICO cases in progress occurred with the wrongful arrest of child sex abuse whistleblower, Austin Davis.

Brad Gioia: Bradford Gioia. B-r-a-d-f-o-r-d, last name G-i-o-i-a.

General Harris: And where are you employed, sir?

Brad Gioia: Montgomery Bell Academy.

General Harris: And how long have you been so employed?

Brad Gioia: Twenty-four years.

General Harris: And what is your position at Montgomery Bell Academy?

Brad Gioia: Headmaster.

General Harris: And, Mr. Gioia, did you receive correspondence or did folks at MBA, parents, faculty and staff, receive correspondence from a gentleman named Austin Davis in October of last year?

Brad Gioia: Yes.

General Harris: And would you please tell the court a little bit about what Mr. Davis, what the nature of this correspondence was?

Brad Gioia: He sent an email to literally hundreds, I can't quantify the number, of individuals at school and, from my point of view and others, used our email list without any authority.

General Harris: And – oh. Excuse me. Go ahead, sir.

Brad Gioia: And the email was an expression of a number of his concerns, **none of which seemed to be about our school.** The problem was that he scared a lot of people and indicated in the email that they should read this email before our homecoming game that evening. That also heightened the alarm of a number of individuals, to the point where I had at least **twenty phone calls** that same morning asking me if there would be police or other protection at the game because they were worried about individual welfare.

General Harris: And you asked for additional protection as a result of that; is that correct, sir?

Brad Gioia: **I did call the district attorney and asked him what he would recommend.**

On April 6, 2018, Brad Gioia provided sworn court testimony that he knew about the widely known child sex abuse cover-up issue within the Covenant – Harpeth Hall community. See an excerpt of his sworn testimony below. Attorney Greg King, a MBA father, represented Austin Davis.



Greg King: I guess the first part of June, were there any emails or concerns or any furtive movements by Mr. Davis or his family toward any faculty members or anything while he was on campus?

Brad Gioia: None that I know of.

Greg King: And I think it was probably known that he would attend some of the campus activities like baseball, football games in the fall, and things like that?

Brad Gioia: He was frequently on campus.

Greg King: Yes. And there weren't any issues there?

Brad Gioia: No. But I would like to add that there were concerns because his engagement with both the Harpeth Hall Community and Covenant Church was well known, and a number of people on the campus expressed their concern about how they felt he had intruded on the lives of those campuses.

Greg King: And was that occurring before the October email to you and the MBA community?

Brad Gioia: Absolutely.

Greg King: Okay. But at the time, you were thinking this could be an isolated or just something temporary.

Brad Gioia: You mean prior to October of 2017?

Greg King: Yes, sir. No, no. Yes, of course.

Brad Gioia: I was hopeful that he would not involve MBA, because I knew firsthand from a number of discussions about the concerns and frustrations from those communities.

Greg King: Okay. And after the email in October, did he, was there anything else he did by any mode of medium that would have caused you concern?

Brad Gioia: Not until February.

Greg King: Until February, and that was--

Brad Gioia: Of this year.

Greg King: That was the first communication you received since the October event?

Brad Gioia: Yes.

Greg King: Okay. All right. And so, when you received the October email, the February 7 and February 9 emails, you considered them as veiled threats, did you think there could be some imminent threat of harm or injury when you received those?

Brad Gioia: Well, I certainly had that feeling directly from a number of phone calls I received.

Greg King: Uh-huh.

Brad Gioia: Personally, I probably felt it more in February when I sensed that his feelings were more intense because of the jail time he served. I don't know that I felt it so intensely but it bothered me.

Greg King: Okay. And then did you think the apology that was being, I guess I didn't realize that this occurred, but a friend of Mr. Davis's tried to contact you to apologize on his behalf?

Brad Gioia: He didn't try. He wrote me directly.

Greg King: He wrote you directly. Did you feel that was sincere.

Brad Gioia: I think he thought it was sincere.

On April 6, 2018, Brad Gioia's deceptive sworn testimony intentionally supported the deceptive sworn testimony of Federal Judge John Bryant, a MBA father and Covenant Presbyterian Church Elder. Brad Gioia and Federal Judge John Bryant were both prosecution witnesses for DA Glenn Funk's malicious prosecution team which shrewdly portrayed child sex abuse whistleblower, Austin Davis, as a creepy stalker and potential elementary school shooter threat similar to the Sandy Hook mass shooter, Adam Lanza. 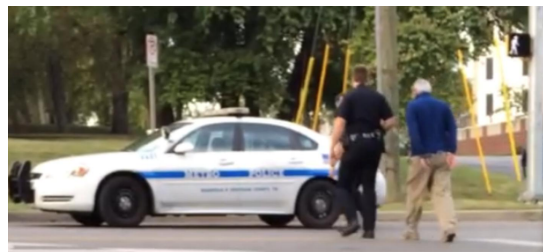

Child sex abuse whistleblower Austin Davis

Federal Judge John Bryant – Sworn Testimony - Sept 11, 2017: *“Mr. Davis stepped up his email campaign against the church. And he sent a series of emails to our membership, congregation membership, also to employees of the school. We have a kindergarten through sixth grade school. It’s a private school the church runs as a ministry. And the tone and content of these emails alarmed people. And I think in fairness part of the alarm was because that just in December of 2012 was the shooting of the school children at the Sandy Hook Elementary School in Connecticut by a man named Adam Lanza which was all over the news. It was a horrible thing. And think it was fresh in everybody’s mind at the time.”*

General Chandler Harris Court Argument - April 6, 2018: *“He emailed Mr. Gioia at least one time, and members of his family emailed Mr. Gioia again. We have the same repeated pattern again. The effect is very clear. Mr. Davis has known this for a long time. Whenever he sends his e-mails out, he knows it intimidates and harasses people. Period. And the court has proof. I submit that the court ought to credit the testimony of Mr. Gioia that that’s exactly what this was intended to do and that’s exactly what the effect was; and that’s to intimidate or harass him, certainly to cause him concern about, you know, as Donald Rumsfeld said, you know, we know where the unknowns are. That’s exactly what we’re dealing with here and that’s exactly the sentiment that Mr. Gioia has presented to the Court. He knows that Mr. Davis exists, but, again, feels threatened because he just doesn’t quite know what he is going to do. And neither does anyone else. The problem is that Mr. Davis knows it, and that’s why he continues to engage in this type of activity. He expressed to the Court he would quit emailing. He has not. The state’s request is that the court modify his probation to take out all his internet access. Certainly, the Court has the power to do it. We do it with people charged with other crimes. The bottom line is that Mr. Davis should not be extended any benefit or a benefit of doubt that he will quit emailing again because he just very simply hasn’t followed through on that before. So the state would ask that the Court take away all his internet access from his home. If the Court is not going to go that far, then certainly I think that an express probation condition disallowing Mr. Davis from communicating with Mr. Gioia personally or with anyone on the faculty or staff at MBA or parents via the list serv, obviously would be appropriate under the circumstances. The bottom line is Mr. Davis has too much time on his hands.”*

Asst. DA Chandler Harris and Brad Gioia made untrue statements during the court hearing on April 6, 2018. For the public record, Judge Cheryl Blackburn did not ban Austin Davis from sending out emails even though Austin Davis volunteered not to send emails as a condition for being released from 18-days of false imprisonment on Nov 6, 2017. On April 6, 2018, Austin Davis raised his hand in court to request for Judge Cheryl Blackburn to allow him to testify after he was not called to the witness stand to respond to the deceptive sworn testimony of MBA Headmaster Brad Gioia, and the untrue oral argument of Asst. DA Chandler Harris. See abbreviated excerpt of Austin Davis sworn testimony below.

Austin Davis: There's a molester living on Belle Meade Boulevard about twelve doors away from -- ... She's asking me why, because I don't want to be shackled on that issue.

Judge Cheryl Blackburn: Okay. Well. You're going to be shackled on that issue, one way or another, and that would be me telling you something or I'm going to put you in jail again."

Austin Davis: So the state wants us not, the citizens not talk about child sex abuse if we know where a molester is?... It's called First Amendment freedom of speech. You just have a right to speech.

Judge Blackburn: Well, in this particular issue, you don't have a First Amendment freedom of speech.

General Harris: Is Mr. Davis presently allowed on campus at MBA.

Brad Gioia: We don’t have a restriction about that. I probably would not be pleased if he were on campus until I had some understanding from him about what his own intentions are and why he has put the school in this position...

General Harris: Understand. What would you like to see the Court do as it relates to Mr. Davis’ contact with you and the MBA community today?

Brad Gioia: I would like him to desist from all contact with me and the entire school community.

“The response of the Darlington School, at the least, was to do nothing and let the situation continue, or threaten the student that they could get in a lot of trouble from making the accusations or physically assaulting the victim Plaintiff... Further, when Stifflemire’s abuse was reported at least in 1978 and 1988, incredibly, the Darlington faculty, administration, and board members actually lashed out at some of the victims further compounding the harm done... other plaintiffs... disclosed the fact that they had been sexually abused by Stifflemire to their respective treatment centers who, upon information and belief, reported the allegations of sexual abuse to Darlington... Darlington actively concealed their knowledge that Stifflemire had been accused of childhood sexual abuse... Darlington took no steps to investigate, verify allegations, report to appropriate lawful local and state authorities, and remove Stifflemire from his position... Stifflemire was allowed and otherwise permitted by Darlington to act with utter and complete immunity... These offenses were part of a systematic and on-going pattern of racketeering activity over a number of decades, which Darlington and the Individual Defendants and other unnamed parties participated directly or indirectly in the conduct of affairs of Darlington, through a pattern of racketeering activities... Defendants conspired to keep secret the above-mentioned facts from any investigative body, from others interested in the well-being of Plaintiff and others, acted to conceal the injuries and harm done to Plaintiff and others, so as to cover up accusations of and confirmed instances of child sexual abuse within Darlington thereby engaging in a pattern of racketeering activities. Defendants conspired to conceal the Individual Defendants’ crimes and the danger posed to Darlington students and members of the general public as well as the prevalence of sexual abuse at Darlington generally through a pattern of fraudulent practices to maximize profitability, preserve and protect their reputations in the community and avoid criminal and civil litigation... The Georgia RICO Act prohibits any person from engaging in certain enumerated activities through a pattern of racketeering or conspiracy.”

The amended complaint states: *“These offenses were part of a systematic and on-going pattern of racketeering activity over a number of decades, which Darlington and the Individual Defendants and other unnamed parties participated directly or indirectly in the conduct of affairs of Darlington, through a pattern of racketeering activities.”* With 20-20 hindsight, new information, and Brad Gioia’s personal misconduct and sworn testimony during at least two RICO child sex abuse cover-up cases, it seems reasonable to consider that former Darlington School Headmaster, Brad Gioia, is possibly one of the *“other unnamed parties”* who participated directly or indirectly in the pattern of racketeering activity that protected child molester, Roger Stifflemire, for four decades.

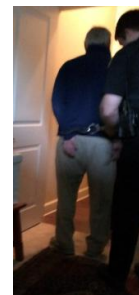

Judge Cheryl Blackburn: And that issue, as I've explained, doesn't have anything to do with this or them. Okay. Just stop...

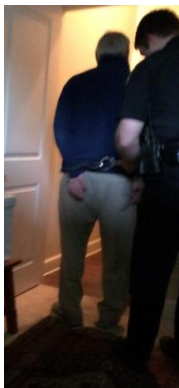

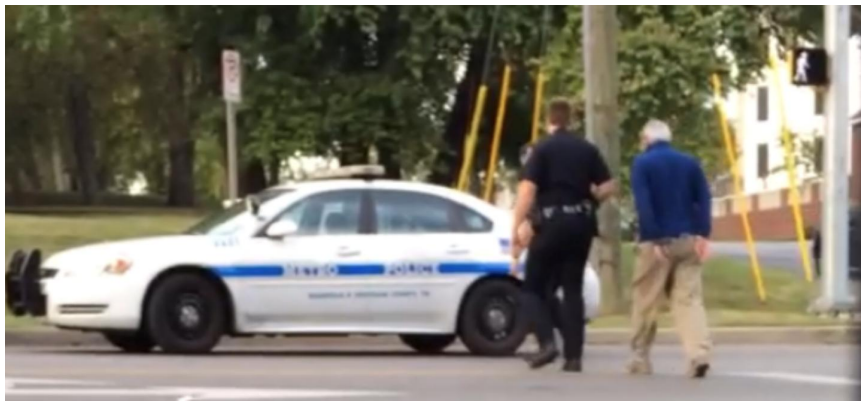

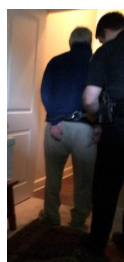

“From the trial transcript... we have gleaned that the Defendant became convinced that the Church’s elected group of elders... was protecting a former member and deacon of the Church who was excommunicated from the Church after redacted revealed that he had sexually abused redacted when redacted was a child. The Defendant believes that the Church was involved in a cover-up of child abuse because it did not take what he considered sufficient action against the former church member... Apparently, the Defendant also at some point sent mass emails and/or letters to the parents of school children at several schools in the Nashville area, including Harpeth Hall and MBA... The Defendant’s defense strategy consisted of trying to prove that the Session lacked the authority to ban him from the Church property and that its members, along with the pastor, were attempting to thwart the Defendant’s righteous effort to expose Church corruption and child sex abuse... The Defendant elicited testimony from State and defense witnesses about the former church member’s behavior, the failure of the Church leadership to immediately excommunicate the member or contact the police when the abuse first came to light, and the fact that many of the members of the Church who once held leadership positions had since left to form splinter churches in the community... After the Defendant sent more unsolicited emails and unsettling mass email communications to the headmaster and parents of students at Montgomery Bell Academy, the State sought and obtained a modification of terms of the Defendant to prohibit the Defendant from contacting any of the Montgomery Bell Academy faculty or staff of their families or anyone else connected with the school... MBA alumnus, Judge Alan E. Glenn, was provided exculpatory info proving that John Perry was a protected child-molester, but he ignored the truth of the child sex abuse cover-up info to protect: 1) The MBA-Harpeth Hall-Covenant-WSMV TV collaborative community; 2) MBA Headmaster Brad Gioia; 3) DA Glenn Funk (MBA father). 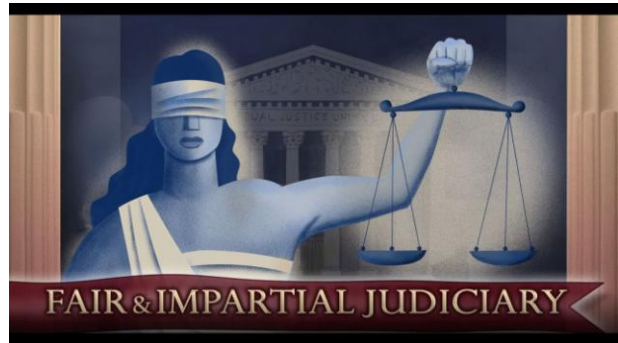

Asst. DA Chandler Harris mocked Austin Davis and the "myths" about a child-sex abuse cover-up during the rigged criminal trial. However, the child sex abuse is true and supported by rock-solid evidence provided to DA Glenn Funk. Asst. DA Chandler Harris has apparently fled Nashville for Philadelphia, PA to work for the Mullen Coughlin Law Firm.

In a related John Perry - \$2.1 million “invasion of privacy – defamation” case, Tennessee Appellate Judge Andy Bennett also took an honorable action to write a minority appellate opinion concluding that MBA Father, Judge Kelvin Jones, undeniably violated the Rule 10B recusal process denying Austin Davis an impartial judiciary: “The Tennessee Supreme Court has said that: *The right to a fair trial before an impartial tribunal is a fundamental constitutional right... Article VI, Section 11 of the Tennessee Constitution provides, No Judge of the Supreme or Inferior Courts shall preside on the trial of any cause which he may be interested... We have recognized that it is important to preserve the public’s confidence in a neutral and impartial judiciary... Rule 10B, § 1.02, mandates that a judge cannot make further orders in the case while the Rule 10B motion is pending. Entering the orders tainted the judicial process. Almost immediately thereafter, Mr. Davis filed another motion to recuse identical to the prior one and five days later, on February 7, 2018, the trial judge recused himself without explanation. The recusal allows us to infer a bias or conflict... I believe Mr. Davis did not receive an impartial trial... I firmly believe that the tainted orders created by the undeniable violation of Rule 10B injure the judicial process if left uncorrected... We must never forget that the only real source of power that we as judges tap is the respect of the people... How can we keep the respect of the people if we ignore rules designed to ensure impartiality? Under the admittedly odd circumstances of this case, the integrity of our system requires appellate consideration of the issues related to the Rule 10B motion.*”



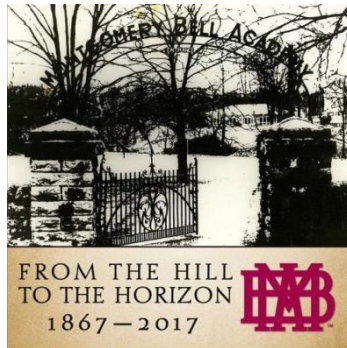

Judge Kelvin Jones (MBA father) violated the 10B recusal rule but the \$2.1 million *“invasion of privacy – defamation”* judgment was still allowed to stand against Austin Davis by the TN Supreme Court. In a related criminal case against Austin Davis, TN Criminal Appellate Court Judge Alan E. Glenn (MBA Alumnus) refused to recuse in violation of the 10B recusal rule and a rigged indictment-judicial process against Austin Davis was allowed to stand by the TN Supreme Court. MBA Alumnus Judge Alan E. Glenn further protected MBA Headmaster Brad Gioia, and at least two RICO child sex abuse cover-up cases connected to the MBA-Harpeth Hall collaborative community. With Judge Alan E. Glenn’s destructive, dishonest appellate opinion, Judge Alan E. Glenn further damaged child sex abuse whistleblower, Austin Davis, and his defamed and injured family. Four months after the appellate opinion was rendered, Judge Alan E. Glenn passed away unexpectedly on Nov 4, 2021, twelve days prior to a settlement being made between the Darlington Survivors, and the Darlington School on Nov. 16, 2021. To date (March 12, 2023), it is unknown if Judge Alan E. To date (March 12, 2023), it is also unknown if Brad Gioia, the Darlington School, or any MBA-Darlington School alumni or attorneys, ever exchanged Roger Stifflemire – John Perry child sex abuse cover-up information with each other, before or after, the retaliation arrest and 18-day jailing of MBA father, Austin Davis. To date (March 12, 2023), it is also unknown if the Headmasters, Board of Trustees, faculties, alumni and attorneys of Christ Presbyterian Academy, Grace Christian Academy, Brentwood Academy, BGA, Baylor, McCallie, Ensworth, MUS, and Harpeth Hall, ever exchanged any Roger Stifflemire – John Perry child sex abuse cover-up information with MBA or Darlington School Leadership since child sex abuse cover-up information was also provided to these educational institutions, along with other schools and universities. With 20-20 hindsight, the Roger Stifflemire cover-up continued another four years after the unconstitutional arrest and jailing of Austin Davis until a settlement was reached with the Darlington School per a news report published on Nov 16, 2021. “This has been a horrible situation for these survivors and for the school. Mr. Stifflemire’s intimidation, manipulation and exploitation have left scars that may never fully heal. The abuse suffered was abhorrent, and we are truly sorry for the pain these men feel because of their time under our care. The Board of Trustees wishes to express its gratitude for the strength of these men to come forward with their horrific experiences while under the supervision of Darlington. Although this will be a stain forever on the history of our beloved school, we are relieved that the truth has been exposed and addressed. We wish to express our sincere apologies for the experiences these men and their families have endured and their lifelong pain. We are also sorry that the school did not do a better job of protecting them or of recognizing what was happening at the time. We realize that no amount of compensation can remove the wounds, but we pledge to continue to work with these men to find peace and healing.”



The Darlington School Board of Trustees apologized to the Darlington Survivors. However, former Darlington School Headmaster, Brad Gioia, seemed to take pride in the fact that he did not respond, or apologize to the Davis children as requested, during his deceptive sworn testimony on April 6, 2018. To bolster his own public image, Brad Gioia shrewdly exploited Heisman Trophy winner, Eddie George, Peyton Manning, John Grisham, R.A. Dickey, and many other distinguished guest speakers at MBA, to divert attention away from his participation in at least two RICO child sex abuse cover-up cases, including the Darlington-Roger Stifflemire case which lasted four decades.

Brad Gioia: He wrote me, and his wife then wrote me, asking me to apologize for his being detained by police and I believe imprisoned, essentially suggesting that this was all my fault and wanted an apology.

General Harris: How did you interpret his demand for an apology?

Brad Gioia: I just think he was frustrated and was somewhat providing a veiled threat.

General Harris: A veiled threat in your eyes. Did you respond to Mr. Davis at that time?

Brad Gioia: I did not.

General Harris: In fact, you reached out to our office; is that correct?

Brad Gioia: That's correct.

General Harris: You received further correspondence on February 9th; is that right?

Brad Gioia: That's correct.

General Harris: And who did that come from?

General Harris: I believe that was a second email from his wife, and then from one of his friends asking me to forgive him and to meet with him and to reconcile whatever concerns there were on my part. I would like to add I really don't have any particular concerns except the welfare of the school. I don't know that I took this personally except that it interfered with my time and work.

General Harris: Including today?

Brad Gioia: Including today.

General Harris: Yes, sir. As it relates to the second email, did you deem that to be a veiled threat as well?

Brad Gioia: I think it was as much a plea for an apology and an expression of their own angst about his having to endure whatever he feels he's enduring.

General Harris: Did you respond to that email.

Brad Gioia: I did not.

To date (March 12, 2023), Brad Gioia still takes pride in offering no apology to at least one Harpeth Hall student who was targeted and abused by certain MBA boys and parents while under Brad Gioia's "thug" leadership and supervision. On Oct 20, 2017, a former Harpeth Hall student suffered further damage when Brad Gioia worked with DA Glenn Funk and the Nashville Police to protect at least two RICO child sex abuse cover-up cases, including the child sex abuse cover-up effort which further harmed twenty Darlington Survivors.

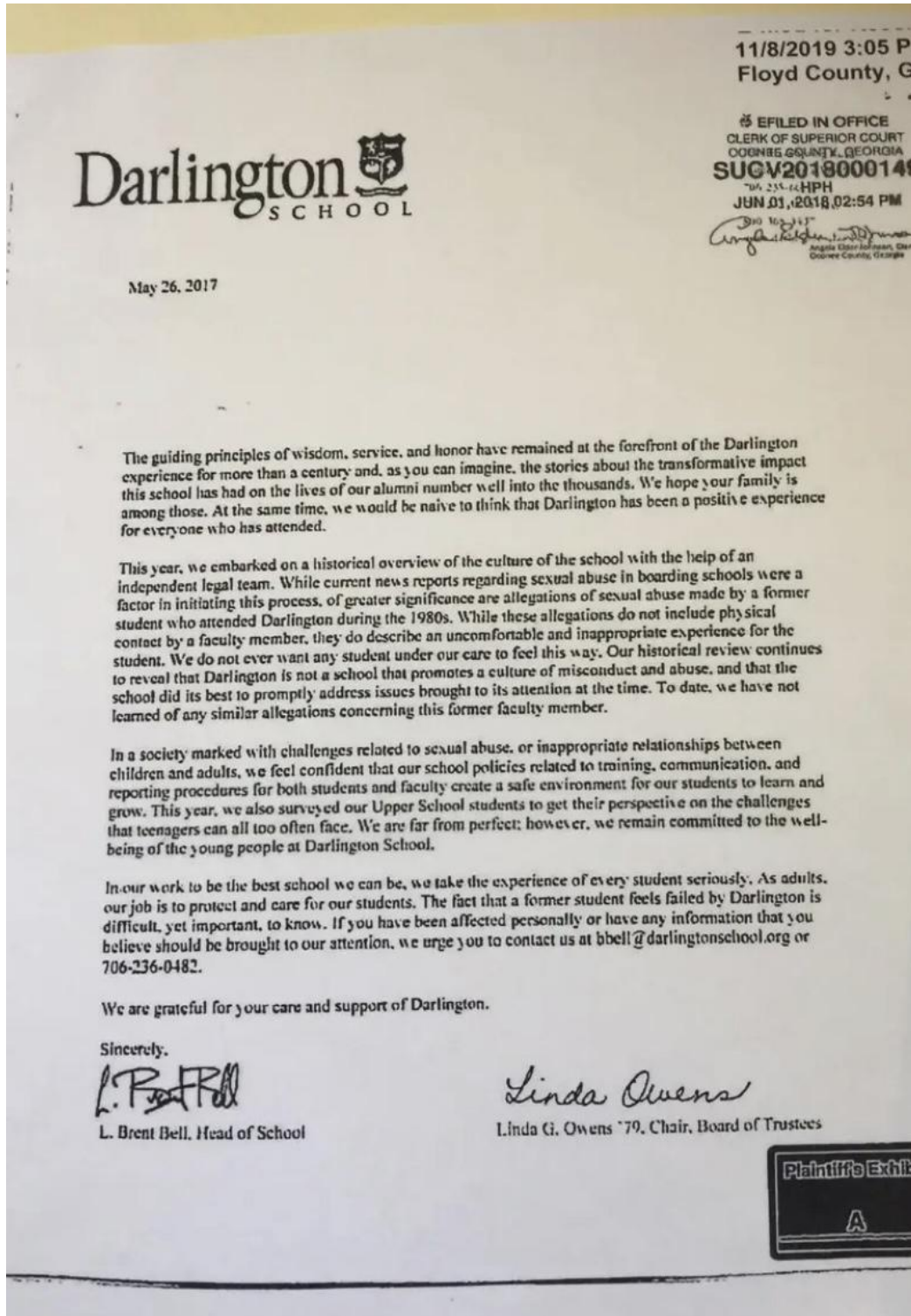

To date (March 12, 2023), it is unknown if Brad Gioia, Jess Hill, or anyone in the powerful MBA-Harpeth Hall community has provided or exchanged any child sex abuse cover-up information with the Darlington School Board Members, or affiliated attorneys, before or after, a deceptive child sex abuse cover-up letter was sent to the Darlington School Alumni on May 26, 2017.

Please know that the former student's email was in no way an approved communication by Harpeth Hall. No one at the school had any prior knowledge of the sender's intended unauthorized use of such information and would not have approved it had such request been made. Harpeth Hall takes every precaution to protect your contact information and strives to communicate with you in an appropriate and professional manner.



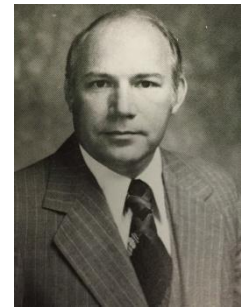
