## Timeline

- 1. 2000 2002 Covenant Deacon John Perry repeatedly molested at least one 11-year old child in multiple states.
- 2. 2002 2006 Covenant Deacon Austin Davis asked internal questions at Covenant about the safety of children placed in John Perry's "safe house."
- 3. 2007 (July) Victim 1 informed Covenant Youth Pastor J Hager about Covenant Deacon John Perry's child sex abuse.
- 4. 2008 (April) Covenant Session Member Larry Ferris informed child sex abuse therapist, Caroline Cone, about John Perry's child sex abuse. Covenant Leadership did not report the child sex abuse to DCS or law enforcement. Instead, John Perry and Covenant Leadership negotiated a "cover-up silence" deal with John Perry to protect the child sex abuse cover-up, John Perry's "safe house," and the multi-million dollar Covenant fund-raising effort for the

new Covenant Gothic Sanctuary. After the "cover-up - silence" deal was agreed upon, John Perry traveled to PCS in Arizona for "sex addiction" treatment.

- 5. 2008 (July 2) Nashville Police protected child-molester John Perry and the Covenant Session cover-up by silencing and falsely criminalizing Austin Davis as a potential "church shooter." (Covenant Leadership knew John Perry was a child-molester, but Austin Davis did not know.)
- 6. 2008 (July 6) Covenant Leadership and Nashville Police targeted the Davis family, including a Harpeth Hall middle school daughter of Austin Davis. The minor daughter was molested during the Covenant-Police-John Perry child sex abuse cover-up.
- 6. 2008 (July 14) Nashville Police attended a Covenant Session meeting to provide a false security briefing on Austin Davis. Covenant Leadership did not report known threat and child-molester John Perry to Nashville Police. Child-molester John Perry was allowed to quietly resign from the Covenant Diaconate as the "cover-up silence" deal was implemented.
- 7. 2014 Attorney General Herbert Slatery ignored the desperate pleas of Catherine Davis.
- 7. 2020 (Sept) The Tennessee statute of limitations is still running on child-molester John Perry because the child sex abuse crimes were concealed by Covenant Leadership and Nashville Police. Victim 1 was told the statute of limitations expired at 18 years of age on July 11, 2007. Police told Austin Davis the statute of limitations expired at 19 years of age on July 11, 2008. But the statute of limitations was really set to expire on July 11, 2010, more than two years after Nashville Police silenced the Davis family from asking questions about child-molester John Perry's "safe house." There is NO statute of limitations for child sex abuse across state lines under the Federal Mann Act. Question: When will child-molester John Perry be arrested?

Subject: Rev. Billy Graham Cover-Up Continues - 12 Years

Dear Chief Drake:

Congratulations on your new position as Chief of Police. I pray you can restore public confidence in the Nashville Police Department.

On Oct 1, 2012, I reported Rev. Franklin Graham's hired ghostwriter, John Perry, as a child-molester to Commander Marlene Pardue and Sgt. Twana Chick. On Dec 5, 2012, Commander Pardue, Sgt. Chick, Commander Brandimore, Detective Michael Shreeve and 4 other high level police officers told us that child-molester John Perry could not be arrested because the statute of limitations had expired at 18 + 1 year (19) for Victim 1.

On Sept 11, 2018, child sex abuse therapist Caroline Cone provided sworn testimony that she reported the child sex abuse to DCS after Covenant Pastor Larry Ferris informed her about John Perry's child sex abuse in April 2008.

Covenant Pastor Larry Ferris informed Ms. Cone three months before Nashville Police intimidated and silenced my family from asking questions about the safety of children placed in child-molester John Perry's "safe house" on July 2, 2008.

Email is abbreviated and redacted. (Note: Police Chief John Drake replaced Police Chief Steve Anderson after twenty-five female police officers stepped forward with complaints via a group called Silent No Longer. See link below).
