The Appellant filed an application for an extension of time to comply with Paragraphs 1 and 2 of the Order dated 07/08/2018, i.e. to:-

- 1) Obtain and file with the Court a transcript of the hearing before DDJ on 04/01/2018  
and of any Judgment given on that date; and
- 2) File a skeleton argument in support of the appeal and an indexed and paginated appeal bundle complying with CPR PD 52B.6

The application was granted and the Appellant was given until 02/11/2018 to comply with the Order of 07/08/2018. The Order was dated and typed on 24/10/2018. The Order was received by my Firm on 26/10/18 therefore only giving 1 week to comply not taking into consideration how long it will take to file (if filed by post).

My Firm has been regularly chasing the Court and DTI (the Transcription Company) for the Transcript and by way of email dated 31/10/2018 my Firm was advised by the court that the draft transcript has been emailed to Deputy District Judge for approval and once approved it will be forward to the transcribers. It is my understanding that once DTI has received the approved transcript a copy of the same will be sent to our firm.

As such, as of 31/10/2018 the draft transcript had not yet been approved. If the transcript was approved late on 31/10/2018 or after, it still would not have been enough time for the Appellant to comply with the Order of

As stated in my previous application, an extension of time is sought for all the documents to be filed as without having sight of the transcript, the skeleton argument cannot be drafted and an paginated bundle cannot be prepared / completed without the inclusion of the skeleton argument.

GSL has not sought consent from the Respondent for the extension of time as the deadline to comply with the Order has already lapsed.

I would like to point that this application has been made promptly. If the Court does not allow the application the Appellant will not be allowed to seek permission to appeal of an Order which was, I submit, made in error.

In view of the above, the Appellant requires and so respectfully requests a further 28 days in which to comply with paragraphs 1 and 2 of the Order of 07/08/18 and the Order of 24/10/2018. I respectfully submit that no prejudice is caused to the Respondent as a hearing has not been listed, once the documents mentioned in paragraphs 1 and 2 of the Order are received, the file is to be referred back to the Circuit judge to consider whether permission to appeal should be granted and/or further directions.
