For the attention of Karim Khan:

Good day.

We write to acknowledge that the International Criminal Court (ICC) as an intergovernmental organisation seated in The Hague, Netherlands, has a duty to serve we the people to prosecute individuals on the Isle of Man, British Isles, for crimes of genocide, crimes against humanity, the crime of aggression, and current, ongoing, war crimes against their people. This concerns deaths by Midazolam, Remdesivir, 'vaccines', and 'ventilators', passed off as 'covid'. We include world and local issues to give meaningful context, to the unfolding 'covid' crimes.

As the ICC operates under Roman Law it must avoid any and all religious transgressions by Jesuit members and their associates. The ICC thoughts and actions must be grounded only in truth and honour, and by clean hands principles. To date, there have been a litany of failures of all such due processes; processes that should have duly served we the people, and not vested interests. As such, we are removing ourselves from fealty to an unjust constitution. A further document will follow, requiring protection and recognition as a group of men and women, of no country.

We are now, unavoidably, making a demand for criminal charges to be made. Although Blackstone, an eminent legal scholar cited: *the opinion of a Judge, is tyranny* - we the people, trust, and now demand, that Karim Khan will finally wipe the slate clean of repeated, sleight of hand, 'justice'.

#### **Under ICC Elements of Crime Article 6 (a), of Genocide By Killing**

On the Isle of Man, perpetrators killed at least 18 elderly vulnerable men and women between 13<sup>th</sup> and 30<sup>th</sup> April 2020 at Abbotswood nursing home, Ballasalla, British Isles. The men and women were in a vulnerable group living on the Isle of Man, in what should have been a facility of decent care.

## **Under ICC Elements of Crime Article 6 (b), of Genocide causing serious bodily or mental harms**

During the period preceding death, Isle of Man men and women became increasingly tortured as they fought for life, many people were aware they were 'suffocating' by drugs and overwhelmed by forced 'ventilation' - but most likely their issue was in reality, one of oxygen starvation, not, the widely misdiagnosed lung function. The early US whistle blower was Dr Cameron Kyle-Sidell, a New York Emergency Room and Critical Care Medic who raised his grave concerns, early in 2020. In his famous 6 minute 3 second video he outlined he'd seen things he had never seen before; *"Everything I have seen in the last nine days, just doesn't make sense. 'Covid-19' is not this disease, we are operating under a medical paradigm that is untrue. I believe we are treating the wrong disease and this will lead to a tremendous amount of harm to a great number of people, in a very short time. I feel compelled to get this information out"*.

Michael P Senger on 25<sup>th</sup> May 2023, re-opened the 'ventilator' deaths debate, often mis-labelled as 'covid' deaths.

**Abbotswood Nursing Home** - The alleged Abbotswood murders shall prove, in time, to be a stain on the Manx nation, a scandal, the true knowledge of which, most people are as yet, unaware. We should remember the following people were most likely State killed between 13<sup>th</sup> and 30<sup>th</sup> April 2020. Their families seem content to stay silent - maybe due to wilful ignorance, or simply, strangely, to let sleeping dogs lie. A society that secretly knows the true horror of these democidal actions, is suffering cognitive dissonance, and can never truly heal. The Midazolam 'secret' is aired widely on social media, demonstrated by increasing use of 'hashtag' postings, not limited to **#midazolam** and **#MidazolamMatt** (Matt Hancock UK Health Minister) and that also; numerous young athletes, many criminally coerced by mandates in all sectors, and the jabbed, have... **#DiedSuddenly**.

The Abbotswood people who were likely murdered (taken from Manx press, with profound apologies for any errors) were: Marjorie Joan KELLY and Thomas Gilbert KELLY, Vernie Doreen PEERS, Pauline BOWMAN, Pauline CROOKALL-IRVING, Ivy WATTERSON, Alfred Ellis Whittaker BROWN, Eileen Elizabeth CUBBON, Margaret Joan PATERSON, John SANDERSON, William Alfred HODGETT, Derek CAIN, Leonard JONES, Marjory 'Madge' Paterson MACDONALD, Elizabeth Cynthia BOULTBEE, Margaret Rose SMITH, Thomas REEDER, and George Horace FREESTONE.

These April 2020 deaths were aided by rapid imposition of, unknown to family(?) use of DNR's, 'Do Not Resuscitate' orders placed on the vulnerable. Were such 'orders' enacted by Isle of Man DHSC deployed personnel and other staff? Such actions were, at the time shielded from view by lockdowns and State peddled, fear narratives. **The 2023 films by Zandra Lewis and Anne Bald (Abbotswood staff) should be viewed publicly so that justice will not be delayed nor denied.**

Between **13<sup>th</sup> and 30<sup>th</sup> April 2020** many elderly vulnerable died in Abbotswood nursing home, Ballasalla, Isle of Man. A location specific event that hinted at a much darker reality, yet to date, no 'covid virus' has ever been identified anywhere (refer 'Christine Massey', on page 10). These deaths were attributed to 'covid' with no easy family access, while no autopsies were ever undertaken to ascertain true causes, certainly not for any symptom specific 'covid'. The Abbotswood Agenda was to drive fear of 'covid' transmission via 'viruses', to get toxic 'jabs in arms' validated by a deceptive 'test' that could *detect nothing*. At least 60,000 jabbed Manx fell for the 'covid' con.

In Abbotswood the use of Midazolam a benzodiazepine, together with an opioid Morphine, acted as respiratory depressants. **DNR 'notices' are often enacted under NG163 ('Managing key COVID-19 Symptoms') and NG 191 ('NICE NG191 Managing Covid-19') which by their use will soon elicit non 'covid' deaths.** In 2014 after wide spread exposure of the deaths of the elderly under the 'Liverpool Care Pathway' such 'protocols' were abandoned. In theory. **Jacqui Deevoy**, an investigate Journalist and **Kate Shemirani a former Nurse**, have done extensive work to expose these barbaric practices.

On **19<sup>th</sup> May 2020** - Accord Healthcare confirmed that French supplies of Midazolam are now being diverted into the UK, and UK stocks were at twice the previous levels. Matt Hancock soon became known as 'Midazolam Matt' as increasing deaths of elderly are seen across the UK in nursing homes. **The UK had never previously had such stocks of Midazolam and this points at a premeditated action.**

On **29<sup>th</sup> June 2023** - in 'A Good Death' an exposé film by Jacqui Deevoy, **Matt Hancock** is seen talking with Dr Luke Evans, of syringe drivers for Midazolam and morphine - while Kate Shemirani, a former Nurse, pleads in a 1 minute 4 second follow up video said: "*Matt Hancock ordered 9.9 million milligrams of Midazolam and all used within a few months during the first year of the plandemic. And all the deaths in that first wave, occurred in the elderly, in the scare homes, and the hospikills, on the National Harm Service. But you know what I just can't get my head around that you Nurses, became the paid assassins. They trusted you, they trusted you to care for them. They looked on you as their Carers, their Nurses, and you murdered them, you assassinated them, executed them, you injected them, even when they were unconscious. Why, why?*"

In **July 2023** - A 58 minute video of Zandra Lewis, the Abbotswood nursing home manager was circulating, confirming DHSC personnel entered Abbotswood, prior to mass deaths of elderly people.

In **December 2023** - A 26 minute film of Anne Bald, Abbotswood assistant was circulating. Anne confirmed unknown faces from the Isle of Man DHSC (Department of Health and Social Care) came into Abbotswood before there were mass deaths of elderly people in April 2020.

### **Brutal truth takes time, and respects no quarter.**

Daily, there is growing international clamour for justice for all those mass murdered people by the 'covid' injectables. Especially in the light that these expected deaths and harms were fully known by chosen State actors, beforehand. To also instil rapid, mass, 'covid' fears, certain drugs were deployed, with deaths billed as from/with/due to 'covid'. But in all cases, denied any true and decent autopsy. In early 2020 false 'covid' patients were 'ventilated' to death - aided by nephrotoxic (kidney harming) Remdesivir - and not just in Noble's hospital, Isle of Man as told to me by a Medic who worked there during the 'covid' period.

**New Evidence** - It is three years ago today that I published: The Covid Con; A Wake, which now seems an appropriate time to bear witness to the deaths of millions of people in many countries, not limited to: New Zealand, Italy, Germany, The USA, The UK, Iceland, Colombia, South Korea and the Isle of Man. The Colombian Health Minister is the latest to highlight 'medical' mass murders. But, since the exposure by New Zealand politician Liz Gunn (@LizGunn18 on 'X') of New Zealand post 'covid' jabs excess deaths, Barry Young the whistle blowing National Data Administrator has been jailed. Let that be a lesson to New Zealand honesty...

This document is meant as a permanent record of these depopulation times. It contains not just anecdotes but real life, lived, experiences. Our widespread observations include post 'covid' jab, fleets of emergency ambulances speeding through Manx towns. We need the will to examine, and to stomach, such records: to honour the maimed and bereaved, and not just in the name of 'science'.

Such a despicable plan, to a strict agenda, has been long planned - peddled by a 'jabs in arms' mass media slogan. It is still beyond the comprehension of the unsuspecting. But, over 20 years have passed since three buildings were demolished on 9/11. Yet most have still not heard of Building 7.

This mass psychological deception used as the primary building block The Joint Committee on Vaccination and Immunisation (JCVI) which advises UK 'health' departments on 'immunisation'. But any claim of 'immunisation' is a false claim as it lacks true science reality when we look, impartially. This all pervasive, *trust the 'settled' science*, accepted no questioning that might have exposed the 'covid' reality. These actions were driven by world-wide hidden agendas funded by vested interests, for unjust enrichment. Such funds were misused and clinically directed against we the people. All in

lockstep of premedicated activities - a phrase deeply enshrined in the Rothschild Lockstep Depopulation Plan. A plan, championed for decades - in resource rich Africa by Henry Kissinger.

They, the misfeasance in public office, order follower, parroted baseless advice of the 'high priests' from overseas. Callous people, of supposed standing, who held the public trust, failed us. Having met Dr Diane Harper lead Gardasil (Merck) HPV vaccine trialist in February 2018 in Thessaloniki, Greece, I saw at first-hand how the bestowed (false) title, and 'doctor' deception really worked.

Now, I am part of an international commissioning team undertaking to validate 'virus' control experiments - to debunk the 200 year 'virus' fraud. Our work will build particularly on thorough investigations previously undertaken by Dr Stefan Lanka and Elena Papadopoulou Eliopoulos. Elena exposed the 'supernatant' witches brew, relied on as 'proof' by Noble prize winning Luc Montagnier, in his claim that 'HIV viruses' caused 'AIDS'. While, Luc conveniently ignored all other causative factors of a non-common symptom, mass media marketed, 'dis-ease'. Our team intends to finally, unequivocally, show there are no pathogenic 'viruses' and that the PCR 'test' is a fraud - which can falsely, find 'anything' in 'anything', cycle dependent. The more 'cycles'... the more 'covid'.

Impartial, open access evidence wherever it leads us shall prevail. Likewise, this document shall be sent to all those mentioned in it, some of whom cruelly tarnish the memory of loved ones to try to save face, their finances, and especially their freedom. It is written in loving memory of two dear friends I made on the Isle of Man, both died during the 'covid' con - Nigel by a 'ventilator', and Roy, via rapid onset, 'turbo' cancer causing, 'covid' injectables. Intelligent men, but blind-sided by fear propaganda, and their deep seated, too trusting, innocent beliefs. Perhaps, the widows of these two fine men will ponder the words of James Baldwin who said: *'People who shut their eyes to reality, simply invite their own destruction, and anyone who insists on remaining in a state of innocence long after that innocence is dead, turns himself into a monster.'*

Sentiments, validated too by copious 'Silence is Suicide' evidence, presented over recent years by Bruce Lamb to the criminally complicit Manchester Police and state lackey's, such as Andy Burnham - doing business as Manchester mayor.

This document will be especially sent to the last known address of those who wish to try to obstruct justice, particularly the Isle of Man Attorney General, Walter Wannenburg, the Isle of Man Chief Constable Russ Foster and to Kate Brunner KC, who is heading up the fraudulent Isle of Man 'covid review'. In reality a cover-up 'enquiry'. An 'enquiry' solely set up to misdirect via false 'pandemic' presumptions. **Such an 'enquiry' under the irrefutable weight of evidence of deaths, as certified by the Organisation of National Statistics UK (ONS), should in reality now be: an impartial INQUEST.**

The early 'covid' deaths of 2020 were initially noted in the elderly on cruise ships, bathed as they are in high levels of electromagnetic toxins (5G) a technology permitted despite the precautionary principle. Sedentary ship passengers, often lack of exercise and maybe compromised by immune depletion through 'travel vaccines'. The variability in the often cited Lombardi 'hot spots', defy all science, driven as it was by money and other factors demanded of 'covid' compliance. On receiving *The Covid Con; A Wake*, the Isle of Man Steam Packet Chairman and shipping magnate Lars Ugland told me: *"the book was too intelligent for me"*. Recent newspaper articles admit 77 Brigade, the propaganda unit of the British Army used highly developed mass psychology tools - which worked on all manners of 'intelligence' in society.

This is a whistle blower document covering fraud, corruption, and criminality. It is the result of injustices over many years. It is written not just as an educational record for an Island and her people, which I love. It demands justice from you Karim. This record is freely put into the public domain without fear, nor does it seek favour, other than true justice. Nor is this document skewed in any way by financial considerations - it is written with clean hands, to be widely shared.

This document is to be read and understood as common parlance English - and not hidden language, nor false interpretations using necromancy nor inferred 'meanings' as favoured by lawyers in their

legal realm, of their private Bar society. Such people, should in reality be called legalers not lawyers, as they flout Natural Law for their unjust enrichment, under false oaths. Necromancy is why the black robe worshippers say: "all rise" in court - to raise the dead. Most are unaware the paper is the court. We cannot get justice whilst the *12 Presumptions of Court* are still unknown to most people. If ignorance is no defence in law nor should be trickery, fraud, or deception.

All dates as stated herein, are in the Gregorian calendar, a Roman imposition to cut us off from inherent circadian rhythms, along with their 12 months 'cycle' for the benefit of corporatism - while 13 months of 28 days is the natural order of things. This document contains both the micro and the macro to put the specific issues raised, into a world-wide context. The 'big plan' has been mapped out in Silent Weapons For Quiet Wars and in many others, not just The Kalergi Plan. Such pre-mediated collusion was never random chance but carried out to decades long plans, which have been exhaustive. Events unfolded as planned, as on the 18<sup>th</sup> October 2019 Johns Hopkins University invited a 'select' list to **Event 201** - 'miraculously' foretelling a major 'viral pandemic'.

We are now seeing many of the moving parts in an unjust enrichment, fascist control, prima facie evidenced, Depopulation Plan. One, that has fear and control and money as primary drivers in the denial of an Intelligent Universe. There is copious evidence for all claims in this document. **Please watch Bill Gates in his TED talk of 2009, saying: "if we do a really good job with vaccines we can reduce the population by 10 or 15%.** In other words: jab genocide of 1 billion or so people. Event 201, showed us the script for pandemic 1. We do not give consent for implementation of 'pandemic 2'. We demand that all State operatives shall recuse us from it and their eugenics platform technologies.

The hierarchy of this collusion is broadly, the: WEF (World Economic Forum), the WHO (World Health Organisation), The Club of Rome, and the Committee of 300 (also known as The Olympians), and others. They all work in lockstep to set scripts, dissipated from central command, handed down through: regions, to nations, to cities, to towns, to villages, and finally to the masses. These self styled 'leaders' are people who attend the Red Wood ritual sacrifices known as "The Cremation of Care", at Bohemian Grove. Recent world wide events were intended to hide a major banking crisis, a massive 'currency reset' under cover of 'covid' aided by digital tracking - to herald in, a New World Order. These seeming flights of fancy, are less so, when we see back in the 1980's the UK government finally confirmed that the 'trials' of 'weather modification' resulted in the floods in Lynmouth of 1952. They glossed over that 35 people were murdered by their governmental 'experiment'. Such experiments are known today as chemtrails and can be seen daily, if we look up. Normalised in Hollywood cartoons to condition our children.

**Follow The Money** - As of December 2023, Bank of Japan teeters on the edge of collapse while the 'FED' (Federal Reserve) printing presses have finally run out of steam, and any willing buyers of US\$ debt. Meanwhile in the British Isles, Baroness Michelle Mone, is embroiled in claims of a PPE fraud. The UK Government has a total bill which has topped £10 billion to store this 'PPE' according to The Telegraph of 7<sup>th</sup> December 2023. The UK Government is seeking to recover £130 billion for these 'gowns' from China in a June 2020 PPE Medpro contract, worth more than £200 billion. On Sunday 10/12/23 as promoted by Manx (State) Radio, Michelle Mone and her husband Doug Barrowman, released a 1 hour 11 minute film. Some people seem to have their own, official narrative supporting, media channel. But by the very next morning of 11/12/23 social media was awash with claims by the Doctor involved in the film saying he had been 'betrayed'. *It was the best of times, it is the worst of times, it was the age of wisdom, it was the age of foolishness.*

**Payment per jab** - The payments to GP's and nurses in the UK for 'covid' jab compliance, are obscured, hidden, and cloaked - and almost never mentioned on TV or in the press. Initially, GP's received £15 for each adult vaccine and £7 for each jab in each deceived youngster. £29 was payable on the 2<sup>nd</sup> dose. It is said £100,000 per practice was paid for 75% 'compliance' for 'jabs in arms'...

**Money** - makes the world go round. The US is one of the most vaccinated, but sickest nations, with poor infant mortality. All driven by an increasing vaccine schedule, which is free of legal liability. As a 1957 baby, my three vaccines compare sparsely with the 16 different vaccines, of upto 72 doses,

upto the age of 18 in the United States. As recommended by financially driven 'doctors'. **The vaccine sector is a \$60 billion/annum business but creates upto \$500 billion per annum in repeat, damaged customers.** I met Robert Krakow, a US lawyer in 2019 at Autism One in Chicago, who has spent over \$2 million since his son suffered serious, life limiting damage, after a 'flu' vaccine.

Also in Chicago I met with Andrew Wakefield, who was the first true doctor to question MMR vaccine toxicity, and the resultant gut health issues of people defined as 'autistic'. Yet, today being 12/12/23, on Manx Radio they still peddle the lies of toxic MMR 'vaccines'. As unsafe, a 'vaccine', as the scientifically illiterate (interim) Isle of Man Director of Public Health, 'Doctor' Hugo C van Woerden can extol. His radio appeal talked of 'rashes', falsely claimed to be 'measles' - the result of natural, growth spurt, cleansing, outfections. *STOP pushing vaccines on vulnerable one to three year olds - the jabs gives no protection, from anything.* Thank goodness Manx Mums are waking up and giving less jabs. It is child abuse, and you Hugo, are willingly complicit... I would absolutely love to face that shameless man in any court along with a process of full discovery.

**In May 2017** - I invited Dr David Healy author of 'Pharmageddon' and 'Let Them Eat Prozac', to address a Noble's Hospital educational session on mental health. He is famous for exposing during his June 2012 US testimony, the regulatory capture of the FDA even as far back then. When we met in February 2017 he cautioned me not to take on the HPV vaccine issue, as; *"it will destroy you"*, then he corrected himself, adding; *"no, they, will destroy you"*.

**De-banked** - My Isle of Man Bank business account was suddenly taken down, just as I had taken David Ashford, Manx 'Health' Minister during 'covid' to court. Yet, Ramsey branch bank staff couldn't cite any reason, nor would those staff show us their monitor screen for any evidence with a bearing on their instructions. In a letter received on 29<sup>th</sup> July 2021 'Customer Services, PO Box 13, Isle of Man Bank, Douglas, Isle of Man, wrote, in an unsigned, un-named letter: *'Dear Mr Heading, we have recently undertaken a review of the banking arrangements that you have with us. We have with regret, reached the conclusion that we will no longer provide these to you. The Bank requires that you make alternative banking arrangements within 60 days from the date (27<sup>th</sup> July 2021) of this letter.'*

Later, even my HSBC card was taken/withheld in mid 2023, by an Isle of Man Bank cash machine, for, no reason. A first, in my 66 years on planet earth, yet there were sufficient funds in my account.

## **HPV vaccines - the pre 'covid' era, vaccine harms, canary in the mine**

**In 2005** - Manx resident A, as a 15 year old took part in the HPV vaccine 'trials'. She has since lost her uterus and blames her current, ongoing medical harms, firmly on the HPV vaccine 'trials'. Her story can be repeated around the world, although the monitoring services, have been regulatory captured, for profit and power. She lives in my home town of Ramsey, Isle of Man, British Isles.

**In June 2013** - Japan cancelled their 'HPV' Vaccine trials after three months, due to safety concerns, resulting in many Japanese lawsuits.

**On 25<sup>th</sup> October 2017** - I visited the Westminster Houses of Parliament to meet with Amanda Dew Mother of HPV vaccine damaged daughter, who has had over 100 seizures. Also in attendance was Karen, an Irish Mother of another HPV vaccine injured daughter. Coincidentally, also there that day (from my contemporaneous notes) were Manx MHK's: Martyn Perkins, Alex Allinson and Graham Cregeen. I called out to Alex Allinson, my then GP: *"I am with the HPV vaccine objectors"*. A Sky News reporter was due to cover the event, but somehow didn't make it, despite promising they would.

**On 15<sup>th</sup> November 2017** - I met Isle of Man Education Minister, Graham Cregeen, and assistant Sue Mowle, at Hamilton House, Douglas, to raise my HPV vaccine harms concerns. Being naïve I allowed them to take notes, which, as I was later told by Sue, *'were lost'*. A big learning curve for me. Later, I sent many emails to Graham, highlighting my serious concerns, but to which I received no replies. (On Thursday 16<sup>th</sup> January 2020 Sue Mowle asked to *'be removed'* from my mailing list).

**In February 2018** - I met Dr Diane Harper Lead Triallist on the Merck Gardasil 'trial' who was due to speak at the 7<sup>th</sup> Hellenic HPV Vaccine Conference. She had been banned from speaking for many years... as she aired criticism of the deaths and harms caused by Merck's Gardasil vaccine. We met for three hours prior to her presentation, in Greece. She told me she was only allowed to speak if she did not mention the vaccine harms. She was told that the conference sponsorship would be pulled if she cast any shadow on the 'safe and effective', but false, HPV vaccine mantra. Sadly, criminal and complicit. Diane now runs the Diane M Harper Lab at Michigan University, peddling, fake, home-based screening techniques for 'HPV'... *On 22/12/2021, Diane emailed me: 'please remove me from this email list, dh.'*

**On 31<sup>st</sup> August 2018** - I emailed the Chief Executive of Manx Education, Ronald Barr, highlighting 'the crime of HPV vaccination that is taking place in your schools', copying in Graham Cregeen, Education Minister. I received no reply.

**On 3<sup>rd</sup> December 2018** - Dr Chris Exley, a researcher from Keele University, and known by many internationally as 'Mr Aluminium', presented about his vaccine ingredient concerns, at the Manx Museum, in an event I funded. Also presenting was US based Dr Sherri Tenpenny at my invitation, and on paying her \$5,800 of my own money, she came. I also paid £350 to hire the Museum. Chris was a snip at under £200 for flights. See the 90 minute film here of accumulated brain aluminium: <https://www.bitchute.com/video/9hxxiqeMvKuj/> Of course, what is unknown is that aluminium adjuvants, have never been tested for safety against a truly inert placebo. The job of an adjuvant is to stimulate 'antibody protection' which to this day no one has proven antibody specificity.

**On 4<sup>th</sup> December 2018** - A similar format morning event, to the evening before, was held in Ramsey Film Studio's, and an afternoon event on HPV vaccine harms, at the Manx Museum, Douglas.

**On 7<sup>th</sup> January 2019** - at 18.20, Manx GP, Dr Helen Freer wrote to 'courtenay@jurbywellness.im' - 'I have read the book 'HPV Vaccines on Trial' and have just started to read 'Fast Tracked and Flawed' (by Helen Lobato). *I am truly shocked by what I have read and fear that we could be sitting on a time bomb so I agree that this audit work is urgently needed on the Island.*' As of 6<sup>th</sup> December 2023 Dr Helen Freer (GMC number 6115015) is Senior Partner of Finch Hill GP Practice, Douglas. Helen examined HPV vaccine harms, and a colleague, retired GP Tim Anglin, wished to examine the UK data (see 10<sup>th</sup> April 2019 email) - on first glance he wrote *the evidence produced a 'red flag'*... On 28<sup>th</sup> September 2020 - however, Tim Anglin emailed: *'Hi Courtenay, can you please not send me any more emails.'*

**On 28<sup>th</sup> August 2019** - I wrote to Manx GP, Dr Helen Freer: *'Dear Helen I hope all is well. Please regard this as a Notice under Equity. Please confirm that you still stand by your retraction as stated below, as dated 28th August 2019. More harms have come to light on Island in the meantime. These will be made public. I give you 14 days to confirm. I also remain willing to meet to confirm my truth in an affidavit.'*

**On 28<sup>th</sup> Aug 2019**, at 13:14 - Dr Helen Freer wrote: *Dear Courtenay. Having done more research on the subject I wish to retract my previous concerns expressed to you. The information you sent me to read is powerful and compelling at first glance, however, it does not stand up to scrutiny. I wish you well, Helen: Dr Helen Freer MBCHB BEng Hons, Finch Hill Health Centre, Kensington Road, Douglas, Isle of Man, IM1 3FH*

**In August and September 2022** - I undertook regular 'HPV' vaccine harms leafletting of homes and business premises in each of five Manx senior school towns. I have hand delivered many thousands of Notice leaflets naming those guilty of 'covid' and 'HPV vaccine' crimes, but as yet, no one has sought to debate, nor take legal action against me - they just get the Manx police to call round. I have sent thousands of strong worded tweets (@courtenaymanx) and stand by the contents of every one.

**On 20<sup>th</sup> September 2022** - As Manx school teachers were aiding the administration of infertility and cancer causing vaccines at Ramsey Grammar School (RGS), I and a friend, were handing out HPV Vaccine Deaths and Harms 'Notice' leaflets at the front of the school. Notices, that named all five



Manx senior school Heads. Soon, Police Sargent Steve Gadman, arrived, mainly to stop free speech, at this calm event. On arrival, together with blue lights, Steve said he *'knew all about me'*. Which, was some claim, as we'd not previously met. My claim of criminal complicity in the 14<sup>th</sup> September 2022 Notice via in 'loco parentis' roles, still stands against: Keith Winstanley (Castle Rushen High School), Graeme Corrin (Ballakermeen High School, Douglas), Charlotte Clarke (Queen Elizabeth II High School, Peel), Chris Coole (St Ninian's High School, Douglas) and Sarah Findlater (formerly head teacher at Ramsey Grammar School). *For Sarah, see page 165 of The Covid Con; A Wake from 2020, where, three years ago we noted... 'However, any change in that role may find later, Sarah, that they are also criminally liable in their private capacity. Now, Sonia Taylor and Ben Eyres, act in 'supervisory' roles at RGS...*

On 9<sup>th</sup> February 2023 - I phoned former Isle of Man Chief Minister, Sir Miles Walker, who I have known for 14 years. I outlined the more than 40% reduction in Manx live births between 2010 and 2023, as highlighted by journalist Adrian Darbyshire. It is surely time to fully investigate the infertility induced by HPV jabs containing **Polysorbate 80** - an ingredient, which is patented as a product for dog infertility... Sir Miles was not willing to enter into a debate.

On 19<sup>th</sup> May 2023 - Adrian Darbyshire highlighted the 105 year birth rate low in 2022, in his Isle of Man Examiner, newspaper, article. But Adrian never asked why did this happen in the, never tested for fertility effects, during the 'HPV' and 'covid' vaccine era. In December 2023 Switzerland was confirmed as experiencing a 100 year, birth rate, low. The Swiss FOPH (Federal Office of Public Health) perpetuates the lies of 'HPV' viruses, of false transmission, and of the need for (infertility and cancer causing) 'HPV' vaccines.

**Vaccine Ingredients** - The following ingredients were obtained from the Centers for Disease Control and Prevention (CDC) website in June 2018, (US spellings) Epidemiology and Prevention of Vaccine Preventable Diseases, 13th Edition, with the following ingredients which are taken from the manufacturers PIL (Patient Information Leaflet) for the HPV Gardasil 'vaccine', which sadly, the unsuspecting, don't read: *vitamins, amino acids, mineral salts, carbohydrates, amorphous aluminum hydroxyphosphate sulfate, sodium chloride, polysorbate 80, L-histidine, sodium borate, yeast protein.*

Worse still, these 'ingredients' enter the body unnaturally, injected through the skin, our largest organ - rather than the natural route of ingested ingredients, via the mouth. It is this anti-science when bypassing our natural filters: of lungs, liver and kidney's that so harms us. When you inject toxins, any resultant anaphylaxis, is because our inbuilt immunity can't naturally vomit - the injected ingredients are viewed as 'enemy', a toxic foreign 'other' invader, not a friendly particle. Anything, in nature that punctures the skin of another, is intended to be harmful, or deadly: snakes, scorpions, bees, wasps. We have to unlearn the 200 year frauds of Edward Jenner (and of Louis Pasteur, a sadistic, animal 'trial', torturer and inventor of the 'rabies' fraud). Polysorbate 80 is patented for dog infertility, so what is it doing, unquestioned, in a vaccine, that is administered to the young of the Isle of Man? Further cause for concern 'vaccine' ingredients include bodily matter *from live aborted babies: HEK-293, MRC-5, and WI-38 cells. With WI-38 being from the Wistar Institute, the 38<sup>th</sup> baby to be experimented upon, cell line... immortal 'cell' lines, some say.*

The never spoken about **vaccine ingredients in 'covid' jabs include: graphene oxide, nano particles, toxic to body, assimilating hydrogels, and as seen under many microscopes, self-assembling entities, resembling micro-chips and circuitry.** It is these various inorganic materials that are causing foot to groin blood clots, as never seen prior to 2021, by US Embalmer of 20 years, Richard Hirschman, and others. (refer Spectator Australia 5<sup>th</sup> November 2022 article by Rebecca Weisser, in interview with David Nixon).

### **There are many 'mRNA' injectables 'patents' - driving trans-humanist agendas.**

**The nasal swab** - the 'testing' stick was curiously buried deep into the nose, to sample a claimed, free moving, in air, 'virus'. The nasal cavity was assaulted by dirty, sweat shop labour produced, swabs, containing DARPA hydrogels, brittle nylon, and dipped in ethylene oxide (EO), a known carcinogen. From 2020 a small javelin, was being inserted towards the normally, skull protected, brain.

**Masks** - As no particle existed, we should not waste much time reading the 97 page document on the uselessness of masks. We must stay upstream, with the no 'virus' reality. That is all that is needed.

**Just six words** - 'No virus', No 'test', No 'contagion' encompass the whole book, the 201 pages of: The Covid Con; A Wake, published three years ago, today. The words remain true. However these simple six words are SO hard for people to take in. They destroy every notion of false 'diseases' and 'cures'.

**No Virus** - A disease causing contagious 'virus', to be so called, must cause a well person to be sick. See the never fulfilled Koch's Postulates for 'virus' evidence. No 'scientists' have ever extracted a specific particle, a 'virus', from all other parts of mucus that can cause a well person, to be ill. Instead, they take mucus, add it to animal cells, add toxic chemicals, reduce the nutrients, then claim the break down artefacts are 'viruses'. But with different brews, and testing techniques, they create different 'variants' or 'strains'. The perpetuated, false basis of 'virology', goes back to John Franklin Enders in 1954 - and more recently, false claims by Isle of Man MHK (with PhD), Michelle Haywood.

**The 'virus' myth** - is encapsulated by retired US Doctor, Tom Cowan: *'If someone can actually show me a so called 'virus' attaching itself to a cell, injecting its genetic material into it, and the cell then bursting open releasing thousands of new 'viruses', or taking a so-called 'virus' by itself and exposing a person or animal to it via the presumed mode of entry and causing the illness it's alleged to cause, I will gladly change my position on it, and admit I was wrong. So far, no one has been able to do either'*. Tom wrote the seminal book: 'The Contagion Myth' which opened many eyes and minds to fake 'virology'.

On **18<sup>th</sup> February 2021** - the Isle of Man Department of Health and Social Care FoI (Freedom of Information) reply (reference number 1646813) to Steven William Gardner admitted they could not cite any SARS-CoV-2 'virus' evidence, and most crucially that the PCR 'amplification' used a clearly fraudulent 45 cycles. **Cycles, simply, which invented a mass of Manx casademic 'covid cases'**. Dr Kary Mullis, credited with inventing the process, (never a certified 'test') warned of its' cycle misuse...

On **13<sup>th</sup> May 2021** I recorded an 18 minute 'no virus' video with US based Andrew Kaufman, MD <https://www.bitchute.com/video/DWqulaZuLuzw/> This video explanation by Andrew, explained the largely unknown basis of all 'virology' fraud, based, as the science is, on culturing 'viruses' on monkey kidney cells, calf serum, other nutrients, plus anti-biotics; amphotericin and gentamycin.

Then 'scientists' reduce the nutrients to the cell 'natant brew', causing the contents to break down and die, resulting voila... in all 'viruses' particles. The toxic to kidney cell, antibiotics, have their key, unnatural role, in creating this toxic brew. That brew is then pipetted and put into a 'PCR' software machine, and amplified/doubled, and doubled, and doubled again, in up to 45 cycles, *creating 34 trillion 'pieces'*. **The 'resultant' pieces are then 'assembled', and 'aligned' and 'smoothed' until they make a whole 'genome' - an invented computer, never existing in reality, one.** Next, the pretended 'virus' soup is viewed under an electron microscope as a 'virus' - one that was never present in the shape nor size, originally. The fraud of Virology since 1954, has perhaps 100,000 peer 'reviewed' Papers - but where no 'peers' ever looked at the basic, independent variable, no controls, 'science'.

On **9<sup>th</sup> December 2023** - the email below was received from data researcher Christine Massey, confirming the lack of any 'virus' evidence: *To date Christine Massey of Canada and her colleagues have asked, via freedom of information, ministries, departments and boards of health, universities, regulators, infectious disease institutes and other institutions to provide/cite all held records of the alleged 'SARS-COV-2' being found in sick "hosts" are prepared (purified) for sequencing, characterization and valid scientific investigation. To date, all 220 queried institutions across 40 countries have failed. Further, all institutions queried in the same manner, including the CDC, failed to provide/cite the same for dozens of alleged viruses including 'HIV', 'HPV', 'Ebola', 'Zika', 'Polio', 'Measles' and 'Smallpox'. Christine has previously supplied an Affidavit to testify these 'no virus evidence' facts and she remains willing to do so again for the International Criminal Court, when required.*

**No Test** - The Corman Drosten PCR 'test' never used an actual 'virus'. A basic fact which is unknown to 99.999% of people, many of whom were later deliberately tricked, by the State, into being injected with poisons. The CDC relied on a likewise fraud, with what they later admitted, was a '*mimic virus*' for their 'covid' claims. **The CDC 'virus' was simply another in-silica, computer: 'assembled', aligned' and 'smoothed', imaginary... 'virus'**. For which there can, obviously, never be any 'test'. From 2020 onwards, the 'scientists' continued to create 'lineages' and 'variants', and 'strains' dependent on 'cycles' and their computer 'particle assembly' techniques. It was a full on, world-wide, fake, 'covid' case-demics. It is only real scientific scrutiny which will expose the truth, not tame, anti-science, Tynwald 'committee' hearings - which have taken place to date, on the Isle of Man. Hence, this demand to the ICC to view all data, method statements, and assumptions, and not as so far, the cherry picking of 'facts' for deliberate, money driven, deceptions.

**No 'contagion' or 'transmission'** - this is the greatest fallacy of 'virology', of harmful, spreadable, physical particles. You can't give poor health to people via a harmful 'pathogenic' particles, miscalled a 'virus'. But you can when there is money, and reputation involved.

**Spanish Flu** - was the major 'catchable disease' false claim, of the early 20<sup>th</sup> Century. It sought to repeat, via fear, the 'contagion' and 'transmission' myths. This was a century before Dr Rosalind Ranson, former Isle of Man Medical Director, relied on her 'scientific' frauds of 'transmission' claims, in attempting to 'lockdown a whole Island. But, if you study landmark research of Milton J. Rosenau, MD and his '*Experiments to Determine Mode of Spread of Influenza*' published in 1919, in the Journal of the American Medical Association, you will never believe in any 'transmission' of any 'thing' again. For the last 120 years true scientists have tried to validate the 'contagion/transmission' of claimed 'pathogens' - but none have succeeded. In all, 50 studies have attempted to prove what the man in the street fervently believes - but he, or she, is simply wrong - unresearched in 'flu' and 'infection'. A private South African, 'DPL', as he is known, has all the failed 'transmission' studies evidence, for the ICC. Whenever they seek it.

On **1<sup>st</sup> April 2020** - the first 'covid' death was reported on the Isle of Man. Meanwhile, the UK's first 'covid' jabbed man was said to be William Shakespeare, no, not that one. This very dark agenda, has a sinister, macabre, and deliberate theatrical ridicule of the masses, at its' very cold 'heart'.

**Red flags wavers on 'covid'** - are not limited to: Australian Senator Gerard Rennick, Naomi Wolf, Andrew Bridgen MP, Steve Kirsch, Dr David Healy, Dr Peter Goetsche, Dr Aseem Malhotra, Dr Mike Yeadon, Dr Peter McCullough, Dr David Martin, Dr Judy Mikovits, and Dr Lee Merritt. But all, as if in a concert party, have harmoniously avoided giving voice to the reputation shredding, no 'virus' reality. Some even peddle a Wuhan 'lab' leak/bat anus, 'gain of function', theory. *Gain, of fiction, more like.*

**My Bio** - Having not visited any GP since February 2014 (and only then to 'sign up' when I moved), as *I thought, back then, I needed a GP.* I have now removed myself from their medicalised, repeat customer, disease mongering (for profit) system. Are we well, without them? Well enough, in my case, in August 2019 on the Isle of Man, as a 62 year old, to become the 1,207<sup>th</sup> Centurion individual, to walk a certified 100 miles in under 24 hours. Whilst blister free, and adhering to a high fat, low carb, diet).

If we study medical mantra's, including the 1939 Cancer Act UK, we are mired in old 'science' which by legal means and heavy enforcement, restricts 'patients' to using outdated, barbaric and brutal 'treatment' methods. When we look at 'cancer' screening, we find it is a fraud, one borne out by three countries (Canada, Denmark and Sweden) which compared their *breast screened women, versus the unscreened*. Those countries found that the unscreened women lived longer, when compared with the breast 'screened' women. Cancer, and cancer funding is a rinse and repeat: "*beating 'it' sooner*", model. Their five year 'survival' claim is a statistical, disease mongering deception, as the 'found cancers' weren't ever real, in most cases.

There was also the 'Factor 8' and tainted blood scandal of the 1970 and 1980's. It came to kill many, not just people falsely claimed to have 'AIDS', and haemophiliacs. It is the same false paradigm with 'diabetes', there are simple solutions - "*reduce the carbs*" we should suggest, or point people to the: two week, reduced sugar diet, for 'diabetes' reversal by Dr Roy Taylor of Newcastle University. Some say the 'diabetes' issue is glucagon (not insulin, as so beloved of business as usual, Dr Emran Khan).

After investigating statins and anti-depressants, the lies of: 'polio', small pox', 'rabies', 'AIDS', and 'covid' were easier to spot. We really should look at what makes us well: clean food, clean water, and decent nutrients. Terrain Reality makes us well, not the fears of 'germ' theory and outside enemies. Exposing dangerous, false notion, 'science' mantras and presumptions, drives many of us to seek truth, beyond the '*Settled Science*'. Many medical assumption are unsoundly based, like 'nice' carbs, but demonised fats. Dark regimes can often hide behind 'national security', that of 'Crown Protocols' - a process that endangers the lives of the people, and leads to major neglect of our most vulnerable.

For three years from December 2013 I co-organised three day ManxBioMed Conferences, over 100 international delegates attended each year. Our focus was medical devices, regulation, and natural botanicals - but plant based medicines were soon blocked by the Manx government, as they flew in the face of big PHARMA, and their repeat customer, chemical prescription model.

In **2014** - Medical carnage was first flagged to me by Noble's hospital Cardiologist, Dr Jan Tibitanzl. Jan called, saying: "*we have another Mid Staffs on Island*". At Mid-Staffordshire NHS Trust around 3,000 - 4,000 people were dispatched on the cruel, end of life '*Liverpool 'Care' Pathway*'. That night, Jan and I met with Minister John Shimmin, with whom I was working. The Mid-Staffs report finally settled on an 'acceptable' deaths figure of '1,000' people and former GP Lynne Hulme (with homes in England and the Isle of Man) was involved as a Caldicott Guardian/overseer. But Lynne Hulme is still uncomfortable releasing full truth. Likewise John Shimmin, when he related... "*what went in the Manx West Midlands Care Quality 'Review' is but nothing compared with what was said behind closed doors*".

As a Healthcare Innovation Consultant (from 2012 to 2016) I worked with John, former MHK, and Minister in six Departments. I worked with John in the Department of Economic Development and later, in the Cabinet Office - where he headed up the wildly claimed 'Policy & Reform'. One Manx civil servant I encountered was the weak and indecisive Dan Davies, who is now Chief Executive in the Department of Home Affairs, with a £30 million budget. It was Dan (and Will Greenhow, then Chief Secretary in the Cabinet Office) who thwarted a project to introduce psilocybin to help hard to treat chemicalised people, trapped in severe depression. The joint proponents of the project finally gave up on Island after 20 Manx visits - yet, within three years, their company floated for \$1.3 billion.

In **2015 and 2016** - I was a regular visitor to the fine home of Pamela Shimwell-Mayo. Pamela had for many years championed the *Parkinson's Disease Society Isle of Man*. I was a welcomed visitor, welcomed, that was, *until I explained that 'flu vaccines', very often later, induce Parkinson's* - similar to resultant, post jab, 'autistic' and 'Alzheimer's' people. They are, expected outcomes, of injectable toxins. About which, there is very ample evidence. When we look.

In **May 2015** - I met Dr Henrietta Ewart, a non-practising 'health' specialist, newly appointed Isle of Man Director of Public Health, via Dr Barbara Hurt. Barbara had come back to work in Manx Health to care for her ailing Father, and as a result of my education, Barbara did not HPV vaccinate her daughter. But by 2016, Barbara had left the Island, and was working profitably, in Singapore, as she

was now rebadged as 'Professor Barbara Helen Rosario'. Barbara continued to 'flu' vaccinate her frail, elderly patients, about whom she was said to care. Meanwhile, in December 2017, true to callous form **Henrietta Ewart emailed me: 'neither I, nor any of my team will attend your (HPV) events'**. It is as if Henrietta was hand-picked for her role, joining a long list of the ex-health obscured - as is the repeated Manx way: just like Malcolm Couch, ex 'Health' CEO, and after him, Mark Charters.

On **16<sup>th</sup> June 2016** at a meeting in Jane Crookall House, Douglas, I asked then CEO of Health, Dr, but never a medic, Malcolm Couch (former head of Manx tax) "*can I debate statins, vaccines, and anti-depressant harms in a public meeting with you*". **Malcolm paused, and slowly said: "we wouldn't allow that"**. It was his use of 'we' that told me my time as a Manx Government health care consultant, was done. Within six weeks I had left - but only slightly missed the decent money I was then being paid.

On **7<sup>th</sup> December 2018** - I was asked to present my vaccine and statins and anti-depressant harms evidence to the Manx Parliament Tynwald Social Affairs & Policy Review Committee. They listened, offered pacifying words, but did nothing. It was recorded on Hansard (on the Parliamentary record).

**Claims of 'rabies', as the Vets are in denial** - Pasteur was a fraudster, when you read his cruel 'method statements', as he injected toxic particles into the brains of dogs, tied them to a post, and kept them short of food, and water. How is that proof of 'transmission'? Sadly, I used to vaccinate my dog until five years ago - now my dog has no jabs at all, and he is thriving well, into his 15<sup>th</sup> year.

**Impact Statement** - My years long, harsh treatment by State concert parties, affronts natural justice, more so since I was a welcomed whistle blower first on financial affairs, where others dare not speak out, in 2012. Targeted malice by State actors is clear victimisation. It has had a material and harsh and unrelenting effect on me, and my Wife. It would have broken a less resolute and fit man, and despite me having the loving support of my Judy, for which I am eternally grateful. For long periods I admit to being very hair triggered, short fused, and with an ungracious and overly sharp tongue. But I have never been violent, due to many long walks in Mother Nature, to sooth, perpetual, mental & spiritual pain when seeing complicit, wilfully ignorant Manx medics, politicians, police, and especially heartless, censorious, Manx media. All such people have acted for years with impunity and without their just punishment. The cost to us has been physical and financial, being unemployed, since 2016. But as my Father said when I was young: *'money is just a tool'* - but a useful tool, with which, I paid \$6,000 of my savings, to host the 3<sup>rd</sup> December 2018 HPV vaccine harms event at the Manx Museum (a 90 minute film is available). When I was eight, my Father also said: *"remember son, in life, you are on your own"*. Child abuse to some, but true wisdom, to others, with ears to hear.

**Remember The Critic** - my mentor & long distance walking partner rebuked me on Sunday 10<sup>th</sup> December 2023. He felt it was a waste of time presenting any evidence into the private society 'legal' realm. But, on a road less travelled, we must re-read this poem, entitled 'The Critic' - and, with new optimism, demand an INQUEST into the causes of the 'covid' jab harmed, the families, and countless innocent victims, maimed and murdered: *"It is not the critic who counts; not the man who points out how the strong man stumbles, or where the doer of deeds could have done them better. The credit belongs to the man who is actually in the arena, whose face is marred by dust and sweat and blood; who strives valiantly; who errs, who comes short again and again, because there is no effort without error and shortcoming; but who does actually strive to do the deeds; who knows great enthusiasms, the great devotions; who spends himself in a worthy cause; who at the best knows in the end the triumph of high achievement, and who at the worst, if he fails, at least fails while daring greatly, so that his place shall never be with those cold and timid souls who neither know victory nor defeat."*

**Police crime investigation obstructers** - often, obstruction by all police and other parties acting in concert, has delayed medical investigations for many years. One dreadful example of justice delayed in England, is scrutiny of the Gosport War Memorial Hospital where over 400 people were State murdered. It is a police 'investigation' which has stretched back over 25 years, into the last century. Every time a public event is held, the police, yet again, claim to be making *'good progress'*.

In the 'covid' vaccine era and the growing clamour for justice and decent treatment of the maimed and murdered, vents are finally moving rapidly in many countries. It is only a matter of time before the International Criminal Court will have to act. The Manx Constabulary have been repeatedly, criminally obstructive, and for now, from Chief Constable Russ Foster, down.

On 16<sup>th</sup> July 2020 - Isle of Man Constabulary, Professional Services Manager, Paul Bryan was invited to visit my home. My Wife sat in on the meeting. **Paul said his daughter had suffered cervical cancer after her HPV vaccine but she was 'private', so, 'would not go public'**. Paul has since retired from the Manx police force. Paul was the official author of the 22 page Manx Police Ethics Code, of 8<sup>th</sup> May 2017, which sadly has been wilfully ignored by each of his Manx police colleagues ever since.

On 11<sup>th</sup> Dec 2020 - at Police HQ, Douglas, I delivered (film available) half a dozen copies of my book 'The Covid Con; A Wake' for educational purposes - to Police woman Emily Perkins. Her demeanour was reluctant and dismissive. Perhaps, she took a 'vaccine' as a good and dutiful order follower. She is the daughter of our former family friend, and politician, Martyn Perkins, MHK. My visit to Police HQ was prior to a book launch event the next day. **The police cannot claim they were not informed.**

On 1<sup>st</sup> February 2023 - I approached Policewomen Louise Kennaugh (#206, on 'X' Louise goes by 'PCLou206') and Lisa Fitzgerald (#337) at the Douglas NSC (National Sports Centre) where we spoke amiably. However, negating the oath to serve the people, both criminally refused, witnessed by the other, to investigate any 'covid' crimes. Later, I met with Castletown based police man Jim Sanderson (#105), yet he too refused to allocate a 'covid' crime number. Jim said: *"if Chief Constable says 'no crime' I have no facilities to report one"*. Jim, also refused to give me his family name, which I later had to visit his colleague in Castletown to establish - one of the few pieces of hearsay in these pages.

On 9<sup>th</sup> February 2023 - Former Chief Constable, Gary Roberts, emailed me: *'Courtenay, I have explained several times before that we will not be registering a crime report for anything to do with properly authorised and administered vaccinations. You know that this is the case and you continue to waste our time. Please refrain from doing so and please stop communicating with me. Gary Roberts, QPM, Isle of Man Constabulary.'* Gary makes two false claims, which must be fully scrutinised, fully impartially, by the ICC. **While, on 9<sup>th</sup> March 2021 in the Isle of Man Examiner, Chief Constable, Gary Roberts pleaded: 'move us up the jabs queue'... He would know that: ignorance is no defence in law...**

On 16<sup>th</sup> July 2021 Detective Inspector Gavin Callow was recorded on film with me, by a friend, outside Police HQ. It was published on 17<sup>th</sup> July 2021, lasting 12 mins 30 seconds. After an initial conversation, and as we on exited police HQ, there was a picture of who I believed to be Richard Lloyd, a former Manx police sergeant - claimed to have been the 2<sup>nd</sup> man to have died on Island from 'covid'. I commented *"that man did not die of covid"*. Gavin responded *"that's not for now"*. I knew then, I would get no justice from Gavin, a stone walling man, a 'not my job' specialist, treading water until his 2023, retirement. The false narrative of 'covid' and 'viruses' was compounded by then, Chief Constable, Gary Roberts who said he was *"heartbroken"* and that Mr Lloyd was a *"giant of a man who has been taken by this wicked virus"* (a film of the 16<sup>th</sup> July 2021 recording is available).

On 8<sup>th</sup> May 2023 - At Police HQ Douglas I attempted to present 600 pages of evidence (film 16 minute 21 seconds film is available) in which, from 6 minutes in, please see: *'Inspector Barker Oscar 4'* and *'Sophie Watterson-Jones'* in criminal collusion to stop evidence being lodged at Police HQ for proper investigation. Inspector Barker instructed Rob Fletcher, the front desk administer not to take the package of evidence. There were two witnesses, Neal Storey and Al' Morrison. This 'extensive covid' crimes evidence bundle had been previously filed under my crime number JS435946946GB. Earlier, on 8<sup>th</sup> May 2023, ManxCare had finally highlighted in public, the need for a Manx vaccine injured service on Manx Radio.

**Enter The Prosecutor, in Italy...** As exposed on yesterday, 11<sup>th</sup> December 2023, on German RTV Aktuell and PharmaFiles: *in Rome, Italy - High-ranking officials, including Roberto Speranza, Italy's Health Minister during the height of the pandemic, are the subject of an investigation by the*

Rome Public Prosecutor's Office. The probe stems from what has been a series of startling revelations concerning the handling of COVID-19 vaccine safety issues by the Italian Medicines Agency (AIFA).

The former director of AIFA, **Nicola Magrini**, is also entangled in the investigation. The allegations are severe. Both Speranza and Magrini are accused of consciously deciding to put the Italian population at risk by not only pushing on with vaccinations despite known dangers, but also mandating them for specific workforce sectors such as teachers and police officers. **The current investigation will delve into claims of murder and severe bodily harm to over 4,200 individuals who report experiencing harm from the vaccinations.**

**In Germany 'Crimes Against Humanity' on Sunday 10<sup>th</sup> December 2023** - from my friend Joska: "we've had an eventful day in Karlsruhe today. There were 6,500 people at a demo outside the German constitutional courts. Our team of lawyers lodged an official criminal complaint for Crimes Against Humanity. The case was lodged against all 599 parliamentarians who voted for the mandatory vaccination for medical workers. With my team of Mitteldeutschland TV, I went around conducting interviews among the participants. That was followed with interviews of lawyers and medical workers, who delivered relevant speeches off the stage. **This is the first phase for a process that will end in the international courts for war crimes in the Hague.** I am knackered now. It was a great day".

**Persecution** - The ICC Statute defines persecution as 'the intentional and severe deprivation of fundamental rights contrary to international law by reason of the identity of the group or collectivity' (Art. 7.2. g of ICC Statute). The Statute of the International Criminal Court (ICC) that was adopted on 17<sup>th</sup> July 1998 and entered into force on 1<sup>st</sup> July 2002. The ICC Statute defines persecution as 'the intentional and severe deprivation of fundamental rights contrary to international law by reason of the identity of the group or collectivity' (Art. 7.2.g of ICC Statute). The ICC has jurisdiction over individuals accused of genocide, war crimes, and crimes against humanity, after certain preconditions have been met. Freedom from persecution is vital to the well-being of individuals in society and to their enjoyment of the rights to which they are entitled. Under international law, persecution is a crime against humanity.

**Harassment** - is subjecting someone to unwanted conduct which is either related to a relevant protected characteristics (race, sex etc) 'where the conduct has the purpose or effect of violating the victim's dignity or creating an environment that is intimidating, hostile, degrading, or humiliating' as defined in LexisNexis, the law reference data base. There are nine protected characteristics, in my case, being: 'religion' or 'belief'. But, supporting evidence makes my views, not merely 'man in the street' simple and unscrutinised 'beliefs', but ones of properly researched, scientific knowledge. I am willing to be challenged in court, under penalty of perjury. Repeated police actions in and around my home are deliberate, targeted malice, and discrimination - with State sanctioned conduct whose sole purpose is to create fear and trepidation in daily life. Over time, as truth emerges, it is a price we must pay under constant duress, if these mass crimes are to be exposed, and finally, ended.

On **23<sup>rd</sup> March 2020** - Manx policeman Mark Hemsall and Manx police woman Rebekkah Ringham called at my home at 11pm, to insist I not visit the Chief Minister (video available). Earlier, during 'covid' lock down, I had delivered five free copies of my 1<sup>st</sup> book 'From Health Heretic To Common Law Advocate' to the wife of then Chief Minister, Howard Quayle, MHK. I had worked with Howard, when he was 'Health' minister, and I, a consultant, to the Isle of Man Cabinet Office. Now, more than three years on, in late 2023, Mark informed me that he has had seven jabs, including 'flu', 'covid' and 'boosters', but he is "not planning to have any more". Good.

On **27<sup>th</sup> August 2021** - Policeman Joshua Dixon (#61) and Police woman Rebecca Cowin (#92) called at my home in Ramsey, on a trumped up claim from IoM Government employee Dr Rebecca Rowley, who claimed 'I had been to her home'. An unscrutinised lie, as I know not where she lives to this day. (I had encountered Ms Rowley in my 2016 Government role, and she was cordial back then, before, of course, her fake 'science' was called out).

It was not just the police, via their unwarranted attention, but others too, in the 'covid' cult, who were triggered, when we stood in Justice For Jabbed T shirts at different island locations, for 18 months.

On 7<sup>th</sup> September 2023 I emailed Allen Corlett, of Corlett Building Material's in St John: regarding his cement mixer driver... *Yesterday lunchtime, while attending my dentist in Tromode I parked my car, and on returning, a yellow cement mixer emblazoned with Corlett's on the side, was being cleaned down by the driver. I engaged a construction worker in pleasantries, especially about the 19 tonne concrete load the cement mixer carried... and despite getting a soaking during the 'chute clean', I remained calm and measured. What happened next shocked me into silence. The man cleaning the chute, for no reason, called out to me: "has no one tried to run you over in Ramsey", and then, "I could turn you into speedbump".* I was beyond shocked, as it would seem my offensive, 'Justice For Jabbed' T shirt, had 'triggered' him.

Not just physical threats, but people in my home town, and on 'X'/twitter, calling me a paedophile - thinking that, disgusting name calling, and untrue character assassination, will put me off. Not at all.

**Quotes** - In reply to my question on the existence of 'viruses', **Robert F Kennedy, Jr**, a US Advocate, sent this reply by text message on 31<sup>st</sup> January 2023: *'Dear Courtenay, I don't take a position on this issue and I don't have the bandwidth to make myself an expert. As a lifelong advocate, I also understand the strategic pitfall of taking a position, even if it is technically correct, that will marginalize one so badly that one will become ineffective on every other issue. Lincoln always abhorred slavery but he did not publicly oppose it until 1864 when the country had caught up with him. If he had endorsed emancipation earlier, he would've lost most of his support for the civil war among urban whites in the northern cities and slavery would have never ended. Timing and a sense of the public pulse are important to successful advocacy. I do not take a position that viruses do or don't exist. I support the rights of people like you and Tom Cowan to argue that they do not and I listen to your arguments with interest. But I do not endorse either point of view for the two reasons that I mentioned above. I admire your courage and your intellectual integrity and I encourage you to continue educating the public.'*

**Christine Anderson** - German Member of the European Parliament, in a 17 second interview says: *"this vaccine campaign, it will go down as the biggest scandal in medical history"*, as can be seen on the Justice For Jabbed website.

**Richard Horton** - former Editor of The Lancet: *'the case against science is straightforward. Much of the science literature, perhaps half, may simply be untrue. Afflicted by studies with small sample sizes, tiny effects, invalid exploratory analysis, and flagrant conflicts of interest, together with an obsession for pursuing fashionable trends of dubious importance, science has taken a turn towards darkness.'*

**Edward Dowd** - author of 'Cause Unknown', in early 2021 said: *'I started hearing alarm bells and unusual stories of young, exceptionally fit athletes dropping dead on the field of play. If those who are the healthiest among us are suddenly dying, what would that mean for the rest of the population? In other words, what if healthy young athletes are the canary in the coalmine? But then in 2021 the stats people expected, went off the rails. The CEO of OneAmerica Insurance publicly disclosed that during the 3<sup>rd</sup> and 4<sup>th</sup> quarters of 2021 death of people of working age (18-64) was 40% higher than it was before the pandemic. Even a 10% increase in excess deaths is a 1-in-200 year event but this was 40%'*

**Dr Mike Yeardon** - is a former Lead Scientist at Pfizer. He said it was too late to save anyone injected with a Covid-19 vaccine. He urges those who have not yet received the injection of deadly compounds to fight for the continuity of human beings and for the lives of their children. The world-renowned immunologist goes on to describe the process that he believes will kill the vast majority of people who are now alive. *'Immediately after receiving the first injection, about 0.8% of people die within two weeks. Survivors have an average life expectancy of 2 years, but life expectancy decreases with each booster injection. Complementary vaccines are being developed to cause the breakdown of specific organs, such as the hearts lungs and brain'*



The forthcoming legal challenge faced by me from Dr Rachel Heather Glover former official Isle of Man Government PCR 'tester', is due in the Manx Court on 15<sup>th</sup> and 16<sup>th</sup> January 2024. Well behaved public are welcome to attend to hear all the evidence. Rachel has claimed for years, to be a PCR 'test' expert. But, there has never been a certified 'test' for any 'covid disease' - there cannot be as there is no 'virus'. These quotes from and to Rachel in her cited 4<sup>th</sup> October 2022 'tweet', are illuminating...

@DrRachelGlover tweeted at 9.11 on 04 Oct 2022, Just a quick FYI for my Manx followers: *Courtenay Heading is sat in Cycle360 in his "Justice For Jabbed" T-Shirt. My recommendation is not to engage...*

@Pluglug1 tweeted 22 minutes later, replying to @DrRachelGlover: *You don't support people who have been injured by a vaccine they were told was safe and effective?*

@Moriarty\_J tweeted 7 hours later: reply to @DrRachelGlover and @AmyL\_IoM: *If only a friendly farmer could have a slurry accident on that corner...*

### Five Arrests...

On Friday 5<sup>th</sup> July 2019 - on Tynwald Day, while wearing an 'HPV Vaccine Deaths and Harms' Yellow Vest I was arrested, to remove me from public view. Ironically, it is said, Tynwald Day is our defined Manx National Day of doleance/grievance. I had been prepared to hand in my prior 'approved' Petition of Redress, at Tynwald Hill. The event was attended by Dr Sherri Tenpenny from the US as Sherri is a researcher into vaccine toxicity. Kim Mack Rosenberg also attended as Kim is a US Lawyer and co-author of the 500 page book: *'The HPV Vaccine on Trial'*, along with Mary Holland. Mary is the legal counsel to US based 'Children's Health Defense', working closely with increasing vaccine sceptic, life-long environmentalist, Robert F Kennedy Jr. (23 minute film available).

On 12<sup>th</sup> July 2019 - while travelling in CLC JURBY (during my 'common law' days) the arresting officer was Stephen Hall (#212) who was standing in the road at Windy Corner. Later, for some reason, Stephen attempted to pretend it was Matt Davison (#313) who had actually stopped me. Manx policeman Stephen Hall was attempting to pervert the course of justice when he wrote to me in October 2019 claiming it was Matt Davison who had stopped me. I later phoned Matt for his clarification and he recalled when I laid out the facts, *"yes, I was most definitely behind you"...*

On Monday 6<sup>th</sup> July 2020 - Another Tynwald Day, and I was arrested again while wearing an HPV Vaccine Deaths and Harms Yellow Vest at Ballacraigne cross roads, 400 yards from those attending Tynwald Day. The arrest was claimed to be under an outstanding warrant, 11 months old to the day, for an unpaid fine. Today of all days, they chose, dressed as I was again, highlighting vaccine deaths, on our day of protest. (Refusing to pay, I spent six days in jail at Jurby, until a friend paid the fine).

On Thursday 25<sup>th</sup> May 2023 - Manx policeman Steve Gorry, had jumped the gun as *'equity does not aid a volunteer'* and didn't need to hand cuff me - (as former police colleague Matt Davison said at the 6<sup>th</sup> July 2020 arrest). Colin Simkiss a shop proprietor witnessed this rough, deliberately intimidating arrest. Afterwards, when accompanying me to my house Steve wilfully chose to ignore the Notice on my front door, clearly directed at private corporate employees looking to do business, such as the private corporation Manx 'Constabulary'. The related 'court case' is on 15<sup>th</sup>/16<sup>th</sup> January 2024.

On Saturday 17<sup>th</sup> June 2023 - Sarah Hay, had made a claim of 'harassment', so I was arrested. I had raised the issue of toxic HPV vaccines the day before in a Ramsey street *exchange of words* as Sarah is a 'science' teacher at Ramsey Grammar School. I was hand cuffed in the street, outside my house as neighbours walked by. My Wife was in tears as I handed her our dog... It was excessive with two vans and three police in attendance, and was humiliating. Arresting officer Lucy Wilson (who has since left Manx Constabulary) together with Ellie Roberts (#106) and Mark Hempsall (#287) later engaged in the process of finger print taking, under threat of force. There was a complete lack of State sanctioned safeguarding. I will make specific police claims under the Isle of Man Human Rights Act 2001 of abuse due to denial of toilet breaks. In my later 'court case' I was fined £1,000...

## Each MHK / MLC should be asked “are you lying” ...

The Isle of Man Tynwald Parliament claims to be the oldest continuous Parliament on earth. It is therefore sad to see breach of trust, and treason, in plain view. Isle of Man MHK's earn over £65,000 per annum of public money and the Chief Minister over £84,000 plus generous expenses. For six years, almost every MHK and MLC has been put in knowledge of a range of 'medical' harms, of vaccines, statins, and other chemical poisons. Evidence consisting of: thousands of leaflets, hundreds of letters, thousands of emails, web blogs, and public event notifications have been circulated. All supported by frequent interviews on Manx Radio and Manx TV - before being blocked in 2019.

**Alex Allinson, MHK** - GMC number 34823839, as a decades long Doctor his Hippocratic Oath should be to first, *'do no harm'*. Yet as a former GP, and 'statin' pusher he is a curiously vocal proponent of abortion, and recently championed the End of Life Bill in the Manx parliament.

**David Ashford, MHK** - the former 'Health' Minister recklessly proclaimed a PCR 'test' to be the 'gold standard' - This false claim drove the toxic *'jabs in arms'* mantra, based on criminal negligence.

**Clare Barber, MHK** - former nurse, Minister of Department of Environment Food and Agriculture. Makes many false claims of *'avian flu'* compounded by the claims of her colleague 'Dr' Amy Beckett.

**Rob Callister, MHK** - when questioned in Parliament Street Ramsey about 'covid' jab & Abbotswood deaths - he threatened to fight, saying: *"I will forget my position"*, (film available).

**Alfred Cannan, MHK** - Chief Minister, made countless unscientific claims, of an *'Omicron variant'*, although as no 'virus' exists, it is just another false *'assembled model'*. Is Alf really that ignorant?

**Claire Christian, MHK** - after she received the damning DHSC role film (featuring Abbotswood nursing home manager Zandra Lewis) on Tuesday 18<sup>th</sup> July 2023 Claire sent me a text: *'I have forwarded the video to the police chief constable'*. Claire, nor Manx Constabulary Chief Constable Russ Foster have been in contact to enquire any further. But we now demand an Abbotswood INQUEST.

**David Cretney, former MHK** - and Minister, told Janet Quane (post jabbed... *'magnetic Janet'*) not to mention her post 'covid' jab harms, subsequent to which she suffered a debilitating stroke.

**Paul Craine, MLC** - Paul is an expert in Isle of Man population statistics, yet currently doesn't air the increased deaths across all ages and the 100 year low, Manx birth, rate. Why has he lost interest?

**Julie Edge, MHK** - Education Minister, blocked whistle blower committee appearances, despite in previous years being keen on truth and transparency. She also pushed masks during the Isle of Man 'covid' Post Office 'initiative'.

**Joney Faragher, MHK** - Her 29<sup>th</sup> July 2022 email, attached with it five 'papers'. However, fake 'science', passed off as expertise is fraud - especially peddling the use of *'vero' cells*, to prove 'viruses'.

**Michelle Haywood, MHK** - claims to be a 'scientist' and one with a PhD. Her recent tweet on 'X' said *there is no need for 'viruses' (as she had a computer model?)*. This lunacy flies in the of the scientific method. Michelle is also involved in 'population re-balancing'... Her Manx Independent newspaper

**Lawrie Hooper, MHK** - 'Health' Minister and pusher of the 'covid' narrative. But is under-researched, hence his Isle of Man Courier newspaper article of 17<sup>th</sup> December 2021 in which he exclaims that: *'No covid test is 100% reliable'*. For a man claiming to be a current Manx 'Health' Minister, yet who is 100% inaccurate with his prediction is a rare talent indeed.

**Peter Karran, former MHK** - former Education Minister, during a meeting at his house, on Tuesday 8<sup>th</sup> August 2023 concerning State obstruction regarding 'covid' jab harms, Peter warned strongly: *"they will cuntify you"* (or, *"yoos"*, as he more likely said). Peter, when asked on 18<sup>th</sup> October 2023 at a Justice For Jabbed event did not wish to ask questions at the public, filmed, event (film available).

**Sarah Maltby, MHK** - daughter of David Cretney, for some in built selection not election, nepotism.

**Jason Moorhouse, MHK** - ex Castle Rushen High School teacher. A big fan of flu' and 'covid' vaccines. Keen to ask so many questions, but not a single one on the 1,000 Manx jab, maimed and murdered.

**Chris Robertshaw, former MHK** - once told me to: *"fcuk off"* in Ramsey, but earlier this year he finally and cordially confirmed that he had suffered *"atrial fibrillation"*, after his 'covid' jabs.

**Laurence Skelly, MHK** - President of Tynwald, who on 2<sup>nd</sup> April 2020 extolled on 3FM, how he was: *"inspired by Isle of Man manufacturing innovation making parts for ventilators, respirators, and face masks"*. Most interestingly, to protect against something that doesn't, actually, exist, Laurence.

**Juan Watterson, MHK** - On 14<sup>th</sup> August 2018 as Speaker of Tynwald Parliament, he hosted an HPV Vaccine event in Government Buildings. Later, Juan was not helpful in allowing Dr William Thompson to address our parliament regarding 'autism' incidence amongst black boys after their MMR jabs. Thousands of documents were shredded from the 2004 vaccine 'trials'. Senator Bill Posey took up the case. Meanwhile in the Isle of Man, a retired GP, Lynne Hulme, of HACA Isle of Man, said she'd attend the 'HPV' debate so long as she wasn't filmed. But as to speaking out *"she'll do anything"* as Mr Meatloaf said: *'but \$he won't do that'*. Now is the time, for any doctor, anywhere, to investigate.

**Tony Wild, MLC** - On 13<sup>th</sup> December 2018 - wrote to David Ashford Health Minister, copying in Steve Rodan, Peter Eagles (The Bishop of Sodor and Man), John Quinn (Attorney General), Rob Callister, Tim Crookall, Alfred Cannan, Ann Corlett, Jason Moorhouse, Tim Baker, me, and Paul Moulton. To quote from the from the email, sent by Tony: *'I suspect that my email will be as welcome*

*"as a hole in the head but it needs sending". I have listened to Courtenay last week and supported him in a Tynwald Committee last Friday. Courtenay tells me that Statins and Vaccines are not good for us. So from a simple banking question when it comes to "whistle-blowing" why does no one argue against him? Courtenay makes a really well balanced case and yet no-one in Health will speak against him and provide the argument. Personally I think it is a disgrace that Courtenay has not been challenged. I only want honesty Minister. Something feels incorrect and I cannot ignore that fact.'*

**But, all political tides turn** - Anne Craine, former MHK (and as Manx as the come) is an ex Isle of Man Treasury Minister (2010 - 2011). Anne sent me a text 'well done' after I had invited her to the Justice For Jabbed 18<sup>th</sup> October 2023 event. Only a small Manx gesture but maybe it's a good sign. To date not one MHK, nor MLC, has asked to debate excess Manx 'covid' vaccine harms and deaths in public - such is the omertà, an oath of silence that rots their collective soul. Remember these matters on election day 24<sup>th</sup> September 2026 if any interloper comes calling for re-election or for their rinse and repeat re-assignment. Likely, none of the current bunch will expose 'covid' in their manifesto...

**Media Role** - Phil Gawne is a presenter on Manx Radio. He is a former MHK, and former Minister, his boast is of a proud Manx language speaker. As a young man, he was a member of Mec Vannin, a Manx nationalist group, which was known to burn down houses of 'come-overs' to the Isle of Man. Now days his behaviour of covering up murders of his own people is unconscionable. He praised the lateral flow 'test' (LFT) not knowing there was no antigen, but using 'LFT' and other 'covid tests' you can get kiwi fruits, lemons, coca cola, (and goats) to 'test' positive for 'covid'. Any strain, of course.

His daughter experienced debilitating MS, so I supplied Phil with a 53 page document highlighting the evidence that vaccines do, largely, trigger 'it'. He admitted his daughter had only had two 'covid' injectables, but *"she wouldn't be having any more"*. In the light of free speech he still chose to redact five minutes off our Manx Radio interview of 10<sup>th</sup> November 2022 (although we do have a full copy, before the 'final' version was taken off air) in which I named five 'covid' criminals. A claim that still stands today for public scrutiny, when Karim Khan is motivated to act in the public interest.

**Chris Kinley** puts on a Manx Radio persona as the happy little chappie, on air. However in August 2022 a couple of us were wearing **Justice for Jabbed T shirts** at the Grand Stand during Manx Grand Prix. We asked Chris to join us for a photo opportunity... **his reply: "I can't get involved"**. Sadly then.

**Paul Moulton** - makes emotional and passionate videos, bemoaning the withholding of Isle of Man government 'covid' emails and 'instructions' during March 2020. Replies to his Data Subject Access Requests (DSAR) are being withheld. However Paul, dares not go upstream to no 'virus'. **He used to interview me regularly, but he warned me on camera about "upsetting big pHARMA lawyers"**. The media was the 'virus', but acted as useful idiots, giving easy access to peddlers and gatekeepers.

**30 Jul 2018 - Manx Radio's Beth Espey** hosted an 'HPV vaccine' video of 17 mins 43 seconds - along with her derisive, over toxic, HPV vaccine harms, colleague, Christy Dehaven. What a hatchet job and how I had to bite my tongue and their right on, left leaning, abject repeaters. Sad in truth.

**Juan Turner** - is a former MLC, now heading up the Isle of Man Energy FM radio station. Despite being informed of the criminal 'covid' con, **he too remains silent to keep his licence to operate.**

**Jason Quinn** - (and before him Ron Berry) runs the 3FM radio. Prior to my first arrest, when highlighting HPV vaccine deaths and harms, Ron shook my hand, intoning *"he had daughters"*. Since then Ron has been 'covid' jabbed and avoided all contact and debate. Ron's colleague, Jason Quinn, was brought into knowledge of 'covid crimes' when we met at 3FM offices on 6<sup>th</sup> December 2022.

### **Media character assassination...**

The Ramsey Spar shop billboard, carried my name and false 'stalking' claim, as did Ramsey EVF Petrol Station, as did the heavy footfall Douglas, Steam Packet Terminal - targeted character assassination, by malicious Manx media. That's how 'it' works, under central orders. Whatever happened the old notion of *'innocent unless (not until) proven guilty.'* One big peddler of 'safe and effective' and 'settled science' mantras during 'covid' was Manx media's very own Gef The Mongoose (@GefMongooseIOM on 'X') but as history unfolds he may regret promoting the 'jabs in arms' mouthpieces, as people die off.

### **Manx Police Criminal Obstruction and Treason...**

On **6<sup>th</sup> May 2021** Mark Newey Detective Inspector of Manx Constabulary and I met at Police HQ in Douglas. He soon became agitated, stood up, and towering over me he ordered me out after I said: *"neither your relative, nor anyone, has died of 'covid'. Anywhere"*. I remained seated. On presenting my book to him, he said he had read 'The Covid Con, A Wake' but not my first book. As the designated 'Investigating Officer' he has not investigated anything of substance related to a 'virus' as causing a single, no autopsy, 'covid' death at Abbotswood in 2020.

Former Manx policeman of 18 years and cover up specialist Ged Power now has a media channel, but quickly took down our 'covid' criminals video two years ago, as truth was never really his thing.

**During August 2021**, I hand delivered to Isle of Man Police HQ a 'covid' jab crimes evidence bundle of around 600 pages. Despite most of the packages being unopened the unscrutinised evidence was later threatened with destruction unless I collected it - which I did for safe keeping and retention in December 2021, from Selena Monplaisir on the front desk at Police HQ, Douglas.

On **13<sup>th</sup> December 2021** - Isle of Man Constabulary Detective Inspector Mark Newey (Oscar 20) the Abbotswood Investigating Officer into at least 18 elderly 'covid' deaths in April 2020, emailed me: *'Courtenay, Please remove me from your distribution list. Mark Newey.'*

On **13<sup>th</sup> December 2021** - While Mark Newey was busy emailing, The Guardian newspaper front page carried the story: *'UK booster jab roll out to increase to 1m a day to battle Omicron 'tidal wave.'* More agenda driven, lies. The 'variant' and 'virus' names are a form of mocking, to see what the masses will wake up to. Literally.

On **29<sup>th</sup> September 2022** - Manx policeman Steve Gadman came upto us in Parliament street where we were standing in silent vigil, I in a Yellow Vest, emblazoned with: HPV Vaccines Deaths & Harms. I was with two friends, who were in Justice For Jabbed T shirts. I later compiled two pages of notes of the meeting for the record as I'd confirmed to Steve that the jabbing may have stopped but the cancers caused, and infertility induced, by HPV jabs, would show up a few years later. On the Isle of Man as they have in UK and Australia - as the most highly HPV vaccinated countries, at 90% 'cover'.

## King's Counsel - Numerous False Statements

**1). Kate Brunner, KC** - claims to be experienced in criminal and healthcare law. Appointed to head up a £1.5 million Isle of Man Government 'covid review'. Despite claiming subject matter expertise and experience, Kate previously made repeated false claims of 'pandemic' and 'covid', in her 17<sup>th</sup> January 2021 Western Circuit 'covid' Report, which contains claims of 'transmission' and 'infection'. *For the avoidance of doubt, we the people now demand an INQUEST, quite simply as the UK ONS figures expose the excess British Isles deaths by jab, reality - which no insulting 'review' will ever expose.* On 11<sup>th</sup> December 2023 Manx Radio announced the 'covid' review report by Kate Brunner would be delayed until 8<sup>th</sup> January 2024. If it contains any claims of a 2020 'covid' deaths pandemic' then that is treason - it would another 'covid' fraud, on the Manx people, of £1.5 million.

**2). Stuart Gale, KC** - is an ex Ramsey, Isle of Man resident. He is now Co-Lead Counsel, in the Scottish 'covid' enquiry. On 28<sup>th</sup> September 2021 Stuart peddled a 'covid enquiry' request in the Manx Examiner - since then he has stayed closer to home making a great living, fraudulently, on the Scots.

**3). Hugo Keith, KC** - during the UK Covid Enquiry, Hugo cited infection rates. As if a 'virus' existed. Peddling the official 'covid' existed narrative is highly profitable - think 2017: Chilcot and Tony Blair.

**4). Richard Wright, KC** - and I met on 16<sup>th</sup> October 2023, outside The Thirsty Pigeon. We chatted, as I recognised him. He said: *"I've got your book"* (The Covid Con; A Wake) as he, with a colleague took a Justice For Jabbed leaflet - inviting him to the public event on 18<sup>th</sup> October 2023. Neither attended.

## Legal Obstruction on and off The Isle of Man

**During 2018** - lawyer Nigel Taylor had been keen to sue for Dengvaxia jab harms (a jab to thwart false claim 'dengue' fever) in the Philippines. We approached a Filipino Nurse working in Ramsey to be filmed in a 'harmed jab recipient awareness', video. But Nigel soon dropped legal action when he realised Bar Society paymasters might not wish to challenge a 'safe and effective' vaccine narrative.

On **Friday 5<sup>th</sup> July 2019** - before my arrest, I had been forewarned of the antics of Roger Phillips, Clerk of Tynwald had when 'approving' my Petition returned it by email with the date altered back to '2018'. His emailed response of '*oops*' didn't cut much ice. On the day of Petition delivery a friend compiled a 23 minute film which shows Roger clearly folding my HPV vaccine harms petition and putting it surreptitiously at the bottom of the pile. To avoid anything contentious, exposing criminality. When Roger retired, his position was taken up by Jonathan King as Clerk of Tynwald. True to form, Jonathan was soon to email: "*please remove me from your mailing list*".

On **9<sup>th</sup> January 2019** - Lawyers: Doug Stewart, Nigel Taylor and Eric Anglin, attended my 'flu vaccines harms talk. Each was brought into vaccine harms knowledge. Doug is better known for chairing the 2022/2023 Manx Tribunal where former Medical Director, Dr Rosalind Ranson was awarded £3.2 million from the Manx Government, despite making as yet unproven, 'transmission' and 'variant' claims. Doug is one to lurk in the shadows, as ten years earlier in 2012 I'd put forward ways to improve the Manx Financial Services Commission. Doug presented his criticism via me, but chose to do so anonymously, in case it harmed his 'prospects'. Whereas mine were attributed to me.

**In March 2019** - I met Robert F Kennedy, Jr at Autism One. During a hearty breakfast, he confirmed his \$1 trillion, 900 page, vaccine lawsuit. Of his seven children five have allergies, induced he says, by vaccines. His croaking voice, is he says, due to a 1990's 'flu' jab. He is standing as 2024 US President.

**On 4<sup>th</sup> April 2019** - the quarterly education session of Isle of Man GP's asked me to present my evidence of statins harms. Afterwards, I ventured evidence of vaccine harms, and the false claims of 'polio' and 'smallpox' eradication by 'vaccination'. In many cases, the 'vaccine' did the damage blamed on 'small pox' and 'polio viruses'. When the 'doctors' couldn't rebut my questions, 15 of them walked out, as witnessed by vaccine pusher 'Dr' Alex Allinson, now Minister for Treasury Isle of Man.

On **14<sup>th</sup> September 2019** I met **Doug Stewart** and Nigel Taylor, senior lawyers. Nigel, though cordial and urbane, started with subtle intimidation (from my contemporaneous notes) saying: "*be careful, you could be done for harassment or defamation*". As the meeting ended, Doug, then warned me off, after Googling a recent news article, he said... "*the state is brutal with people who go against it, the establish has ways*", or very similar intimidating words. It was a clear threat, but I stayed silent. Doug was the tribunal head of the 'Dr' Rosalind Ranson, unfair dismissal case, to her £3.2 million benefit.

On **Thursday 16<sup>th</sup> January 2020** Sue Mowle asked to be removed from my e-mailing list (as I was reminding her of our 15<sup>th</sup> November 2017 meeting on HPV vaccine harms, with then Education Minister, Graham Cregeen, for which she had 'lost' the notes).

On **11<sup>th</sup> Nov 2021** - I received an email from **Natalie Birchall**: *Hi Courtenay, Suzanne said you may want to reference this in court cases. Here is email forwarded to you to use with attachments.*

The attachments confirmed over 1,000 Manx people had been MHRA Yellow Card recorded as being 'covid' vaccine killed or injured (upto 12<sup>th</sup> December 2021, by Moderna, AstraZeneca, and BioNTech Covid-19 vaccines). Freedom of Information reply email dated 21/11/21, FOI 21/1208 CSC 74951, for MHRA post 'covid' jab harms Yellow card reports, up until 12<sup>th</sup> Nov 2021. It was Natalie, who after seeing a video where I outlined the loss of the appendix of my god daughter, after her HPV jab, called to say her son has suffered a similar fate. Presumably it was a jab, for his cervix?

On **17<sup>th</sup> November 2021**, my Mother Margaret Eileen was cremated. Knowing her lifelong resilience I chose instead to be in Court in the Isle of Man, as that date was set for one of my three hearings against David Ashford, Health Minister, to expose his false claims of 'viruses', 'variants' & 'covid'. The hearings were judged by Isle of Man First Deemster Andrew Corlett Master of The Rolls. Andrew highlighted key issues: "*we are not here to judge science, nor politics*". Hence the court never sought proper discussions regarding proof of any: 'virus', or 'test', or 'contagion'. The Deemster said my case was weakened due to me making no financial claim, but now we demand an ICC, Hague, INQUEST.

**In 2022** - <https://justiceforjabbed.im> was launched. The website was set up in memory of over 1,000 injured Manx men and women as exposed in Official MHRA Yellow Card Reports. At least 700

people maimed or murdered after **Oxford Astra Zeneca** jabs, for which **'Sir' Andrew Pollard** was chief 'scientist'. A further 300 Manx people presented MHRA Yellow Cards for Pfizer deaths & harms. Also, see we retain updated MHRA Yellow Card reports, as emailed to me on 5<sup>th</sup> December 2023 for Manx harms post 'covid' jab up until 15<sup>th</sup> November 2023 - ref FOI 23/857. A London lawyer, Peter Todd, of Scott-Moncrieff is now suing Astra Zeneca after a Coroner ruled death by 'covid' jab... Brook Jackson is a Pfizer 'trial' data integrity, whistle blower. She worked at Ventavia, a contractor whose role was to ensure no criminality took place - but it clearly did, in spades, as she reported to the FDA.

**On 8<sup>th</sup> February 2023** - Manx Policeman Muscutt (#180) & Policewoman Faragher (#24) refused to give a 'covid' crime number for the 'covid' jabs being administered later at Ramsey Cottage Hospital.

**On 8<sup>th</sup> May 2023** - whilst coincidentally, I was attempting to deliver hundreds of pages of 'covid' crimes evidence to Manx police: Danielle Smith, Premier of Alberta Canada, was the first politician to apologise to the 'covid' unvaccinated. She admitted she was vaccinated with one dose of the Johnson & Johnson 'covid' vaccine. She also said that the 'COVID' unvaccinated have faced the most discrimination of any group she has seen in her lifetime. She continued, *"as everyone knows, I was against the use of vaccine mandates during COVID."*

**On 5<sup>th</sup> July 2023** - A Manx Tynwald Day Petition of Redress by 'covid' vaccine harmed Nikola Brindley, and Steve Wooton over the death of his Mother from Astra Zeneca and Pfizer 'covid' jabs, accompanied by Natalie Birchall, collator of the MHRA, Yellow Card, evidence of 1,000 covid jab injured and deceased Manx people. Well done to all!

**On 27<sup>th</sup> September 2023** - case lawyer Michael Jelski emailed me *'This matter was heard as a criminal prosecution in the jurisdiction of the Isle of Man Courts of Justice Summary Courts Division'*, in my 'dog on the beach' case. But with all three complainants citing me as 'an anti-vaxxer' the agenda was clear. I got a £1,000 fine, and £500 costs, against me. Michael Jelski acted ultra vires in claiming that it was a 'criminal' case, while beach 'rules' ARE private corporation ordinances, not 'laws'.

Paul Beckett is the newly appointed Tynwald 'Ombudsman'. But, so far, Paul refuses to look at the complicit nature of all Manx parliamentarians. Likely, Paul was just dropped in position to obstruct.

**Jersey and Guernsey** - The 'close to the people' nature of smaller nations enables easier access to servant politicians, who should if they choose, be able to act more quickly than larger nations, such as recent activity in Italy and Germany. The smaller locations are likely our easiest and likely quickest remedy against State democide. In big countries bad things are easier to obscure. In early December 2023 we wrote to key people in politics, schooling and medicine who were sent: The Covid Con; A Wake, along with HPV vaccines papers, to help stir their conscience.

In Jersey we wrote to: Andy Jehan, Sarah Hague, Nashima Rashid, and Maria Stegenwalner.

In Guernsey we wrote to: Peter Ferbrache, Heidi Soulsby, Sue Morgan, Juliet Ford, Alison Elliott and Director of Public Health, Dr Nicola Brink.

### **Deliberately Broken Laws and Acts...**

We have arrived at a place none of us thought we would see. We are at war with cruel 'rulers' who have never served our interests so poorly. Not one thing, but countless harms, carefully delivered by bribed and compromised, selected candidates, to do the bidding of massive business interests.

Those interests lurking in the shadows are enormously wealthy corporations: BlackRock, Vanguard, and State Street - names unknown to most people. The entitlement bullies flout their crimes through criminally corrupted practices, brutally ignoring: Crimes Against Humanity, Fraud Acts, Medicines Acts, Poisons Acts, Nuremburg Code, Evidence Acts, Human Rights Act, Body Autonomy, Informed Consent, Unjust Enrichment, Magna Carta, Equalities and Discrimination Acts, Children and Young Person's Acts, Police and Criminal Evidence Acts. **Such transgressions, confirm the shameless ...**



denial of decent justice. Our foundation of lawful remedy depends upon honourable enforcement as claimed in Blackstone UK, Three Volume 2023 Police Manuals: Volume 1 Crime, Volume 2 Evidence and Procedure, and Volume 3 General Police Duties. Across the board on the Isle of Man, the people have been failed by many insiders turning a blind eye, while ignoring: Hippocratic and Police Oaths, duty of care, duty of candour, the need for due process, and true impartiality. This shall not continue.

The Isle of Man Attorney General, Walter Wannenburg, is acting on behalf of 'King Charles III' in my forthcoming legal case on 15<sup>th</sup> and 16<sup>th</sup> January 2024. Both lack subject matter knowledge, and will try, with colleagues, to obscure the real reason of State Protocols - by bringing a false claim, to 'trial'. Before Walter, as Attorney General, we had the corrupted John Quinn, who blocked every exposure.


We urgently need to adjudicate all claims of any 'viruses' and the criminally fraudulent PCR 'test'.

**Pfizer, Astra Zeneca, Moderna**, and others, were only vaccine distributors of highly toxic, DARPA (Defense Advanced Research Projects Agency) weapons. It bears repeating there were 1,291 harms, including deaths, on the Pfizer 'trials' - facts which Pfizer wished to keep hidden for 75 years. These genocidal treasonous facts were only exposed after a Court Order, triggered by US lawyer Aaron Siri.

**Finally** - I have written to you Karim, as decent justice has been repeatedly blocked at every turn in my location of the Isle of Man, British Isles. The issues I have consistently, publicly raised since 2017, include targeted infertility, and unlawful killings - resulting in dreadful crimes against humanity. All 'viruses' and 'vaccines' are but deeply embedded, 'well' marketed, yet catastrophic, superstitions.

Many of us can now see the State democide, and fertility reduction plans, in plain sight. Again, Karim, for the avoidance of any doubt it is our behest that these killings demand your urgent and fullest attention for an impartial, no holds barred, INQUEST, with immediate prosecutions of all criminals.

I am whole complete and fully accounted for from fertilisation to last breath.
