### Corporation Grant Deed

TO 406 CA (8-65) THIS FORM FURNISHED BY TITLE INSURANCE AND TRUST COMPANY

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,

MARBLEHEAD LAND COMPANY

a corporation organized under the laws of the state of Delaware hereby GRANTS to

MILDRED MANSDORF, a single woman

the following described real property in the County of Ventura, State of California:

As per legal description attached hereto and made a part hereof:

Part of Lot 5 of Section 26, Township 1 South, Range 20 West, San Bernardino Meridian, in the county of Ventura, state of California, according to the plat of the survey of said land filed in the District Land Office on April 10, 1900, described as follows:

Beginning at a point in the center line of the State Highway right of way, as described in deed to the State of California, recorded October 9, 1937, in book 522 page 333 of Official Records, at the northwesterly extremity of that certain center line course described as "South 68° 03' 00" East 1700.21 feet" in said deed running thence, South 21° 57' 00" West 50 feet to a point in the south line of that certain strip of land 10 feet wide, as conveyed to the State of California, for a public highway, by deed recorded March 20, 1944, in book 690 page 19 of Official Records, thence South 68° 03' 00" East along the southerly line of said 10-foot strip of land so conveyed to the State of California, 705.40 feet to the true point of beginning for this description; thence from said true point of beginning and continuing along the south line of said 10-foot strip of land,

- 1st: - South 62° 03' 00" East 125 feet to a point; thence,
- 2nd: - South 21° 57' 00" West to a point in the ordinary high tide line of the Pacific Ocean; thence,
- 3rd: - Westerly along said ordinary high tide line to the intersection of said ordinary high tide line with a line bearing South 21° 57' 00" West from the true point of beginning; thence,
- 4th: - North 21° 57' 00" East to the true point of beginning.

EXCEPT all minerals, oil, petroleum, asphaltum, gas, coal, and other hydrocarbon substances, contained in, on, within and under said land. and water

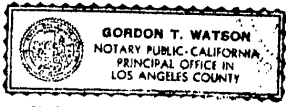
