Pursuant to the authority delegated to me by the Attorney General, under Title 21 U.S.C. Sections 871(a) and 873(b), and Title 28 CFR Subpart R, Section 0.100, you are hereby designated to:

- (a) conduct intelligence, investigative, and law enforcement activities, vested by law in the Attorney General, which relate to the suppression of illicit traffic in controlled substances;
- (b) execute and serve search warrants, arrest warrants, administrative inspection warrants, subpoenas, and summonses issued under the authority of the United States in the enforcement of the Controlled Substances Act and the Controlled Substances Import and Export Act;
- (c) make arrests without warrant pursuant to 21 U.S.C. 878 in the enforcement of the Controlled Substances Act and the Controlled Substances Import and Export Act; and
- (d) make seizures of property pursuant to the provisions of the Controlled Substances Act and the Controlled Substances Import and Export Act.

This designation is being issued in conjunction with the Metropoitan Area Task Force and will continue until unless terminated earlier in writing.

The above authorized duties will be performed by you in compliance with established DEA policies and procedures and under the supervision of the SAC of the Washington Division, DEA, or his designee.
