Dr. Fogg received the [NAACP coveted 'Barrier Breakers'](#) award presented by U.S. Congresswoman and 'House Speaker' the Honorable Nancy Pelosi after he won a 1998 U.S. District Court Title VII Landmark Verdict (**Fogg v DOJ/USMS**).

Dr. Fogg **joined BIG in 1999** after being recruited by **the honorable Oscar Eason (deceased), BIG's former National President** and a staunch proponent of BIG advocacy. President Eason directed a BIG press release on Dr. Fogg's 1998 landmark and successful Title VII (\$4-million in damages & promotion to Chief Deputy) race discrimination verdict in DC Federal Court against the U.S. Department of Justice (DOJ & USMS) [**Matthew Fogg, v. 2003 – 2005 - Dr. Fogg was BIG President of the RXI Department of Commerce Chapter (DOC) and he was responsible for changing the Chapter name in honor of the late Secretary of Commerce, **Ronald H. Brown**. **Matthew was instrumental in creating a BIG Central Committee of (6) six BIG RXI DOC chapter presidents to include NOAA, Census, Patent & Trademark, NIST and Main Commerce with DOC's Chief Operating Officer.**

Matthew Fogg spearheaded the implementation of an official BIG/DOC program that tracked and promoted Black employees from GS/5 through SES.

Dr. Fogg utilized his USMS Official EEO and Union expertise **to conduct fully attended workshops at every BIG NTC & NTI to present**. Today, he continues to represent many BIG members as victims of employment discrimination. He has prevailed in more than 20 official EEO Complaints at the Equal Employment Opportunity Commission (EEOC) process and mostly BIG members. Dr. Fogg **Co-Chaired** the famed *'Notification and Federal Antidiscrimination and Retaliation Act'* (**NoFEAR ACT**) committee consisting of BIG, NECEPS and other coalition partners led by Dr Marsha Coleman Adebayo pivotal in the congressional promulgation of the First Civil Rights legislation of the 21st Century. Signed law by President George Bush on May 15, 2002

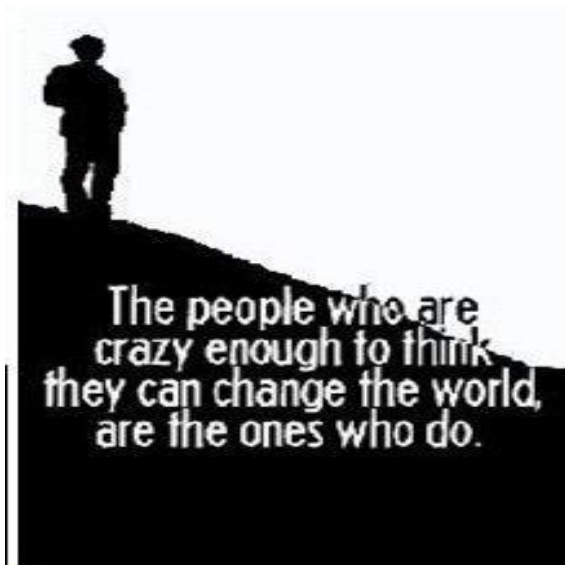
