**RETIRED CHIEF DEPUTY U.S. MARSHAL AND NAMED BLACK CLASS COMPLAINANT TO
SPEAK AT FUNERAL OF BLACK MAN SHOT DEAD BY WHITE DEPUTY U.S. MARSHALS IN
WASHINGTON D.C. ON FEBRUARY 28, 2023**

According to the Washington Post and Metropolitan D.C. Police Chief Robert J. Contee III [news conference](#) Alaunte [Scott 22 years old](#) was killed by Deputy U.S Marshals who approached him on Tuesday, February 28th on a Parole Violation warrant when Scott ran away and allegedly produced a gun.

CARCLE Executive Director Dr. Matthew Fogg a retired Chief Deputy U.S. Marshal, a CNN/MSNBC Guest Law Enforcement Analyst who filed a race-based (Black) Class Action Complaint in 1994, and still pending after 29 years, emailed [President Biden, Vice President Harris, the Congressional Black Caucus and cc'd other American VIP's](#) in January 2023. In his email Fogg presented seven (**7**) solutions to America's growing law enforcement racial divide and further indicated, the U.S. Marshals Service (USMS) supervised by the U.S. Justice Department (DOJ) is complicit in the demise of Black and Brown citizens as a threat to National Security and Public Safety.

Fogg who won a 1998 Federal Jury Verdict that stated, *'the U.S. Marshals was operating a Racial Hostile Environment for African American deputy U.S. marshals.'* Fogg said, "Alaunte's death is truly another horrible Black tragedy and may now be a travesty-of-justice because race discrimination reeks in the USMS public and internal operations. Therefore, their integrity has been totally breached, and nothing the USMS/DOJ Officials say or [do when race is involved should be trusted.](#)"

Congress Against Racism And Corruption In Law Enforcement (CARCLE) organized in 1997 following long standing racial divisions in Federal law enforcement and USMS rank & file that garnered a Congressional Black Caucus Hearing of all Federal law enforcement Agency-Heads. The Hearing was predicated upon a New York Post featured cover story calling the USMS ["Bigots With Badges"](#). The news report detailed systemic and egregious internal racial exploits, including White Marshals using Dr. Martin Luther King's photo for target practice, White Marshals running through the Office wearing KKK hoods, abandoning Black colleagues on dangerous fugitive arrest and mocking photos of the death of a young Black girl amongst many other racially motivated incidents as an ongoing racial hostile environment, still unresolved today, and the longest running litigation in America's history.
