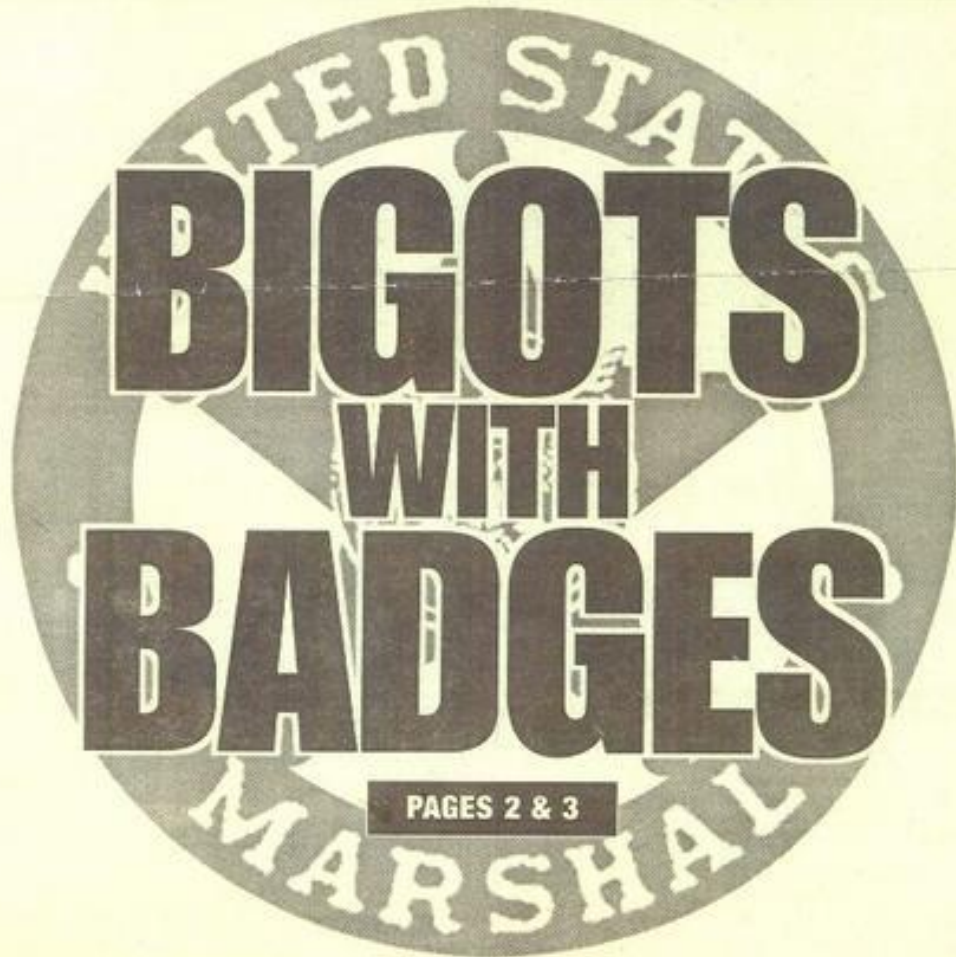

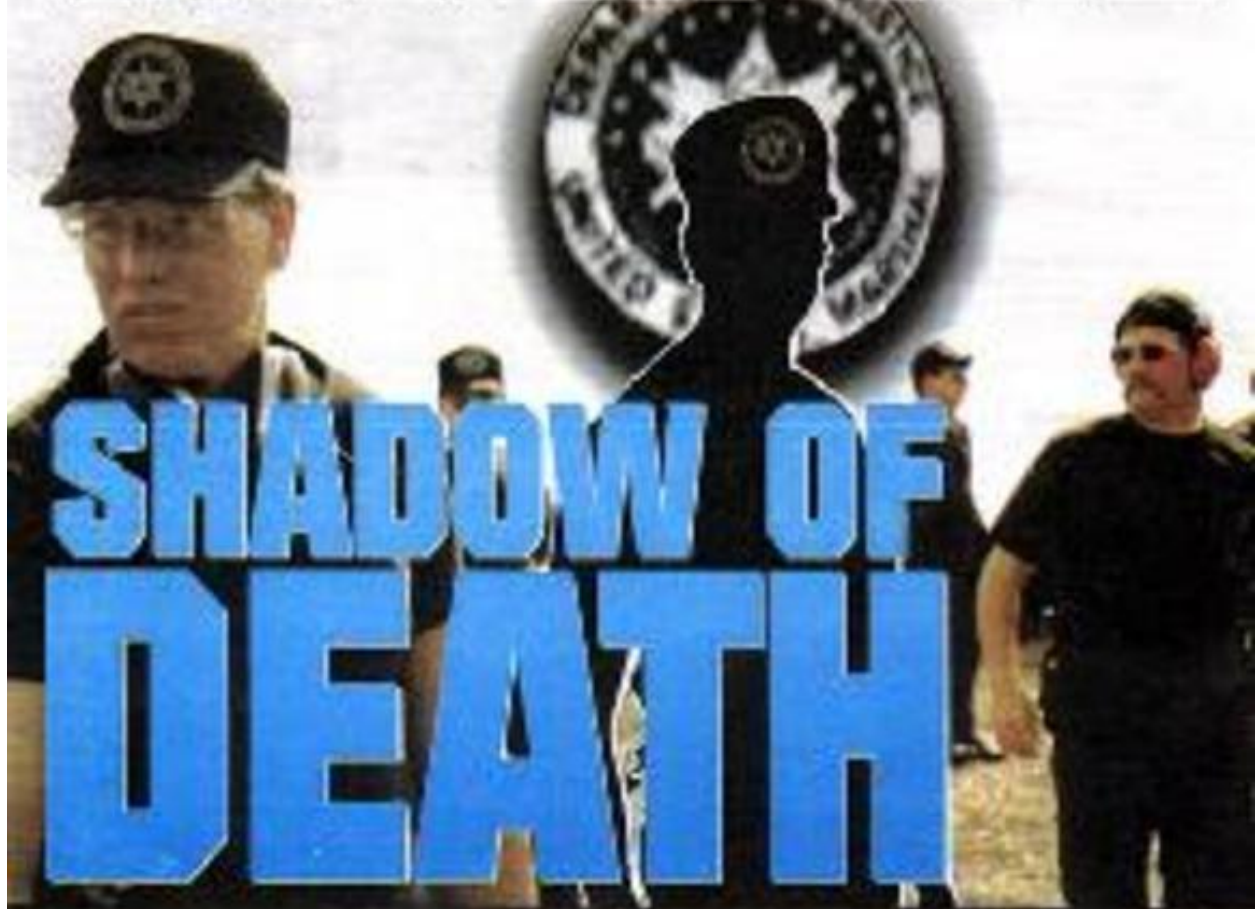

Sitting to Zanowic's right & left respectively, are District of Columbia USMS Supervisory Inspector Matthew Fogg and NYC Inspector William Scott. (Inspector Scott later died from injuries he sustained in a suspicious assault and unresolved NYC car crash). All three US Marshals had filed official USMS internal civil rights complaints and provided supporting testimony at the hearing on dangerous and long standing, systemic racism & corruption inside the USMS.

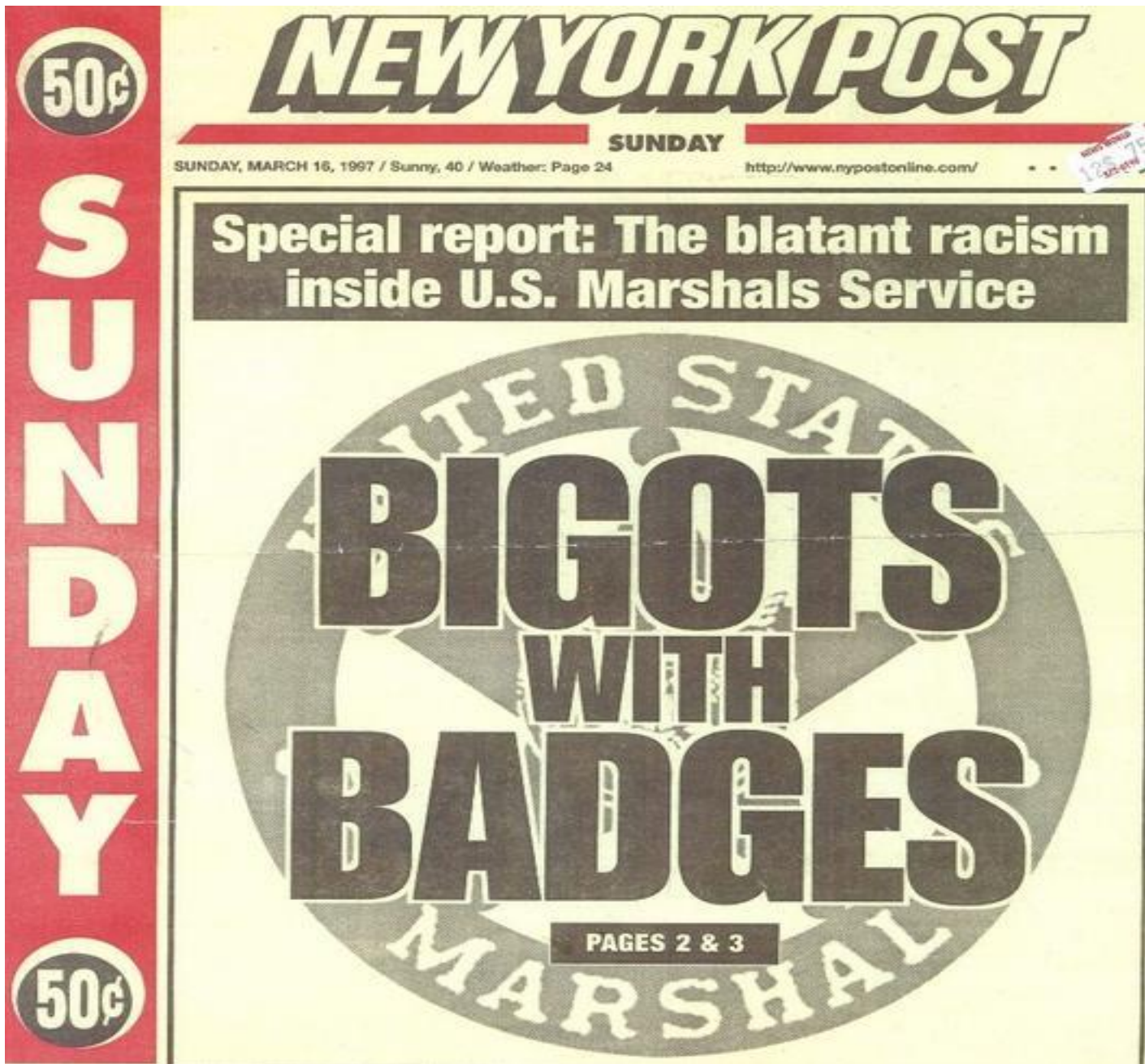

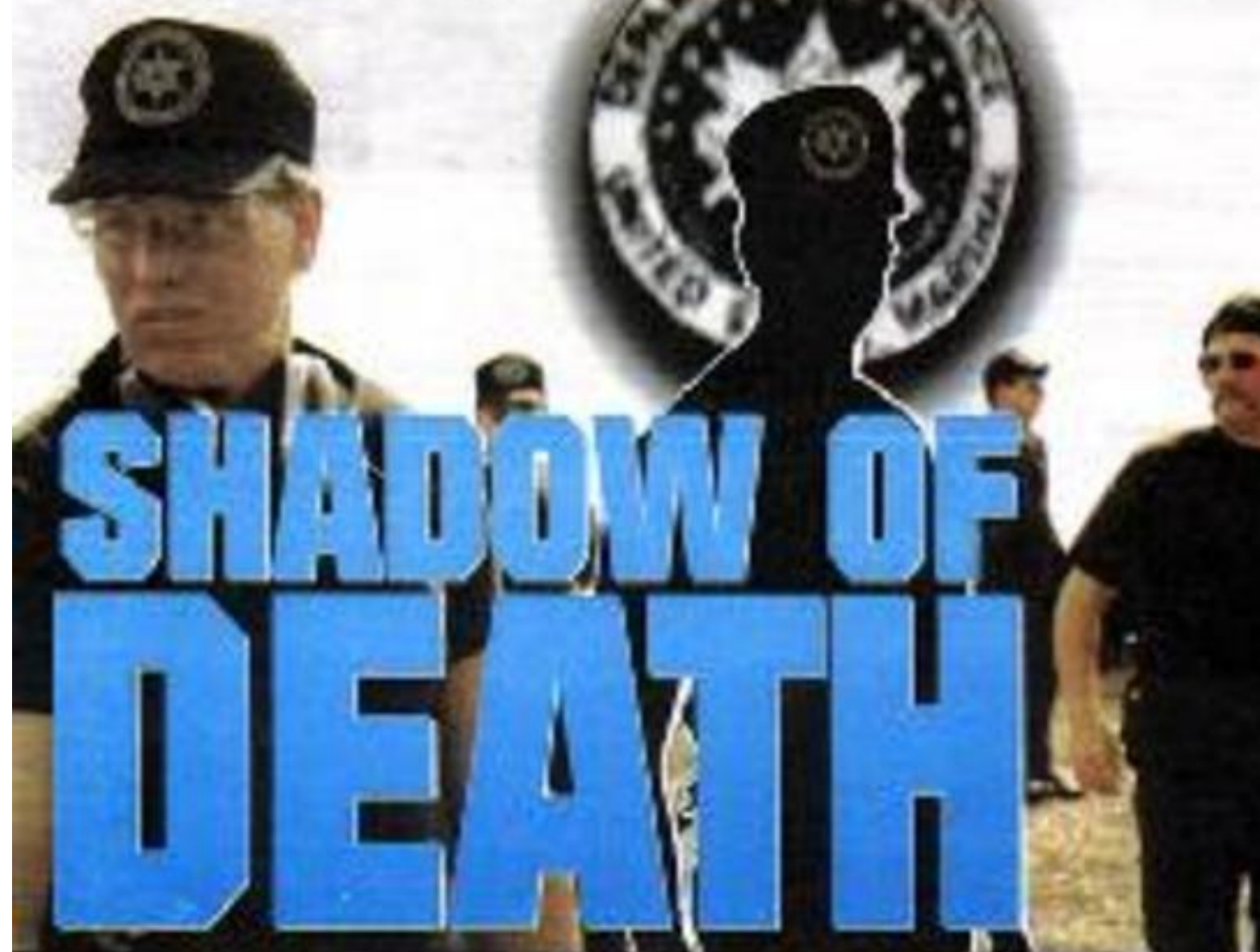
