 2. **Technical Specifications**
 - A. General

All fittings and support hardware shall be stainless steel. ~~All new panels shall be 4X rated.~~

All new panels shall be 3R rated.
 - C. Inside Columns

Add electrical outlets to every other inside column (20 Amp Circuit Outlets) Quads with four (4) circuits

Outlets shall be mounted on side of interior columns. FX boxes shall be used and all outlets shall be GFI

New breakers to be installed for new outlets and contractor shall dedicate (2) two circuits for each column
 - G. East Side

Replace outlets by Southeast corner

~~Add power to junction boxes under the bleachers and add 10 outlets on each 20 Amp separate circuits~~

Create in ground pull bow with tier 15 cover to replace existing pull box on pedestal. Trench along the edge of the existing concrete to power supply.

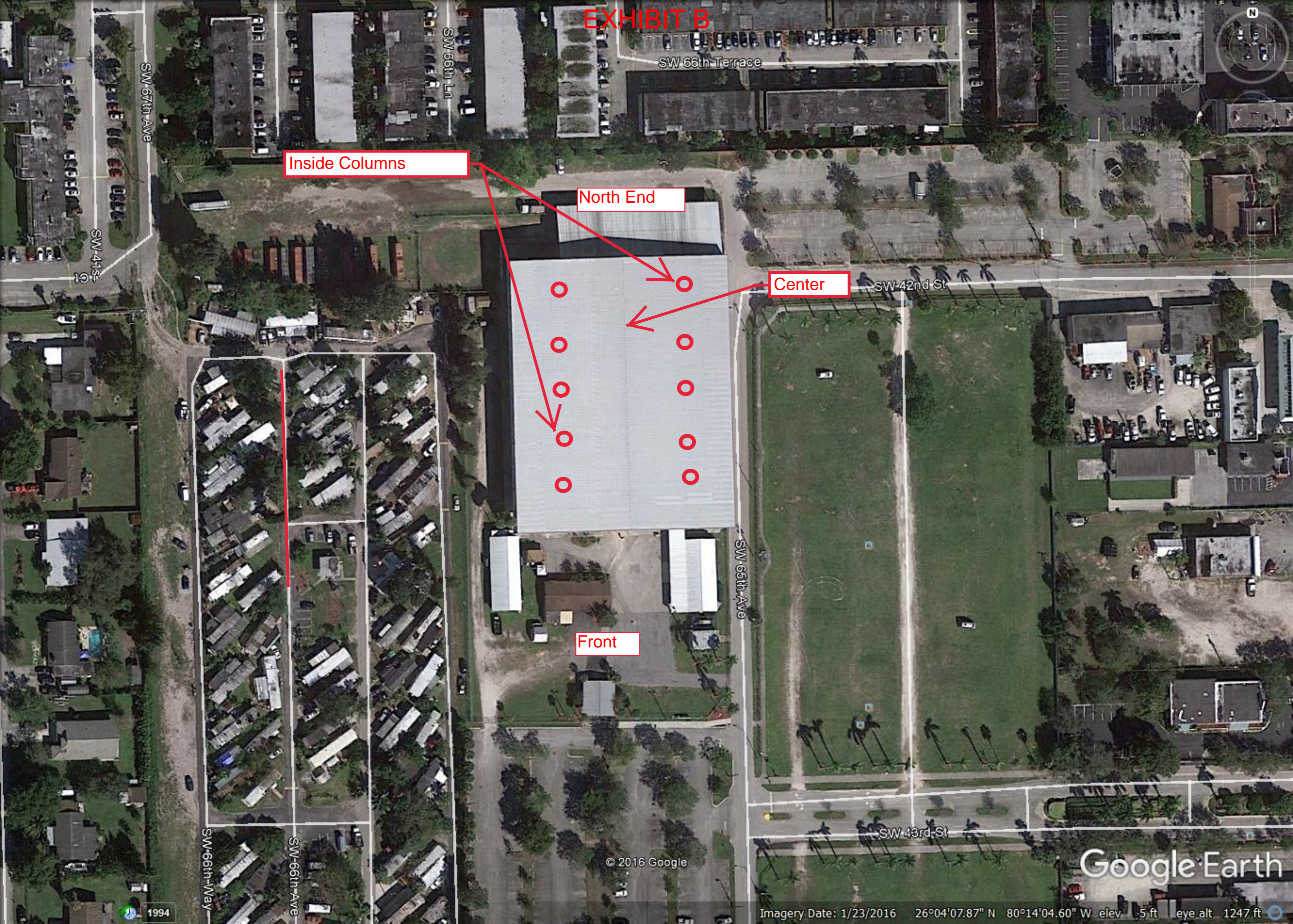
