

PRIZE COMPETITION POLICY (ONE Esports App Survey – August 2024) Prize Competition Terms and Conditions

By entering this prize competition, you agree to the terms and conditions set out below. ONE Esports Pte Ltd (the "**Promoter**") reserves the right to amend the rules of this prize competition at any time.

- 1. The prize competition is open to all aged 18 years or over, except employees of the Promoter, their families, agents or any third party directly associated with administration of the prize competition, and except residents of countries where participation to such game is not allowed under applicable law.
- 2. The prize competition is free to enter, and no purchase is necessary.
- 3. Each person may enter the prize competition by filling up and submitting the ONE Esports App Survey August 2024 questionnaire form in the ONE Esports App ("Questionnaire Form"). Participants may only access the Questionnaire Form from within the ONE Esports App installed on a Samsung Galaxy device. The ONE Esports App is available for Samsung Galaxy device users located in Indonesia, Malaysia, the Philippines, Singapore, Thailand, and Vietnam, and may be downloaded from Google Play Store at https://play.google.com/store/apps/details?id=gg.oneesports.
- 4. Each completed Questionnaire Form entitles one (1) entry to the prize competition. Participants acknowledge that all information submitted must be accurate, complete, and operational. Entries are strictly limited to one (1) entry per person, and any duplicate entries will be forfeited.
- 5. The prize competition opens on 1830hrs Singapore Time on August 28, 2024, and closes on 2359hrs Singapore Time on October 27, 2024 ("**Prize Competition Period**"). Entries received after the Prize Competition Period will not be considered.
- 6. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
- 7. Three (3) winners will be chosen by random draw by November 1, 2024. Winners will be announced on November 1, 2024 via a livestream on the Promoter's official Instagram channel (https://www.instagram.com/oneesports/).
- 8. Each winner will receive an Amazon eGift Card worth US\$50 (fifty US dollars).

- 10. The prizes will be sent to the email address as provided by each winner in the Questionnaire Form before November 8, 2024. Winners shall provide the Promoter with a valid email address for prize delivery. The Promoter shall have no liability for the winners' failure to receive notices due to spam, junk e-mail or other security settings or for the winners' provision of incorrect or otherwise non-functioning contact information.
