

Learn the Art of Developing and Formatting Annotated Bibliography in APA Style

Annotated Bibliography

Bibliography refers to the reference list of the secondary sources used, mentioned at the end of your paper. Annotation refers to a summary or evaluation of the content. An annotated bibliography is therefore a summary of all the secondary sources that you used in your paper. If you're already tired of writing your essay, you can ask an online [essay writer](#) to complete the annotated bibliography. As a bonus, they may also correct your small errors such as grammar and spelling.

APA Format

APA is a type of referencing and citation style that is owned by the American Psychological Association. Many scholarly journals follow this format and it is encouraged in most colleges as well. It has a unique citation, referencing, and organization style.

APA Formatting rules

1. Font: The font should either be size 12 of Times New Roman or size 11 of Ariel.
2. Spacing, margins, and indentation: The line spacing should be set to double (2), margins should be 1 inch on all sides, and each paragraph should be indented 0.5 inches using the Tab key
3. Page corners: Each page (including the cover page) should have a page number at the top left corner. The cover page has a running head with a shortened title while the rest of the pages only have a shortened title on the left-hand side.

How to develop an Annotated bibliography:

An annotated bibliography is written at the end of the paper. It is usually around 150 words for one reference. You should first complete your regular works cited page (bibliography) and then annotate each reference. There is a particular pattern that you must follow for a perfect annotated bibliography.

Skills required for annotated bibliography

Since you will have to write annotations for at least 3 sources in your paper, the process is a little tough. Some crucial skills that are utilized in this process are skimming, scanning, summarizing, and written communication. If you do not possess these crucial skills, contact a **paper writing service** online and send them your essay. These services will correct any minor mistakes in your paper and write your annotated bibliography for you.

What to write in your annotation?

You will start each annotation by discussing the author and study background in a couple of sentences. After that, you can discuss the audience that these authors had in mind. In a few sentences discuss the theme of the paper including methodology and findings. You must relate it with your work by explaining how the source is relevant. Finally, discuss if any limitations in the paper may make it biased.

Example of an annotated bibliography

Doe, J. (2020). The effect of temperature on the rate of boiling. Journal of Science, 8(1), 10-16

Note: The reference provided is a dummy APA article titled “The effect of temperature on the rate of boiling”. It was hypothetically written in the year 2020 by the author John Doe. The 8(1) represents the journal while the 10-16 represent page numbers of the articles within the journal. Sample notes of an annotated bibliography for this hypothetical article have been created. Please note that the annotated bibliography is to be written in paragraph form and that the provided bibliography is just the notes.

1. In 1 to 3 sentences: Professor John Doe has written this article in 2020. He is a professor of Chemical Engineering at MIT. Doe wanted to find the relationship between temperature and the rate of boiling.
2. The paper is available in the Journal of Science the primary audiences are physicists and hydraulic engineers.
3. 5 to 8 lines: Doe quantitatively proved that an increase in temperature is directly proportional to the rate of boiling. He carried out 10 sets of experiments on 10 different liquids to check this relationship. The results of the experiment proved his claims.
4. This source is relevant for my paper because I aim to find the relationship between viscosity and temperature. Since temperature and viscosity are directly related, a direct relationship between temperature and boiling rate can be predicted
5. The only limitation of this experiment was that it did not use oil as a medium whereas oil is significant for my research.

What are your options now?

The first step is to stay calm and make a mental note of what is required. Sometimes this mental note can cause unnecessary anxiety and stress. In that case, simply send your essay to an [essay writer website](#) and tell them “I have provided you with the professor’s instructions; please write my paper and include an annotated bibliography for the sources”. Within the provided deadline, you will receive your final paper that is ready to be sent.
