## ehealth Q2 Cancellation Survey Sweepstakes Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. MAKING A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. The following Sweepstakes is intended for participants in the fifty (50) United States and District of Columbia only and shall be construed and evaluated according to the laws of the United States. Do not proceed in this Sweepstakes if you are not a legal U.S. resident residing in the fifty (50) United States or District of Columbia. Further eligibility restrictions are contained in the official rules ("Official Rules") below.

- 1. The administrator of this Sweepstakes is Creative Zing Promotion Group, 2265 Lee Road, Ste 229, Winter Park, FL 32789 ("Administrator"). Any information provided by an Entrant will be used in compliance with the Sponsor's Privacy Policy at <a href="https://www.ehealthinsurance.com/about-ehealth/privacy-policy/">https://www.ehealthinsurance.com/about-ehealth/privacy-policy/</a>. The Sponsor and Administrator shall collectively be referred to as the "Sweepstakes Entities".
- **2. ELIGIBILITY:** In order for an Entrant to participate in the Sweepstakes and to be considered as a potential winner the Entrant must meet the following eligibility criteria:
  - Entrant must be a legal U.S. resident physically residing in the fifty (50) United States or the District of Columbia.

Entrant must follow the on-screen instructions to complete the online survey, click submit as directed and opt-in with their email and phone number to receive one (1) entry into the Sweepstakes. Email survey link is valid for one (1) use only and expires upon conclusion of the Sweepstakes Period. **Limit one (1) entry per person, per email.**

All entries must be by Wednesday, June 30, 2021 at 11:59 pm Pacific Time. Entries in excess of the limit may result in disqualification of the Entrant. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, registrations, logins, and/or any other methods will void such Entrant's entry and that Entrant may be disqualified from the Sweepstakes. Entries generated by a macro, script or other automated means will be disqualified. Each Entrant must be the rightful owner (or have authorized use) of the email address used for entry.
